

# Ban bulkheads movement for safe Eid journey: SCRF

UNB, Dhaka

Shipping and Communication Reporters Forum (SCRF) yesterday urged the government to ban movement of sand-carrying vessels or bulkheads from April 8-15 to prevent accidents on waterways during the Eid journey.

The organisation also demanded mobile court drives against all types of illegal vessels.

In a statement, SCRF president Ashis Kumar Dey and its general secretary Lion Mohd Jahangir Alam called for immediate action to conduct mobile court drives across the country.

They urged the Ministry of Shipping, Department of Shipping (DoS), Bangladesh Inland Water Transport Authority (BIWTA), River Police and Coast Guard to pay heed to their demand.

The organisation called for the involvement of district administration and the police to prevent waterway accidents.

In addition to punishing masters and drivers (sailors) without documents, the statement also demanded that vessel owners be held accountable for employing sailors without proper documents.

The statement expressed deep concern over frequent waterway accidents and the sinking of cargo boats in different parts of the country after being hit by bulkheads.

Despite the restriction on the movement of bulkheads from sunset to sunrise, the statement highlighted that hundreds of bulkheads are operating at night in absence of monitoring by the administration.

Citing the Parliamentary Standing Committee on the Ministry of Shipping, the leaders of the SCRF stated that while the number of registered vessels is 15,000, there are at least 85,000 types of vessels across the country.

Among these, approximately 70,000 vessels are operating illegally, with bulkheads making up at least 6,000 of them, they said.

# Passenger launches at risk of running aground

Passenger launches on Dhaka-Barishal river route are at risk of running aground during the Eid journey due to underwater shoals in the rivers.

As such, operating launches on the route may be risky during the journey of home-goers ahead of Eid, said launch drivers.

At least one lakh people may travel on the river route daily ahead of Eid-ul-Fitr.

According to Bangladesh Inland Water Transport Authority, passenger launches and cargo vessels require at least 8-12 metres of depth of water to navigate and sometimes run aground where the water is no more than four or five metres deep, often due to underwater shoals.

A total of 20 passenger launches will operate on the route for Eid journey, said launch owners.

They also said these launches will make round trips if passengers are available.



There are also plans to double the number of launches on domestic routes, but the need for navigability at different river points is likely to cause obstacles to that end, the launch owners added.

"Due to shallow waters and underwater shoals at different points, launched will have to run slowly, thereby taking more time to reach the destination. Sometimes, if a launch runs aground, it has to wait for the tide, which often takes up to three hours," said Saidur Rahman Rintu, vice president of Launch Owners Association.

"If a launch runs aground, it takes hours to make it move again, while fuel consumption also increases. It also poses a risk for the vessel to sink or undergo accidents at any time. So, we are worried," said Abdus Shukkur, chief master of MV Survi 7.

Launch drivers said that underwater shoals have formed in at least 18 places on Dhaka-Barishal route as well as local routes within Barishal.

# JP leader jailed for 4yrs in graft case

A Dhaka court yesterday sentenced Jatiyo Party leader Col (ret'd) Dr Abdul Kader Khan to four years in jail in a corruption case filed against him for amassing wealth beyond known sources of income.

Judge Sheikh Hafizur Rahman of Dhaka Special Judge Court-9 of Dhaka delivered the verdict in presence of Kader, also a former lawmaker from Gaibandha-1.

The judge also fined him Tk 61.92 lakh and directed the authorities concerned to confiscate the fined money in favour of the state.

Kader was, however, relieved from the charges of concealing wealth statement of Tk 24 lakh as the allegation could not be proved against him.

Anti Corruption Commission filed the case against him with Ramna Model Police Station in 2019.

After investigation, the ACC pressed charges against him on March 16, 2022.

# Cops to monitor highways with drones

Highway Police will monitor the areas prone to traffic congestion by flying drones to alleviate sufferings of passengers during the Eid journey.

Md Shahabuddin, additional inspector general of police and also chief of Highway Police, confirmed the matter yesterday after inspecting Dhaka-Aricha and Nabinagar-Chandra highways.

"Use of technology improves the quality of our services and enhances our efficiency. For this reason, we will use body cameras, drone cameras and CCTV cameras to monitor the highways. Areas that are prone to traffic congestion will be monitored with drones. We will also try to give traffic instructions through drones," he said.

He also informed that construction materials have been removed from the highways to make Eid journey smoother, while construction works will continue within enclosures.

Strict legal action will be taken against those who will collect extra rent anywhere on the highways, he added.

# 15 detained for pickpocketing, snatching phones

The Detective Branch of Dhaka Metropolitan Police yesterday claimed to have arrested 15 persons involved in criminal activities including pickpocketing and stealing mobile phones.

They were arrested during special drives conducted in the capital's Pallabi, Jatrabari, Signboard, and Chattogram Road areas on Wednesday.

The detectives recovered 79 smartphones, and 24 button mobile phones from their possession.

Among the arrestees, some are wanted in numerous cases filed over theft and snatching, said Mashur Rahman, deputy commissioner of police, Lalbagh Division.

These criminals used to steal mobile phones and cash by entering houses where the residents go to sleep without locking doors properly after Sehri, he said.

They also used to snatch away cell phones from anyone using those at crowded places such as markets, or while sitting next to open windows in public transports and private cars, he also said.

After stealing the phones, they used to sell those to brokers in front of Dhaka South City Corporation, at Stadium Market, and in Gulistan at Tk 500 to Tk 7,000, said Mashur, also an additional deputy inspector general of police.

"For selling the phones, they used to change the IMEI number with software. Sometimes mobile displays, camera casings, motherboards, batteries, and other parts are sold separately," he added.

# RMG workers protest for arrears

Hundreds of workers from Odyssey Craft (Pvt) Ltd in Dhamrai protested for the second consecutive day yesterday, demanding their salaries for March and Eid bonuses.

The demonstration began at 8:00am near Sombhag Union Parishad Bazar.

Arriving at the factory, workers found it closed without prior notice, leading to frustration and anger. They protested in front of the factory, attempting to block the Dhaka-Aricha highway, said Russell Pramanik, president of the Bangladesh Textile and Clothing Industry Workers League's regional committee.
