Nawajesh Salahin Sunny's trademark was sitting at his factory in a zenlike state of mind amidst scattered wooden planks and huge containers. His craftsmen noisily worked all over the place; while he supervised the work being done to give the factory a showroom-like facelift.

A graduate of BGMEA University of Fashion & Technology, Sunny worked many years as a designer in the RMG sector. When he got bored, he shifted his gear to making full-furnished

container homes. However, the business idea backfired due to the Covid-19 pandemic. He then wanted to

restart slowly by just



making aesthetically pleasing, small furniture and kitchen accessories. And thus, Ikigai Dhaka was born. For those of you who are not familiar with Ikigai Dhaka, let me clarify that

it is just a four-year-old furniture and



lifestyle brand. When I met them at the recently-concluded Dhaka Night Market, the name stuck with me for their aesthetically designed handcrafted kitchen wares and that thin, tanned, brown

leather tag. Everything about them spelt artistic appeal and like a hound, I followed their visiting card and found them at the chaotic Bosila Garden City.

Sunny said, "When we make a box, we don't just nail the four wood slabs with the base and leave it at that. Well, yes that is how an untrained carpenter with no design concept would do it, but I want to make the box look tasteful. So, I add tiny wooden hinges and hidden nails and retain the wood colour to appreciate its natural beauty.

"I lack the skills of a carpenter, so I

Ikigai Dhaka is still taking baby steps and according to Sunny they still have no identity in the tough furniture business. Their few ventures include making furniture for Ajo restaurant, Mermaid Beach Resort, and renovating a few family heirloom pieces for people who just walked in on their factory.

Besides conventional teak and mahogany, they work with wood that is not usually used for furniture-making babla, neem, shishu, gamari, shal, kanthal, and taal. The marble effect of different wood grains and the texture one can get are the fascinating aspects of Ikigai's small items like chopping boards, boxes, trays, spatulas, cheese and charcuterie boards, and food bowls. thing that pops up on your screen. You are not concerned with the feel of the product, the durability of the colour, whether you and most importantly actually need it or not!

"These random purchases are making your homes cluttered like a junkyard. You have no attachment to these mindless purchases. You cannot build a story with your chair, sofa, or bed unless you appreciate their worth and comfort," Sunny said.

The Ikigai philosophy originates in Japan and is the concept of discovering your purpose through exploring the intersection of what you love, what you're good at, what the world needs, and what you can be paid for. When aligned properly it gives you a purposeful life.

### Elderly woman dies in stampede during zakat distribution

An elderly woman died in a stampede during a zakat distribution programme in Rajbari Sadar upazila last morning.

The deceased was identified as Banu Bibi, 65, wife of the late Abdul Gofur Sardar of Gangaprosadpur village.

Locals say every year, Haji Delwar Hossain, a resident of Bhavanipur village, organises a Zakat distribution programme for those in need.

He started donating clothes and money around 7:00am at a pandal (bamboo shed) built next to his house for the programme.

People started arriving there early in the morning and formed queues for the zakat. At one point when people began pushing and shoving the woman fell on the ground and was seriously injured after being trampled on.

She was rescued and sent to Rajbari Sadar Hospital, where an on-duty doctor declared her dead.

Haji Delwar Hossain said he had asked for some police personnel from the Sadar thana to keep order but to no avail.

Assistant Superintendent of Police (Sadar Circle) Iftekharuzzaman, said, "A mobile police team was sent to the spot but the accident happened before they arrived."

### Young woman stabbed to death by neighbour

A woman died after being stabbed by her neighbour over a trivial matter in Jamalpur's Madarganj upazila yesterday.

The incident took place in Ramchandrapur

Mahamudul Hasan said the victim's husband Shafiqul Islam had an altercation with their neighbour Fazlul Haque three days ago blocking the road to the latter's home. There was another fight between them over the same

matter last morning. At one stage of the altercation, Fazlul stabbed Shafiqul's wife Jiban with a knife.

Later, locals rescued her and took her to Jamalpur General Hospital, where the on-duty doctor declared her dead.

Police recovered the body and sent it to Jamalpur morgue for post-mortem.

No case was yet immediately filed over the incident but the police are trying to arrest the attacker.



On July 27, 2017, for implementation of the Matabari the 2x600 MW Ultra Super Critical Coal Based Power Plant, CPGCBL signed a contract with the Consortium of Sumitomo Corporation, Japan; Toshiba Energy System & Solutions Corporation, Japan; and IHI Corporation, Japan (STIC) who are contractor of the jointly the EPC project. Before, signing the contract, contractor was selected by the EPC an International Competitive Bidding process which was approved by the competent authority and as well as JICA. In order to monitor the EPC contractor's work and support CPGCBL to achieve the efficient and proper preparation and implementation of the project, CPGCBL appointed the company Matarbari JV Consultant [consist of Tokyo Electric Power Services Co., Ltd (TEPSCO), Japan; Fichtner GmbH & Co. KG (FICHTNER), Germany; Nippon Koei Co., Ltd. (NK), International Pty Japan; and SMEC Ltd (SMEC), Australia, on January 07, 2015, as owner's engineer which is also approved by JICA. 4. The project is being implemented STIC under the provision of the EPC contract, and in that contract's price schedule, there is this item no. 6.6 'Plant, Water and Cooling system' which includes many items, including item no 6.6.11: 'Piping System of Entire Plant Water and Cooling System'. The news published on your esteemed daily is mainly on scheduled item named 6.6.11: Piping System of Entire Plant Water and Cooling System' of the said contract, which is on a lump sum basis. CPGCBL can only monitor the scheduled items, whether they are properly implemented within the quoted scheduled value. CPGCBL in this case only authorized to check whether the total item value is exceeded or not. Therefore, CPGCBL has no scope to verify the small item wise invoices as it is not Bill of Quantity (BOQ) item rather, this is a lump sum contract price. And for further convenience, the definition of lump sum contract is 'it is the form of contract in commercial transactions in which contractual obligations are undertaken for a fixed amount agreed upon as the contract amount. In principle, the amount can not be changed without agreement between the parties to the contract. 5. Despite the price variation among the smaller items, the total

price of item no 6.6.11: Piping System of Entire Plant Water and Cooling System remains unchanged. Moreover, before every shipment of materials of the power plant, CPGCBL's owner's engineer 'Matarbari JV Consultant' verifies the credibility of the materials on behalf of CPGCBL.

6. The lump sum contract price for schedule 6.6.11 is payable in foreign (JICA), the financer of currency under is - Any amount pavable to EPC contractor is disbursed directly from JICA to EPC contractor's (STIC) bank account in Japan. When asked, the Japanese EPC Contractor (STIC), informed us that the invoice value for the concerned shipping is appropriately priced based on lump sum contract value. Besides, each Invoice value is priced within the Price Schedule amount and it will never be exceeded, which means STIC follows the EPC contract. 8. As described above, it is clearly noticeable that CPGCBL can only monitor the scheduled item whether they are within the quoted scheduled value on the basis of consultant certification and scheduled price of the item mentioned in the contract. Needless to say, it does no good to the reputation of your own publication to publish such misleading news. I hope you will publish this rejoinder to set the record straight and restore the image of CPGCBL and the Government of the Peoples Republic of Bangladesh as well



guideline for bikes. Despite a draft already prepared last year, no such guideline has been approved yet.

The number of three-wheelers, especially easy-bikes and locally-made Nosimon and Korimon, started to swell over the last decade. The authorities concerned had to ban them on 22 major highways in August 2015 as they were involved in a large number of crashes.

These vehicles, however, continue to ply the highways and their numbers have increased to such a point that even some bus routes had to be cancelled.

In June 2019, the Road Transport and Highways Division had formed a 12-member committee to make recommendations on how to control these vehicles. The committee submitted a draft guideline in 2021, which is yet to see the light of day.

In May last year, the government set the economic life limit of buses at 20 years, and trucks and lorries at 25, with an aim to reduce accidents and pollution.

However, the implementation of the limits was halted in August last year following demands from the transport associations.

#### **EXPERTS AND AUTHORITIES SAY**

Transport expert Prof Hadiuzzaman said although the country's road infrastructure saw much progress over the last decade, the quality of the public transports and drivers has not improved.

"As a result, the number of road crashes and deaths have increased."

He said the government, in some cases, has taken up contradictory policies, intensifying safety risks.

Hadiuzzman, also former director of Buet's Accident Research Institute, said small, illegal and unfit vehicles are major reasons for recurring accidents but the government has at times encouraged use of those vehicles, further increasing the numbers of crashes and casualties.

"When such vehicles could've been controlled, the government didn't take necessary initiatives. Now, it's very difficult to bring those under control. Very strong political will and commitment are required to make roads safer now.'

Contacted, ABM Amin Ullah Nuri, secretary of the Road Transport and Highways Division, said, "I can't make a comment as I have not seen the data yet.

"However, we're collecting authentic data now. The previous one was not authentic.

About the measures that were not implemented, he said the enactment of guidelines for three-wheelers, scrapping of outdated vehicles and setting speed limits were all at their final stages.

## Hundreds rescued after flooding in Australia

AL leaders said.

Widespread flooding in Australia left hundreds needing to be rescued after a natural disaster was declared in regions across New South Wales vesterday.

Intense rainfall at the start of the weekend saw around 300 homes evacuated in north-east Sydney, emergency services said.

Floodwaters had caused widespread damage across the state in a very short

amount of time, federal minister for emergency management Catherine

King said. "The New South Wales government is continuing to assess the damage and understand the impact of this disaster," King added.

Emergency crews had performed about 200 flood rescues since Friday, said state minister for emergency services Jihad Dib, as some regions were left cut off by damaged or flooded roads

Around 5,000 volunteers had worked through the night helping those affected, he added.

State emergency commissioner Carlene York said 60 community warnings remained in place for regions affected by the flooding.

support had Disaster been triggered by officials in a dozen areas to help cover clean-up costs and pay for emergency accommodation. It was the region's seventh flood in 18 months.

#### **OUR RESPONSE**

The rejoinder almost entirely deals with technicality of the project, its components and the stakeholders involved for its funding and implementation – none of which was the subject of our report.

The rejoinder does not address the issue raised in our story, i.e., the abnormally high prices of some hand tools imported for Matarbari project with public money. It appears that the rejoinder rather seeks to avoid the issue of public spending and divert readers' attention with unrelated technical details.

To be clear, the very first claim in the rejoinder that The Daily Star published the story without checking the facts with the authorities is outright false. Project Director Abul Kamal Azad, who signed the rejoinder, has himself been quoted in our story. We quote him again

"We think the prices are normal even though the customs said the prices are abnormal. The price may seem higher than the market price as the items were tailor-made upon a special order."

We also quoted the PD in our original story as saying that "the price is high as the two pipe cutters were made using special metal for use in the power plant.

Other than this untruthful claim that The Daily Star did not check the facts with the authorities, the rejoinder does not challenge any facts of our story.

We stand by our report.
