

Martyrdom anniv of five family members

The 53rd martyrdom anniversary of five members of the family of Saidur Rahman, founder (president) of Projonmo '71, was observed yesterday, said a press release.

The deceased are the father, mother, and three elder brothers of Saidur Rahman, a senior news presenter at Channel-i.

His father Fazlur Rahman, an engineer; mother Hosne Akter, an NGO trainer; and brothers Mostafizur Rahman (Mojnu), a college student; Hasinur Rahman (Hiron), and Azizur Rahman (Babu), both high school students, were brutally killed at their railway government residence in Saidpur, Nilphamari by the Pakistani occupation army and its collaborators on April 15, 1971.

The perpetrators charged Saidur's mother with a bayonet and buried her alive.

They were killed for their involvement in the Liberation War. Saidur, along with his elder sister Dilruba Khatun (Kajol) and younger sister late Camellia Rahman (Kakon), narrowly escaped the killing mission.

against Boro Moni under the Women and Children Repression and Prevention Act with the police station.

She accused Boro Moni of raping her at gunpoint at his residence in the capital's Uttara on the night of March 29.

Boro Moni, who is also secretary general of the district's Bus-Minibus Owners' Association, is currently on the run.

Earlier, on April 5 last year, Boro Moni was accused in a case filed over raping and torturing a 17-year-old girl in Tangail Sadar. Boro Moni's wife Nigar Aftab was also

accused in the case on charges of torturing the girl. The victim had alleged that she became pregnant due to the rape.

On October 9, 2023, the Appellate Division of the Supreme Court upheld a High Court order that on July 11 granted bail to Boro Moni in the rape case.

The apex court passed the order after examining the DNA test report that stated that Kibria is not the biological father of the rape victim's child.

Later, the victim was found dead in her house on November 18.

The authorities concerned alleged that the victim died by suicide.

Patients endure hours of wait

While some were sent for observation, some returned home after getting first aid.

An official at the emergency department said the department usually sees around 200 patients a day, while during the three days of Eid vacation, the hospital saw around 250 patients daily.

On the night of Eid day, these correspondents witnessed a long serial of patients in front of the OT, while long queues of their relatives were seen in front of the emergency doctors' room.

Most of these patients came to the facility after being injured in road accidents in different parts

of the country.

Thirty-year-old Arifuzzaman Arif was also waiting outside the OT on Saturday morning after he got injured in a motorcycle accident in Khulna on Friday.

"I required an emergency surgery which wasn't possible at Khulna Medical College Hospital, so they sent me here," said Arif.

Director of Nitor, Prof Kazi Shamim Uzzaman, said during the three days of vacation, patients from all over the country came to the facility.

While most were discharged with first aid, some required operation. But many had to wait for hours for surgery, he added.

"To tackle the rush of patients, an emergency response team comprising 12 doctors was formed. Apart from this, seven senior consultants, including myself, have been on duty every day during the vacation," said Prof Kazi Shamim.

When asked why less than 100 doctors were on duty, he said they tried their best to provide services with the limited number of available doctors and nurses.

On Eid day, a senior staff nurse of Nitor told this newspaper that only two nurses were on duty for 79 patients in the ward she was working at.

"My shift started at 9:30pm, and it took until

midnight to give medicines and injections to all the patients."

Seeking anonymity, another nurse said, "We are under a lot of pressure to handle the patients. But we are happy to serve them during Eid."

Meanwhile, doctors at the emergency department of Dhaka Medical College Hospital said 40 percent of the accident victims were of bike accidents.

Mohammad Alauddin, resident surgeon of the hospital, said around 120 people from Dhaka and adjoining areas came to the hospital after being injured in road accidents from Wednesday night to Sunday, while four of them died.

Meanwhile, Saleh Ahmed and Anwal Haque Raju, two of the sailors who were aboard the hijacked MV Abdullah, both hail from Noakhali.

While Saleh Ahmed's house is in Rampur Union of Companyganj Upazila, Raju is a resident of

Noakhali Union of Chatkhil Upazila.

Saleh's wife and three daughters are eagerly awaiting his return. The feeling is mutual for the parents of Anwal Haque Raju. The families can finally celebrate Eid.

Raju's relatives said that Raju, the youngest sibling, was supposed to celebrate Eid at home. He had boarded the ship from Singapore in late November last year. Azizul Haque, Raju's father, said, "We finally found relief after the news of his release. We are also happy all of the sailors were returned unharmed."

On the other hand, Saleh Ahmed had spent his last Eid at work. This year, he was supposed to spend it with his family.

Tanya Akhtar, Saleh's wife, said, "I was very worried. I was not sure if we would ever see him again."

Both families expressed gratitude to the concerned authorities for handling the situation.

private chamber and also in the medicine ward at Chittagong Medical College Hospital (CMCH). However, most patients don't need hospitalisation as their symptoms are mild," said Dr Aniruddha Ghosh, professor of medicine at CMCH.

People have to be cautious when eating food

and drinking water, as most of the microorganisms spread through contaminated water and food, he explained.

"Besides, there are risks of heat stroke. So, people should not go under the sun directly and if anyone suffers a heat stroke, immediate treatment should be started," he added.
