# The Nigerian man who fell in love with Bangla music

Oli Louis, a Nigerian garment merchandiser, whose initial visit to Bangladesh was solely for business purposes, found himself captivated by Bangla songs.

In the realm of creative inspiration, few pursuits rival the journey that leads an individual to explore unfamiliar musical territories. Yet, who could have foreseen that the enchanting verses of legendary Bengali musicians Gauri Prasanna Mazumder and Hemanta Mukhopadhyay's Oiliro Kotha Shune Bakul Hase would ignite a passion for Bangla music in a Nigerian musician?

Oli Louis, a Nigerian garment merchandiser, whose initial visit to Bangladesh was solely for the purpose of business, found himself captivated by Bangla songs through this very melody. "One day, I stumbled upon the song, and it entranced me with its magic. It took me just two days to learn it. As I delved deeper, the profound lyrics, melodious tunes, and sweet harmonies inspired me to delve further into the world of Bangla music," shared Oli, who recently made his mark in Coke Studio Bangla's third season with the debut song *Tati*.

Navigating the bustling streets of Dhaka posed a linguistic challenge for Oli, who didn't speak the language. "Learning Bangla was quite a feat. I picked it up by conversing with rickshaw

pullers and garment sellers in Bangabazar," he recalled with a grin.

Having been part of a choir and musical band in Nigeria, Oli recognised a rhythmic kinship between Bangla folk and African music, which piqued his interest in Bangla melodies. "When I began listening to Bangla songs, I sensed a familiar cadence in the improvisational beats and rhythmic patterns. That's what drew me to Bangla music," shared the musician.

His rendition of Shada Shada Kala Kala marked a turning point, garnering widespread acclaim and affirming his belief that Bangladeshis would embrace him as one of their own if he pursued Bangla music

"Music transcends language; it speaks to the soul. Even though I couldn't grasp the lyrics

initially, I felt a profound connection to the singers and found my own interpretation of the music. That's what fueled my admiration for Bangla music," reflected Oli.

Seeking to bridge cultural divides, Oli endeavoured to blend the rich chronicles of Bangla and African music. His collaboration with Coke Studio Bangla's third season was a testament to this endeavour. "My inclusion in Coke Studio Bangla felt like a divine intervention. A friend approached me about joining the show, and I embraced the opportunity wholeheartedly," shared Oli.

The thematic essence of the song centered

around weaving struck a chord with Oli, who perceived it as a metaphor for unity. "Weaving isn't a prevalent theme in Nigerian music. By infusing elements of my culture into the song, I aimed to foster harmony," he emphasised.

taken initiatives to set up an economic zone on 55,968 acres in Maheshkhali of Cox's Bazar.

"The government has decided to form a new authority to provide necessary assistance to the local and foreign entrepreneurs who will work there," he said, adding that MIDA will be an institution under the Prime Minister's Office, with the premier as chairman of its board of directors. A chief executive officer will be appointed to run MIDA.

Mahbub said the main task of MIDA will be to ensure the use of the land in a planned way for the entrepreneurs after formulating a master plan and also to ensure compliance with the rules and regulations.

He said the proposed law will provide protection to local produce such as salt, shrimp, and betel leaf.

The cabinet also approved in principle the draft of The Chief Election Commissioner and Other Election Commissioners (Remuneration and Special Rights) Act-2024.

Regarding the proposed law, Mahbub said the ordinances enacted during the previous military regimes are gradually being converted into laws from English to Bangla as per court orders.

He said that only 16 ordinances are left to be converted into laws.

"The prime minister is aware of which ministries are related to these ordinances. She has directed the ministers and secretaries concerned to take prompt steps in this regard," the cabinet secretary said.

Australia unveiled its first National Defence Strategy yesterday, signalling a new focus on deterring China's "coercive tactics" in a region seen as lurching towards conflict.

gloomy assessment of Pacific security and sets out a massive increase in defence spending to retool Australia's military to cope.

The optimistic assumptions that guided defence planning after the end of the Cold War are long gone," said Defence Minister Richard Marles, presenting the new strategy.

On February 6, Preeti, an irregular domestic help, fell to her death from the flat of Ashfaque and his wife, Tania Khondoker, located on Shahjahan Road in Dhaka's Mohammadpur.

The death came as a huge shock for the couple, who were asleep at the time of the accident, and they both surrendered to law, Anowara

Ashfaque phoned and informed the police immediately and the couple was later accused of death by negligence under Section 304A of the Penal Code-1860, and the investigation into the incident is going on.

behind bars for the last 71 days, she said.

Referring to the statement by 117 citizens on April 2, Anowara said issuing such a statement is tantamount to contempt of court because the matter is sub judice.

"The statement condemned what it called the 'police inaction' in relation to the case.

"About the so-called police inaction, I would like to say: my son and his wife were taken into police custody within hours of the incident; they were interrogated by police multiple times during their about 28-hour custody at Mohammadpur Police Station before being produced at a court around 2:00pm the next day. The court sent them to jail," she

The couple was subsequently interrogated at jail gates and again interrogated for four days while on police remand.

Later, the case was handed over to the Detective Branch of police. Detectives questioned Ashfaque and Tania in their custody and produced before a court which sent them to

evidence," Anowara said. "I wonder what proof the said 117 citizens have in their possession to ascertain that she was hanging from the grill for about 13 minutes," she

It is also not clear on what basis CCTV footage at Ashfaque's home went missing", Anowara said.

Ashfaque and Tania only used a Chinese camera for streaming live video footage from their home to their mobile phones like many other households and businesses do these days, she said.

'Since this was a live camera and Ashfaque and Tania have been no footage was stored on any device or memory cards ever, the question of footage going missing does not arise," she added.

Regarding the injury from the fall of Ferdausi from Ashfaque's home made a number of "fictitious claims", said Anowara.

"The statement falsely claims that she suffered a '3cmX3cmX3cm wounds from deep inside her reproductive organ leading up to the opening of anus'. It is an outrageous claim."

Doctors at Dhaka Medical College Hospital, where Ferdausi was taken after the accident on August 4, 2023, recorded her injury saying: "A lacerated wound from labia minora up to anal sphincter in midline measuring 3cmX2cmX2cm."

Anyone familiar with the medical term "labia minora" would know that labia minora are two small and thin skin tissues located outside the female reproductive organ, not deep inside it, Anowara said.

"I am shocked that the 117 citizens, many of whom are highly respected and accomplished in the fields of academia, journalism, research, criminal investigation and categorically deny the claim made law, would make such uninformed Tania physically assaulted this one, especially when it is under my son and his wife," she said.

statement claimed that Ferdausi suffered the wounds before the fall which led her to make an attempt on her own life.

"Can such serious claims be established simply by visiting a scene and without any material evidence? After months-long investigation, Mohammadpur police did not find any foul play by my son and submitted the final report, and both the family and the CMM court in the said statement claimed that the Dhaka accepted it. Ashfaque and Tania were acquitted by the court,' Anowara said.

> About the financial assistance for Ferdausi and her family, Anowara said it was never an out-of-court settlement. "As instructed by the court, an amount agreed upon by all parties was deposited through Treasury Challan No-310 on November 1, 2023, in the judicial account with Bangladesh Bank."

Rejecting all the "false claims and the insinuations" made in the said statement, Ashfaque's mother said carrying out this type of propaganda in August 2023, the said statement not only tarnishes the society, but also influences the institutions tasked with the investigation of the incident.

She said that Tania also comes from a respected Muslim family. draws strength Bangladesh's Liberation War as a granddaughter of late Khondoker Abdul Mannan, a Language Movement veteran and an organiser of the Liberation War from Bhola

"I am a recipient of the President's Award in 1980's for my special contribution to agriculture. My son Ashfaque, much like his freedom fighter father, has always been principled, ethical, and respectful in life," Anowara said.

Due to Ashfaque's bold and fearless journalism over the last 33 years, many have become "resentful and hostile towards him", she said.

She said both the families are suffering socially, mentally, and physically due to this "vicious propaganda".
