#### 25 elected unopposed in first phase of upazila polls

A total of 25 candidates for chairman posts, nine for vice chairman posts, and 10 for vice chairman posts reserved for women have been elected unopposed in the first phase of the upazila polls.

"They were the sole candidates in the posts they were vying for, so after their candidacies were approved through a scrutiny of their nomination papers, the returning officers concerned declared them winners yesterday [Tuesday], Commission Additional Secretary Ashok Kumar Debnath told The Daily Star.

Consequently, elections won't be necessary in four upazilas Bagherhat Sadar, Munshiganj Sadar, Madaripur's Shibchar, and Feni's Parshuram -- as the chairmen, vice chairmen, and female vice chairmen in these four upazilas have all been elected unopposed, he added.

Similarly, uncontested chairman candidates in Gaibandha's Saghata and Natore's Singra were also declared winners, eliminating the need for elections for these two positions, the EC official also said.

A total of 1,588 candidates will contest in the first phase of the elections to 150 upazilas. Of them, 554 will vie for chairman posts, 605 for vice chairman posts, and 429 for vice chairman posts reserved for women.

Meanwhile, the EC said that the fourth phase of the elections to 55 upazilas will be held on June 5.

Election Commission Secretary Md Jahangir Alam declared the schedule after a meeting of the commissioners at the EC office in the capital's Agargaon yesterday.

He said that the last date for submission of nomination papers in the fourth phase is May 9, scrutiny of the nomination papers will take place on May 12, and the last date for withdrawal of candidacy is May 19.

In this phase, voting will be held in two upazilas using electronic voting machines (EVMs) and ballots will be used in the remaining 53 upazilas, he further said.

The upazila elections will take place

in four phases.
A total of 161 upazilas will go to polls on May 21 in the second phase, and 112 upazilas will go to polls on May 29 in the third phase.

## Asia hit hardest in 2023: UN

Asia was the world's most disaster-hit region from climate and weather hazards in 2023, the United Nations said yesterday, with floods and storms the chief cause of casualties and economic losses.

Global temperatures hit record highs last year, and the UN's weather and climate agency said Asia was warming at a particularly rapid pace.

The World Meteorological Organization said the impact of heatwaves in Asia was becoming more severe, with melting glaciers threatening the region's future water

The WMO said Asia was warming faster than the global average, with temperatures last year nearly two degrees Celsius above the 1961 to 1990 average.

"The report's conclusions are sobering," WMO chief Celeste Saulo said in a statement.

frequency and severity of such events, profoundly impacting societies, economies, and, most importantly, human lives and the environment that we live in."

The State of the Climate in Asia 2023 report highlighted the accelerating rate of key climate change indicators such as surface temperature, glacier retreat and sea level rise, saying they would have serious repercussions for societies, economies and ecosystems in the region.

"Asia remained the world's most disasterhit region from weather, climate and waterrelated hazards in 2023," the WMO said.

#### Man dies after fainting on Dhaka road

He is believed to have died of heatstroke

A 56-year-old man died after falling ill and fainting while he was walking down the road in Dhaka's Gulistan area yesterday morning. He is primarily believed to have died of heatstroke due to the excessive heat, police said.

Alamgir Sikder, a resident of Kazla area in the capital's Jatrabari, worked at a printing press in

The incident happened around 10:30am as the man was walking down the slope of Mayor Hanif Flyover, said Shah Alam, a sub-inspector of Wari Police Station.

All of a sudden, he fell ill and fainted. Pedestrians took him to Dhaka Medical College Hospital, where doctors declared him dead around 11:00am,

Marcelina Sarker, a medical officer in the emergency department, said, "The cause of his death, such as heatstroke, can only be confirmed through an autopsy."

Doctors warn that extremely hot weather can lead to heatstroke. When the body is exposed to high temperatures, its internal temperature rises rapidly. To cool down, the body sweats, losing both water and minerals. This can lead to an imbalance in electrolytes, causing fainting and even convulsions. In severe cases, heatstroke can damage the kidneys and lungs, and even be fatal.

BNP and its like-minded parties had also boycotted the last and fifth upazila polls in 2019. AL-nominated candidates were elected chairman in more than two-thirds of the upazilas in that election.

Out of the 473 upazilas, ruling party candidates have won the post of chairman in 320. Of them, 115 were elected uncontested. One hundred forty-nine chairmen won as independent candidates, according to EC data.

Among the other political parties, three members of Jativa Party and one from Jatiya Party (JP-Monju) have been elected in the chairman post in

policies, he said. "How fair and reasonable is it to transfer the burden of default loans and forgeries to good banks without first assessing the assets and liabilities

of the weaker ones?" "It appears that the ongoing actions are akin to prescribing

paracetamol for cancer treatment." On the one hand, the TIB chief said the culture of loan defaults is exacerbated by shielding those responsible for them and forgery

under the guise of mergers. On the other hand, significant attempts are underway to compel good banks to absorb weaker ones.

"This has created an atmosphere of crisis with impunity rather than anxiety and restlessness across the banking sector," he said.

"It is unrealistic to believe that simply merging banks, without ensuring effective accountabilitybased good governance to address the basic challenges in the banking sector, will resolve the problem or

safeguard the interests of clients." The TIB criticised the provisions of the merger policy, which permit directors of under-performing banks to return to the board of the stronger bank after a five-year break, as well as the provision for the reappointment of top executives.

"This provision rewards the
