Music in Bangladesh was never the same after Black launched Amar Prithibi in 2002. Taking off the much harder edge brought in by the rock bands of the '90s, it was Black who arguably popularised alternative rock in the country, along with acts like Nemesis and Stentorian.

to the bonded warehouses by the sugar refinery.

According to the NBR letter, the company illegally removed 5.25 lakh tonnes of raw sugar from its bonded warehouse without paying customs duties worth Tk 1205.52 crore. Although it was ordered to pay the sum in six installments, the company paid only Tk 533.17 crore. The remaining Tk 674.35 crore has not yet been deposited.

Earlier, a two-member committee headed by the then additional commissioner of Chattogram Customs, Abu Noor Rashed, looked into the bond register and import information of the company from March 2020 to March 2021.

The probe report, seen by The Daily Star, shows the company imported 2.13 lakh tonnes of raw sugar against its entitlement of 1.11 lakh tonnes at the time.

This means, the company imported 1.02 lakh tonnes of surplus raw sugar without paying customs duty worth Tk 217 crore during that period alone, the report said.

Customs officials told The Daily Star vesterday that Abdul Monem Sugar Refinery Limited imports and releases raw sugar under bond (for home consumption) facility without paying any customs duty on condition that the duty will be paid when the items are released from the bonded warehouse.

"But the company imports goods beyond its entitlement and markets them without paying duty. As a result, the government is not getting import duty and VAT on those imports," one official said.

Contacted, Chief Commercial Officer of the Group Kazi Nazmul Hasan said, "We released the goods from the port with prior permission from the customs and bond authorities. However, we failed to pay the duty immediately while releasing the goods from the bonded warehouse. This was a procedural lapse on our part due to various business challenges, but we had no intention to evade duties."

He said the company already paid half the installments and is committed to pay the rest in phases in the coming days.

"We also met the commissioner of the Customs Bond Commissionerate today [vesterday], and offered to pay Tk 100 crore immediately to resolve the issue," he added.

Customs Bond Commissionerate (Dhaka South) Commissioner Khaled

knowledge of the development said the company was fined Tk 15 crore over duty evasion worth Tk 1190.52 core following an investigation spanning more than two years.

"But the company did not pay the amount in full, even after the Bond issued Commissionerate several notices," the official said, requesting anonymity as he is not authorised to speak to the media.

Meanwhile, six customs officials at Chattogram, Mongla, Dhaka and Kamalapur ICD Customs houses confirmed that the NBR instructions took effect yesterday.

Officials said they already suspended the release of hundreds of consignments of six companies owned by the Group.

Of them, shipment of about 50,000 tonnes of raw sugar and food products in 10 consignments of Abdul Monem Sugar Refinery Limited at Chattogram port was stopped yesterday.

Officials also suspended at least 10 more shipments of the company's Igloo Dairy, AM Beverage, Igloo Ice Cream, AML Construction and other subsidiary companies.

"Âll consignments of the company have been suspended. At the same time, there is no scope to release the imported and exported goods as the company's BIN [Business Identification Number] has been locked," Mohammad Fyzur Rahman, commissioner of Chattogram Custom House, told The Daily Star.

Kamalapur Customs ICD Commissioner Akbar Hossain said they relayed the NBR instructions to the officials concerned and to act accordingly.

In one incident, Al-Nuseirat residents said an army helicopter landed near the camp and engaged in gun battles with fighters. The area then came under heavy tank fire.

Israeli media suggested Israel would, after weeks of delay, soon send troops into Rafah, on the southern border with Egypt, where more than a million displaced Palestinians are sheltering.

Plans for an attack on the town, where Israel says four intact Hamas battalions are sheltering, has raised widespread international concern, with aid agencies warning of a potential humanitarian catastrophe.

according to the 2023-24 report. At least 2,152km or 10.48 percent of

all surveyed roads were in "poor, bad or very bad" condition, the report said.

After the publication of the media reports, the ministry had asked RHD not to make the report public anymore and also to take down the previous reports from the website, sources said.

The Highway Development and Maintenance Circle of the RHD carries out the survey every year to make a projection of the total maintenance costs for its roads, they said.

The report puts the roads under five categories as per their conditions good, fair, poor, bad or very bad.

The survey also aims to prioritise the roads needing maintenance because the RHD does not get enough budgetary allocation to repair all roads in a timely manner, they added. RHD usually completes the report between April and June every year and publishes the full report on its website. This year's report is now being prepared, they said.

RHD Chief Engineer Syed Moinul Hasan told The Daily Star yesterday, "It is not that we won't make the report public anymore. We will make public partially."

He said some media outlets "misinterpreted" the report on many occasions.

"For example, after our long efforts, the conditions of more than 90 percent roads are now either 'good' or 'fare'. But some media outlets ran reports stressing that 10 percent roads are still in bad shape even after spending thousands of crores of taka. This is not fair," Moinul said.

Besides, making projections of road maintenance costs public is causing some other problems, he said. "That's why we will not make the report public fully."

Asked about the matter, Road Transport and Highways Division Secretary ABM Amin Ullah Nuri said he was not aware of it.

There are 22,476km of road under the RHD network. Of this, 3,991km are national highways, 4,897km regional highways and 13,558km district roads, according to the RHD's 2022-23 annual report.

It urged the Bangladesh Bank and all authorised banks in Bangladesh to prioritise the remittance of the airlines' funds.

Officials of foreign carriers that serve Bangladesh told The Daily Star that they were not selling tickets to local travel agencies as they could not repatriate a large chunk of their earnings.

Aviation experts said the carriers were instead selling tickets to overseas online travel agencies (OTA) who then sell tickets to local travel agents, forcing the passengers including the migrant workers, to buy tickets at a higher price.

to make the world safer and it continues American leadership in the world and everyone knows it," Biden said of the legislation.

"It gives vital support to America's partners so they can defend themselves against threats to their sovereignty and to the lives and freedoms of their citizens."

The aid legislation only passed the House of Representatives after months of acrimonious debate among lawmakers over how or even whether to help Ukraine -- which Russia invaded in February 2022 -- defend itself.

A similar aid package passed the Senate in February, but had been stalled in the House while Republican Speaker Mike Johnson --heeding calls from ex-president Donald Trump and his hardline allies demanded concessions from Biden on immigration policies, before a sudden reversal.

The United States has been a key military backer of Ukraine, but Congress had not approved large-scale funding for Kyiv for nearly a year and a half, and the financing of the war has become a point of contention ahead of a presidential election in November.

Ukraine's military is facing a severe shortage of weapons and recruits as Moscow exerts constant pressure from the east, with frontline circumstances are expected to worsen in the coming weeks.

Under the civil service rules, there are four types of major penalties forced retirement, removal from the job, suspension, and demotion to a lower rank. Demotion is considered

the lightest punishment. Speaking to The Daily Star, a joint secretary said, "Corruption is not rare in the administration. But in some cases, even when investigations prove it, exemplary punishment is not meted out. This is making the administration weaker day by day. The corrupt officials now think they can get away without serious consequences."

Firoz Mia, former additional secretary of the Ministry of Public Administration, said, "If corrupt officials are punished like this, they will be further encouraged to engage in corruption."

He said the government servants (discipline and appeal) rules in 1985 were quite strict about corruption. There were provisions to force corrupt employees into retirement.

"Since the rules were eased in 2018, corrupt officials have not been subjected to significant penalties for their involvement in corruption. This lack of stringent consequences will not yield positive results for the administration," he added.
