A syndicate made an arrangement with at least 200 candidates prior to the third phase written test for the recruitment of assistant teachers in government primary schools, offering to provide leaked question papers along with

Candidates received the questions and solutions a few minutes before the tests. Mobile

phones confiscated from some examinees during the March 29 exam contained both the genuine question papers and their solutions.

Around 3.5 lakh candidates from 21 districts of Dhaka and Chattogram divisions took part

Asim Gain, the mastermind behind the syndicate, took amounts ranging from Tk 10 lakh to Tk 15 lakh from each

He accepted cash payments ranging from Tk 2-5 lakh, along with a cheque for the remaining balance, as per an investigation of the Cyber and Special Crime

Three new SC judges sworn in

Three judges were sworn in as Supreme Court justices yesterday.

Yesterday, the new judges were elevated from the HC Division to the Appellate Division, raising the number of apex court judges to eight.

Chief Justice Obaidul Hassan administered their oath at the SC Judges' Lounge where judges from both Appellate and High Court divisions of the SC and lawyers were present.

SC Registrar General Md Golam Rabbani conducted the oath-taking ceremony.

Later, the Attorney General's Office and the Supreme Court Bar Association congratulated threenewly appointed apex court judges.

Attorney General AM Amin Uddin and SCBA Secretary Shah Monjurul Hoque accorded the felicitations to Justice Muhammad Abdul Hafiz, Justice Md Shahinur Islam and Justice Kashefa Hussain at the courtroom No 2 of the Appellate Division of the Supreme Court.

Later in the day, the three new apex court judges paid homage to Father of the Nation Bangabandhu Sheikh Mujibur Rahman and the martyrs of the Liberation War by placing wreaths at the portrait of Bangabandhu at Dhanmondi-32 in Dhaka.

Mohammed President Shahabuddin made the appointments of three apex court judges under Article 95(1) of the constitution.

Eight years on, trial of case yet to start

Eight years into the murder of blogger Nazimuddin Samad, the trial of the case is yet to begin at a Dhaka court.

The prosecution said the trial in the murder case did not start due to non-appearance of the accused before the Anti-Terrorism Special Tribunal of Dhaka.

On April 6 of 2016, the 28-year-old law student Jagannath University (JnU) was hacked and shot to death by unidentified assailants in Old Dhaka's Sutrapur area.

Nazimuddin, who was critical of extremism on his Facebook posts, moved to Dhaka from Sylhet for higher studies.

The charges were not framed against the accused as they were not produced before the tribunal on most scheduled dates in the past. During charge framing, the accused in custody must appear before the court," assistant public prosecutor Golam Sharuar Khan Jakir told The Daily Star recently.

"March 25 was scheduled for framing charges in the case. On the day, we got a letter from the jail authorities, which

stated the accused could not be produced before the tribunal due to absence of police escort," he said.

Asked about arranging online attendance for the accused, Jakir said, "We installed equipment for it, but it is yet to be operational."

"It took more than four years to complete the investigation. In addition, the court also remained closed for several months due to the coronavirus outbreak Moreover, five accused are currently absconding. For this, the court had to follow certain procedures," he added. Wishing anonymity,

tribunal staffer said, "The accused have not been produced before the tribunal since the incident of two death-row convicts in publisher Faisal Arefin Dipan murder case getting snatched away from the Dhaka court premises on November 20, 2022." The day after Nazimuddin's murder,

It is now up to the people in society to take on the task of completing the important work left unfinished by Dr Zafrullah Chowdhury, said speakers at a programme yesterday. Zafrullah devoted his



life to serving the people of the country, with all his thoughts and considerations focused solely on their well-being, they added.

"Zafrullah addressed issues such as cancer, heart transplants, and various others, harbouring numerous desires to further benefit the people. Although he is no longer with us, it is now incumbent upon everyone to honour his legacy by completing his unfinished works," said Prof Altafunnessa Maya, chairman of the Trustee Board of Gonoshasthaya Kendra.

Gonoshasthaya Nagar Hospital organised the discussion yesterday marking the first death anniversary of Zafrullah.

At the event, attendees watched a video depicted Zafrullah's life. Additionally, doctors, nurses, and staff reminisced about their memories of Dr Zafrullah during the gathering.

Sayeed Zaman, director of Gonoshasthaya Nagar Hospital, emphasised Zafrullah's advocacy for enhancing the nation's health and his dedication to progress and democracy.

"We are fighting today without Zafrullah. We have to continue this fight," he added.

The event was attended by Zafrullah's wife and Naripokkho member Shireen Huq, his son Bareesh Hasan Chowdhury, trustee board members Abul Qasem Chowdhury and Kona Chowdhury, and Bangladesh Environmental Lawyers Association Chief Executive Syeda Rizwana Hasan.

Zafrullah, 82, died on April 11 last year due to kidney complications, while receiving treatment at Gonoshasthaya Nagar Hospital in Dhanmondi.

The acquittal came to light recently although the verdict was announced over two and a half months ago.

On February 5, Judge Md Asaduzzaman of the Metropolitan Tribunal-1 of Dhaka delivered the verdict, said additional public prosecutor Tapash Kumar Pal.

He was acquitted as the charges brought against him were not proven, he said.

A total of 16 prosecution witnesses testified before the court during trial.

'Want Bangladesh to be a net security provider in the region' Says US political officer

The US wants Bangladesh to be a net security provider in the Indo-Pacific region as the country has made exponential progress since independence and demonstrated its capacity in helping the regional countries, said a US official.

It also wants to see Bangladesh as a prosperous country having the principles of democracy, good governance and human rights, which is why Washington has been speaking aloud on free elections and taken actions against Rab, he said. Maxwell Martin, political officer at the US embassy

in Dhaka, said this at a briefing on the Indo-Pacific Strategy (IPS) and implications for Bangladesh at the embassy yesterday as IPS has renewed focus in the region including South Asia. Martin said the US supported Bangladesh Armed

Forces with training, capacity building and equipment in countering terrorism. Bangladesh also made exponential progress, supporting Myanmar during the cyclones last year, responding positively in sheltering the Rohingya and its contribution to the UN peacekeeping is notable.

"You have seen us become more open and vocal about the political situation in Bangladesh. This is part of the IPS. We are also engaged in multiple fronts that include economy, security and politics."

Martin said, "We thought our sanction against Rab was important for that unit to change their behavior in SEE PAGE 4 COL 7
