First heatwave, now water crisis

Sufferings of Dhaka dwellers continue to escalate

Amid the severe heat wave, there is an acute water crisis in various areas of the capital.

The areas include Shewrapara, Kathalbagan, Azimpur, Nandipara, Ibrahimpur, Solmaid, Matikata, Malibagh, and Mohammadpur. Besides, there have been complaints that water is not available at all in some areas. Additionally, in some places, the available water is smelly and dirty,

However, Dhaka Water Supply and Sewerage Authority (Wasa) said there is no shortage of water supply in the city. There are temporary problems in some places based on the area, mainly due to the depletion of groundwater level, increased demand for water due to excessive heat and fewer deep tube-wells than required.

According to consumers of Nawabganj, Jafrabad and Katasur of Wasa zone-2; Barabagh, Manipur, Agargaon and Mirpur-12 of zone-4; Gulshan-1, road 83 of Gulshan-2 and Malibagh Bazar Road of zone-5, they are not getting water as per demand.

Residensts of Nandipara and F block of Banasree under zone-6: Rasulpur, Pagla, Shahi Mohalla, Nurbagh, Adarshnagar, Nama Shyampur, Nischintapur, Delpara, Shantidhara and Daulatpur under zone-

7 and Ibrahimpur, East Shewrapara of zone-10 echoed the same. Monir Hossen of Kathalbagan Bazar said, "The little water that comes late at night does not meet the demand. We coped by collecting water from Ŵasa via their trucks."

> Janatul Ferdousi, of Azimpur New Paltan Lane area, said, "We have very little water supply here.

There is no water in the morning. We take

Harijan cleaners in Sreemangal earn only Tk 550 a month

Sukon Basfor, 33, a Harijan woman, starts her day at the break of dawn. She works tirelessly for over four hours, from 5:00am to 9:30am every day, cleaning the streets from Puran Bazar to the Bus Stand area in Sreemangal.

Yet, for her backbreaking labour, she receives a meagre Tk 550 a month.

A non-Bangalee community, Harijans live in congested pallis (colonies) under the city corporations and municipalities. Most of the Harijan pallis in the country that shelter around 100,000 souls are located in the dirtiest places

Harijans mostly work as sweepers and cleaners, keeping the streets clean. Despite this, they are considered "untouchable" by society.

While underpaid everywhere, Sreemangal sweepers have it particularly bad, earning a fraction of what their counterparts receive in the neighbouring Moulvibazar (Tk 3,500) and Sylhet (Tk 2,200).

Even Kulaura (Tk 3,000) and Chatak (Tk 2,500) municipalities pay more. Habiganj municipality, at Tk 900, comes closest to Sreemangal's abysmal wages, according to the Society for Environment and Human Development (SHED).

When asked why she is working for such a low salary, Sukon, with a sigh, replied, "What other option is there?"

Sukon's plight is echoed by her husband, Pradeep Basfor. Their combined income is barely enough to make ends meet. With two children -- an 18-year-old son and a 7-year-





old daughter -- household and educational expenses add another layer of burden. Their meagre earnings force them to strictly ration their diet, with fish and meat appearing on the table only once a month, if at all.

Chattogram's Mirsarai upazila Awami League General Secretary AKM Jahangir Bhuiyan has admitted to a series of "misdeeds" aimed at securing victory for AL candidate Mahbub ur Rahman Ruhel in the Chattogram-1 constituency during the January 7 national polls.

Then he "promised" voters that they will not interfere in the electoral process in the upcoming Mirsarai upazila polls on May 8.

Five independent candidates including General Secretary of Chattogram north district unit AL Sheikh Ataur Rahman are contesting the polls.

Speaking at an election rally of Ataur on Monday, Bhuiyan said, "We did many misdemeanours to win... We made sure Ruhel, the son of our beloved leader Engineer Mosharraf Hossain, the candidate of people's leader Sheikh Hasina, emerged victorious on January 7.'

But we will keep the polling centre free from interference on May 8," he added.

Accusing an individual of "hurting religious sentiments" for posting lyrics from a Lalon song is an insult to our culture, said Naripokkho in a statement yesterday.

They vehemently protested the arrest of Sanjoy Rakhit, 40, who had posted lines from Lalongeeti on his social media account.

"It is the civic right of a person to practice their culture,"
