# **Goods worth** Tk 16k imported at Tk 2.63 crore

State-run power supplier now cites 'human error' but customs authorities reject the explanation

State-run Power Grid Company of Bangladesh Ltd (PGCBL) imported 68 kilograms of tower bolts, nuts and washers from India for a whopping \$2,39,695 or Tk 2.63 crore, which is 1,619 times the contract value.

The actual price of the consignment should have been \$148 (Tk 16,280) at \$2.18 per kg, according to the purchase agreement PGCBL submitted to the customs authorities.

The consignment reached Mongla port in April last year, but customs officials halted its release after spotting the abnormally high price.

Chinese firm TBEA CoLtd, contractor of Extension and Empowerment of Eastern Grid Network project under PGCBL, imported the items from Skipper Limited of India for installation of electric lines and building towers in Chattogram, Cumilla and Feni regions.

Earlier, the state-owned power supplier imported 178.8 tonnes of the same goods at a cost of \$3,89,252 (\$2.18 per kg), customs documents and purchase agreement show.

'This time the price is high even though the import volume is less. It is because more goods were sent by mistake in the previous shipments," the company wrote to the Mongla Customs House commissioner on June 5 last year, seeking to explain the abnormal value.

# Sikder family loses grip on Nat'l Bank

A new set of directors now at helm

The Sikder family has apparently lost its grip on the National Bank Ltd as a new board takes over the country's first private Only four and a

half months after restructuring the NBL Bangladesh board, Bank on Sunday dissolved the board again with Parveen Haque Sikder losing the post of director.

Earlier, Parveen's mother Monowara Sikder, brothers Rick Haque Sikder and Ron Haque Sikder had been removed from the board by the

central bank in December last year.

The banking regulator kept three of NBL's previous directors in the new board and made sponsor director Khalilur Rahman the new chairman.

The restructuring came after the now-defunct board split over the bank's merger with United Commercial Bank (UCB). Three independent directors, including the NBL chairman, resigned over the issue.

Parveen had issued a note of dissent over the merger proposal, said a former board member of the bank, seeking anonymity.

# were confined to only 5pc area

Say forest officials, blame siltation, elevated land; locals point finger at 'influential' fishermen

All fires in the Sundarbans over the last 23 years took place in just five percent area of the mangrove forest under the east forest division, said officials concerned.

While they blame the fire incidents on siltation and the consequent elevation of forest land, locals allege the fires are often lit intentionally by a section of influential fishermen who act in collusion with some crooked forest

Explaining natural causes behind the fires, Mihir Kumar Doe, forest conservator in Khulna region, yesterday told The Daily Star that siltation has elevated the land of the east forest division. This has severely disrupted the impacts of low and high tides, which are crucial for any mangrove forest.

The tide is the main characteristics of the Sundarbans, he said.

"Water cannot enter many parts of the forest [due to the elevation] ... The ecology of the area is changing because of the irregular water access. Not only the riverbeds, but even the forest ground has risen.

"The dry leaves accumulated on the ground have rotted and formed a layer that is between an inch and a foot thick, which can fuel fires.'

Doe also said that during the dry season, natural boundaries like narrow channels and canals between the forest and the human settlements surrounding it disappear, exposing the forest to a range of human

## All fires in 23yrs Astronomical rise in incumbents' income

TIB finds after analysing candidates' affidavits

The incomes and moveable assets of incumbent chairmen, vice-chairmen and vice-chairmen in reserved posts for women at the upazila parishads have seen a whopping rise, according to a Transparency International Bangladesh

Unveiled yesterday, the report shows that their incomes rose by up to 18,233 percent, while their movable assets soared up to 4,251 percent since 2014.

In the first phase of this year's upazila polls, the number of candidates with moveable or liquid assets worth at least Tk 1 crore each has more than doubled in

TIB prepared the report after analysing the affidavits submitted by candidates in 144 upazilas to the Election Commission.

A total of 150 upazilas are expected to go to polls in the first phase tomorrow.

Executive Director Iftekharuzzaman described the results of the analysis as "shocking".

He said it can be seen that the earnings of many candidates have increased "astonishingly", and in some cases, the rate of rise in income and wealth is even higher than that of national election candidates.

"There are also doubts about whether the information in the affidavits is legit or correct. Some candidates have presented very low income, which is unbelievable."
