

INDIA ELECTION BJP deletes X post accused of targeting Muslims

Indian Prime Minister Narendra Modi's party yesterday deleted a cartoon video posted on social media platform X that was criticised for targeting Muslims during an ongoing national election.

India's election code bans campaigning based on "communal" incitement but the Hindu-nationalist Bharatiya Janata Party (BJP) has frequently invoked the country's main religious divide on the campaign trail.

The video, posted by an official BJP account, featured caricatures of opposition politicians scheming to abolish special affirmative action programmes for marginalised Hindu groups and instead distribute them to Muslims.

The election commission wrote to the platform's Indian office on Tuesday saying the "objectionable" post violated Indian law.

Yesterday, the original post had disappeared from the platform, with a notice saying it had been deleted.

Patients, medics flee major Rafah hospital

The closure of Abu Youssef al-Najjar Hospital will endanger lives of 200 dialysis patients: WHO

Fearful medics and patients are fleeing a hospital in Rafah and transfers of the sick and injured via a border crossing with Egypt are at a standstill due to Israel's military operation, doctors and residents said.

The Abu Youssef al-Najjar Hospital is located in an area of southern Gaza the Israeli army has designated a combat zone in a conflict that has seen repeated Israeli attacks on hospitals. The World Health Organization warned that only a third of health facilities in Gaza is still operational.

Israel justifies such attacks by saying that Hamas uses them for military purposes - a claim both hospital staff and Hamas deny.

Doctor Marwan al-Hams told Reuters on Tuesday that Israel had put Abu Youssef al-Najjar Hospital at the centre of the battle field. "Its threats to it resulted in people and



patients leaving the hospital," he said, adding that some medical crews had also left.

The dialysis department for patients with kidney disease remained open for now, he added.

World Health Organization spokesperson Margaret Harris warned that its closure would immediately endanger the lives of some 200 dialysis patients since it is the only one in Gaza.

New blow for PM Sunak

Second UK MP
defects to Labour
after losses for
Tories in local polls

Britain's ruling Conservatives yesterday suffered their second defection to the main opposition Labour party in as many weeks, piling pressure on Prime Minister Rishi Sunak.

Natalie Elphicke crossed the floor in the House of Commons just moments before Sunak's weekly grilling by lawmakers, adding to his woes after heavy losses for the Tories in English local elections last week.

Elphicke is MP for Dover, on the south coast of England, which is heavily affected by the small boat crossings from northern Europe which Sunak has vowed to stop.

But she criticised the Tories "dramatic" lurch from the centre to the right since she was elected under Boris Johnson's leadership in 2019, and cited concerns over "housing and the safety and security of our borders" as prompting her move.

MP Dan Poulter -- a qualified medical doctor -- announced last month that he had defected to Labour, saying only they could be trusted to reform the state-run National Health Service (NHS).

Wife of ex-Pak PM moved to jail on her request

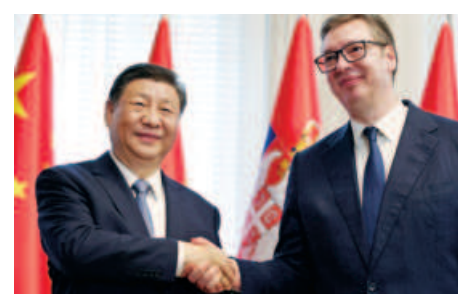

A court in Pakistan yesterday granted a request by the wife of former prime minister Imran Khan to be moved to jail, her lawyer said, instead of the house arrest ordered by the government. In her petition to the Islamabad High Court, Bushra Bibi had accused authorities of violating her privacy and serving contaminated food in her home cell, which she and her lawyers said was dominated by men, a charge the prison staff has denied. Bibi says she has been detained in one room at Khan's hilltop mansion in Islamabad since the couple's January conviction on charges of illegally selling state gifts. Through her lawyers Bibi had asked to be shifted to jail, which authorities complied with shortly after the court issued the order, her party said. The court ordered authorities to shift her to Adyala jail in the garrison city of Rawalpindi, where Khan, 70, is serving his 14-year sentence. The party said Bibi's shift to jail will answer critics that her stay at home instead of prison was part of some deal to seek concessions from government. Pakistan army spokesperson Major General Ahmed Sharif said on Tuesday that it was not possible to open talks for any deal with a party that had been involved in attacks against the state institutions.

Australia raises minimum savings for student visa

Australia said yesterday it would raise the amount of savings international students will need to get a visa and warned several colleges of fraudulent student recruitment practices, as part of efforts to rein in migration. From Friday, international students must show proof of savings of at least AS\$29,710 to get their visa, the second increase in seven months. It was raised to AS\$24,505 from AS\$21,041 in October. English language requirements for visas were increased in March.



China, Serbia agree to follow a 'shared future'

China and Serbia yesterday agreed to follow a "shared future" as President Xi Jinping visited the Balkan country, part of his bid to forge stronger relations with allies at the edge of the European Union.

Xi's visit is part of his first European tour in five years, and is seen as an effort to strengthen ties with eastern European countries that are pro-Russia and large recipients of Chinese investment. He will fly to Hungary later in the day.

Afghan blast kills 3 Taliban security personnel
