# **ARTS & ENTERTAINMENT** Filmmakers and Star Cineplex clash over industry priorities, who said what?

Mahboob Rahman Ruhel, chairman of Star Cineplex, stressed the organisation's commitment to Bangladeshi cinema. He expressed a desire for filmmakers to create movies similar to Poran, Hawa, Privotoma, and Surongo, which have successfully drawn audiences to theatres.

Earlier on May 3, two movies hit the screens-Shyama Kabya, directed by Badrul Anam Saud, and *Deadbody*, directed by Mohammad Iqbal. Both directors have accused Star Cineplex of favouring foreign films over Bangla cinema.

Badrul Anam Saud aired his concerns in a detailed post critiquing the movie theatre chain, while Mohammad Iqbal organised a human chain and press conference last Sunday (May 12), to protest against Star Cineplex's treatment of his movie Deadbody.

On Monday (May 13), Star Cineplex held a press conference at Dhaka Club to address and counter the allegations circulating in the media.

Mahboob Rahman Ruhel, chairman of Star Cineplex, stressed the organisation's commitment to Bangladeshi cinema. He expressed a desire for filmmakers to create movies similar to Poran, Hawa, Priyotoma, and Surongo, which have successfully drawn audiences to theatres.

Regarding the discontinuation underperforming movies, Ruhel emphasised that Star Cineplex is a business with obligations such as electricity, sound systems, projection maintenance, and employee salaries to uphold. Therefore, they cannot continue screening films that fail to attract audiences.

> "We operate on the principle of supply and demand. If a movie performs well, we will keep screening it. For example, after Eid, we brought back *Rajkumar* and *Kajol Rekha* due to popular demand. If certain directors are not actively

responsibility for their lack of success," added the Star Cineplex chairman.

Earlier on Sunday, the creators of **Deadbody** held a press conference attended by prominent actor Omar Sani, Producers and Directors Association President Kazi Havat. Combined Film Council Convenor Khorshed Alam Khosru, and director Delwar Jahan Jhantu.

Md Iqbal alleged that Star Cineplex has undermined his film, claiming that the management allocates morning showtimes to made similar allegations against the cinema's Bangladeshi films to prioritise peak times for foreign movies.

Kazi Hayat's Green Card was also removed from Star Cineplex this Eid. The director criticised Star Cineplex for its indifferent attitude towards Bangla films, suggesting that continued behaviour of this addressing the issue publicly on social media nature would lead to a cessation of movie offerings to the movie theatre chain.

Against such accusations, Chairman Mahboob stated, "This is entirely absurd. If a movie resonates in Hall-3 at the Bashundhara branch. Due to Covidwith audiences, they will watch it regardless of the related restrictions, we were unable to upgrade screening time. My target audience comprises the the screen at that time and were planning to do

promoting their films, we cannot shoulder the middle class, upper middle class, and educated individuals. If filmmakers fail to produce content that appeals to this demographic, it's not my responsibility if their film fails.'

He further explained that initially, he supported the Bangladeshi film industry by screening Tareque Masud's Runway, even when only 10-15 people attended. He aimed to introduce quality films to his audience. However, "Star Cineplex is a brand, and we cannot compromise on our quality," he highlighted.

Earlier, director Saud of Shyama Kabya also management, citing issues with projection quality and irregular scheduling.

Regarding the Shyama Kabya controversy, Mahboob acknowledged the allegations against Hall-3 but also criticised the filmmakers for instead of discussing it directly with the hall management.

"Yes, there was a minor issue with the projection

so after a new agreement. However, we want to clarify a few things: the film itself was shot in a darker setting, which posed a lighting challenge for us. If the filmmakers had concerns, they could have approached us directly, and we would have accommodated them by shifting the screening to another hall. It's unfortunate that they chose to make accusations against us while seated in our lobby.

"With multiple halls, occasional issues can arise, but it shouldn't be blown out of proportion. The data clearly indicated that the film wasn't attracting audiences. If people aren't interested in watching it, there's no point in blaming us on social media," he added.

Previously, Star Cineplex faced criticism from filmmakers for terminating screenings of Eidul-Fitr films after only four weeks in theatres. Filmmakers such as Himel Ashraf, Gias Uddin Selim, and Mishuk Moni protested strongly against this decision. However, the cinema hall management subsequently began screening Rajkumar and Kajol Rekha in response to overwhelming demand.

This Eid-ul-Fitr, three other movies were also taken down from Star Cineplex as they couldn't fare well in theatres, they are - Kazi Hayat's Green Card, Chotku Ahmed's government-granted film Ahare Jibon and Fuad Chowdhury directorial Meghna Konnya.



The recent exchanges between filmmakers and Star Cineplex highlight the complex dynamics at play within the Bangladeshi cinema industry. While allegations and counterarguments have fueled debate, it's evident that both parties share a common goal- the promotion and success of Bangla cinema. Ultimately, a vibrant and thriving Bangladeshi film scene hinges on the collective efforts of all involved, ensuring diverse cinematic experiences for audiences and sustained growth for the industry as a whole.

If the cattle is registered, this will also reduce theft cases," Saha added. Additionally, details of any newborn calves will be promptly recorded in the database within a few days. Initially, 16 upazilas with high cattle production have been identified for registration. new destinations or increase flight frequencies."

Nazrul said a huge amount of foreign currencies are going out of the country as foreign carriers dominate the market.

The more passenger numbers will increase, the more foreign currencies Bangladesh will lose, and the more market share foreign airlines will have, he said.

"We created an aviation market that has been captured by others," he said, adding. "It's because we have only two airlines that are operating flights on international routes and they cannot cash in on the booming passengers."

Since foreign carriers dominate the market, they have the luxury to hike airfares citing high demand, he added.

Incomes and profits of foreign airlines are so much that the government is now not able to allow them to remit all their incomes and profits due to dollar crunch.

According to International Air Transport Association (IATA) that represents some 320 airlines comprising 83pc of the global air traffic, Bangladesh was withholding \$214 million of airlines' funds until June, 2023.

Nazrul said the government should reform the aviation sector and policies to promote local carriers.

Local carriers should have lower charges, like landing, navigation, and parking fees, and pay less for fuel.

He said regulatory authorities and espective governments share some blame for the eight to 10 local carriers closing shop over the last 28 years.

Kazi Wahidul Alam, editor of The Bangladesh Monitor, an aviation and tourism related publication, said foreign airlines are increasing flight frequencies to Bangladesh in a planned way to capture passengers.

"But our local carriers failed to do this. That's why our market share is decreasing," he added.

Wahidul, also a former member of the Biman board, said usually local carriers of other countries enjoy about 50 of the market share in their hubs.

"But Biman failed to capture the market due to the absence of proper planning, marketing, and expansion of its fleet and network," he said.

This paper could not reach the managing director and CEO of Biman for comments despite repeated attempts.

Kamrul Islam, general manager of public relations at US Bangla Airlines, said the carrier is in the process of fleet enhancement and will increase flight frequencies to different destinations to better tap into the market.

"At the same time, we need policy support from the government and CAAB so that we can compete with foreign carriers," he said.

achieve its Tk 4.80 lakh crore revenue target for 2024-25 (FY25).

The target represents a 17 percent increase compared to this year's target and exceeds the NBR's average annual revenue growth of 11 percent over the past five years.

At yesterday's meeting at the Prime Minister's Office, NBR officials presented tax plans and received PM's approval for most proposals that focused on increasing revenue collections and reducing reliance on borrowing to implement the budget, according to officials aware of the developments.

The NBR is considering maintaining the current Tk 3.5 lakh tax-exempt income threshold for the second consecutive year.

Stock investors might be taxed 5 percent to 25 percent on their capital ins, stemming from the sale of shares. Carbonated beverage manufacturers are likely to face a 5 percent tax on their turnover in FY25, up from the existing 3 percent, said a senior official.

The NBR aims to collect Tk 1.77 lakh crore in income tax in the next fiscal year, a 20 percent year-on-year increase, according to officials.

It is likely to remove exemptions and reduce VAT benefits on nearly 20 items to increase the tax-to-GDP ratio. Bangladesh has one of the lowest taxto-GDP ratios in the world.

The revenue administration is expected to raise the supplementary duty on mobile phone calls from the current 15 percent. It may impose VAT on metro rail travel fares, the officials added.

of them may get fresh contracts because the policymakers are satisfied with their performance.

Besides, the secretaries themselves are lobbying hard for reappointments, several bureaucrats said, adding that it is the prime minister who will make the final call.

Public Security Division's Senior Mustafizur Rahman's Secretary contract with the government ends on May 25.

On May 23 last year, a day before his tenure ended, Mustafizur was promoted as senior secretary. On May 25, he received a one-year contract. Similarly, several other secretaries were blessed at the end of their tenure.

"Even if Mustafizur does not get an extension again, there are chances that he will be appointed to another key position," said a senior officer, requesting anonymity.

Commerce ministry's Senior Secretary Tapan Kanti Ghosh's contract expires on May 17. He has already been a secretary for over five years.

Usually, a senior minister runs the commerce ministry. But after the January 7 election, a state minister was given the charge of the ministry.

"As an experienced official, Tapan may get a renewed contract," said an additional secretary of the ministry.

Defence ministry's Senior Secretary Golam Hasibul Alam's one-year contract will end on May 30 and financial institutions division Secretary Sheikh Mohammad Salim Ullah's on May 19.

At least 18 other ministry secretaries will reach the end of their regular and contractual tenures this vear. Among them are the principal secretary to the prime minister and the cabinet secretary, two of the most significant bureaucrats.

PM's Principal Secretary Tofazzel Hossain Miah's contractual appointment ends on July 4 and Cabinet Secretary Mahbub Hossain's on October 13.

According to public administration ministry officials, Tofazzel may get an extension. At present, he is one of the most influential officers in the bureaucracy, they said.

Besides, the previous principal secretary got multiple extensions. If

is a strong chance that the cabinet secretary will too, they added.

If Mahbub is not reappointed as the cabinet secretary, Mesbah Uddin Chowdhury, the public administration senior secretary, may get the post, said the sources.

Mesbah, the most senior among the secretaries on regular tenure, will retire on December 30.

Shipping ministry's Senior Secretary Mostafa Kamal, Election Commission (EC) Secretary Jahangir Alam and Chittagong Hill Tracts Affairs Senior Secretary Mashiur Rahman may get key positions.

**Religion Affairs Secretary A Hamid** Zamadder, Land Secretary Khalilur Rahman, Cultural Affairs Secretary Khalil Ahmed, Information Secretary Humayun Kabir Khandaker, Primary Education Secretary Farid Ahmed, and IMED Secretary Abul Kashem Md Mohiuddin are among the officials

Several senior officials said the contractual appointments in each of the top positions deprive at least four other officials -- eligible to get promoted --- who are at the final stage of their career.

The number of contractual appointments has increased in recent years. But now they are getting contracts multiple times. This will weaken the administration in the long run," said an additional secretary.

Another official said. "Contractual appointments can be given in technical posts. We urge the government to not give contractual appointments to the administrative positions."

Former secretary Badiur Rahman said, "What we are seeing is the top officers availing the opportunity of contracts. It would be difficult to break this cycle if senior officials do not stop seeking such opportunities." Contacted, Public Administration Minister Forhad Hossain told The Daily Star that the government gives contractual appointments to those it trusts to perform the duties.

"It's not possible to say who will get contractual appointments. The government tries to run the administration with a blend of senior and junior officials to ensure that people get the best service," he said.

Legal Aid Committee. But to whom is the chairman responsible? To the National Legal Aid and Services Organization or the chief justice? This part is not clarified," he said.

He also said the lawyers who are providing services to the litigants are also being deprived. He said he learned from three former chairmen of the Supreme Court Legal Aid Committee that the budget is very low.

In his written speech, the chief justice said helpless litigants are constantly facing physical, mental, and financial losses due to long delays in the disposal of cases, and one of the ways to resolve this problem is to settle the cases through alternative dispute resolution (ADR) system.

The judiciary of Bangladesh has become hunchbacked due to an intolerable backlog of cases. Against the huge number of cases, the number of judges is very insufficient. As a result, people seeking justice are being affected. I believe the country's legal aid offices can play a significant role in this regard," he said.
