Monitor markets to keep prices under control **Instructs PM**

Prime Minister Sheikh Hasina yesterday instructions to monitor the market to control the prices of essential goods, said Cabinet Secretary Mahbub Hossain after a meeting held at the PMO.

Mahbub said, "Although the supply of some goods is adequate, there is an artificial price hike in the market," he added.

Tears of grief, instead of joy

Abontika's mother says after receiving her daughter's last academic result

Perhaps joy and festivity swept through the homes of law students from Jagannath University's batch-14 as their final results for the bachelor's degree were announced on Sunday.

While the majority of parents would have been extremely pleased with their children's accomplishments, Tahmina Shabnam, mother of Fairuz Abontika, broke down in tears when she learned the results of her daughter, who is no longer with her.

"A day of joy has instead become one of sorrow and regret. The loss of Abontika has devastated us. How are we going to deal with this?' Tahmina cried.

With a grade point average of 3.65 out of 4, Abontika secured third position in her batch. Her final semester grade was 3.73, according to

the law department at JnU. Abontika was a bright student who pursued her education at Nawab Faizunnesa Govt Girls' High School. She consistently received good grades on her school and board examinations.

After achieving a GPA-5 in her SSC and maintaining consistency in her

HSC exams, Abontika was selected to pursue general duty pilot training in the Air Force. However, she had to turn

down the offer because of health issues. "For years, I have stood outside classrooms and exam halls, waiting for my daughter. I remember the smile of contentment on her face when her results came out. That smile only lives in my memories now," said Tahmina as tears rolled down her cheeks.

sexual abuse and spreading rumours about her on campus, under the refuge of the assistant proctor.

Following the incident, her Nurunnahar, an associate professor of mother filed a case against the two with Cumilla Kotwali Police Station, accusing them of abetting suicide.

They were arrested and taken into remand, following which Din Islam was granted bail by the High Court. Meanwhile, Amman remains behind bars, said inspector Mujibur Rahman of judge court in Cumilla.

BR to buy 200 new carriages

Looks to expand services in southwestern region

Bangladesh Railway will buy 200 broad gauge passenger carriages from an Indian company aiming to expand its service in south-western region, benefiting from the newly constructed rail line via Padma Bridge.

BR yesterday signed a Tk 1,205 crore contract with RITES Ltd of India to procure the carriages, which will help replace many decade-old ones.

As per the contract, the Indian company will start delivering carriages within 20 months from yesterday and complete shipment of all carriages within three years.

Zaidul Islam, project director, and Rajeev Chaudhary, executive director (expotech) of RITES Ltd, signed the contract at Rail Bhaban in Dhaka.

BR in March 2022 took the Tk 1,704.66 crore project to procure the 200 BG carriages to mitigate its long-standing crisis for passenger carriages.

"I have to now walk three kilometres across the shoal and ride two boats over a one-kilometre stretch of water," he said.

The Padma river begins to dry up from the end of November and doesn't recover until late July, depending on the monsoon

The shoal between Shilaidah and Pabna extends over three kilometres of the four-kilometre crossing, leaving only two small areas with navigable water during this season.

The intense heat of the sand makes the journey nearly impossible, Jubayer added.

Manik Hossain, a boatman at Shilaidah ghat, said, "Previously, several hundred individuals would journey between Pabna and Kushtia via the Padma daily. However, now due to the existence of vast shoals, half of the passengers have opted out of this mode of transportation."

Manik attributes the problem to reduced water flow from upstream.

"The river dries up during the summer months due to reduced water flow from upstream, leading to difficulties for commuters," he explained.

Anwar Hossain, an ice cream vendor from Koshba village in Kumarkhali, has stopped travelling to Pabna markets.

"I used to sell 'Kulfi' at the Pabna markets but ceased my trips there recently due to the challenging conditions of crossing the Padma in the past few weeks," he said.

Shahidur Rahman, the secretary of Bangladesh Nodi Bachao Andolon in Pabna, reiterated the severe impact of Farakkah on the Padma River, which leads to prolonged dry spells in many areas of the river, causing immense hardship, especially for low-income

people.
