### UZ vice-chairman candidate killed in pre-polls clash

An upazila vice-chairman candidate was killed and seven people were injured as supporters of two vicechairman aspirants clashed in Narsingdi's Raipura upazila yesterday afternoon.

The deceased is Suman Miah, 40, son of Charsubuddi Union Parishad Chairman Nasir Uddin.

Suman was facing tough competition from his rival contender Abid Hasan Rubel in the Raipura upazila parishad polls, slated for May 29.

Witnesses said Rubel along with his supporters was campaigning in Paratali area around 2:00pm.

"All of a sudden, a group of people in a microbus came and opened fire on us," said Sajib Miah, 22, a supporter of Rubel.

"Several posters of Suman Miah were pasted to the window of the microbus. So, it is clear that the attackers were supporters of Suman Miah," said Sajib, claiming that he and three others suffered bullet injuries.

The Daily Star could not independently verify the claim.

Around half an hour later, supporters of Rubel attacked Sumon and his supporters at Mirer Bazar.

"They [attackers] beat up my son to death. Three of his supporters were also injured in the attack," said Suman's father Nasir Uddin.

Contacted, Rubel said, "Suman and his supporters first attacked us with firearms. In retaliation, we chased them away.'

About the allegation of beating up Suman to death, Rubel did not make any comment.

Khan Noor Uddin Md Jahangir, Raipura upazila health and family planning officer, said Suman was brought dead to the hospital. "He died from profuse bleeding from his nose."

Farid Uddin Khan, inspector (investigation) of Raipura Police Station, said, "We have heard about the clash and death of Suman. No one has filed any complaint in this connection."

Police were investigating the incident. he said, adding that additional police personnel were deployed to avert any untoward incidents.

# Ukraine strikes Russia, occupied east

#### Moscow forces capture village Kyiv took back in 2023

#### AFP, Moscow

Ukraine attacked a number of villages in Russia's Belgorod border region and the occupied eastern city of Lysychansk yesterday, killing two people, authorities and Russian media said.

Belgorod sits directly across the border from Ukraine's northeast Kharkiv region, an area that has seen intense fighting since Russia launched a major ground assault on May 10.

"Several air targets were shot down as they approached the village of Belenkoye. To our great sorrow, one civilian was killed," Belgorod region governor Vyacheslav Gladkov said.

One civilian in the Russian village of Belenkoye was injured, while a Ukrainian aerial attack near the town of Shebekino, close to the border, wounded another, he said.

The Ukrainian army has come under intense pressure in the past two weeks, fighting off a fresh Russian offensive in the northeastern Kharkiv region while facing critical shortages of ammunition across the front lines.

Ukrainian President Volodymyr Zelensky's office has been charged with making illicit gains worth almost \$400,000, Ukraine's anti-graft watchdog said yesterday.

The suspect, whom Ukrainian media identified as Andriy Smyrnov, is accused of purchasing property, land and luxury vehicles with the funds, the origin of which was not clear.

Smyrnov faces five to 10 years in prison if found guilty.

Ukraine, which had severe corruption problems even before Russia's 2022 invasion, has pledged to bolster efforts to combat graft as it seeks EU membership and to reassure its Western military backers. Smyrnov was sacked in March.

All kinds of gas supply to household and commercial consumers will remain halted during the period, said Titas.

Consumers in adjoining areas may experience low pressure in gas supply, it added.

# 'Narrow escape from crossfire'

The ministry in a letter to the NHRC on June 3, 2021, attached a Police Headquarters report dated May 18 that year. The report said the allegations against OC Abdun Naser and SI Mizanur were primarily proved. Later, the ministry informed that allegation against another SI Samraj Mia was also primarily proved. It said proceedings of departmental cases against the accused cops were underway, according to a letter that the commission wrote to the ASK. Police said Amanullah was once a leader of Purbo Banglar Communist Party. He was in prison for 20 years in two murder cases.

Requesting anonymity, an officer said, "Akhtaruzzaman rented a flat in Kolkata for Jihad and Siam. Akhtaruzzaman and Amanullah went to Kolkata on April 30.'

Amanullah, Mustafizur and Faisal told investigators that they murdered the MP in a rented flat. The body was then cut into pieces, piled into two suitcases and handed to an Indian man for disposal.

Amanullah told the investigators that the suitcases changed hands, and he did not know where they were dumped.

suspects agreed to do the job for Tk 5 crore.

According to intelligence sources, Delhi Akhtaruzzaman left for Kathmandu on Tuesday.

Azim's friend Gopal Biswas, at whose home he was staying, told The Daily Star that an investigation officer of Borah Nagar Police Station said the suspect who planned the murder was named Mohammad Akhtaruzzaman.

The officer, Suvendhu Goswami, also told Gopal that Akhtaruzzaman is from Kotchandpur upazila of Jhenaidah.

"Akhtaruzzaman rented a flat in the New Town area a year ago at a monthly rent of Rs1lakh. He came to Kolkata with a US passport and committed the crime with the help of seven Bangladeshis," Gopal said, quoting the officer.

According to security camera footage seen by the Indian police. Azim, two other men and a woman entered the flat. Only the two men and the woman were seen leaving the flat later, Gopal added.

A source at a law enforcement agency in Bangladesh said. "Akhtaruzzaman had close ties with Azim. We suspect he may have killed the lawmaker over business conflicts."

Akhtaruzzaman's brother Shahiduzzaman is the mayor of Kotchandpur Municipality.

Contacted, he said, "My brother had sited Bangladesh during Ramadan." He claimed the lawmaker and his

brother had a good relationship. THE ARRESTS IN DHAKA

On Tuesday night, police arrested Amanullah, said A DB official, adding that following up on his information, Faisal and Mostafizur were arrested.

"I demand a fair investigation into the murder. I want to see the end of this. Why did they kill my father?" she told reporters at the DB office in the capital vesterday.

Muhammad Ahad, officer-in-charge of the police station, said it was not a murder case because "his body has not been found and we have not been officially informed about his death".

According to the proposal, the SUVs are needed to conduct mobile court drives, maintain law and order, and ensure uninterrupted movement of officials involved in election duties.

The finance ministry, however, advised the public administration ministry to cut the number of the vehicles. The ministry later sent a revised proposal on procuring 261 SUVs.

and April 1 this year, but to no avail. In reply to the NHRC letters, the senior secretary's office time and again stated that allegations against the cops were primarily proved and proceedings of departmental cases were underway.

According to one of the letters written to the NHRC on March 20, 2022, fifty witnesses were detected in the departmental cases filed against SI Mizan and SI Samraj and statements of 15 of the witnesses were recorded.

The process to file a departmental case against former Zakiganj OC Abdun Naser is under process, according to the letters.

This correspondent contacted NHRC on May 8, the officials said they sent another letter to the home ministry, requesting it to complete the probe by May 20.

Asked, NHRC Chairman Kamal Uddin Ahmed said there has been dilly-dallying over the matter, but punishment to the persons responsible has to be meted out.

"Sometimes we get frustrated. In some cases, they are taking action as per NHRC's request. The culture of punishing those responsible and providing compensation to victims has not yet been established in our country," he told The Daily Star.

Amirul Islam, additional superintendent of police at the PHQ, who is tasked with NHRC issues, said the departmental cases were under investigation against the three officers.

Narrating the incident, Basit said OC Naser called him over his mobile phone around 8:00pm on the day before the incident and asked him to meet.

"I immediately informed the matter to local Manikpur Union chairman Mahatab Uddin and chairman of nearby Kaskanakpur UP Riaz Uddin," he said.

On their advice, he met the OC at Union Office Bazar from where he was taken to a nearby checkpoint area. There, police detained him and put handcuffs on him.

"I repeatedly begged for my release, but my requests went unheeded," he said.

Naser then boarded him in a police van, took away Tk 5,000 and his mobile phone. After taking him to different places, the police took him to Rarai village. They asked him to get down from the van and run away.

Basit said some influential neighbours with whom he had a dispute over a piece of land, "might have used the police to have him killed".

He claimed that the rivals earlier framed him in two false cases over snatching and drug peddling.

"My family has been going through an ordeal as police filed an attempted robbery case against me and four others a day after the incident," Basit added.

He was released on bail on January 3, 2020, upon a High Court order.

Contacted recently, former Manikpur Union Chairman Mahatab Uddin said Basit was on good terms with OC Naser while he was serving in district DB. After Naser became Zakiganj OC, Basit called the chairman and introduced him to the OC.

Naser, who is now posted at Sylhet SP office as an inspector, claimed himself and other officers to be innocent.

"Since an investigation is going on over the complaint, I cannot make any comment. If the authorities find us guilty, they may take action. And if we feel aggrieved with that action, we may go to a court," he said.

He also said senior officers submitted 10 reports to the authorities over the matter and the reports did not find him guilty.

Mizan and Samraj could not be contacted for comments.

percent, 36.54 percent, and 38.62 percent. The average turnout in that elections was 40 percent.

This year, 38.47 percent voters exercised their franchise in 129 upazilas where elections were held using paper ballots. The figure was 32.17 percent in 23 upazilas where electronic voting machines (EVMs) were used.

Panchari upazila of Khagrachhari logged the highest turnout at 74.95 percent, while Bagmara of Rajshahi recorded the lowest 17.98 percent. Voting in both the upazilas was conducted using paper ballots

#### ÂL MEN WIN BIG AGAIN

Like the first phase of the upazila polls, Awami League men won chairman elections in almost all 156 upazilas that

went to polls in the second phase on became victorious in the two phases of Tuesday.

Though the ruling party did not field candidates this year, grassroots AL leaders ran for chairman as independents.

Party sources said at least 136 AL leaders have been elected upazila chairman and at least six expelled BNP leaders have won chairman polls.

BNP boycotted the elections saying that polls cannot be held in a free and fair manner under the incumbent Election Commission. The party has expelled many grassroots leaders for running in the elections.

This year, a total of 24 women candidates contested the upazila polls in the first phase. In the second phase, the number went up by only one.

Only six women chairman candidates

the upazila elections. Of them, four won the polls in the second phase, shows EC data.

On Tuesday, Selina Mirza won the chairman polls to Ullapara Upazila Parishad in Sirajganj, Sabekunnahar was elected chairman of Panchbibi upazila in Joypurhat, Nargis Begum of Bhuapur upazila in Tangail and Wana Marzia Nitu Galachipa upazila in Patuakhali.

Chairman elections were not held in seven out of the 156 upazilas that went to the polls on Tuesday as the candidates there were elected uncontested.

In the first phase of the polls, Sarkar rhana Akter was elected chairman of Domar upazila in Nilphamari and Roma Akter of Nasirnagar upazila in Brahmanbaria

In the previous upazila polls held in 495 upazilas in 2019, seven women were elected upazila chairman.

Debnath said a fewer number of women candidates are winning the upazila polls and the number of women participating in the direct election is less.

The number of women in politics is less which is another reason for a few women candidates coming out victorious, he said.

The sixth upazila parishad elections are being held in four phases this year. A total of 112 upazilas will vote in the third phase on May 29, and 56 in the fourth phase on June 5.

A total of 139 upazilas went to polls on May 8 and eight of them saw the chairman aspirants becoming elected uncontested.
