

Couple held for impersonating NSI officials

UNB, Chattogram

Rapid Action Battalion (Rab) on Thursday arrested a couple in Chattogram's Sitakunda who identified themselves as National Security Intelligence (NSI) officials, and swindled money from people.

The arrestees are Mumtaz Begum, 34, and her husband Mujibur Rahman, 46.

They were arrested in Premtola College Road area, said Md Sharif-ul-Alam, senior assistant director (mass media) of Rab-7, in a press release yesterday.

Rab also seized 960 yaba pills from their possession.

Manjur Alam, a victim, was looking for a job after passing SSC exams. He met Mumtaz at a wedding in 2021. At that time, Manjur came to know that Mumtaz is the deputy director of NSI, Chattogram unit.

Pretending to be an NSI official, Mumtaz took more than Tk 34 lakh from Manjur, promising to a job in the NSI.

Her husband Mujibur helped her commit the fraud, said the Rab official.

They were handed over to Sitakunda Police Station.

"We had a house on two bighas of land and had another one bigha of paddy field. Aila swept away our land. We lived on the remaining land for three years before it also went to the river due to erosion. All we got as compensation was Tk 20,000 and a 1,500-litre water tank," Satyajit said.

He now pulls a rickshaw while his father catches fish in the river to survive. They were neither considered for the government's shelter project nor got any help from the social safety net programme.

About 10 families of Channirchak and 40 families of Jaliakhali in the upazila are toiling through a similar situation on the same embankment.

Monsur Ali Khan, chairman of Dakope Upazila Parishad, said around 400 families across the upazila are living on embankments and khas lands after cyclone Aila left them homeless.

The story of Ranjit Mandal, a resident of

Mathbari village in Koyra, echoed Satyajit's plight.

Over 700 families across Koyra are living on the embankments, while being left to fend for themselves being excluded from the government's rehabilitation and safety net schemes.

Meanwhile, at least 50 families were seen living on the embankment of Kapotaksha river in Mathbari, while 22 families are living on the river's embankment in Patharkhali area, and 19 families on the embankment from Hazatkhalia Sluice-gate to Kashiya Hatkhola area.

Contacted, SM Shafiqul Islam, chairman of Koyra upazila, said the government, as well as different private organisations, are working to rehabilitate the victim families.

Md Abdul Karim, relief and rehabilitation officer of Khulna district, however, claimed that all affected victims of cyclone Aila in the district were rehabilitated and helped by the government under various schemes including the shelter project.

A decade-long misery

Primary school field in Jashore remains waterlogged

The field of Arshingripukuria Government Primary School in Chougachha upazila of Jashore has remained waterlogged for the last one decade in absence of a proper drainage system.

As such, students have to wade through dirty water accumulating in the field to get to their classes and do the same again to return home after school every day.

The school, established in 1958, is on 33 decimals of low-lying land. Even a little rain results in knee-deep water submerging the field. In the monsoon, the situation becomes unbearably worse.

Parents, students and local residents have long been seeking intervention of the authorities concerned and local public representatives to look into the matter.

Yet, there has been no step taken to this end.

"The field always remains under water. We face great difficulty entering the school premises. We could never play in the field due to waterlogging," said Hasibur Rahman, a student.

Mehdi Hasan, another student, echoed him.

"The school field has remained waterlogged all year long for the last 10 years. It has no boundary wall, no tube well, and its bathrooms are in a shabby state. Since there is no other school in the vicinity, we have no choice but to send our children here," said Shafi Khatun, a parent.

Jahangir Alam, another parent, urged everyone concerned to look into the matter and take necessary steps to solve the problem.

"We have reached out to the local union parishad member, upazila parishad chairman, and

the education officer in this regard. However, no step has yet been taken while my school continues to bear this misery," said Ruhul Amin, headteacher of the school.

Muktadir Rahman Soheli, president of the school's management committee, echoed him.

"It is necessary to elevate the school compound by filling up soil. Unfortunately, there is no fund for this at present. I will discuss the matter in the union parishad meeting," said Najibur Rahman, local UP member.

Contacted, Mostafizur Rahman, upazila education officer in Chougachha, said they are aware of the school's situation.

"We received the school's application and informed the higher authorities about it. Once fund is allocated, the problem will be resolved," he added.

adding that provisions are in place to address heat issues.

She mentioned that to address health issues regarding heatwaves, the government is now working to formulate a Health National Adaptation Plan (HNAP) where specific health actions will be outlined to address climate change and heatwaves.

To minimise the losses in the agricultural sector due to heatwaves, Shameem Hassan Bhuiyan, deputy director at Bangladesh Meteorological Department, said they have developed some agro-meteorological advisory services.

"This is the blending of agricultural information and meteorological forecast," he said, adding that they are trying to disseminate information to the farmers.

Ranjan Chakraborty, senior programme manager at the Climate Change Programme, BRAC, delivered a welcome address at the seminar while Dharitri Kumar Sarkar, deputy secretary at the environment ministry, also spoke.

Zahirul Islam from Gandaria, Dhaka, was advised by his doctor to seek treatment in India. However, at the Keraniganj Regional Passport Office, he was told he couldn't get a passport because his DSCC birth registration number wasn't in the national server.

"It is very important for me to go to India for treatment, but I can't go because of the birth registration. I don't know when it's going to be fixed," said Zahirul.

Towhidur Rahman's two-month-old daughter, despite having an Australian passport, does not have a birth certificate in the country yet.

"Australia now requires parents' birth registration numbers for a child's birth registration. My wife has hers, but mine from DSCC isn't accepted here because it's not in the national server," said Towhidur.

So the LGD intervened. A letter signed by Mohammad Shamsul Islam, deputy secretary of the City Corporation-1 branch, reminded the DSCC that all other local government entities use the central server for birth and death registration.

The letter stressed that a separate system could lead to "chaos" and hinder citizen services. In the public interest, the

LGD directed the DSCC to resume using the central server and transfer existing data from their own system.

Contacted, DSCC Chief Executive Officer Mizanur Rahman said on Thursday that they have received the letter.

"However, we are still requesting the Registrar General to integrate our new server with their server. We do not want to use the central server," he said.

He said the Registrar General's Office did not have the capacity to register the large number of people across the country.

"Considering people's sufferings, DSCC has started the registration work on its own server," he said.

He also mentioned that they have sent letters to the relevant authorities to resolve the issues related to obtaining a passport and other essential services.

"Deals will be signed with various government organisations in this regard," he informed.

When asked if DSCC would reply to the LGD letter, he hung up the phone, saying that he had urgent work.

Speaking with the newspaper, Registrar General (Birth and Death Registration) Zahid Hossain said, "We are working based on government directives and the Birth and Death Registration Act 2004 and the Birth and Death Registration Rules 2018."

"If the DSCC wants to register its residents again through our central server, we will welcome them as their users are still on our servers. At the same time, if they give us the data of the 80,000 birth registrations they have completed, we will add them to the central server. For this, no citizen will have to come in person or pay any fee," he informed.
