### 53pc rise in allocation for debt servicing


Spiralling amount will put strain on reserves, say experts

#### REJAUL KARIM BYRON

The government's allocation to repay foreign debts may reach Tk 57,000 crore in the next budget, a 53 percent rise from the current year, putting further pressure on the country's dwindling foreign currency reserves.

The interest payments for increasing levels of foreign loans in recent years and the tumbling value of the taka against the US dollar have forced the government to set aside more for debt servicing.


Allocation for foreign debt repayment has been Tk 37,076 crore in the current fiscal year, according to the finance ministry.



The dollar traded at an average of Tk 109.97 in FY24, according to Bangladesh Bureau of Statistics.

Considering this exchange rate, the government has paid \$3.36 billion in the current fiscal year and will require \$5 billion in the next fiscal year of 2024-2025.

However, an official of the Economic Relations Division (ERD) said the actual amount of the repayment would depend on the exchange rate between the taka and the dollar at the time of repayment.

### Fewer but fiercer since the 90s

Says DoE study

Though Bangladesh is experiencing fewer cyclones than in the 1960s, their intensity has increased, a recent study has found.

In the 1960s, the number of cyclones hitting the Bangladesh coast was 24, which came down to 13 in the 2010s, according to a study conducted by the Department

the Center for Environmental and Geographic Information Services

The country did not experience any super cyclones -- a cyclonic storm which at least packs wind speed of 222kmph -- between 1960 and 1989. However, between 1990 and 2020, at least three of them hit the coast.



### Ensure smooth supply of power, gas to factories

#### **Business leaders urge PM**

Business leaders vesterday urged the prime minister to ensure uninterrupted power and gas supply to their factories.

They also demanded the reinstatement of the previous rates of cash incentives on export receipts until the country graduates from the Least Developed Country group in 2026.

The leaders, who met Prime Minister Sheikh Hasina at the Gono Bhaban yesterday, wanted different tax benefits in the next budget. They also urged her to ensure that officials of customs and NBR do not harass them.

Led by Mahbubul Alam, president of the Federation of Bangladesh Chambers of Commerce and Industry (FBCCI), the meeting discussed the overall business climate and the upcoming national budget with the PM.

They also held a meeting with Salman F Rahman, adviser to the prime minister on private industries and investment, at the office of Bangladesh Investment Development Authority in Dhaka

Business leaders have been demanding that the import duty on solar panels be lowered as the high tariff is discouraging factories to use them.

A group of businesspeople also held a meeting with Tawfiq-e-Elahi Chowdhury, the power, energy, and mineral resources' adviser to the prime minister, on Wednesday.

They urged the same regarding solar panels and cited the target to produce over 12,000 megawatts of renewable energy as per the Paris Agreement.

Apart from the FBCCI, leaders from Dhaka Chamber of Commerce and Industry; Bangladesh Garment Manufacturers and Exporters Association; Bangladesh Textile Mills Association; Bangladesh Knitwear Exporters Manufacturers and Association; cement manufacturers association; and many other chambers and trade bodies attended the meeting.

### Israel strikes Rafah defying ICJ's order

Tel Aviv may renew ceasefire talks 'this week'; death toll in Palestinian enclave rises to 35,903

Israeli air strikes and artillery pounded Rafah on yesterday, despite the International Court of Justice ordering an immediate halt to its military offensive in the southern Gazan city.

Palestinian witnesses and AFP teams reported Israeli strikes or shelling in Rafah, the central city of Deir al-Balah, Gaza City, Jabalia refugee camp and elsewhere.

The health ministry in Hamas-run Gaza said yesterday that at least 35,903 people have been killed in the territory since October 7. The toll includes 46 deaths over the past 24 hours, a ministry statement said.

In a case brought by South Africa

alleging the Israeli military operation amounts to "genocide", the ICJ ordered Israel to halt its Rafah offensive and demanded the immediate release of hostages still held by Palestinian militants.

The Hague-based ICJ, whose orders are legally binding but lack direct enforcement mechanisms, also instructed Israel to keep open the Rafah crossing between Egypt and Gaza, which Israel closed earlier this

In its ruling, the ICJ said Israel must "immediately halt its military offensive, and any other action in the Rafah Governorate, which may inflict on the Palestinian group in Gaza conditions of life that could bring about its physical offensive in the Gaza city of Rafah.

Meanwhile, France's president, Qatar's prime minister and the foreign ministers of Saudi Arabia, Egypt and Jordan held talks Friday on the Gaza war and ways to set up a Palestinian state alongside Israel, the French presidency said.

French President Emmanuel Macron organised the meeting amid growing international concerns over the Israel-Hamas war. It came a few hours after the UN's top court ordered Israel to halt its

### Rickshaw driver found dead in paddy field

Police yesterday recovered the body of an autorickshaw driver from a paddy field in Parpara village of Kandua union under Jamalpur Sadar

The deceased was identified as Shahadat Hossain, son of Jabed Ali of Pathalia village of Sharifpur union of the upazila Quoting family members, Mohammad

Mohabbat Kabir, officer-in-charge of Jamalpur Sadar Police Station said Shahadat Hossain left the house with his autorickshaw Friday night but didn't return home.

Later in the morning, locals found him dead in a paddy field in Parpara village and informed police, the OC said.

Police recovered the body and sent it to Jamalpur General Hospital for autopsy.

His autorickshaw was also recovered, but the battery was stolen.

"The body bore several injury marks. No case is yet to be filed over the killing," the OC said, adding that the victim might have been killed by robbers.

### Four children drown

In Sylhet, two sisters drowned while swimming in a river in Golapganj upazila.

Suheda Begum, 10, and Majeda Begum, 5, were daughters of Joynal Ahmed of Fatehpur Paschimpara village of the upazila, said Golapgani Model Police Station Officer-in-Charge Masudul

Suheda and Majeda drowned while swimming in the Kushiyara River near their house in the afternoon. Their bodies were recovered around

In Chuadanga, two children drowned in a pond while playing next to it at Shakharia village in Jibannagar upazila.

Tabassum, 6, daughter of Ashraful Haque and Ritu, 5, daughter of Raju Ahmed, went missing in the morning. Later, their bodies were found in the pond next to the house.

SM Jabed Hasan, officer-in-charge of Jibannagar Police Station, said an unnatural death case has been filed with the police station.

The bodies were handed over to their relatives, added the OC.

"We had a general conception that the number of cyclones has been increasing in the Bay due to climate change. But it is the harshness or intensity of the cyclones that is increasing, not the numbers," said BUET Professor Rezaur Rahman after reviewing the study titled "Projection of Sea Level Rise and cyclones are measured not only by Development of Digital Elevation the storm's severity but also by the Models in Support of SLR Decision extent of loss and damage to human Making'

Analysing the data on cyclones that made landfall on the Bangladesh coast from 1960 to 2020, meteorologists found that 24 cyclones hit the country in the 60s, while only 16 hit the country in the next decade. There were nine cyclones each in the 80s and 90s, 10 in the 2000s, and 13 in the 2010s.

The analysis considered a weather event as a cyclone only if its wind speed was greater than or equal to 63kmph (34 knots).

The formation of cyclones largely depends on sea surface temperatures reaching 26-27 degrees Celsius.

From 1951 to 1987, the temperature had been on a constant rise, increasing the intensity of cyclones, the study said.

The devastating impacts of life and property.

The cyclones of 1970 and 1991 caused high waves leading to the flooding of the country's coastal regions and causing the deaths of over 500,000 and 138,000 people respectively.

Sidr hit Bangladesh in 2007 with heavy rains, strong winds and storm surge, resulting in the death of around 3,000 people and damage to property worth around \$450 million, according to reports.

Speaking to The Daily Star, From 1990 to 2020, there were Professor Emeritus Ainun Nishat of BRAC University and a leading climate expert, said though the number of cyclones has been decreasing, the sea surface temperature is on the rise and so, many cyclone-like weather events are taking place in the Bay.

"While we can't avoid cyclones, we can take precautionary measures like building our embankments properly. Being well prepared will help reduce the catastrophic impacts

The maximum sustained wind speed within the 54km of Cyclone Remal's eye was 62kmph and it could increase up to 88kmph, said Met officials.

State Minister for Disaster Management and Relief Md Mohibur Rahman yesterday said Remal was expected to make landfall in the coastal districts between Satkhira and Cox's Bazar by this evening.

The coastal districts of Satkhira, Pirojpur, Khulna, Bagerhat, Jhalakhati, Barguna, Noakhali, Barishal, Patuakhali, Laxmipur, Feni, Cumilla, Chattogram, Cox's Bazar, and their offshore islands and chars are likely to be inundated by storm surges of 3-5 feet above the normal astronomical tide.

Abul Kalam Mallik, a meteorologist Bangladesh Meteorological Department, said the cyclone will head towards the coast at a speed of 12 to 15kmph.

"If it gathers strength, it may gain speed," he added.

However, Indian Meteorological Department (IMD) said Remal may have wind speeds of up to 120kmph. Speaking at a press briefing at the

Secretariat, State Minister Mohibur yesterday said nearly 4,000 shelter centres have been readied in the coastal districts with adequate amount of dry food.

"We have 80,000 volunteers ready to tackle the situation and all necessary preparations have been made," he added. The state minister also warned of

### 53pc rise in allocation for debt servicing

After nine years, in 2021-22, the amount went past \$2 billion. The following year, Bangladesh paid \$2.67 billion in debt servicing. The amount is going to be over \$3 billion in the current

In the first nine months of FY24, debt service repayment in both principal and interest amounted to \$2.57 billion, a 49 percent increase year-on-year.

Interest payments alone reached \$1.05 billion in July-March. This was the first time the interest payment crossed the \$1-billion mark. It was \$485 million in the first nine months of FY23. Mustafizur Rahman,

distinguished fellow at the Centre for Policy Dialogue, said spending \$2 billion or \$3 billion in servicing debts would not be a problem if the forex reserves were \$46 billion, which was the case in early When the reserves are less than \$20

billion, spending \$5 billion to repay loans becomes difficult because the payment has to be made in foreign currencies, and for foreign currencies, the country needs the earnings, he said.

On May 21, the reserves stood at \$18.61 billion, central bank data showed.

"In the next few years, debt servicing will be a major issue, and we should be careful in managing the debt repayment and try our best to earn more through export and remittance," Prof Mustafizur

Besides, the government needs to

demonstrate zero tolerance on capital flight, which often takes place through hundi, he said.

The economist said the government should be careful in choosing and implementing projects and ensure the desired outcome of the schemes.

With its rising per capita income, Bangladesh's access to cheap loans is decreasing and foreign borrowing is also



becoming costlier.

According to an ERD report, the country now has to borrow at the costlier market-based rates to cover the

development spending. The interest rate risk is high when the debt portfolio is dominated by marketbased rates because the volume of the payment is based on the vagaries of the global economy.

The cost of foreign loans has been on the rise as the interest rates have shot up globally. The interest rates for market-based loans have also increased significantly, an ERD official said.

In 2023, the government borrowed about \$2.6 billion at the market-based rate, which accounted for 30.7 percent of the total committed loans. In 2022, it was \$3.42 billion, representing 43.9 percent of the total.

The ERD official said the funds released for mega projects like the metro rail, the Matarbari power plant, and the Rooppur Nuclear Power Plant have increased in recent times as the physical works are in the final stage.

Bangladesh significant budgetary support in the last three years after development partners accelerated lending to help the economy make a turnaround from the impacts of the coronavirus pandemic. This has pushed up the loan repayment.

"Moreover, the grace period of some major loans will come to an end over the next few years," Prof Mustafizur said.

During the grace period, a borrower pays only the interest. After it expires, both interest and principal amounts are paid in instalments.

With Bangladesh set to graduate from the group of least-developed countries, the costs have gone up while the share of concessional loans has come down drastically, he added.

### RHD to turn 10km road into 4-lane

### It will enhance connectivity with Dhaka-Ctg Highway, port

With the Bangabandhu Sheikh Mujib Shilpa Nagar expected to revolutionise the country's trade, was launched by Prime Minister the roads authority is planning to Sheikh Hasina in November 2022. make its connectivity smoother. the Dhaka-Chattogram Highway and the Chattogram Sea Port.

The Roads and Highways Department (RHD) is going to turn the existing 10km road, which connects Shilpa Nagar with the important highway, into a four-lane one.

The Shilpa Nagar, built on about 33,800 acres or 136.86 square kilometres of land in Mirsarai,

The biggest economic zone in Bangladesh is located 200km from Dhaka, 60km from Chattogram city and 70km from Chattogram Port and the Shah Amanat International Airport.

Bangladesh Economic Zones Authority, the implementing agency of the flagship economic zone, aims to attract investments of \$20 billion for the Shilpa Nagar by 2030, generating employment opportunities for around 14 lakh

Till January, five companies started commercial operations at their industrial units in the industrial zone.

The study, conducted by Estiaque Bari, senior lecturer at the Department of Economics, Eas West University, also said over 333MW could be added to the national grid if 30 percent of open spaces can be utilised.

The findings were unveiled at a roundtable organised by Change Initiative at The Daily Star Centre in the capital.

Zakir Hossain Khan, chief executive at Change Initiative, said, "If 80 percent of spaces and household rooftops come under the net metering, the power generation will be massive and the country will be highly benefited." Net metering is a billing tool that allows one

## Spectre of another exodus looms

#### Over 100 families at risk as Jamuna erosion worsens in Pabna

AHMED HUMAYUN KABIR TOPU,

A decade ago, an entire village in Natun Varenga union under Pabna's Bera upazila went underneath the Jamuna river.

Displaced and homeless, the villagers sought refuge near the Mujib Bandh, a flood protection embankment. Roughly a kilometer away from the water's edge, they began anew.

Brick by brick, they rebuilt their resurrecting their village from the ashes. They named the settlement Moricha -- after the name of the village that was swept away.

However, after a decade later, the community is under the threat of losing everything to the river yet

The spectre of another exodus looms large, shattering the fragile peace they've managed to establish.

Over the last couple of weeks, erosion has taken a severe turn, devouring the banks just ahead of the monsoon. Locals fear the erosion may turn worse in the monsoon.

The present situation brings back horrors from a decade back, when I lost all my lands and homestead to the river, when it engulfed Moricha village entirely," said Md Lutfor Rahman.

Md Alamgir Hossain from Leulai Ghat area, said, "As water level of Jamuna has swelled up in the last two weeks, it started devouring vast

swathes of croplands in Moricha (new) and Leulai villages on the river banks. At least one kilometre stretch of the river bank has already been eroded.'

Md Abu Daud, chairman of Natun Varenga union parishad, said, "Over a hundred families, as well as Leulai gravevard and other establishments are under threat.

have already informed Bangladesh Water Development Board," he added.

Contacted, Amitav Chowdhury, executive engineer of BWDB in Bera upazila, said experts have already visited the affected areas. "Preparation is on to launch protection work in the affected areas soon," he added.

Bangladesh's geophysical condition is now critical due to the unilateral withdrawal of water from over a hundred shared rivers by a neighbouring country, speakers said at a discussion yesterday.

The government must put immediate pressure on the neighbouring country to ensure water flow during the dry season, speakers also said.

They were addressing discussion titled "Uniform River Water Distribution: Perspective Padma Teesta."

The Workers' Party organised the event at the Dhaka Reporters Unity in the capital.

Author Siddiqi said the Ganges Treaty of 1996 will expire in 2026. Unless it is renewed, there will be no negotiated arrangement for Ganges water sharing

or agreed basis for negotiations on other rivers in the post-2026 period. So it must be reviewed by a powerful committee.

There must be a guarantee clause in the renewed treaty like 1977, he added.

Mahbub also pointed out discrepancies in the number of shared rivers between Bangladesh and India, stressing the need for expert intervention to prepare an accurate list and notify India accordingly.

Additionally, called compensation from India for the economic losses Bangladesh has suffered since 1975 due to the Farakka Barrage.

He said bilateral discussions alone cannot resolve water issues and advocated for the formation of a regional water forum or commission under the supervision of international organisations.

### China ends military drills around Taiwan

AFP, Beijing

China has ended two days of military drills around Taiwan that saw jets loaded with live munitions and warships practise seizing and isolating the self-ruled island.

The exercises simulated strikes targeting Taiwan's leaders as well as its ports and airports to "cut off the island's 'blood vessels'", Chinese military analysts told state media.

Beijing considers the democratic island part of its territory and has not ruled out using force to bring it under its control.

The war games kicked off Thursday morning, as aircraft and naval vessels surrounded Taiwan to conduct mock attacks against "important targets", state broadcaster CCTV said.

Codenamed "Joint Sword-2024A", exercises were launched three days after Taiwan's President Lai Ching-te took office and made an inauguration speech that China denounced as a "confession of independence".

Beijing's ministry spokesman Wu Qian said Friday that Lai was pushing Taiwan "into a perilous situation of war and danger".

"Every time 'Taiwan independence' provokes us, we will push our countermeasures one step further" until "complete reunification" is achieved, he said.

The origin of the dispute dates back to the Chinese Civil War, when nationalists fled to Taiwan following their defeat at the hands of the Communist Party in 1949.

A total of 111 Chinese aircraft and dozens of naval vessels took part in the drills over two days, according to Taiwan's defence ministry.

On Friday evening, China's army published images of the drills' "highlights", featuring missile-launching trucks, fighter jets taking off and naval officers looking through binoculars at

## Moscow fumes as G7 mulling to use assets

G7 finance ministers cited "progress" in finding ways to use profits from frozen Russian assets to help Ukraine as they wrapped up a meeting Saturday, envisioning a concrete proposal to present to a leaders' summit next

A search for creative yet legally sound solutions was top of the agenda at the two-day Group of Seven meeting in Stresa, northern Italy, as Kyiv continues its urgent appeals for more funds from Western allies in its third year of war with Russia.

"We are making progress in our discussions on potential avenues to bring forward the extraordinary profits stemming from immobilised Russian sovereign assets to the benefit of Ukraine, consistent with international law and our respective legal systems," the ministers said in a final

G7 finance ministers reiterated in their final statement that Russian assets frozen by the Group of Seven nations "will remain immobilised until Russia pays for the damage it has caused to Ukraine".

But they went further, saying they were 'committed to further financial and economic sanctions... including continuing to target Italy and Canada - to back a loan that could two confirmed deaths.



Russia's energy revenue and future extractive capabilities".

The G7 is "ready to impose sanctions on individuals and entities that help Russia acquire advanced materials, technology, and equipment for its military industrial base," added the statement.

Russian Finance Minister Anton Siluanov said Moscow would reciprocate if the G7 went through with its threat. His government has already taken control of some Western businesses active in Russia.

Financing for Ukraine and meeting China's growing export strength were the main themes addressed in comments from finance ministers during the gathering.

The United States has been pushing its G7 partners - Japan, Germany, France, Britain, He said 24 people were injured along with the

provide Kyiv with as much as \$50 billion in the near term.

However, the cautious wording of the statement, containing no figures or details, reflects many legal and technical aspects which need hammering out before such a loan could be issued.

The issue will now be discussed by G7 leaders at a summit in southern Italy in mid-June. The G7 ministers also called out China's trade policies and industrial overcapacity, warning that the bloc could take measures to counter them.

The United States has led warnings that a surge of low-cost Chinese exports fuelled by Chinese government support in key sectors like solar and electric vehicles pose a risk to global markets.

Meanwhile, Russian strikes on a crowded DIY hardware store in the Ukrainian city of Kharkiv yesterday killed at least two people, wounded many more, and triggered a huge blaze that fire crews were battling to contain, regional officials said.

Oleh Syniehubov, Kharkiv regional governor, said via the Telegram messaging app that two guided bombs had hit the DIY hypermarket in a residential area of the city.

### **Pandemic talks** end without a deal

Negotiations on a landmark global agreement on handling future pandemics ended Friday without a deal -- though countries said they wanted to keep pushing for an accord.

Scarred by the devastation caused by Covid-19 which killed millions of people, shredded economies and crippled health systems countries have spent two years trying to hammer out binding commitments on pandemic prevention, preparedness and response.

The talks gathered momentum in the final weeks, but failed to meet a final deadline before next week's World Health Assembly -- the annual gathering of the World Health Organization's 194 member states.

'This is not a failure," WHO chief Tedros Adhanom Ghebreyesus insisted as the talks ended at the UN health agency's headquarters in Geneva. He urged countries to see it as a "good opportunity to re-energise".

The assembly, which runs from Monday until June 1, will take stock and decide what to do next.

The main disputes revolved around access to pathogens detected within countries, and to pandemic-fighting products such as vaccines derived from that knowledge. Other tricky topics were sustainable financing, pathogen surveillance, supply chains, and the equitable distribution of tests, treatments and jabs but also the means to produce them.

### Fire at gaming zone in Gujarat kills 16

At least 20 people, including children, were killed in a massive fire that raged in a gaming zone teeming with people enjoying a summer vacation outing in Gujarat's Rajkot city yesterday.

Rescue operations are underway at the affected TRP game zone for more than four hours after the blaze erupted at a fibre dome constructed for gaming activities at around 4:30 pm, officials said.

"Extremely distressed by the fire mishap in Rajkot. My thoughts are with all those who have lost their loved ones. Prayers for the injured. The local

administration working to provide all possible assistance to those affected," Prime Minister Narendra Modi

According to officials, the structure collapsed due to the huge fire which broke out when several persons, including children, were playing games.

"The fire caused the collapse of the structure. So far, we have received a figure of 16 deaths," said Rajkot Collector Prabhav Joshi.

Rajkot Police Commissioner Raju Bhargav told media persons that the cause of the blaze would be investigated and a message had been issued to all the gaming zones in the city to close operations.

### Vote against dictatorship

Says Kejriwal as India votes in sixth phase of polls

Two top rivals of Indian Prime Minister Narendra Modi who accuse his government of targeting them in unjustified criminal probes cast their votes in New Delhi yesterday as the country's six-week election resumed.

Hindu nationalist Modi, 73, remains broadly popular after a decade in office and his ruling Bharatiya Janata Party (BJP) is widely expected to win a third term next month after a poll hit by high summer temperatures.

But accusations that the BJP has sought to sideline its opponents via the justice system have sparked concerns from UN rights chief Volker Turk and rights groups over the election's fairness.

Rahul Gandhi, the most prominent leader of India's opposition Congress party, cast his ballot at a polling station in New Delhi, where temperatures were forecast to reach 43 degrees Celsius (109 degrees Fahrenheit).

A son, grandson and greatgrandson of former prime ministers, Gandhi paused after voting to take a selfie with his mother Sonia but did not speak to crowds of reporters.

The scion of a dynasty that dominated Indian politics for decades, he was convicted of criminal libel last year after a complaint by a member of Modi's party. His two-year prison sentence saw him disqualified from parliament until the verdict was

suspended by a higher court.
After voting, Delhi Chief Minister Arvind Kejriwal, 55, leader of the opposition Aam Aadmi Party (AAP), urged citizens: "Please vote, use your right to vote, and vote against dictatorship."

Kejriwal was arrested in March in a long-running graft case and detained for several weeks before the Supreme Court granted him bail earlier this month and he returned to the campaign trail.

Investigators "had no proof and yet they jailed him", opposition voter Yogesh Kumar, 42, told AFP. "This is a blunt show of power."

Congress is spearheading an opposition alliance of more than two dozen parties competing jointly against Modi, including the

Kejriwal's organisation grew out of an anti-corruption movement a decade ago -- its name means Common Man's party -- and has been elected to office in the Delhi region and the state of Punjab, but has struggled to establish itself as a nationwide force.

In February, authorities froze several Congress bank accounts as part of a running dispute over income tax returns filed five years ago, a move Gandhi said had severely impacted the party's ability

to contest the election. Modi's political opponents and international rights campaigners have long sounded the alarm on India's shrinking democratic space.

### S'PORE AIRLINES 43 still in Thai hospital for turbulence injuries

Fourty-three people who were on board a Singapore Airlines flight that hit severe turbulence remain hospitalised in Bangkok four days after the emergency, a hospital in the Thai capital said yesterday.

The 43 patients are in three different hospitals in Bangkok, Samitivej Srinakarin hospital said in a statement.

On Thursday, the Samitivej Srinakarin hospital director told reporters 22 patients had spinal cord injuries and six had brain and skull injuries, but none were lifethreatening.

### Young people being ignored, neglected

### We must get off this suicidal path

Bangladesh is facing enormous economic challenges caused by both external and internal factors. But it is also in a deep moral crisis, as corruption and lawlessness have spread their tentacles in every sphere of society. Among the most-affected are young people who are supposed to be our future leaders. But how optimistic are they about their own future? Do we know how they feel or what they think? Most importantly, do our leaders even care?

These are burning questions that our policymakers and all those in positions of power must think of and try to answer. In a population of 169.8 million, almost 28 percent are between the ages of 15 and 29. Having so many young people would put any country at a natural advantage, but to reap the benefits of this demographic dividend, the right policies, opportunities, and visions need to be there. Unfortunately for Bangladesh, it is this very vital demographic that is being completely neglected.

A recent column in this paper has brought this issue to the fore, citing a survey of young people aged 16-35 that offered some damning findings: that 55.3 percent of the respondents think Bangladesh lacks peace, 71.5 percent are not comfortable about expressing their views publicly, and 68.6 percent are frustrated with the education system. An overwhelming 89 percent said corruption affected their wellbeing. They also cited unemployment, inflation, and climate change as contributing reasons. It is no wonder, then, that so many young people see no future for them in their own country; a large number are looking for opportunities to migrate to other countries.

Educationists and potential employers have been crying themselves hoarse about the lack of skills of young people applying for jobs. Only a miniscule percentage actually qualify and get employment. Those who are left behind either stay jobless or take up low-paying jobs in the informal sector. Many become involved in criminal or corrupt activities, which seem to offer the only means to survive. Crime in the name of student politics has also turned many young people away from politics. The rising number of criminals connected to power and wealth, who get away with the most heinous crimes, has created a deep mistrust in the system. The perception is that there is no justice for the ordinary person. When young people see their seniors taking the unethical route and getting away with it, they either become disillusioned and frustrated, or decide to follow suit. The number of teenage gangs committing serious crimes such as extortion and murder is on the rise.

The lack of role models, the trend of rewarding corruption and punishing honesty, the widening gap between the rich and the poor, and a huge dearth of opportunities to acquire the right education and skills for the desired employment or entrepreneurship-these are some of the overriding factors robbing our youth of their potential.

The high dropout rates in secondary schools, the prevalence of child marriage (with a staggering 41.6 percent of girls still married under 18), and 39.88 percent of the youth being involved neither in studies nor in work—these are foreboding indicators of economic and social decline, hurting the future of both our young generation and country at large. A nation that does not pay attention to the anxieties gripping most of its young people is just plain suicidal. We, for our own sake, must get off this dangerous path.

### **SUVs for bureaucrats** amid economic woes?

### Govt cannot waste public money like this

Last year, a proposal to buy 261 SUVs-worth about Tk 1.46 crore each-for deputy commissioners (DCs) and upazila nirbahi officers (UNOs) was approved. But after severe criticism against the backdrop of a struggling economy, the government decided to halt the buying process. It is, therefore, quite puzzling to see the revival of that decision, especially when the country's economic condition has worsened. Going ahead with this decision, rather than using facilities that are already available, will be nothing but a waste of public money.

On May 11, Bangladesh's foreign reserves fell below the \$19 billion-mark for the first time in 11 months; on May 21, it stood at \$18.61 billion. Despite the crisis of dollars, it is quite baffling that the government is okay with importing these vehicles which will likely further impact the reserves. As per a report by Prothom Alo, officials say foreign currency won't be used to buy the cars, but the parts will be imported and assembled to make them, which, as they admitted, will require foreign currency. It's clear that this logic does not stand. The authorities are going through with this decision after the taka further depreciated against the dollar, standing at approximately Tk 117. This means the initial total expenditure—Tk 381 crore will increase. This is nothing but an ill-considered initiative.

The rationale for buying these vehicles originally was to ensure that the national election was successfully conducted, maintaining law and order. Now, the public administration ministry has a new reason: to maintain the efficiency of public works. These changing arguments diminish the declared need to buy these SUVs. Maybe this is why the administration is pushing the move in a clandestine manner. Reportedly, the public administration and finance ministers bypassed the purchasing committee to approve the proposal, which points to ill-intent. As an expert has stated, this sets a dangerous precedent for moving other questionable proposals in this manner.

Last month, food inflation hit 10.22 percent—the first time it hit double digits in five months-while non-food inflation stood at 9.34 percent. When our people are struggling to make ends meet, how can the government be this liberal while spending their hard-earned money, that too going against its own austerity policy? We strongly urge the authorities to reconsider this initiative, and prudently evaluate all financial decisions to restore our economic health.

parliamentary democracy. parliamentary standing committees are important tools for holding the government accountable. These committees, consisting of members of both the government and opposition parties in various democratic countries, scrutinise the activities of the respective ministries of the government, review the proposed draft laws, and investigate corruption allegations.

As the absolute dominance of the ruling party has been established in the National Parliament of Bangladesh, the parliamentary committees are not seen to play any strong role in bringing the relevant ministries of the government to account. According to Article 188(2) of the Rules of Procedure of the National Parliament, "No member shall be appointed to a Committee who has a personal, pecuniary or direct interest in any matter which may be considered by that Committee." But due to the dominance of the ruling party and businessmen in parliament, these conflicts of interest have so far not been considered during the formation of parliamentary standing committees.

A study conducted by Transparency International Bangladesh (TIB) on the matter showed that, according to the information declared in their affidavits submitted to the Election Commission. the members of six committees of the 9th Parliament and five committees of the 10th Parliament had committeerelated business involvement. But according to information collected from the local level on 38 members of 11 committees included as case-studies, 19 of these members of nine different committees had business in related areas. There have been allegations of exerting influence for promoting personal or business interests during decision-making within the committees. Besides, allegations of influence-peddling in decision-making have also been reported in instances where the ministers of relevant ministries are ex-officio members and where former ministers were appointed as chairs of the concerned standing

The current 12th National Parliament is no exception in this regard. With an overwhelming majority comprising Awami League nominees and party supported "independent" candidates, 50 parliamentary committees were formed within just five working days of committees, which may starting of the Parliament, of which 39 are related to the activities of various ministries. The remaining 11 committees to a report in *The Daily Star*, many

members of 20 parliamentary standing committees own businesses in sectors they are supposed to watch over.

For example, Shamim Osman, a member of the standing committee on labour ministry, owns the garment factory "Wisdom Knitting Mills", while another member of the committee, SM Al Mamun, is involved in ship-breaking yards. Golam Kibria Tipu, a member of the parliamentary standing committee on shipping, has several launches.

Nizam Uddin Hazari, who has a manpower export business, is a member of the parliamentary committee on the Ministry of Expatriates' Welfare and


the chairman of the parliamentary standing committee on Ministry of Commerce. Former foreign minister AK Abdul Momen is the chairman of the committee on Ministry of Foreign Affairs, while former finance minister AHM Mustafa Kamal is the chairman of the parliamentary body on Ministry of Finance. The same can be said for former ministers and state ministers who are now members of standing committees on the ministries of land, planning, agriculture, fisheries, CHT affairs, expatriate's welfare, housing, and youth and sports.

In fact, it's not just the parliamentary committees. The entire Parliament is dominated by businessmen. According to a report by Prothom Alo, the number of businessmen in the 12th National Parliament is at least 199. almost two-thirds. They include several former presidents of the Federation of Bangladesh Chambers of Commerce & Industries (FBCCI), and owners of various groups of companies. At least 15 businessmen from the garment sector

benefit while preventing the drafting or formation of laws and policies against their class interests.

Because of this state-business nexus. businessmen in key sectors like banking, apparel, or power and energy are deciding what the laws, policies or incentives will be. The case of amending the Bank Companies Act in June 2023 to increase the term of directors of banks from nine years to 12 years can be discussed as an example. As reported by The Daily Star, the version of the bill that was first placed in the Parliament did not seek to amend the tenure of the bank directors. And according to Prothom Alo, the written proposal for this extension was prepared by the Bangladesh Association of Banks (BAB), an organisation of private bank entrepreneurs and directors. This proposal, with little to no edits, was eventually submitted by a member of parliament of the government party in the form of an amendment, which was passed by the Parliament without any

This has led to a dominance of businessmen in the policy-making of the state, which they are using to increase the expanse of their business and wealth. As there is no effective opposition party in the Parliament, there is no opportunity to bring these businessmen under accountability. They are making or amending laws and policies for their own

entanglement, Parliament enacted the Quick Enhancement of Electricity and Energy Supply (Special Provisions) Act 2010 with immunity provisions. Under the protection of this law, one power and energy project after another have been implemented without competitive bidding, leading the country's economy to bear the burden of excessive capacity charges and increased energy imports. For this same reason, garment industry owners get more benefits from the government than any other sector in the country, including tax exemptions, cash assistance, exemption from customs duties, low interest loans from the Export Development Fund (EDF) and import of duty-free raw materials.

### Government mishandling of personal data: Where does it end?

The news of a handful of government employees selling the personal data citizens-including National Identity (NID) card numbers and phone call details—has raised alarms in the last few days. On May 21, this newspaper reported that a few crooked government employees were stealing the sensitive personal data of citizens from the national intelligence servers and selling it in exchange for money in over 750 groups, pages, and profiles on different social media platforms.

In a world that makes sense, this news would have made a much bigger splash. Not here though. Here, we are too used to indifference. The National Telecommunication Monitoring Center (NTMC), the body that discovered the breach, did notify the Anti-Terrorism Unit (ATU), and RAB-6, the two government security units harbouring the accused officials, and the two units did assure that appropriate actions are being taken. But there's no guarantee that this will be the last of such incidents.

Indeed, the NTMC itself was accused

of mishandling our data not too long ago. In November last year, WIRED, an American magazine, published a story on the NTMC leaking sensitive, private data of the citizens. WIRED claimed that NTMC was unknowingly publishing scores of personal dataphone numbers, names, blood groups, professions, parents' names-through an unsecure database linked to its system. WIRED reported that hackers had gained access to this unsecure database and proceeded to steal and sell the data.

NTMC denied the leak to the local media later but the proof WIRED presented in its investigation was quite comprehensive. The leak was discovered and confirmed by Viktor Markopoulos, a cybersecurity researcher who was the first to identify the earlier massive data leak from the Office of the Registrar General, Birth and Death Registration where over 50 million citizens' personal data remained exposed online for anyone to grab through a simple Google search.

Incidents like these are not

uncommon in the country. With a poor record of cybersecurity, Bangladesh has been home to some truly eyebrowraising breaches in recent years. In March last year, hackers stole over 100 gigabytes worth of personal data from Biman Bangladesh, the state carrier, and demanded \$5 million in ransom.

In July, notorious hacker group ALPHV stole over 170 gigabytes of sensitive personal data—including employees' names, passport and NID information-from Bangladesh Krishi Bank's servers and demanded a large sum as ransom. In October of the same year, this newspaper reported that NID information of citizens was available for sale in a Telegram channel managed by unknown miscreants. Most notably, the entirety of the stolen funds from the 2016 Bangladesh Bank heist that made numerous international headlines, has

still not been fully recovered. Has anyone at the highest levels of the government stopped to think, for a moment, about the consequences of these massive data leaks? From identity theft to financial scam, small and large, the possibilities are dangerously endless. A Bangladeshi I know who resides in Finland only found out last week that his personal MFS account was terminated because apparently another account was opened with his same NID details the week before, and you can only have one account against each NID. The poor fellow—and his NID—never left Finland in the last two

A victim claimed that his NID was

used to create an MFS account in his name, while he never even picked up his card from his hometown. Another person I know found out last month that there was an MFS account created in his name and phone number while he has no idea who or how.

This is just the tip of the iceberg: the few cases that get disclosed, the few cases that get discussed and dissected. If one looks deeply into the issue, there's bound to be many more incidents like these. Who will take the blame for the many lapses in our cybersecurity? Why should we, tax-paying, law-abiding citizens, be okay with our data being sold off to scammers and hackers?

Is our government really that careless, or just completely incapable of even comprehending the graveness of the situation that they put us in? The government generally loves to boast about "Digital Bangladesh" and "Smart Bangladesh." Higher-ups of the government proudly boast our "robust" IT infrastructure, our data-centres, our booming freelancing economy and routinely incite tech giants to open local bases of operations. Are these incidents of data breach and data leaks not contradictory to the very image of the smart, digital, developed Bangladesh that they are desperately trying to portray or advertise? In the end, the question that really matters is, where does this mayhem stop? With a lack of accountability, disciplinary actions, and in many cases any acknowledgement at all, the answer-with complete and total despair—is seemingly never.

## We need a universal school education programme

A fifth round of primary school development programme (PEDP5) for the next five years is under consideration by the government and development partners as the PEDP4 comes to an end this year. But should we not initiate the first universal school education programme (USEP1) instead?

A roundtable was hosted on May 9 involving government officials, NGOs, parents and students by the Campaign for Popular Education (CAMPE) on the topic of educational opportunities for out-of-school children. It was reported that compared to about 18 million children enrolled at the primary school stage, at least 10 million children of 6-14 years never enrolled in a school or dropped out early without acquiring basic literacy, which severely limited their life opportunities. non-formal primary education (one-room, one-teacher community school, free of cost to parents and managed by the sponsor NGO, viz., BRAC) was introduced in the mid-1980s. Through a course of threefour years, the 8 to 14-year-old children completed the equivalent of five years of primary education and a large majority went on to secondary school. The model served the purpose of educating out-of-school children remarkably well. By the mid-1990s there were over a million students, two-thirds girls, served at any one time in over 30,000 single-room, non-formal primary schools run by BRAC and smaller NGOs. International donors, impressed by the model's success. funded it, relieving impoverished families of the cost burden.

Donor environment and the government's attitudes shifted by the end of the 1990s. A sub-sector project for primary education was launched in 1997 by the government, which was actually a combination of several separate projects, and was retrospectively called primary education development programme I. As a sequel, and designed more as a coordinated sector (actually, a sub-sector) programme for primary education, PEDPII was begun in 2004. The so-called "sector-wide approach" or SWAP became the buzzword both with donors and the government. One significant characteristic of SWAP was that all international education assistance would be directed to SWAP and controlled by the government. Thus the NFPE programme of BRAC was largely cut off from donor assistance and the successful NFPE run by NGOs languished due to lack of funding.

In the four rounds of PEDP from 1997 to 2024, some \$20 billion (roughly Tk 1,50,000 crore) have been spent. Over 80 percent has been domestic funds

remain inadequate, the outcome in learning has been disappointing. An assessment has shown that the majority of children, after five years of primary schooling, do not acquire basic literacy and numeracy at a functional level.

As part of PEDPII (2004-2011),

an NFPE-type project called Reaching Out-of-School Children (ROSC) started with a grant from the World Bank. Its management and supervision were kept in the hands of the Directorate of Primary Education, instead of engaging the successful NGOs such as BRAC and others with proven track record to manage the project. Bangladesh Institute of Development Studies (BIDS) in an evaluation in 2014 found that "the project was implemented fully in terms of numbers.... [but] schools were established without a compulsory education law was The outcome, therefore, was NGO-run NFPE.

Under PEDPIII and IV (2011-17 and 2018-24), ignoring the weaknesses As a response to this situation, and poor outcome of ROSC, a similar government-controlled approach (this time by the Bureau of Non-Formal Education, or BNFE, under the Ministry of Primary and Mass Education) was followed, although the name of the project was now changed to "the second chance" education project. The Covid pandemic led to shutting down the project in 2021. It reopened on a reduced scale in 2023. But its learning outcome and management problems make many sceptical about the project's value and its future.

The round-table organised by CAMPE was an occasion for the project's direct beneficiariesstudents, parents, teachers and BNFE staff—to make a plea for the continuation and accommodation of the second chance in the forthcoming PEDP V, the shape and size of which are to be considered now. Some have expressed their grievances about poor management, corruption, lack of transparency and accountability, and a lack of motivation and responsibility among personnel which led to disappointing results.

Some of the speakers (including myself) argued for a basic rethinking than just accommodating in PEDP V the current model of "second chance," which with its present management structure has not worked very well. The relevance and value of a fifth round of primary education development up to class V in government primary schools itself need to be rethought, some speakers pleaded.

Some basic questions arise if this line of rethinking is pursued. Is a subsector programme up to class V meaningful, when the SDG4 goal is for achieving quality, equity and inclusion (pre-primary, primary and in secondary education) for all children by 2030? Moreover, how can we reconcile the aspiration of an upper middle-income country by 2031, and a developed country from the government. But except by 2041, keeping large proportions for the expansion of enrolment of children and youth deprived of and physical facilities, which still education up to secondary level?

Where is the time-bound plan for universal secondary education in Bangladesh, consistent with the aim of Smart Bangladesh and skilled

In this context, how rational is the reported government decision to proceed with a plan for extending primary education up to class VIII by introducing classes VI-VIII in primary schools? Presumably, the Directorate of Primary Education would take control of junior secondary schools which offer lessons up to class VIII.

Two observations are pertinent here. Primary education up to class VIII as a compulsory and universal stage of education is a 50-year-old idea broached first in the 1974 Qudrat-e-Khuda Commission report and reiterated in the Education Policy 2010. But in all these years, this goal has not been implemented. This plan is now outmoded and irrelevant, when universal secondary-level school education is the worldwide norm and an imperative for Bangladesh's human development needs.

Secondly, repackaging the old plan of primary education up to class VIII is designed to fit the existing bureaucratic structure of two ministries for school education, rather than reshaping the organisational structure to meet the need of the programme. In other words, why shouldn't all school education, K-12, be brought under one ministerial jurisdiction, like everywhere else in the world? Thus, a coordinated and holistic school education development can be carried out. A turf battle between the two ministries has thwarted the implementation of universal education up to class VIII.

Coming back to the decision about extending primary level to class VIII, there are good technical reasons for not putting classes VI-VIII into primary schools. The nature of learning content and pedagogy begins to diverge from class VI onward from the primary level up to class V. At this level, the focus is on foundational skills of language and math which all primary teachers are expected to handle. From class VI onward, the learning content is divided into subjects and disciplines which require specifically trained teachers for these subjects. It will be impractical and expensive to try to provide for these additional teachers in primary schools if classes VI-VIII are inserted there. Indeed, this has been a problem in some 700 primary schools where the higher "primary" classes were introduced a few years ago. These schools are struggling to provide a credible educational experience to their students in the higher classes.

What is a pedagogically sound and logistically pragmatic way forward? First, school education should come under one ministerial jurisdiction so that a coordinated and total school development programme is undertaken. Secondly, the primary level up to class V with its distinctive features of foundational focus on literacy in the national language and the four arithmetic functions should be retained. Classes VI-XII should be regarded as the secondary stage with appropriate subject- and disciplinebased provisions for teachers and learning facilities. We need to design and implement the first Universal School Education Programme (USEP I). A step-by-step, timebound plan needs to be prepared for high-quality school education for all children in all localities of the country, so that no child is deprived of school education of acceptable

So, what are the risks that Basu, the former chief economist at the World Bank, is referring to? The growing level of income and wealth inequality is undoubtedly one of them. Inequality in Bangladesh is rising, slowly but steadily. And it poses a very severe risk to our economic development and social stability. The government and society at large have to pay attention and work on the issue on an ongoing and sustainable basis.

The data from the past Household Income and Expenditure Surveys (HIES) carried out by the Bangladesh Bureau of Statistics over the last two decades clearly indicate the trend pointing to the rising levels of income and wealth inequality. Whether we take the well-known measure, the Gini coefficient, or an alternative measure, such as the Palma ratio, and compare the income share of the top 10 percent with the income share of the bottom 40 percent, the signs are clear. We are heading towards a very unequal society.

The final report of HIES 2022 released by BBS last December showed that the top 10 percent of households increased their share of wealth to 40.91 percent, around 2.83 percentage points rise in the past six years. In 2016, their share of wealth was 38.09 percent and 35.84 percent in 2010.

One of UN's Sustainable Development Goals, SDG 10, is unequivocal about the deleterious effects of an increasingly unequal society. First, it can weaken trust in public institutions and undermine democratic governance. Secondly, inequality threatens long-term social and economic development, harms poverty reduction, and destroys people's sense of fulfilment and selfworth. Finally, this, in turn, can breed crime, disease and environmental degradation. Obviously, all this also may also result in political unrest and stunted progression in other

The Princeton economic historian Walter Scheidel paints a more ominous scenario. In his book "The Great Leveler: Violence and the History of Inequality", he offers a panoramic view from the Stone Age

answer in unambiguous terms. "Are mass violence and catastrophes the only forces that can seriously decrease economic inequality? To judge by thousands of years of history, the answer is yes!"



### **Urgent global action** is needed to combat antimicrobial resistance

A new Lancet Series calls for urgent global action on antimicrobial resistance (AMR) to prevent 750,000 deaths annually through available vaccines, water and sanitation, and infection control methods. Authors stressed the need for intensified efforts in promoting vaccination, ensuring access to safe water and sanitation, and implementing hospital infection control to reduce infections and antibiotic use.

The series highlights that nearly 5 million of the 7.7 million global deaths from bacterial infections annually are associated with antibiotic-resistant bacteria. To address this, expanding access to both existing and new antibiotics is crucial. Increased investment in affordable and accessible antibiotics, vaccines, and diagnostics is also essential.



recommendations improving infection prevention methods, such as hand hygiene and equipment sterilisation, which could save up to 337,000 lives a year. Universal access to safe drinking water and effective sanitation could prevent around 247,800 deaths, while expanding pediatric vaccination programs could save 181,500 lives.

AMR disproportionately vulnerable groups, including infants, the elderly, and chronically ill patients. Without prioritising AMR now, the global death toll from resistant infections will continue to rise, threatening progress on sustainable development goals.

The series calls for ambitious global  $targets for 2030, including a 10\% \, reduction$ in AMR-related mortality and reductions in inappropriate antibiotic use in humans and animals. An independent scientific body is also proposed to guide policy implementation and inform new targets. Immediate global action is essential to preserve the effectiveness of antibiotics and safeguard public health.

### Protecting youth from tobacco and nicotine industry

The World Health Organisation (WHO) and Stopping Tobacco Organisations and Products (STOP), a global tobacco industry watchdog, have launched "Hooking the next generation," a report highlighting how the tobacco and nicotine industry targets youth through product design, marketing campaigns, and policy manipulation.

Ahead of World No Tobacco Day on May 31, the report reveals that 37 million children aged 13-15 years globally use tobacco, with adolescent e-cigarette use often exceeding adult rates. In the WHO European Region, 20% of 15-year-olds reported using e-cigarettes in the past

Despite progress in reducing tobacco use, e-cigarettes and new nicotine products pose a grave threat to youth. Studies show e-cigarette use increases the likelihood of conventional cigarette use among non-smoking youth by nearly three times. The industry markets products with candy-like flavors to attract children, contributing to nicotine addiction.

WHO calls for strong regulations to protect youth, including smokefree public places, bans on flavored e-cigarettes, higher taxes, and increased public awareness. Youth advocates globally are exposing these deceptive practices and advocating for a tobaccofree future.

### Managing ovarian cancer in young women

STAR HEALTH DESK

Women aged 55 to 63 are most likely to get ovarian cancer, but it can also occurs in younger women. About one-third of cases are in women under 55, and 1 in 10 are under 45. Younger women face unique challenges, such as impacts on careers, children, and future family planning. Fortunately, they often have better long-term outcomes with the most common type of ovarian cancer compared to older women.

Why ovarian cancer happens: Ovarian cancer is more common after menopause. The exact cause is often unknown, but risk factors include:

- Being overweight or obese
- Smoking
- Having children later, or not having children • Previous breast cancer
- A family history of ovarian, breast, or colorectal cancer

• Inherited cancer syndromes About 25% of ovarian cancers are linked to inherited gene variants. These genes can increase cancer risk and are inherited from parents. Talk to your doctor if you have a family history or genetic concerns.

and diagnosis: Symptoms Symptoms of ovarian cancer can include unusual vaginal discharge, bloating, loss of appetite, feeling full quickly, abdominal or back pain, frequent or urgent urination, and constipation. Persistent symptoms for more than two weeks should be discussed with a doctor.

Diagnosis involves reviewing medical history, performing a pelvic exam, and conducting tests like ultrasounds, CT scans, MRIs, laparoscopy, biopsies, and blood tests.

Types and stages of ovarian cancer: Most ovarian cancers (epithelial cancers) start on the ovary's surface and are less common in younger women. Other types affecting younger women include:

- *Borderline tumours:* slow-growing, treated with surgery only. • Germ cell tumours: start in egg cells, often treated with surgery and
- chemotherapy.
- Granulosa and Sertoli-Leydig cell tumours: rare, develop in supportive ovarian tissue, usually treated with surgery and sometimes chemotherapy.

Treatment for younger women: Treatment typically involves surgery, possibly including a hysterectomy (removal of the uterus, ovaries, and fallopian tubes) and chemotherapy. For less advanced cancers, fertilitysparing surgery may be possible. This involves removing only one ovary and fallopian tube, allowing for future pregnancies. If fertility-sparing surgery is not an option, freezing eggs or embryos before treatment can

Some chemotherapy can induce early menopause, so discussing fertility preservation options with specialists is crucial.

Other considerations for younger women: Younger women with ovarian cancer may face financial, career, and family concerns. Social workers can provide financial assistance and work-related support. Communicating simply and honestly with children about the diagnosis helps them cope. Counselling for the patient and family can be beneficial.

Keeping open lines of communication with loved ones and seeking support from those in similar situations can ease the emotional burden. Remember, everyone's coping mechanisms are different, so be patient and seek help when needed.

### bans in hockey Abahani, Mariners named joint champions

In an unprecedented decision, Federation Bangladesh Hockey (BHF) yesterday slapped suspensions of various tenures on 14 players and 10 officials, including veteran Mohammedan player Rasel Mahmud Jimmy and Mohammedan manager Ariful Haque Prince, following a meeting of the governing body vesterday

The BHF also slapped monetary fines on a number of clubs after disciplinary committee's decisions on the recently-concluded Dhaka Premier Division League were forwarded to the governing body by the league committee.

The suspensions on players ranged from two matches to 12 matches while the suspensions on officials ranged from a couple of matches to lifetime bans. Some of the suspended players and officials were also foreigners who came here to play or coach the sides in the 11-team league.

Meanwhile, Abahani and Mariner Youngs Club were declared joint champions of the league, which saw chaos on April 19 after Mohammedan had refused to complete the last match against Abahani following brawl between the two teams over a decision by a foreign referee.

Both Abahani and Mariners had ended on top with 37 points each, and even though the federation had repeatedly asked the clubs to engage in a playoff, neither were willing, citing shortage of time.

BHF's general secretary Mominul Haque and vice-president Abdur Rashid Shikdar read out the decisions to reporters following the meeting, which was attended by 27 out of 29

"Both clubs had asked for two months' time because they had visa/ NOC issues to sort out for foreign players," Sayeed told reporters. "However, we couldn't allow that much time since we had to start the first division and the second division leagues.'

The suspensions on players and officials, meanwhile, were based mostly on referees' match reports of disciplinary issues on individual matches of the league, with Mohammedan's Jimmy receiving the toughest suspension of 12 matches.

"Jimmy had stopped play 173 times for a duration of 216 minutes in 14 matches, which does not bode well for a player of 19-year-international career," Mominul said.

Among the officials, Mohammedan manager Ariful Haque Prince was suspended from club activities for four vears while Mohammedan's adviser coach Gobinathan Krishnamurthy

– a former coach of the Bangladesh national team -- was handed a lifetime ban from Bangladesh hockey.

"We win as a team, we lose as a team," is a cliche that members of the Bangladesh team often resort to while reading out from their age-old scripts, explaining disappointing losses.

If that is indeed the case then the team management spearheaded by head coach Chandika Hathurusingha should be taking a share of the blame for Bangladesh's plight. The Tigers hit a new low when they lost a T20 World Cup buildup series against the USA -- an associate nation ranked 10 places below the Tigers.

While the fact remains that the kind of cricket the current Bangladesh side has been playing in the lead-up to the T20 World Cup can be deemed abhorrent and at times inexplicable, Hathurusingha's role in the mess could also be brought into

When so much credit is given to the coaches when the Tigers are on a good run, why should they evade criticism when the same side fails to show signs of life?

Renowned coach Salahuddin, in an interview with The Daily Star, pointed out that the coach has little to do when the team does well but when things go south, the coach has to take responsibility and work his expertise to nurture the players, solve the puzzle to pull them out of a slump.

More than a year into his contract, Hathurusingha got to see both sides of the coin. ### Workover makes gas worth Tk 2,590cr usable

Following successful workover procedures, a well at the Titas Gas Field resumed production yesterday, generating around 12 mmcfd (million cubic feet per day).

A workover project for the existing Titas-14 well began on March 19. Authorities completed the procedures on May 21 with the local rig Bijoy-11. The well has an estimated reserve of around

The well has an estimated reserve of around 40 billion cubic feet (BCF) and it can continue to produce gas for the next 10 years, according to a press release from the Ministry of Power, Energy and Mineral Resources.

The estimated price of the gas reserve is Tk 2,590 crore and around Tk 75 crore has been spent to conduct the workover, the press release said.

The Titas Gas Field operates under Bangladesh Gas Field Company Limited, which has five other such fields, namely, Habiganj, Bakhrabad, Narshingdi, Meghna and Kamta.

There are 39 gas wells under these six fields that produce around 560 million cubic feet of gas per day (mmcfd).
