Remal makes landfall near Khepupara

Cyclone Remal battered the coastal region at wind speeds that might have reached 130kmph, and lost much of its strength while sweeping over the Sundarbans, Met officials said.

"As predicted, the centre of the severe cyclone fell between Khepupara in Patuakhali and Sagar Island in West Bengal," said Abul Kalam Mallik, a meteorologist at Bangladesh Meteorological Department.

He said Bangladesh was on the east of the cyclone's eye which means Bangladesh took the main blow because the east side of a cyclone always causes more damage than the west side in the sub continent.

The Sundarbans always acts as a natural shield," he added More than eight lakh people were evacuated to safer areas in 16 coastal districts ahead of the year's first cyclone.

It brought heavy rains and tidal surges as high as 12 feet yesterday evening.

According to officials, by midnight, wind speed at the coast may have reached 130kmph.

The authorities were yet to assess the extent of damage caused by the cyclone.

A 24-year-old man drowned after he was swept away by the strong current in his flooded village in Kalapara, Patuakhali, while a 65-year old died after falling from a bicycle while going to a shelter amid strong winds in Satkhira.

People living in some affected areas were left without electricity since Saturday night. Mohibur Rahman. state minister for disaster last night management. said eight lakh people were evacuated to 9,000 shelters. "There is adequate dry food,

biscuits, safe water and medical supplies there," he said. The met office issued the "great danger signal no-10" for

Barishal region and its shoals, "great danger signal no-9" for the southeastern coastlines.

The Met department said Remal made landfall between 6:00pm and midnight.

According to the Indian Met office, wind speeds may reach up to 120kmph, with gusts up to 135 kmph while the storm hits West Bengal's Sagar Island and Bangladesh's Khepupara area.

Meteorologists warned that the storm could uproot trees and cause major damage to thatched houses and disrupt power and communication systems.

Authorities closed Bangladesh's three seaports and airports in coastal districts.



Stocks shed 1,000 points in 3 months

Investors shun the market as economic outlook darkens

The key index of the Dhaka Stock Exchange plunged by 1,000 points in a span of three months as investors keep selling their holdings, fearing further deterioration of economic indicators.

The DSEX, the benchmark index of the DSE, has fallen by 1,022 points, or 16

percent, to 5,250 since February 27. During the period, market capitalisation or share value of the listed companies dropped by Tk 114,845 crore or 15 percent.



The index has been falling sharply since February when Bangladesh Securities and Exchange Commission (BSEC) withdrew the floor price that was launched in mid-2022.

NBR may miss tax collection target again

The National Board of Revenue (NBR) posted about 16 percent year-on-year growth in tax collections in the first 10 months of the current fiscal year. Still, it might be tougher for it to attain the government's goal of raising Tk 410,000 crore by the end of the year.

Two research agencies also said the target, which many have described as ambitious at the beginning of the year, would once again remain unachieved. The revenue administration raised Tk 289,376 crore in July-April of FY2023-24, which represented 70 percent of the revised target for the year, shows provisional data of the NBR.

BUDGET FOR FY25 Scope likely for legalising black money

Govt also mulling ways to bring laundered money home

The government is thinking about allowing again undisclosed money to be legalised and laundered money to be brought back home through formal channels in the next budget.

A finance ministry official said the National Board of Revenue and Bangladesh Bank are trying to find out ways this could be done.

The official said they were considering to impose a 15 percent tax on legalising black money.

Similar steps had been taken in the past, but the result was not as expected, the official added.

Economists and government officials suspect that a huge amount of money was laundered abroad before the January 7 parliamentary polls.

Besides, a significant amount of foreign currency was also sent abroad in the name of export-import, which is reflected in more than \$10 billion deficit in the financial account of balance of payment.

The official said the government was weighing options so that the money could be brought back home for boosting the foreign currency reserves.

The judge had previously issued an arrest warrant against Jasim on April 30, sentencing him to five months of prison.

He directed that a copy of the order be sent to the Chattogram superintendent of police and deputy inspector general.

Earlier, Padma Bank, to which Jasim owes Tk 89 crore, submitted a joint application on behalf of him to the court, requesting that the warrant issued against him be recalled.

The highest Tk 20,600 crore was legalised during the pandemic in fiscal year 2020-2021, when 11,859 people availed the opportunity.

Currently, the tax authority does not raise questions about the source of investment if any person invests undisclosed wealth in the construction of factories inside economic zones and high-tech parks and pays a 10 percent tax on the invested amount.

The amnesty was available since the first day of July 2019 and is to last till June 30, 2024, said the NBR in an income tax law of 2023.

Dhaka passed the order after Anti-Corruption Commission Deputy Director Md Hafizul Islam, also the enquiry officer, applied to the court, ACC Public Prosecutor Mahmud Hossain Jahangir told The Daily Star vesterday.

On May 23, the same court ordered the authorities concerned to confiscate properties under 83 deeds, which state 114 acres of land, and freeze 33 bank accounts under the name of Benazir and his family members.

In yesterday's application, the ACC said Benazir stands accused of amassing illegal wealth worth hundreds of crores of taka at home and abroad by resorting to abuse of power, irregularities, and corruption. The properties were registered in the names

of Benazir, his wife, and three children. The former IGP and his family members are trying to hand over the assets. If they can do it, the investigation will be hampered, read the application.

For a fair enquiry and establishing justice, the properties should be confiscated, it added.

On April 18, the graft watchdog decided to launch an enquiry into the allegations of amassing illegal wealth by the former inspector general of police.

It also formed a three-member committee to investigate the allegations, ACC Secretary Khorsheda Yasmin told reporters at a press briefing at its headquarters on April 22.

"A national daily ran a report on March 31 on Benazir Ahmed's illegal wealth. Later, reports on similar allegations were published by some other media outlets," said Khorsheda. Bangla daily Kaler Kantho recently published a two-part investigative report on the acquisition of substantial property by Benazir and his family.

The first report was published on March 31 under the headline "Aladdin's Lamp in Benazir's House.

According to the report, the former police chief's family owns an eco-resort on around 1,400 bighas and has bought another 800 bighas of land next to that resort. They also own 2,00,000 shares in five-star hotels.

Additionally, his family owns 3,500sqft flat in the capital's Bashundhara residential area, and all these properties were purchased with illegal money, the report said.

Bangladesh law enforcement agency said.

Aktaruzzaman's friend Celesty Rahman, now on an eight-day remand, came back from Kolkata on May 15 and went directly to the Gulshan flat.

Aktaruzzaman also had another flat in Baridhara. Law enforcers sealed off one of his flats, and a search would be conducted there soon, said investigators

Investigators said Celesty was not present at the Kolkata flat when the lawmaker was killed on Mav 13.

In January, the assailants planned to abduct the lawmaker using chloroform.

But the plan was foiled when Azim came to meet Aktaruzzaman with some companions, said an officer involved with the investigation.

They also planned to shoot him dead in Jhenaidah before the January 7 election, but that plan also didn't work due to the presence of security personnel.

JS TO WAIT

Parliament will wait a little more before declaring slain lawmaker Anwarul Azim Anar's Jhenaidah-4 seat as vacant.

'The incident is exceptional. Nothing like this happened in the past. That's why we want to wait," Speaker Shirin Sharmin Chaudhury told reporters yesterday.

After a lawmaker dies or resigns, the parliament secretariat issues a gazette notification stating that a seat has fallen vacant.

The Election Commission then holds a by-election within 90 days. If Azim's death is officially confirmed, the seat will be declared vacant.

Law enforcers in India and Bangladesh believe that Azim was killed in Kolkata on May 13, but they have not made a formal announcement of his death because his remains have not been found yet. On May 22, Prime Minister Sheikh Hasina and the Speaker sent condolence messages for Azim's

demise. Meanwhile, a three-member Dhaka Metropolitan Police team, headed by Additional Commissioner (DB) Harun Or Rashid, reached Kolkata yesterday. We have spoken to our higher authorities in the government and discussed how we can seek Interpol's assistance to get hold of

A prosecutor told a court that Jihad, who worked at a meat shop in Mumbai, reached Kolkata in March with the suspected intent to commit the murder. He allegedly scouted the location and planned the execution meticulously.

Meanwhile, West Bengal CID continued its efforts to find Azim's remains. It earlier deployed divers and fishermen in the Bagjola canal in Bhangar and ponds in the area.

Azim went to Kolkata on May 12 and stayed the night at his friend Gopal Biswas's house. He left the next day, saying he had a doctor's appointment. Gopal later received a couple of texts from Azim's mobile phone that said there was no need to call him. On May 22, India and Bangladesh police said the MP was murdered at a flat in New Town, Kolkata.

Three dead in Israeli strikes on south Lebanon

Two Israeli raids yesterday killed three people in south Lebanon, official media and a source close to Hezbollah said, as Israel's military claimed attacks targeting the Iran backed militant group.

Lebanon's Hezbollah, a Hamas ally, has traded regular cross-border fire with Israel since the Palestinian militant group's October 7 attack on southern Israel which triggered war in the Gaza Strip.

Lebanon's official National News Agency (NNA) reported "two martyrs and wounded civilians in the raid that targeted a motorcycle in Aita al Shaab", a border village.

It said the strike was carried out by an "Israeli" drone.

The NNA had earlier said a separate strike by "enemy aircraft" on the border town of Naqura "targeted a motorbike", reporting unspecified casualties.

The Israeli army later said in a statement that "a Hezbollah terrorist was identified exiting a military structure" in the Naqura area, adding that "an aircraft struck and eliminated" the operative.

Unseen and unrecognised

Speakers stress recognising women's unpaid care work

Contribution of female unpaid care work, in GDP equivalent terms, is five times higher than similar contribution by their male counterparts, said speakers at a seminar yesterday.

They also noted that if a woman could work one hour less on unpaid care and domestic work, her probability of participating in the labour market would increase by 2 percent.

Additionally, having an underfive child in the family reduces a woman's probability of joining the labour market by 2.5 percent, they added

These data were presented at a seminar, titled "Recognition of Unpaid Care Work: A Step Towards Financial and Social Empowerment of Women," organised by Manusher Jonno Foundation (MJF) at a city hotel.

Tk 5,307 billion, equivalent to 14.8 percent of GDP that year. Men's contribution to GDP that year was only 2.8 percent."

According to the study, women spend an average of 4.6 hours on unpaid household services for household members, such as cooking and cleaning, and 1.2 hours on unpaid caregiving services such as childcare and adult care, while men spend 0.6 hours and 0.2 hours on domestic and care work, respectively, he also said.

"On the other hand, women get only 1.2 hours for paid and selfemployed work, while men get 6.1 hours for such tasks," he said.

Dr Sayema Haque Bidisha, professor of Economics department at Dhaka University, stressed the importance of recognising unpaid care work as the initial step.

'River grabbers are criminals' State minster for shipping tells conference

The government sees river grabbers as criminals, said State Minister for Shipping Khalid Mahmud Chowdhury yesterday.

He said the political identity of encroachers, be it Awami League, BNP or Jatiyo Party, bears no significance to the government. The current establishment has a zero tolerance stance against all river grabbers, he added.

Khalid made these remarks at a conference at the Krishibid Institution Bangladesh at Khamarbari in Dhaka.

The two-day National River Conference 2024 was organised by the Association for Land and Development, Bangladesh Environmental Lawyers Association, Water Rights Forum, Riverine People and Bangladesh River Travelers Network.

Speaking as chief guest, Khalid said, "We face many problems while

freeing the river from grabbers. We with this year's event starting on can't handle the greed of sand... June 4, he added. Who do I blame for this?"

Speakers tell book launch

As great power competition intensifies in the Indian Ocean region, it is high time that Bangladesh prepares better and plays its balancing act effectively to ensure its national interest, said international relations analysts at a book launch yesterday.

German think tank Friedrich Ebert Stiftung (FES) published the book "The Changing Nature of Geopolitics and the Futures of Bangladesh" edited by Prof Imtiaz Ahmed, executive director of Centre for Alternatives. The book is written by 11 writers on various aspects of current geopolitical scenarios and the position of Bangladesh.

Addressing the event at Foreign Service Academy, Prof Imtiaz said the Indian sub-continent was once the second richest region after China, and that drew the British and other European countries to this region, particularly the Bengal.

He said after the fall of the colonies and the two world wars, two powers -- the US and the Soviet Union -- emerged. Now, with the rise of China and



other powers, the world is bracing multipolarity And, the Indian Ocean has become the focus of the global and regional powers.

Bangladesh, which is located at the centre of the Indian Ocean and a rapidly growing economy with no enemy, has also become very significant.

"Against this backdrop, our engagement with the outside world also should be multiverse, multi-focused and multilayered," Prof Imtiaz said.

"Are we ready to pursue effectively this policy? Is our education system ready? No," he said, suggesting that the technology, however, has created opportunity for the policymakers, diplomats and leaders to equip with the knowledge.

Mahfuzur Rhaman, former principal staff officer at Armed Forces Division, former state minister for foreign affairs Abul Hasan Chowdhury, AK Abdul Momen, chair of Parliamentary Standing Committee on foreign ministry, FES programme advisor Shadhan Kumar Das and Diplomats World Advisor Dr Mohammed Faruque also spoke.

The 50-metre bridge over the Ratnai River between Marichbari and Kalirhat on the Bhelabari-Durgapur road in Aditmari upazila, Lalmonirhat, has been in a dilapidated state for four years.

The railings of the bridge are damaged and the pillars cracked. As there is no alternative road, locals are constantly crossing this bridge risking their lives.

No heavy vehicles can cross this bridge, which has left local traders facing a challenge when transporting their goods.



During his stays in jails at different times, Rizvi said he found some students, journalists, and youth languishing in prisons for a long time in cases filed under the DSA.

No rice imported in FY 2023-24

Directorate General of Food tells JS body

The Directorate General of Food yesterday informed that no rice was imported in the 2023 2024 fiscal year, which happened for the first time in many years.

It disclosed the information at a meeting of the parliamentary standing committee on food ministry, held at Jatiya Sangsad Bhaban.

Directorate General of Food imports rice and wheat through international tenders or G2G basis, and in the fiscal year, no rice has been imported at the government or private level, it said.

The country's rice production has met the demand for rice in the local market. However, wheat was imported following due process, it also informed. Mentionable, around 10 lakh tonnes of rice was imported in the 2022-23 fiscal year.

The meeting was also told that plans have been adopted to discourage food waste through the Bangladesh Food Safety Authority. It was also recommended in the meeting to conduct public awareness activities for preventing food wastage.



Additional police have been deployed to avert further trouble. The brick kiln authorities have been asked to relocate the soil soon.

embarrassment, it will not only be unacceptable to the people but also be suicidal for the government."

"People are already valid realising that highly the three publicised incidents are not isolated; they are symptomatic of deepseated institutionalised corruption and represent just a tip of the iceberg."

He said it's also clear that the responsibility for these crimes extend beyond those directly involved. Therefore, unless the direct perpetrators along with those who aid, abet, benefit from, and protect

them are held accountable, the government's election promises will be deemed rhetoric, empty as corruption and and wrongdoing will continue to proliferate further.

TIB urged the government to hold the high-level power abuse accountable by following due process and to release a whitepaper on corruption.

Additionally, consistent with the ruling party's election manifesto, TIB calls for the establishment of short-, medium-, and long-term strategies and road-map to ensure good governance and prevent corruption.

Wheat production as well as its cultivation area in five northern districts of Rangpur region is seeing a significant of land was brought under wheat decline over the past few years as farmers shifting to other crops for higher profits.

The country now requires about 85 lakh tonnes of wheat annually, but the production is only about 11 lakh tonnes in recent years, which is far below than the required quantity, agronomists said.

As a result, the country has to depend on wheat imported from other countries to meet the local demand.

Higher cost of cultivation against poor yield is one of the main reasons behind the dwindling popularity of wheat among farmers in the region comprised of five districts -- Rangpur, Nilphamari, Gaibandha, Kurigram and Lalmonirhat.

Farmers said they are shifting to other crops as they were not getting expected profit from wheat cultivation. So instead of wheat cultivation they are cultivating other crops including maize.

Most of the farmers across the country used to grow wheat only a few years back. But nowadays, the number of growers has decreased significantly due to its higher production cost and less profit.

At present, it costs a farmer Tk 7,000 to Tk 8,000 to cultivate one bigha of land and get a yield of eight to ten maunds of wheat, while each maund of wheat is being sold for Tk 1,300 to Tk 1,350 in local market.

According to Rangpur Department of Agriculture Extension (DAE), this year wheat has been cultivated on a total of

17,167 hectares of land in five districts of Rangpur region, compared to 18,210 hectares last year.

Mentionable, about 25,650 hectares cultivation in 2020, which was nearly 67,500 hectares only about a decade ago.

This year, wheat has been cultivated on about 3.2 lakh hectares of land across the country, while the production target has been set at about 11 lakh tonnes, DAE sources said.

Farmer Sahir Ali of Char Gokunda village in Lalmonirhat Sadar upazila said as farmers in the northern districts have been struggling to turn a profit from wheat farming in the past few years, about 95 percent farmers of the village have given up wheat cultivation in recent years.

Mansur Ali, a farmer from Rayanj village in Kurigram's Nageshwari upazila, said even 10 years ago he used to cultivate wheat on eight to ten bighas of land.

But for the last four years, he has been cultivating maize instead of wheat for a better profit.

Like him, many other farmers of his locality have given up wheat farming and opting for other crops.

Farmer Suresh Chandra of Madhupur village in Rangpur's Kaunia upazila said wheat farming gradually losing its popularity as other crops now ensure higher profits for farmers. Rangpur DAE Additional Director Obaidur Rahman Mandal said they are encouraging farmers to grow wheat as they can get up to 12 to 14 maunds of wheat by cultivating the improved variety on each bigha land.



Israel not 'akin' to Hamas

Says ICC prosecutor

International Criminal Court (ICC) prosecutor Karim Khan justified his decision to request arrest warrants for Israel's prime minister and defence minister in an interview with a British newspaper published yesterday.

Khan said on Monday that he was seeking warrants for Benjamin Netanyahu and Yoav Gallant, as well as top leaders Yahva Hamas Sinwar, Ismail Haniyeh and Mohamed Deif, on suspicions of war crimes and crimes against humanity.

"I am not saying that Israel with its democracy and its supreme court is akin to Hamas, of course not," Khan said in his interview

"I couldn't be clearer, Israel has every right to protect its population and to get the hostages back. But nobody has a licence to commit war crimes or crimes against humanity. The means define us,' Khan added

Famine should be declared in Gaza Strip

Say rights organisations as Israel using starvation as a 'weapon of war' against Palestinian people

At least 70 organisations are calling on relevant authorities and international institutions to officially declare a famine in the Gaza Strip, where there is a rapid spread of famine, according to the Geneva-based Euro-Med Human Rights Monitor yesterday.

It said that food insecurity is increasing across the enclave because of Israel's use of starvation as a "weapon of war" against the Palestinian people – something the organisations say is part of a genocide, a charge Israel has denied.

"The organisations stated that food security levels have significantly declined as a result of **Health authorities** officially recorded 30 deaths due to famine: Euro-Med

the Israeli army's ground operation in Rafah City, south of the Gaza Strip, which began on May 7 and was preceded the day before by blocking the entry of humanitarian aid trucks through the Rafah crossing" the statement read. "Thousands of trucks on the

other side of the Rafah crossing have been at a standstill for weeks and are inaccessible to the residents whose lives depend on them due to Israel's decision to starve the people of the Gaza Strip, close the crossings and prevent the entry of aid."

Euro-Med said health authorities have officially recorded 30 deaths due to famine, and that faminerelated deaths occur nearly daily, compounded by Israeli bombings and inadequate medical treatment, reports The Guardian.

About 200 aid trucks were expected to enter Gaza yesterday through the Kerem Shalom border crossing, Khaled Zayed, the head of the Egyptian Red Crescent Society in North Sinai, told Reuters earlier.

The Rafah border crossing has been shut for almost three weeks, since Israel took control of the Palestinian side of the crossing.

Death toll rises to 33 in India game zone fire THE HINDU ONLINE

The death toll from a game zone fire in India's Rajkot rose to 33, a top local official said yesterday, as rescuers scoured the site the morning after the blaze.

The fire was reportedly caused when some welding work was being carried out. The four-year-old sprawling amusement park was built in temporary structures that had tin roofs and two floors.

Members of the Special Investigation Team held a meeting with local administration in Gujarat's Rajkot city. The bodies were charred beyond recognition. The DNA samples of bodies have been collected for identification of the deceased, they said.

JULY 4 ELECTION UK Tories pitch national service for 18-year-olds

Britain's Conservative Party will introduce mandatory national service for 18-year-olds if it wins the national election on July 4, comprising military or community participation, Prime Minister Rishi Sunak said yesterday.

Young adults will be able to choose between spending one weekend a month volunteering over the course of a year, or take up one of 30,000 spaces to spend a year in the armed forces, Sunak said. The announcement followed Labour Party leader Keir Starmer's comments on Saturday that he was in favour of allowing 16 and 17-year-olds to vote.

Sunak's Conservatives lag Labour by a wide margin in opinion polls, which have shown little change in fortunes for the prime minister since his surprise election call last Wednesday.

"Britain today faces a future that is more dangerous and more divided. There's no doubt that our democratic values are under threat. That is why we will introduce a bold new model of national service for 18-year-olds," Sunak said in a statement. The Conservative Party said the proposal would be funded by cracking down on tax avoidance and evasion.

Debt servicing becoming costlier

Be careful with future external borrowing

The government needs to pay closer attention to the management of external sovereign debt, as in the upcoming budget, allocation to repay foreign debts may reach Tk 57,000 crore, a 53 percent rise from the current year. This will put further pressure on our dwindling foreign currency reserves, which also needs to be monitored closely. According to the finance ministry, allocation for foreign debt repayment has been Tk 37,076 crore in the current fiscal year. However, interest payments for increasing levels of foreign loans in recent years and the rapid devaluation of the taka against the US dollar have forced the government to set aside a greater amount for debt servicing.

Bangladesh's foreign debt service requirement has increased over the years, with the amount crossing the \$1 billion-mark for the first time in 2012-13. In 2021-22, the amount went past \$2 billion, and in the year after that, Bangladesh paid \$2.67 billion in debt servicing. In the current fiscal year, it is going to cross the \$3 billion-mark. Interest payments alone reached \$1.05 billion in the first nine months of the fiscal year-crossing the \$1 billion-mark for the first time. Given that Bangladesh's access to cheap loans is decreasing and foreign borrowing is also becoming costlier with its rising per capita income, debt servicing could become an issue in the coming years, unless the government takes a cautious approach.

According to the Economic Relations Division (ERD), Bangladesh is now having to borrow at the costlier market based rates to cover its development spending. As the debt portfolio becomes increasingly dominated by marketbased rates—and the volume of the payment becomes more dependent on the unpredictability of the global economy-the interest rate risk goes up. We have seen that happen recently, with the cost of foreign loans going up as interest rates shot up globally. With Bangladesh set to graduate from the group of least-developed countries, its share of concessional loans has drastically fallen. Alongside this, the grace period-when a borrower pays only the interest, rather than both interest and principal amounts-of some of its major loans will come to an end over the next few years. Therefore, the government needs to do some careful analysis of what the debt repayment situation will be in the near future.

The government will be well advised to accept any further loans based on careful calculations, as well as ensure the development projects it undertakes using foreign loans are truly beneficial. In that regard, the government has to do better in ensuring timely completion of development projects, as time extensions often lead to massive cost overruns. Additionally, it needs to ramp up its negotiation capacity and try to opt for more concessional loans over costlier options. And finally, it has to devise effective strategies to boost its foreign currency reserves via increased exports and remittance inflow.

Have we forgotten about our polythene ban?

Authorities must not turn a blind eve to its rampant use

Bangladesh may have been the first country in the world to ban the production, marketing, and use of polythene on March 1, 2002, but frustratingly, its pioneering attempts to curb polythene use seem to have fallen by the wayside over the past two decades. Polythene use is back with a vengeance in shops and markets around the country, making us wonder: why has the government completely given up on implementing the ban, when it has taken multiple laudable initiatives over the years to curb polythene usage and promote eco-friendly alternatives? For instance, the government enacted the Jute Packaging Mandatory Use Act in 2010, which prohibits the use of plastic or polythene packaging for 11 specific products and outlines severe penalties for individuals who violate the polythene ban. Offenders face up to 10 years in prison, a fine of Tk 10 lakh or both. In addition to legal measures, the government has also taken various steps to promote the use of jute as a sustainable alternative to polythene. Yet, all the laws, initiatives, directives and High Court orders over the decades seem to have had no impact on reducing the rampant use of polythene and plastic in the country. A recent study conducted by Environment and Social Development Organisation (Esdo) found that more than 2.5 crore polythene bags are thrown away after being used only once in Dhaka city every day. This deluge of plastic waste clogs drains, canals, ponds, and other waterways, obstructing water flow and leading to frequent flooding even during light rainfall, to say nothing of the irreparable damage to the environment. We urge the Ministry of Environment to take urgent steps to reverse the disturbing trend. What's the point of having so many progressive laws, policies and directives if no one is bothered about implementing them? It is imperative that the government accepts responsibility for its failure to follow through on its commendable initiatives. The persistent use of polythene highlights the need for stricter enforcement of existing laws, comprehensive public awareness campaigns, and the development of sustainable and affordable alternatives to polythene and plastic packaging.

Children must be protected from abuse and torture

A 15-year-old worker at a local shop in Feni was returning to work after saying Zuhr prayers, when a man sought his help to lift up a bag. Unsuspecting, the boy followed him to a nearby shopping centre, where the stranger and another man subjected him to unspeakable, bestial acts of sexual abuse and torture. Injured and bleeding, the boy was rescued by his employer some two hours later and taken to the hospital where a surgery was required to remove the bathroom cleaning brush handle that the criminals had shoved up his back.

This reminds one of the 12-year-old mill worker in Bogura, who was killed by his co-worker in 2019 by pumping air into his body. Similar incidents of physical torture and sexual abuse of children have taken place before, with many of the victims succumbing to the injuries. Child abuse reports have become a regular feature in our newspapers and newsfeeds, portraying the picture of a society with a festering rot at its core. Unfortunately, we are doing little to remove the rot.

According to a recent Prothom Alo report in 2023 the Child Helpline 1098-operated by the Department of Social Services under the Child Sensitive Social Protection in Bangladesh (CSPB) project-received 15,785 calls, which is almost double of the 8.021 calls received in 2022. While the increasing number of calls mean that more people are now aware of this helpline and are overcoming their fears of stigma and uncertainty to seek help when required, the staggering number of such reported incidents reveal a grim picture of its widespread prevalence. We do not have enough research to understand the actual scope and scale of this social malady.

Between January and April 2024, according to Ain O Salish Kendra (ASK), 226 children have been subjected to violence and abuse in the country, 176 children have been killed. Of them 37 were below the age of six. From being tortured at domestic sphere and outside, to abduction and rape, children-innocent, helpless, unsuspecting—are highly vulnerable to multiple forms of abuse. The home environment completely eliminated from the society 1,013 children were subjected to presenting the case in the court, every should make children feel safe and to ensure a safe and comfortable space violence, 485 had been killed, of whom 116 were below the age of six.

As per the ASK data, cases were filed in about 60 percent of these incidents. One major reason why people do not seek legal redress is the power enjoyed and exercised by the perpetrators, who coerce the victims and their families into silence. Then there is the fear of social stigma that the victims and their family would have to endure for the rest of their lives if word got around. Even if the victims and their families

families often shy away from seeking legal recourse.

We have become a society in which innocent, vulnerable children have become a tool to satiate the filthy desires of the stronger-in various forms, from subjugation to sexual gratification-be it within the security of one's own home, school or outside. Unfortunately, we have become so desensitised that when they are tortured and abused even in front of us, we merely take out our phones to make TikTok videos or Facebook lives, instead of rushing to the rescue of the child victims.

These incidents leave lasting mental and emotional scars on children. Their self-respect and dignity are compromised forever and they often fail to recuperate from these horrors.

A CLOSER LOOK wonder then that the traumatised fear of being victim blamed. Most importantly, the families, especially the parents, should prioritise social and family values in their conduct so that they can spread the same values among their children.

Schools should have separate curriculum on child rights and safe conduct. The government should partner with the INGOs for technical assistance and resources to train teachers in primary and secondary schools on child psychology and institute effective sexual harassment complaints committee in each educational institution.

The government and judiciary should look into the perennial issue of case backlog-which stood at around four million in all types of courts as of June 2023-and expedite delivery of justice. Perpetrators should be



We must abandon our ecocidal mindset

In March this year, while visiting Sugandha Residential Area. Chattogram, I was alarmed to see that numerous trees had been felled along the roadside. Shocked, I took photographs and asked why they were cut down. The woodcutters said the decision had come from the residential authority. I filed a complaint with the Department of Environment (DoE) through its online platform, providing evidence of the illegal activity. However, five days later, my grievance was rejected without any explanation.

Seeking further clarification, I reached out to the Forest Department, which conducted an investigation into the matter. Their findings revealed that more than 100 trees had been cut down on both sides of the road in Sugandha Residential Area by the contractor in charge of widening the road. While the local councillor supervised the tree-cutting, neither the councillor nor the contractor took responsibility for their actions.

This is just one example of the relentless deforestation happening across Bangladesh which persists unchecked, as authorities largely turn a blind eye to its destructive impact on the environment. Existing forest and environmental laws are often ignored, leaving them only on paper without proper enforcement. Individuals and organisations recklessly clear out trees to serve their own agendas, without any repercussions.

systemic ieopardisesBangladesh'scommitment to preserving its environment and natural resources. This issue is further compounded by frequent violations of environmental laws by governmental institutions themselves. often influenced by corruption or vested interests. For example, agencies have been accused of approving projects that involve the destruction of protected areas, cutting of trees, and disruption of natural habitats, all in violation of established laws and regulations meant to safeguard the environment.

The Chittagong Development Authority (CDA) is one such agency that recently suspended its plan of cutting trees to construct a ramp for the elevated expressway from Tigerpass to Pologround in the city in the face of public pressure. The initial decision followed significant opposition from local residents and environmentalists, who protested the proposed construction. Ironically, the original plan had received permissions from the Forest Department that authorised felling 46 trees, many of which were 100 years old and culturally significant.

According to our constitution, the state has a responsibility to protect and improve the environment and biodiversity for current and future citizens. Despite this, the government continues to sanction ecocidal projects and allow the destruction of natural resources and biodiversity.

For instance, the decision to clear 52 lakh trees in the Mirsharai mangrove forest for an economic zone left 7,000 deer and other species without a home overnight, demonstrating an ecocidal mindset. The approval of a

negligence 102-km tourist railway line through home. Strict enforcement of existing three protected forests further led to laws, coupled with enhanced authority the destruction of 670,000 trees and the blocking of 16 critical elephant corridors.

> In June 2023, the Chattogram district administration cut down a mangrove forest in Kattali to create a sanctuary for birds. Supervised by the Forest Department, it involved the removal of many trees along the shores of the Bay of Bengal, raising concerns about the lack of oversight and the prioritisation of development over conservation.

> Sometimes, despite the best intentions of the Forest Department and the Ministry of Environment, their efforts fall short due to power dynamics within the government. The recent killing of a forest officer by owners of illegal quarries has highlighted the waning power of authorities to enforce environmental laws. A study by Transparency International Bangladesh (TIB) found that the Forest Department is facing several challenges. They don't have enough resources, which makes it difficult for them to do their job effectively.

> Centralisation of administrative power prevents agencies outside specific domains from effectively implementing decisions, which hinders proper enforcement and accountability. As a result, the checks and balances to safeguard the environment are weakened, leading to continued violations and further damage to natural resources.

> In the face of this crisis, urgent action is needed. The government's 2030, made during COP26, must be translated into meaningful policies at

and resources for environmental agencies, is imperative.

Enhancing collaboration between Department, local the Forest administration, and law enforcement agencies is crucial. Establishing clear protocols and mechanisms for cooperation will streamline communication and facilitate swift action against environmental offenders. For instance, joint task forces could be formed to investigate and prosecute illegal quarrying operations or deforestation activities. Additionally, providing specialised training to law enforcement personnel on environmental law enforcement techniques can enhance their effectiveness in supporting the efforts of Forest Department.

Decentralising administrative power to empower forest and environmental officers at the grassroots level entails a fundamental shift in governance structure aimed at placing decision-making authority and resources directly into the hands of those closest to the environmental challenges. This process involves devolving responsibilities traditionally held by centralised authorities to frontline officers stationed in local communities. These officers, intimately familiar with the local ecosystems and environmental dynamics, are strategically positioned to swiftly respond to emerging environmental issues. With decisionmaking authority at their disposal, they can assess the situation, enforce regulations, and implement pledge to halt deforestation by tailored conservation measures best suited to the specific needs of their surroundings.

Why are IMF policies failing to stabilise our economy?

During its latest partnership with the International Monetary Fund (IMF), Bangladesh has been experiencing high inflation for the past 22 months, its economic crisis at low rates, causing capital flight worsening gradually. Financial account deficits have surpassed \$9.26 billion. With outstanding payments across various sectors like electricity, aviation, fuel imports, and various digital sectors, the net reserves have plummeted to just \$13.8 billion, a situation reminiscent of nine years ago. The continuous dollar crunch and dollar payment crisis have persisted for the past 22 months, further strangling the country's business and employment sectors due to LC's substandard control.


The savings interest rates on circles, false hardware capability, deposits have not been adjusted at the right time. Banks have created a messy window for swapping loans and deteriorating private sector investments. The Bangladesh Bank failed to put a brake on the rise of politically motivated nonperforming loans (NPLs), nor could it restore depositors' trust.

The IMF has not really been critical about the mechanism of hiding billions of dollars' worth of NPLs. Despite IMF engagement, there has been no pressure on banks suffering with NPLs. Four state-owned banks alone have seen a 27 percent increase in defaulted loans, reaching nearly Tk 63,000 Meanwhile, the government is crore in total at the end of last year. The crucial issue is that there hasn't been any attempt to bring the top IMF has not been able to address the root cause of systemic economic issues.

All efforts to reduce inflation resulted in further increase in prices. Measures like increasing interest rates, restricting capital in the value of taka during this flight and NPL, and halting capital

capacity charges, faulty power plants, inefficient power plants, renewal of inefficient ageing power plants, high system loss, and other systemic flaws. Analysis of unitwise production in 2023 shows that despite 23-25 percent unit mechanical failures in electricity production, revenue is obtained through capacity charges and overbilling. The Bangladesh Power Development Board (PDB) is procuring electricity production capacity from plants that are sitting idle through billion-dollar electricity purchases. All of these are absent in the IMF's "policy proposals." The pressure to reduce administrative expenses (austerity) is not visible.

IMF's policy on waivers is contentious. Despite failing to meet the three main conditions (dollar rate, net reserve limit, and percentage of NPLs) during the second instalment, Bangladesh received a waiver, which was delayed in other countries for the same reason. Despite the dollar crisis, the country has maintained regular debt servicing (payment of

Need someone's phone number to promote your products or do something similarly invasive? Need a rival's call history to know secret? Or someone's NID card to open a fake bank/MFS account, or take out loans in their name? Or their driving licence to stage an incriminating scene?

There was a time when these questions would be almost as dangerous to ask as the pursuit of their answers. You would be looking over your shoulder constantly, lest someone catch a whiff of your unseemly interests. The criminal market built around such pursuits was still niche, and the *personal* of "personal data" still meant something other than just the nature of the data in question-it was a hands-off warning to anyone looking to infringe upon someone else's privacy. But those days are coming to an end. Today, thanks in large part to the frequent breaches of government websites and servers, there has been a gradual normalisation of data-related crimes, to an extent that hardly do you see anyone raise an eyebrow anymore. Citizens, too, seem to be accepting the fate of their data being inherently vulnerable the moment it is digitised.

There has also been a thriving market for stolen data-a hidden domain populated by men trading in secrets-and leading it from the front are apparently government officials themselves: people who are supposed to protect our data. This was the subject of a recent report that, as a columnist of this daily has rightly assumed, would have "made a much bigger splash" in any other country. But not here. According to the report, citing a letter by the National Telecommunication Monitoring Centre (NTMC),

data from the national intelligence servers and selling it to some 789 groups and pages onFacebook, Telegram, with whom they are talking in and WhatsApp. Collectively, these pages and groups-where questions like the above would be routine-have 32 lakh members and followers.

The sheer size of the network, and its disruptive and destructive potential, is frightening. It's like a data bazaar or supermarket, or, in marketing language, your one-stop shop for all things you. Here, your personal details are up for grabs to anyone willing to pay-to be used at their disposal and tossed away when their job is finished. Even payment is not necessary for information that is already publicly available, thanks to previous data breaches and exposures.

The NTMC is legally authorised to monitor all electronic communications in coordination with the telecommunications ministry, BTRC, and law enforcement and intelligence agencies. It stores data related to citizens' NID cards, passports, driving licences, and call detail records. Reportedly, nearly 500 officials of 42 organisations can log in to its National Intelligent Platform (NIP) using their IDs, and access the data for verification and investigation purposes. The digital trail of the latest breach was discovered when the NTMC traced unusually high numbers of logins to the NIP by IDs belonging to two officials from the Anti-Terrorism Unit (ATU) and Rab-6. Both of them are now under investigation for unauthorised data transfers. Previously, two data entry operators of the IDEA 2 project were also arrested for similar offences, according to our report. The question is, with so many

citizen data-are the detected four the only ones to have abused their login credentials? Knowing how prone to corruption many government employees are, and how weak our data security infrastructure is in general, we cannot be sure. It is more likely that other attempts have gone unnoticed. Although we don't know how many people were or will be affected by the latest breach, the number is likely huge.

Over the last few years, we have had many such data breaches which were usually blamed on outsiders. What will the authorities say now that insider involvement has been found in illicit data sharing/selling? Who will take the blame for this lapse in our data security protocols? For the citizens whose data was sold or otherwise made available, the consequences are not hard to imagine. A widespread dissemination of their private data poses a severe risk to their security and privacy. NID details, for example, can be abused to commit various crimes. In the past, we have seen how NID cards were used to open fake bank accounts and obtain loans, or to illegally access government grants. Victims, it goes without saying, may have to pay the price for such identity theft even years after the commission of any crime in their names.

The recent incident has raised fresh alarms both for the victims involved and Bangladesh's existing data ecosystem. A country that once promised a techno-utopian vision through catchphrases like "Digital Bangladesh" and Bangladesh"—with "Smart accompanying digitisation-is increasingly seeing its efforts descend into a dystopian nightmare. How the government responds to this scenario will determine the future of those grand visions.

In my opinion, there are five major reasons: mismanagement of policies; overlooking largescale statistical discrepancies; failure to propose research-based policies; the nexus between corrupt governance and institutional incompetence; and, ultimately, the mindset of giving concessions to reform policies.

As a result, the country will directly experience a new wave of inflation.

interest and principal on foreign loans), which may be why the IMF has brought flexibility into its policy here, adjusting its lending business to the government's terms. The June 2024 target for forex reserves has been brought down to \$14.76 billion from \$20.10 billion. Not only that, but the IMF has also reduced the government's revenue target. The question is, has the IMF not conducted sufficient research and preparation? Or does the Bangladesh mission lack enough expertise and the knowledge of local data manipulation?

One of Bangladesh's major problems is misinformation, and the IMF remains indifferent to that. According to IMF studies, the actual amount of defaulted loans is twice the government's figure. There are discrepancies not only in population data, but also in per capita income data. There's uncertainty whether the new exchange rate will adjust the dollar value of the GDP. In the past year, despite a nearly 25 percent decrease in the value of the taka, there has been no trustable adjustment in the dollar rate for GDP. Despite inflating GDP at 9.5 percent inflation rate, a nearly 30 percent decrease has happened in the value of money over the last 1.5 years. There should be a drop in GDP and per capita in terms of dollars, and a sharp rise in debt-to-GDP ratio.

Based on its own information, the Bangladesh Institute of Development Studies (BIDS) found a 15 percent food inflation in a recent survey. But the Bangladesh Bureau of Statistics (BBS) reported a 10.22 percent food inflation in April 2024. The deviation between the two surveys is 46.77 percent. This level of misinformation and/or information discrepancy has crossed all limits. Controlling inflation is crucial as a means to restore macroeconomic stability in the country. If the inflation data remains misleading, the effectiveness of the proposed







Among the Hindu bhadralok class there was a recrudescence of the Hindutva sentiments of the swadeshi period, a sentiment which found literary expression in the writings of Sarat

On the other side of the divide, it is a recognized fact that, despite a notable share of the Bengali Muslims

of the awakening of the masses of Bengal, Wadud is led to enquire about the question of the 'true worth' of Nazrul Islam as a literary figure. His first anxiety relates to the persistence of a dualism (as distinguished from 'syncretism' celebrated by the Orientalists) widely noted in the Bengali poet's theology. Wadud formulates the problematic

as not simply coexistence of Islamic and pagan traits, but of their simultaneous development: "Nazrul Islam has endeared himself to his coreligionists of Bengal by his poems and songs on Islam and Muslims. He is also widely held to be responsible for a new ferment among them. But along with his pieces called Islamic he has penned innumerable lines in eulogy of gods and goddesses of the Hindus over which his coreligionists do not feel comfortable."

Wadud proposes an understanding of this problematic as the fact of cohabitation of the Islamic symbolic with the Hindu Imaginary simultaneously in every Bengali Muslim true to his creed and to his soil. Thus, Kazi Abdul Wadud writes: "The Mussulmans of Bengal sprang, it is undeniable, mostly from the Hindus, i.e., Buddhists and Hindus, of the land. Man's emotional awareness is hardly a fact till he realizes his intimate relationship with fellow man and nature. That emotional awareness again is vitally linked with man's selfassurance of the powers he has been born with (which is another name for Renaissance). So, the Mussalmans of Bengal wishing their own fulfilment must have a deep comprehension of the environment they have been born in and of their heritage from their ancient Hindu forbears-even

echoed K.A. Wadud's concerns: "He holds a pre-eminent place in the story of efforts to communicate through music the ideal of a nationalism rising above religious differences."

What differences? Some became apparent in course of the Swadeshi agitation against the partition of Bengal. The movement produced a remarkable crop of patriotic songs by many, and music proved one of the most effective techniques of mass contact. "However," Gupta adds, "the appeal of the agitation to Muslims in general was limited. While one cannot deny the involvement of some Muslim leaders and their followers, and the composition of patriotic songs by Muslim writers (like Ismail Husain Shirazi), most of the songs and plays had not shed Hindu imagery and historical allusion to the 'glories' of ancient Indian civilization. The revolutionary secret societies excluded Muslims from membership, even when some young Muslim boys wanted to join them."

In the wake of the Swadeshi agitation and the imperial policy of introducing separate electorates, the distance became apparent.

The annulment of the partition of Bengal (1911) was unpopular with most Bengali Muslims, especially East Bengal Muslims. They were also hurt, even in their imaginary, by the fact of Britain's stand against Turkey. The lesser demographic weightage granted to Bengali Muslims in the Lucknow Pact of 1916 also embittered them. Thus, the Bengali Muslim goodwill to make a common cause with the Bengal Congress for a Hindu-Muslim alliance to demand constitutional concessions from the imperial administration was already fraught with fragilities. In these circumstances, when the fragile Hindu-Muslim alliance bore fruit as the Government of India Act, 1919, Nazrul Islam was demobilized because the regiment to which he

of early Bengali literature, the as Firdausi felt the compelling need Muslims of the colonial era failed to take a worthy share in the making of modern Bengali literature. K.A. Wadud holds the political changes of the eighteenth century as well as the Islamicist reform movements of the nineteenth mainly responsible for this misfortune. Without necessarily taking such a myopic view, we can concede that in the first half of the nineteenth century, while the Hindu cooperated with the British, a significant part of the Muslims for the most part remained 'sullenly hostile' and after the uprising of 1857, they faced the wrath of the conquistadores. Neither the Islamicist reform agitation nor the prostrations of Aligarh did much to rescue the Bengali Muslims from their torpor.

K.A. Wadud's remark is apposite: The Aligarh movement of Sir Syed Ahmed Khan did something towards the uplift, mental as well as mundane, of the Muslims of North-Western India, but left Bengal practically untouched. Thanks to Syed Ameer Ali, a disciple of Sir Syed Ahmad, just a faint ray of modernism touched the minds of the English educated Muslims of Bengal, but it was too faint to be effective."

That the English educated Muslims of Bengal did not, for the most part, represent the Bengali Muslims did not deter Kazi Abdul Wadud from making generalizations need not blind us from his appreciation of Nazrul Islam's debut as a tour de force (his 'true worth' in manner of saying) in the history of the Bengali Muslims. "Some have not hesitated," Wadud admits, "to describe his writings as ephemeral. This view, however, no longer holds the field. None in the literary world of Bengal would deny today that Nazrul is a memorable poet of twentieth-century Bengal, nay, of India."

A second problematic that worried Kazi Abdul Wadud concerns a sign of self-confidence, sometimes taken for a wonder. Nazrul once uttered "I bow to no one except to myself", and the utterance, as Wadud takes it, "was no stray outburst but the expression of an abiding feeling in him-it is in fact his dominant feeling."

We would suggest this dominance as an outburst of the Symbolic, in the sense in which Jacques Lacan (1901-1981), the psychoanalyst, employs the notion. Lacan's use of the term symbolic endeavours to show how the human subject is inserted into a pre-established order which is itself symbolic in nature, where the symbolic, exemplified by language as the structure per excellence provides prototype of the unconscious.

Wadud pays tribute to this notion of the symbolic when he writes the following: "The popular ways of viewing him as a poet of Rebellion, as a champion of the cause of the have-nots, as a unifying force between Hindus and Muslims are not to be challenged; they are good inasmuch as they endear the poet to us by stimulating in us some creative thoughts peculiar to our age and environment; yet it is too true that his Rebellion, his espousal of the cause of the have-nots, his endeavours to unite Hindus with Mussalmans, all are rooted in his sense of glory of the self and have derived their potency from that consciousness.'

Hosts thrash Korea in opener

Three-time champions Bangladesh made a flying start in the 4th Bangabandhu Cup International Kabaddi, outplaying Korea 67-22 with 'five lonas' in the opening match of the 12-team tournament at the Shaheed Suhrawardi Indoor Stadium in Mirpur yesterday.

The hosts had lost to the same opponents in their last two meetings, getting thrashed 38-18 in 2018 Asian Games following a nerve-wrecking 35-32 defeat in the 2016 Kabaddi World Cup.

The charges of Abdul Jalil did not repeat the mistakes of the past as they completed a convincing win over the Koreans in front of a passionate home crowd who cheered the team throughout after the match got underway one hour after the scheduled time.

The crowd were especially behind captain Arduzzaman Munshi, chanting 'Munshi, Munshi' during his successful raids, of which there were many.

Mizanur Rahman, who was in doubt for the match after returning to the national team's fold just one week before the tournament, put on a stellar show alongside another star performer Al Amin as the men in red and green collected points from both raids and in defense.

Bangladesh led the first half 23-11 and kept widening the margin as the game progressed.

"Our team communication was really good, so the margin was also big. If we can keep this communication going among the players, I am confident that we can reach our target of becoming champions," said captain Arduzzaman, who had missed the Hangzhou Asian Games in 2023 following injury.

Coach Jalil believes the strategy was key in the Korea match.

"The footwork of the Korea team was initially good and we were losing points while trying to catch them. They were also attacking from one side to another. But they did not have a raider from the left side. So, we analysed it and started defending the opponents accordingly.

They played wide but we defended closely. I think the strategy made the difference while our raiders - Munshi, Mizan and Al Amin – also performed boldly in the match," said coach Jalil. Korean coach Jinseok Kang said that they have brought a comparatively young team. "Most of our players are aged between 20 to 23. Though there are also a few old campaigners," said Jinseok Arduzzaman, who announced that he will retire after the tournament. said that although it was a new-look Korea team, the hosts didn't take them lightly. "It is true that I did not find the Korean players that I had played against before as most of their players are new. But they are still good. We were wary of them from the beginning."

Nadal bidding to avoid early French Öpen exit

Rafael Nadal admits he will be facing "one of the toughest opponents possible" when he plays Alexander Zverev in the French Open first round on Monday.

This year's event was expected to be the 14-time champion's farewell to Roland Garros, but he has since insisted he could not confirm "100 percent" it would be his last appearance.

A hip injury and then a muscle tear had seen Nadal out of action for the most part since 2023 and that left him unseeded for the draw and vulnerable to a difficult opening round.

World number four Zverev arrives in Paris as one of the favourites for the title after winning the Rome Open earlier this month.

"Of course, on paper, it is not the best draw," Nadal said ahead of the match on Court Philippe Chatrier.

"I play against one of the toughest opponents possible, and at the same time, he came here winning the last event"

Nadal, who turns 38 in a week's time, has shown flashes of his best form in the clay-court swing, but was thrashed 6-1, 6-3 by Poland's Hubert Hurkacz in the second round of his last outing in Rome.

Nadal has a favourable head-to-head record over world number four Zverev ahead of their first meeting since the 2022 French Open semifinals, when the German left the court in a wheelchair near the end of the second set after injuring his ankle.

"I am not anxious. No, I am focused on trying to play well. That's it," said Nadal.

Zverev did not play again in 2022 after that ankle injury but has climbed the rankings again in recent months.

Nadal lost only three of his 115 French Open matches, claiming the title a record 14 times.


However, Nadal has only played four tournaments since January 2023 after suffering a hip injury.

Zverev has reached the semifinals in each of the last three years at Roland Garros.

The 27-year-old has long been touted as a future Grand lam champion but remains without one of tennis' four iggest titles.

"I can guarantee you Novak didn't want to play Rafa in the first round and (Carlos) Alcaraz didn't want to play, Jannik (Sinner) didn't want to play him," admitted Zverev.

"I don't want to play him in the first round, but it is how it is. Everybody now is excited for a tough battle and tough first round. I think he's excited and I'm excited for it."



Russian attack on Kharkiv kills 16 Dozens injured; Ukraine's President Zelensky condemns Russian 'madness'

A Russian strike on a crowded DIY hardware store in Kharkiv killed 16 people and wounded dozens more, Ukrainian prosecutors said yesterday morning, the death toll rising as the country's second-largest city reeled from two attacks a day earlier.

Two guided bombs hit the Epicentr DIY hypermarket in a residential area of the city on Saturday evening, regional governor Oleh Syniehubov said on national television, adding that "unfortunately, 16 have already been recorded dead".

The strikes caused a massive fire which sent a column of thick, black smoke billowing hundreds of metres into the air.

Forty-three people were injured, the local prosecutors' office said, adding that ten of the twelve dead had still not been identified. Kharkiv Mayor Ihor Terekhov said about 120 people had been in the hardware store when the bombs struck.

"The attack targeted the shopping centre, where there were many people - this is clearly terrorism," Terekhov said. In a post on the Telegram app, Ukraine's Interior Minister Ihor Klymenko said 16 people were still missing after the strike.

The past week has seen an uptick in strikes on the city after Russian troops stormed across the border, opening a new front north of the city.

Russia has bombarded Kharkiv, which lies less than 30 kilometres (20 miles) from its border, throughout the war, having reached its outskirts in a failed bid to capture it in 2022
