Begum Firoz Haider, the youngest niece of Hussein Shaheed Suhrawardy and wife of freedom fighter and former lawmaker late Syed Haider Ally, passed away on Saturday evening. She was 86, said a press release.

She left behind two sons, a daughter, grandsons, granddaughters, and a host of well-wishers. Syed Shahed Reza, secretary general of Bangladesh Olympic Association, is her son-in-law.

She was buried at Mirpur Martyred Intellectuals' Graveyard yesterday after a namaz e-janaza held at Gulshan Azad Mosque.

Her family members have requested all to pray for the salvation of the departed soul.

'It may collapse any time'

Bridge over Ratnai river remains dilapidated for 4 years

The 50-metre bridge over the Ratnai River between Marichbari and Kalirhat on the Bhelabari-Durgapur road in Aditmari upazila, Lalmonirhat, has been in a dilapidated state for four years.

The railings of the bridge are damaged and the pillars cracked. As there is no alternative road, locals are constantly crossing this bridge risking their lives.

No heavy vehicles can cross this bridge, which has left local traders facing a challenge when transporting their goods.

Badsha Mia, a businessman from Kalirhat area, said, "No trucker wants to transport goods over the broken bridge. Because of this, we have to transport goods in light vehicles at higher costs. We have been demanding a new bridge for the last four years, but we are not seeing any results," he said.

Sirajul Islam, a van driver of Marichbari area, said, "When I get on the bridge with a van full of



goods, I feel very nervous. It could collapse at any moment."

Nur Mohammad, a farmer of Sethibari village, said, "Moving on the bridge with even a bicycle feels risky nowadays. The railings and pillars are damaged."

Chairman of Bhelabari Union Parishad Mohammad Ali said several applications were sent to the LGED authorities for the construction of a new bridge, but no action has been taken so far.

Chairman of Durgapur Union Parishad, Asaduzzaman Nannu said

people of his union have suffered the most due to the dilapidated condition of the bridge. LGED authorities have inspected the bridge several times and promised to build a new one.

Aditmari Upazila Engineer Ali Hossain said that under LGED's "Supporting Bridge Project", a proposal has been made to construct a 50-metre bridge over the Ratnai river on the Bhelabari-Durgapur road on May 14. The construction of the bridge will be implemented if the approval and allocation of funds is received.

Justice Anwarul Haque NO MORE

economy, and acknowledging its significance in society, she added.

Dr Hossain Zillur Rahman, former adviser to the caretaker government and executive chairman of PPRC, emphasised the necessity of altering social norms, promoting a sense of social responsibility, and addressing toxic masculinity.

Such efforts require implementing additional policies and budgetary steps, he added.

"We need investment in childcare support in workplaces, maternal health, and to prevent child marriage and much more," he also said.

Speaking as chief guest, State Minister for Finance Waseqa Ayesha Khan, said disregarding women's unpaid care work is a global problem.

"There is no reason to exclude women's household and care work from GDP. We are trying to include unpaid care work in the budget. Because without care economy, the economy of smart

Bangladesh will not be smart," she said.

She also emphasised recognising the work of domestic workers, as it is not easy to work outside the house without their help.

Referring to the prime minister's directive to include women's unpaid care and domestic work in GDP, MJF Executive Director Shaheen Anam said, "A CPD study has shown that the value of unpaid work is three times higher than the paid work of women."

"Even if women are paid for their work, 80 percent of them work in the informal sector, where their salary is not secured," she said. "Now is the time to economically recognise women's unpaid work through a satellite system of accounts," she added.

UN Women Representative to Bangladesh, Gitanjali Singh, believes the recognition process has to be a collective approach. Partnerships are fundamental and collaboration is the key here, she added.

The Rab then claimed that Akram was killed in a "gunfight" between the elite force and drug dealers. It said Ayesha's allegations and statement were "completely untrue".

Arafat Islam, director at Rab legal and media wing, on Saturday said, "The incident was investigated as per the law, but I am not aware of the findings as I was not in Rab at that time."

Generally, an executive magistrate posted in Rab on deputation carries out an inquiry whenever any incident of firing takes place, said a former senior Rab officer, wishing anonymity.

Neither Rab nor any other authorities ever disclosed any investigation findings or whether any action was taken against Rab members over the incident.

On December 10, 2021, the United States imposed

sanctions on Rab and its seven current and former top officials, including the then IGP Benazir Ahmed and former Rab-7 Commanding Officer Lt Col Miftah Uddin Ahmed, for "serious human rights abuses".

The State Department, in a release, then specifically mentioned the extra-judicial killing of Akram.

On July 21, 2022, the National Human Rights Commission asked the home ministry's public security division to send a report after investigating the incident and the allegation of not registering a case by any agency other than Rab.

But the commission has yet to receive any report, though the NHRC chairman wrote 12 times to the senior secretary in this regard, said an NHRC official.
