"Meanwhile, collaborating with the government to either facilitate their travel or a refund," he added. Nizam Lawmakers

Uddin Hazari, Benjir Masud Ahmed. Uddin Chowdhury and President Mohammad Abul Bashar also attended the conference.

Benjir is also the president of the parliamentary body on home ministry.

Nizam denied existence of any syndicate within recruiting agencies. He said this in response to a question on how he managed to send 8,300 workers to Malaysia in the last two years while only 300 in the years before.

He claimed he wasn't directly involved in sending workers or processing visas

but rather facilitated the process.

He said a certain group is attempting to discredit them through various means.

Contacted, State Minister Shofigur Islam Choudhury said the ministry was not responsible for the e-visas issued by the Malaysian government.

"I think there is no point in blaming anyone for the current crisis. Legal action will be taken as per the investigation. No one will be exempt," he said.

Replying to other claims from Baira that the number of workers who could not go to Malaysia will not be more than 5,000 to 6,000, the minister said, "We have formed a probe body which will investigate the overall irregularities related to the

335 illegal brick kilns FROM PAGE 3 shut down in

Rangpur div STAFF CORRESPONDENT

The government vesterday submitted a report to the High Court, saying that operations of 335 illegal brick kilns out of total 502 in three districts of Rangpur division have been closed in compliance with its directives.

The government has stopped the operations 114 illegal brick kilns out of total 172 in Rangpur; 87 out of total 155 in Gaibandha and 134 out of total 175 in Dinajpur, according to the compliance report.

Assistant Attorney General Kalipada Mridha placed the report on behalf of Rangpur's divisional commissioner before the HC bench of Justice JBM Hassan and Justice Razik-Al-Jalil during hearing on a writ petition as per its previous directive.

The bench ordered the government to close the remaining brick kilns.


