Govt approves price for 40MW power import from Nepal

REJAUL KARIM BYRON

Bangladesh has agreed to buy 40 megawatts of electricity from Nepal at Tk 8.17 per unit, including transmission cost, under a five-year agreement.

The Cabinet Committee on Government Purchase yesterday approved the price, ending a long negotiation over hydropower import from the Himalayan nation via India.

Mahmudul Hossain secretary (coordination and reforms) of Cabinet Division, said Nepal will get \$0.640 per unit while India will receive 0.0595 rupee as trade margin.

He said the transmission cost that India would get has not been mentioned in the summary of the However, a Power Division official

said Bangladesh will pay \$0.697 per unit (Tk 8.17), including power price, transmission charge, and trade margin. He said the transmission charge

would vary from time to time.

Two teachers of St Scholastica's Girls' School sued for sexual abuse

Two teachers of St Scholastica's Girls' School and College in Chattogram city's Patharghata area have been sued for sexually abusing a fifth-grade schoolgirl for over a year.

The accused are Rakib Uddin, 35, who teaches fourth grade, and Surjit Pal, 33, who teaches fifth

Of the duo, Rakib was detained last night for interrogation, confirmed Obaidul Haque, officerin-charge of Kotwali Police Station.

Earlier in the day, the 11-year-old victim's mother filed the case with Kotwali Police Station, said Atanu Chakraborty, assistant commissioner (Kotwali Zone) of Chattogram Metropolitan Police.

"We've accepted the case and received some screenshots of messages sent by the teachers to the victim as supporting evidence. We've launched an investigation into the allegations of sexual abuse brought against the teachers."

According to the case statement, the 11-yearold had been sexually abused by both teachers for

Since 2023, the two teachers have sexually harassed and molested the girl on several occasions. Whenever she tried to resist them, they reprimanded her in class and threatened to fail

For land development at the site, Benazir's men dug up a huge pond spanning about 30 bighas of land in Bairagitol and brought the sand and soil from there, locals said.

According to its website, there is a farm within the resort, several ponds, a swimming pool, boat ride facilities, play zones for children, a country club, a helipad and other facilities.

CLEVER TACTICS According to locals, Benazir first bought a piece of land in the area in 2016-2017. The floodgate had since opened as the mighty cop went on a land acquisition spree, with Inspector Taimur Islam intimidating the poor and mostly Hindu villagers to sell their land.

Benazir's men would fly drones and make a map, marking various plots in white and red, presumably to determine which land to target, said Tarun Baul of Bairagitol village.

He recalled that Taimur would eventually approach the targeted land owners and say, "You know Benazir and how powerful he is. If you decline to sell your land, he would surely take it anyway. You will lose both your land and the money. If you agree to sell, I will help you get a handsome price."

When someone refused to sell their land, Benazir would buy the surrounding land and block the entry to the land in the middle. This would ultimately force people to give in, said Sanjay Baul of Bairagitol village whose 30 bighas of family land were "forcefully acquired" by Benazir in 2018-2019.

"Two locals left for India with their families after selling their land to Benazir," said Biplob Baul. One of them is Pranshanta Baul, 40, who left the country along with his wife

and four children about a year ago. "I was compelled to sell my 51 decimals of agricultural land at Tk 2
