It all began as what I could only describe as a bittersweet - and often hilarious - relationship with one of the city's cheekiest primates.

I first noticed the visitor on my windowsill one fine morning. Far from a swinging, lively creature inhabiting the lush forests, this monkey appeared sad and lonely. Curious, I learned from my homeowner that this was the same animal raiding our mango tree.

Despite the landlady's frustration, my heart went out to this solitary figure. To lighten its spirits, I offered some fruits and biscuits, only to be rewarded with a scratch that sent me to the hospital for a rabies vaccine. Lesson learned -- not all monkey friendships start with a handshake!

This experience, although painful, got me thinking about the deeper issues at play.

Monkeys, once reigning supreme in the tree-laden areas of Old Dhaka - particularly Gandaria and Wari now find themselves navigating the concrete jungle. With much of their natural habitat replaced by urban sprawl, these animals have been forced to adapt in unexpected ways.

Without their ancestral homes' abundant trees and natural food sources, they have now turned to scavenging human food. Rooftops

The plight of these urban monkeys is a mirror reflecting our actions.

The gradual erosion of green spaces in Dhaka has not only robbed these creatures of their homes but also of their independence.

Where once they thrived on the fruits of the forest, they now depend on the scraps from our tables. This dependence has led to conflicts and often misunderstandings on both sides. Monkeys stealing clothes and food has become a part of urban legends, and sometimes, they manage to outsmart us in ways that are as infuriating as they are funny.

Despite these challenges, there are moments of genuine connection and understanding. After my initial encounter, the same monkey has become a regular visitor. These visits have taught me about resilience and adaptability. Who knew that sharing a city with monkeys could be so entertaining?

As urban expansion continues, we must acknowledge and plan for the wildlife displaced by our actions. Instead of viewing them as intruders, perhaps we could see them as fellow city dwellers trying to navigate the complexities of urban life.

Simple steps like preserving existing green spaces, planting more trees, and creating urban sanctuaries can make a noticeable difference in the lives of these animals.

As we look towards the future, let's aim for a harmonious coexistence. where monkeys and humans share the cityscape with mutual respect. After all, in the grand symphony of life, every creature has its part to play, and sometimes, a good laugh is the best harmony of all.

Law doesn't allow sending Khaleda Zia abroad for treatment

Says law minister

Law Minister Anisul Huq yesterday said there is no provision in law that would allow BNP Chairperson Khaleda Zia to go abroad for treatment.

"As far as I know, a process has been initiated to place a pacemaker in Khaleda Zia as part of her cardiovascular treatment. We received no request for sending her abroad," he said.

"Khaleda Zia's jail sentence has been suspended under an executive order, which was issued based on a [specific] law. Under the law, there is no scope for sending her abroad."

Anisul said this while answering questions from journalists after attending the inauguration of the training course for senior assistant judges at the Judicial Administration Training Institute (JATI) in Dhaka. He was the chief guest at the programme.

The minister said Khaleda was released from jail on March 25, 2020, after Prime Minister Sheikh Hasina suspended her sentence with an executive order on humanitarian grounds. "Due to this, Khaleda is being able to have treatment as per her own will in the country.'

Replying to another question, he said it was not necessary to formulate a new law to collect the wealth statements of government officials, adding that the existing provision requires the officials to submit their wealth statements at the entry stage of their services, which have to be updated from time to time.

The law minister, however, urged journalists to be alert and not malign honest officials.

In response to a separate question, Anisul said there is a provision for the Anti-Corruption Commission to inform the government regarding taking action against any government official for corruption.

It has been incorporated in the law so that the government can be aware of the ACC's action and also think about what action it will take from its end against the official concerned.

JATI's Director General Justice Hasan Foez Siddique presided over the programme, where Law and Justice Division Secretary Md Golam Sarwar also spoke.

Matiur has plunged into controversy over his wealth after his son, Mushfigur Rahman Ifat, posted a photo of a sacrificial goat on social media and claimed to have bought it for Tk 12 lakh. There have also been media reports on his family's lavish lifestyle

These raised questions about the income of this official at this grade (grade-1) with a basic monthly salary of Tk 78,000.

Photos of Ifat with various expensive cars and the family's properties, including flats and resorts in places like Dhaka, Gazipur, and Narsingdi, began doing the rounds on social media.

On Wednesday, Matiur told The Daily Star that Ifat was not his son and that he was a victim of a conspiracy.

Matiur claimed he has two children: a daughter and a son. His daughter lives in Canada, while his son graduated from a university in the US.

Later, media reports, quoting lawmaker Nizam Uddin Hazari of Feni-2 and local leaders, said Ifat is the son of Shammi Akhter Shibu, who is Hazari's cousin and Matiur's second wife.

ACC sources said Benazir's letter was addressed to the ACC chairman, two commissioners, director general (money laundering) and the head of the investigation team.

Benazir wrote that he was staying abroad with family for medical and other personal reasons.

He said he worked in different districts and it would take time for him to collect documents, records, and files relating to his assets and prepare a statement.

He did not respond to our calls and text messages over the last two days.

According to the Companies Act, a company can sell shares at a discount price but with approval from the High Court, and it must be shown in the company's financial reports.

However, the company did not take any approval and did not show it in the financial report of 2015-16 when it got listed. Moreover, the IPO prospectus showed that all shareholders bought shares at face value of Tk 10 each.

Under service rules, government officials cannot work as consultants to facilitate companies to be listed in the capital market. The securities rules also have no option for any individual to offer consultancy related to IPO listing.

It is the job of merchant banks with issue management licences, and there are 66 such merchant banks in Bangladesh, according to BSEC data.

The merchant banks offer their service against a fee, and cannot accept any shares from the company, listing according to company regulations of 2015.

The issue manager is in no way connected with the issuer and does not hold any of its securities," the regulations say.

Faruq Ahmad Siddiqi, a former chairman of BSEC, said a public service-holder should not offer such consultancy. The securities rules also have no option for that.

"Why did the company give him shares at Tk 8? This is a serious allegation of irregularities that the official himself revealed. It should be investigated thoroughly," he said.

A top merchant banker, who usually offers IPO consultancy service, preferential treatments to buy shares

He received 37 lakh shares from Acme Pesticides and 14.5 lakh shares from Associated Oxygen. His first wife Laila Kaniz Lucky had 4.5 lakh shares and his son Ahmed Tawfigur Rahman Arnab 5 lakh shares from Associated Oxygen.

From a single company -- C&A Textiles -- he and his family members got 47.3 lakh shares.

Additionally, he received 88.83 lakh shares from SK Trims, 21 lakh shares from Kattali Textiles, 16 lakh shares from ML Dyeing, 10 lakh shares each from Mamun Agro Products and Ring Shine and 8 lakh shares each from Dominage Steel and Lub-rref (Bangladesh).

According to securities rules, any individual can get placement shares. Before getting listed with the stock exchanges, many companies sell placement shares to individuals, especially to friends and family.

Usually, they sell shares at face value or at a higher price considering that the share would be traded at a higher price after listing. In the meantime, investors can make money by holding the shares for one year or more.

But if the same people buy shares from many companies, it raises question as to whether they are getting

BSEC Spokesperson Mohammad Rezaul Karim said if any company sells shares at discount prices, it must take approval from the High Court, but Fortune Shoes did not do that. It only took approval from BSEC to issue shares at face value.

"We have no information as to how he [Matiur] got the shares at Tk 8. Only the company and the person involved can sav if.'

Any company can offer placement shares to anyone. So BSEC has nothing to say or do if any company sells its shares at face value, he added.

Ferdous Doreen told reporters after meeting Home Minister Ásaduzzaman Khan that she heard a vested quarter was trying to get some of the arrestees out of jail.

On June 16, Saidul Karim Mintu, the general secretary of Jhenaidah Awami League, who allegedly told the assailants that they would get the blood money, was sent to jail before his eightday remand was complete.

Mintu was placed on an eight-day remand, but the Detective Branch (DB) of the Dhaka Metropolitan Police, sent him to court within three days

He did not make a confessional statement and maintained that he was not involved in the murder.

Asked why Mintu was taken to jail before the remand period was over, DB chief Harun said, "No law has been violated. It is the investigating officers' discretion. If officers believe there is nothing more to learn from a suspect, they can take the person to a court and the court can send them to jail.

"Had there been any pressure, we

would not be able to accomplish so much. The home minister repeatedly said that there was no external pressure. He has instructed us to investigate impartially. No innocent person will be harassed."

Aktaruzzaman, who allegedly planned the murder, and several others have not been arrested yet, he said.

As the US and India have an extradition treaty, the authorities have requested Indian police to bring Aktaruzzaman back from the US.

Besides, the Interpol was contacted over the matter, and detectives have talked to the US Embassy in Dhaka.

"The investigation is winding up. We have arrested many. We have got some names. We are trying to arrest them."

Asked whether Doreen was going to Kolkata to give DNA samples, Harun said, "Indian police through the embassy requested Doreen to go to India. We spoke to her. She has been suffering from a fever for a few days."
