Foreign debt costs to spiral

Interest payments to surge 65pc to \$2.21b by 2027

Bangladesh's interest payments on external borrowing are projected to soar by 65 percent within three years due to rising global interest rates and an expanded foreign loan portfolio, which will put further pressure on the dwindling foreign currency reserves.

According to a finance ministry report, the interest payments will rise to \$2.21 billion or around Tk 26,000 crore by 2027 with the taka losing 35 percent of its value against the greenback over the last two years.

The principal amount is also forecast to jump by 28 percent to \$3.17 billion in fiscal 2026-2027, compared to the current fiscal .


Foreign loan repayments, including interest and principal amount, are projected to reach \$3.82 billion in the current fiscal year. Foreign debt servicing already stood at \$2.81 billion in the first 10 months of the fiscal year. The amount will rise to \$5.38 billion by 2027.

"The impact of currency depreciation on external debt levels underscores the need for careful monitoring and management of external debt risks to maintain economic stability and resilience," said the report titled Medium-Term Macroeconomic Policy Statement (MTMPS).

A moronic end to a daring jailbreak

4 death row convicts dig a hole for 20 days to escape Bogura jail, get caught after an hour and half

MOSTAFA SHABUJ, Bogura

Sentenced to death in separate cases, four convicts were housed together in a condemned cell in Bogura District Jail on June 1.

Over the next 25 days, the four -- Nazrul Islam, 60, of Kurigram; Amir Hamza, 38, of Narsingdi; Md Zakaria, 31, and Farid Sheikh, 28, of Bogura -hatched an escape plan and worked accordingly.

After managing a screwdriver and an ironsheet scrap from outside sources, they used those to make a hole in the ceiling. They also tied several bedsheets together to use as a rope.

Then early yesterday, they climbed out of the

cell one by one and scaled down the building. However, their taste of freedom lasted just an hour and half, as police rounded them up from Chashi Bazar, a few blocks from the jail.

Bogura Superintendent of Police Sudip Kumar Chakraborty described the incident at a press briefing at his office yesterday.

The jail has three condemned cells, housing 13 death row inmates. The four escapees were shifted to one of the cells on June 1, according to jail sources.

They said the building was built in the British era, and no iron rods were used in the construction of the roof.

Fooled by a gang, a widow in Chuadanga got her daughter married to a Chinese national named Cui Po Wei on July 1 last year, hoping that she would rise out of poverty.

The family was led to believe that the Chinese man had converted to Islam, worked at a factory in Gazipur, and would settle in Bangladesh

But six months later, Lovely, not her real name, was taken to China by the man and forced into prostitution, according to a case filed by the mother with a Dhaka tribunal on March 31 this year. On March 11, Lovely managed to

call her mother using an app and told she was seriously ill because of the torture she was facing. She added that Bangladeshi traffickers had sold her to Cui Po Wei for Tk 10 lakh.

Lovely's mother told The Daily Star that she personally knew four other poor women who were duped into marrying Chinese nationals. The same group of local people who had duped her were involved in arranging those marriages.

Requesting anonymity, a resident of the capital's Uttara, who works for a Chinese firm, said he personally knew two groups of locals who actively SEE PAGE 2 COL 2

Legal issues delaying Tarique's repatriation Hasina tells parliament STAFF CORRESPONDENT

Some legal issues were delaying the process of bringing home BNP acting chairman Tarique Rahman from the UK, Prime Minister Sheikh Hasina told parliament vesterday.

Tarique has been convicted in multiple cases, including the August 21 grenade attack case.

The government is determined to bring the BNP leader back home after resolving all pending legal issues to make him face the punishment, Hasina said in response to a query from Farida Yasmin, an Awami League lawmaker from a reserved seat for women.

The questions to the PM and her answers were tabled in the House, with Speaker Shirin Sharmin Chaudhury in the chair.

The premier said strong diplomatic and legal initiatives have been taken to bring Tarique back home.

A total of 15 convicts in the August 21 grenade attack case, including Tarique, are absconding.

Hasina, also the Leader of the House, said an Interpol red notice was issued against the absconding convicts, including Maulana Tajuddin, Md Harish Chaudhary and Ratul Ahmed Babu.

She informed parliament that she sent several letters to the heads of state and governments of the countries concerned at different times seeking cooperation from them in bringing the murderers back home.

The PM said she raised the issue with some government leaders at international forums.

Hasina, however, said the progress in bringing the convicts back home has not been satisfactory.

Another solar farm to go online in days

Commercial operation of another solar power plant may start on June 30 on the bank of Jamuna in Sirajganj.

The "Sirajganj 68MW Solar Park," which was financed by Bangladesh and China companies, will be the 12th operational commercial solar plants in the country.

Eleven such plants now generate 536 megawatts of electricity, according to the national database of renewable energy.

When the Sirajganj plant supplies power to the national grid, the total production will be over 600 megawatts from renewable energy, said sources.

The solar park has been constructed in Soydabad area near Bangabandhu Bridge at a cost of Tk 880 crore. Bangladesh and China Renewable Energy Company Ltd (BCRECL) and North-West Power Generation Company Ltd (NWPGCL) funded the project, whose construction

work began on January 9, 2023. Following power purchase and implementation agreements, NWPGCL and China National Machinery Import and Export Corporation (CMC) started

implementing the project, Tanvir Rahman, project director of Sirajganj solar park, told The Daily Star.

A total of 1.56 lakh solar panels have

been set up to produce 68MW of power. "We have already completed construction work of the plant. Now we are working for commissioning the plant," Tanvir said.

Line commissioning and other work for the commercial operation have successfully been completed, the PD said, adding that they are hopeful of starting the commercial operation on June 30.

"We will supply power to the national grid at a cost of Tk 11.20per unit," said Tanvir.

Talking to this correspondent, Khandakar Mokammel Hossain, a member of Bangladesh Power Development Board, said the government is determined to increase solar power generation.

"We are getting only 536 megawatts of power from renewable energy sources, but we want to get a significant amount of power from this sector. So, the government is patronising solar plants," he said.

Principal secy's tenure extended

The government yesterday extended the contract of Tofazzel Hossain Miah, the principal secretary to the prime minister, by another year.

The contractual appointment will be effective from July 5, according to a gazette notification from the ministry of public administration.

The government appointed Miah on a year's contract when his regular service age expired on July 4 last year. The contract expires on July 4 this year.

Meanwhile, the government also extended the tenure of service of ABM Amin Ullah Nuri, secretary of road transport and highways division, for another year.

Nuri has been reappointed on a contractual basis in continuation of his previous contract with the government and under the same conditions from July 1 or the day of his joining the office, according to a public administration order vesterday.

In another notification, additional secretary Gautam Chandra Pal was appointed the chairman of the Bangladesh Road Transport Authority. Pal is currently serving as the personal secretary to Obaidul Quader, the minister of road transport and bridges.

Postal officials embezzled Tk 55cr: Palak STAFF CORRESPONDENT

Postal officials have embezzled Tk 55 crore from people and the department, Zunaid Ahmed Palak, state minister for posts, telecommunications, and information technology, said yesterday.

We have found that Tk 55 crore was misappropriated by postal officials nationwide, and I have already written to the ACC chairman, urging him to take action," he said.

Most of the fraudulent activities involve postal officials embezzling people's deposits without issuing official documentation for the purchase of government savings certificates.

The state minister made the remarks while speaking to reporters after a workshop jointly organised by a2i (Aspire to Innovate) platform of Information and Communication Technology Division, and the International Telecommunication Union at a city hotel.

On June 21, Bangladesh Police Service Association (BPSA) issued a statement condemning what it termed a "smear campaign orchestrated by certain media outlets" against current and former members of police.

BPSA termed some recent media reports on retired and serving police officials "ill motivated, sweeping, and exaggerated". It also requested the media to be more cautious while publishing reports on the force.

The statement came at a time when the Anti-Corruption Commission is conducting an investigation into the allegations of accumulating huge illegal wealth by former inspector general of police Benazir Ahmed and his family members.

Former Dhaka Metropolitan Police commissioner Asaduzzaman Mia also hogged the headlines recently over allegations of amassing illegal wealth.

Matiur Rahman, president of the National Board of Revenue's (NBR) Customs, Excise and VAT Appellate Tribunal, has been transferred to the Internal Resources Division of the finance ministry following a controversy over his wealth.

look for gullible Bangladeshi women, especially the ones from indigenous communities of the hill tracts, and get them to marry Chinese citizens.

"I often see parties at restaurants in Uttara where Chinese men meet women from the hill districts. Sometimes, I see them preparing marriage registration documents. Some locals are members of the gangs."

He had heard that the local arrangers get from Tk 10-Tk 20 lakh for each woman who agreed to fly to China.

The people accused in the case filed by Lovely's mother are Cui Po Wei; Ji Yixian, a woman who introduced herself to the family as Wei's sister; Abdullah Al Mamun of Bogura, Faruq and Abdul Mannan of Chuadanga; Solaiman of Kashimpur; and Hafizur Rahman Mollah, a marriage registrar from Jatrabari in the capital.

"The accused are organised human traffickers who took advantage of our helplessness... and trafficked my daughter to China for sexual exploitation and forced prostitution," reads the complaint.

The Criminal Investigation Department is investigating the case. On May 1 in Rangamati, a Chakma woman filed a case with Naniarchar

Police Station, stating that a gang of communities were brought back from traffickers held her sister captive at an unspecified place in the capital and may soon take her to China.

The complaint said the gang promised to admit the 21-year-old woman to a nursing institute and took her to Dhaka in a microbus. The gang later took indecent photos of her and forced her to marry a Chinese man.

A woman named Rika Chakma was accused in the case as the leader of the gang. Rika, who is from Khagrachhari's Dighinala upazila, lives in the capital's Uttara Sector-14. Seven named and four to five unidentified others were accused in the case.

On April 26, a 21-year-old Marma woman from Khagrachhari filed a case with Laxmichhari Police Station accusing five named and two or three unknown others of attempting to traffic her to China.

She was taken to a house in Uttara Sector-11 and was compelled to marry a Chinese man. Luckily, locals rescued her and caught three of the gang members on April 25 when the men were taking her to a government office in Khagrachhari to get a document for her passport.

DU allocates only 2.12pc for research

Dhaka University authorities yesterday approved a Tk 945.15 crore budget for the 2024-25 fiscal year, while setting aside only Tk 20.05 crore as research grants.

The research budget was approved against 2,000 teachers of the university, meaning only Tk 1 lakh has been allocated per teacher. The allocation for research grants is only 2.12 percent of the total outlay.

More than half of the budget will be spent on the salaries and pensions of teachers and staffers. There are 60 research centres

at the university. If the amount of grants is divided among them, each would get Tk 33.41 lakh for research work for a year.

Of the total outlay, around Tk 299.19 crore (31.65 percent) was allocated for salaries, Tk 218.43 crore (23.12 percent) for gratuity, and Tk 112.95 crore (11.95 percent) for pensions and retirement, according to the DU budget book. Educationists have expressed dissatisfaction over such a paltry

of Victims of Torture, the global rights group said impunity continues to prevail for police and security forces in Bangladesh, despite the country ratifying the UN Convention Against Torture in 1998 and enacting the Torture and Custodial Death (Prevention) Act 2013.

There has only been one conviction under the torture law in more than a decade. In September 2023, the Bangladesh government reported to the UN Human Rights Council that 24 cases had been filed under the 2013 torture law so far, reads the statement.

Between January 2013 and May 2024, Bangladesh rights group Ain O Salish Kendra documented 138 deaths that were allegedly caused by physical torture by law enforcement agencies.

It also documented 923 deaths in jail custody that were reported in the media during the same period, reads the statement.

'Forced into sex work'

Eight members of online racket held

The Criminal Investigation Department busted an online sex trade ring led by two medical students who forced women into prostitution under the guise of offering them lucrative jobs, modelling opportunities, and talent hunting.

The victims, including underage girls, were tricked and coerced into taking inappropriate pictures and videos, which were then shared on social media.

As such, the gang was blackmailing hundreds of young women to participate in explicit activities, CID Chief Mohammad Ali Mia said during a press briefing at the CID Headquarters vesterday.

CID arrested eight individuals in this connection, including the two medical students, from Jashore,

Satkhira, Chandpur, and the capital on Tuesday. Those who responded were added to different Telegram groups. The gang then developed relationships with these women and coerced them into taking inappropriate photos, claiming that these were needed for foreign buyers.

Under the threat of these images being leaked, the women were forced (ADC-Prosecution) to participate in explicit video calls and eventually coerced into sexual

services, the CID said. The gang members used their illegal earnings to purchase significant amounts of land and build luxurious houses in Jashore, Satkhira, Khulna, and Dhaka.

Additionally, substantial amounts of money were found in the bank accounts of their relatives, the CID chief said.

They used hundreds of mobile SIM cards, none of which were registered under their real national IDs. The gang used Telegram premium accounts and various paid cloud services for content sharing and subscriptions.

The CID seized 12 mobile phones, 20 SIM cards, one laptop, ATM cards, and chequebooks from various banks.

Around one lakh pictures and 20,000 videos were found on mobile phones and laptops of the accused.

Members of the Anti-Tobacco Parliamentary Women's Forum yesterday called for the swift passage of amendments to the Tobacco Control Act proposed by the Ministry of Health, in line with Prime Minister Sheikh Hasina's vision of a tobacco-free Bangladesh by 2040.



CONFLICT IN MYANMAR Blasts heard across Teknaf border

STAFF CORRESPONDENT, Cox's Bazar

The sound of sporadic mortar shell explosions across the border in Rakhine State of Myanmar has been heard in Teknaf and neighbouring areas in Cox's Bazar since Tuesday afternoon.

Due to this, locals have become wary in the upazila, including the areas along the Naf river.

The fighting between the Myanmar Junta and rebel Arakan Army has intensified in recent times, prompting many Rohingyas in Rakhine State to leave their homes behind to look for safety in and around Maungdaw township, said Rohingya leaders living in Cox's Bazar camps.

Many Rohingyas have gathered along the Naf river, trying to flee into Bangladesh, said border sources.

However, Border Guard Bangladesh personnel are on high alert to prevent any intrusion.

BGB men are patrolling different areas, including Chowdhurypara Transit Ghat in Teknaf town, Nightong Para, Keruntali, and Baraitili, said locals.

No one is being allowed near the border areas, they added.

Around five lakh Rohingyas live in Maungdaw township in Myanmar, in close vicinity of the warzone.

Increase agriculture budget, subsidies **Economists urge govt**

Economists have called on the government to increase subsidies and budget allocations to improve farmers' livelihoods in the proposed budget for the 2024-25 fiscal year

The new budget has reduced subsidies by Tk 272 crore compared to the current fiscal year, they said during an event

"Around 40 percent of the workers are engaged in the agriculture sector, yet the new budget gives it little attention. The prices of agricultural products and machinery have also risen due to the higher dollar rate," said Narayan Chandra Sinha, associate professor at Dhaka School of Economics.

"In this situation, without increased budget and subsidies, how can farmers boost their production?" he asked

A group of teachers and economists discussed these issues at the event organised by the Dhaka School of Economics in the capital yesterday.

Sinha also said, "In the current global situation, every country should prioritise increasing internal production.' SEE PAGE 4 COL 7

Port city grapples with frequent power cuts

Shuvechha Ghosh, a resident of Askar Dighir Par area in Chattogram city, was finding it hard to put her toddler to sleep on Tuesday night, amid severe heat alongside frequent power cuts.

"Power cuts occurred a total of eight times today, including four times since the evening. This situation has been going on over the last one week. It has become very difficult for us to stay inside in this heat with power outages occurring so many times daily. My father-in-law

and my son couldn't sleep the whole night due to discomfort," she said. Like her, many residents in the port city, including in Askar Dighir Par, Panchlaish, Bakalia, Chawk Bazar, Halishahar, Bahaddarhat, Chandgaon, Agrabad, Pahartoli, Muradpur, Katalganj, Sholoshahar, Mehedibagh, Bibir Hat and

Dampara areas, have been suffering due to frequent load shedding, occurring as many as 12 times a day in some areas. and lowest highest The

temperatures recorded in the port city were 33.1 degrees Celsius and 26.4 degrees Celsius on Tuesday, said Mahmudul Alam, officer of

Chattogram Met Office. Abdul Aziz of Panchlaish area said, "Such frequent power cuts are somehow tolerable during daytime, but at night it is unbearable. We could not sleep last night due to this amid the heat."

officials of Power The Development Board, Chattogram said they were compelled to go for load shedding due to a big discrepancy between the local demand for power and its supply.

Chattogram city has a daily demand for around 1,200 MW in peak hours and around 1,100 MW in off-peak hours during summer. It gets only 900-1,000 MW power from the national grid on average.

"Chattogram city has a daily demand for around 1,200 MW in peak hours and around 1,100 MW in off-peak hours during summer. It gets only 900-1,000 MW power from the national grid on average. As such, there is no alternative to load shedding in the present scenario," said Akbar Hossain, assistant director of PDB, Chattogram.

According to PDB sources, the power stations in the greater Chattogram region generate more power compared to the demand. On Tuesday, the 29 units of 22 power stations in the region produced 2,202 MW power, against a demand for 1,175 MW at 11:00am and 1,217 MW at 7:00pm in the port citv

However, the supply to the port city was 900 MW at 11:00am and 1,084 MW at 7:00pm.

As such, frequent load shedding happened every now and then across the city, causing sufferings to the city dwellers.

Asked, Humayun Kabir, chief engineer of PDB, Chattogram, said the power supply is controlled centrally through the national grid and they had nothing to do with it.

"We have to manage the distribution of power with what we get from the national grid. Due to the discrepancy between demand and supply, load shedding becomes unavoidable," he added.

Contacted, SM Nazer Hossain, central vice president of Consumers' Association of Bangladesh, said the government should set a criterion for distribution of power according to priority.

ATTACK ON MINORITIES 70pc incidents land related **Says Peace Observatory** report on 2013-2021

At least 10 people from the Hindu community died and 862 were injured in 3,710 incidents of violence against the country's Hindu community between January 2013 and September 2021, said a recent report of Bangladesh Peace Observatory.

The religious minorities have been facing physical, non-physical and gender-based violence, it said, adding that around 2 percent of the incidents are of gender-based violence.

Land grabbing continued to be a threat to religious minority groups during this time, irrespective of the political party in power, the report said.

Citing rights body Ain o Salish Kendra, the report mentioned that at least 26 incidents of land grabbing took place between 2013 and 2021.



AUSTRALIA A desired destination for higher education

Australia has become a popular destination for international students aiming to pursue higher education abroad. It is home to some of the most student-friendly cities in the world. According to the Australian Government's Department of Foreign Affairs and Trade, over 14,000 Bangladeshi students enrolled to study in Australia in 2023 alone - a 70 percent increase from the previous year and the highest number on record, taking 13th place in student numbers.

More than half a million international students from 192 countries choose to study in Australia for its quality education. Australian universities offer numerous scholarships to support these students. For example, Charles Sturt University offers attractive scholarship opportunities for international students. Each applicant is granted with 10 percent international student support scholarship and there is also a 25 percent international student merit scholarship available.

The Australian Government has a large scholarship programme for international students and invests some AUD 200 million per year in programmes at universities and other tertiary institutions around the country. Among Australia Awards Scholarships alumni surveyed in Bangladesh, 97 percent reported that the skills and knowledge developed through their scholarship would enable them to contribute to the development of Bangladesh. During 2023, a total of 72 Australia Awards Scholarship recipients from Bangladesh (36 women, 36 men) studied at master's degree level at Australia's world-class universities, including three people with disability. One of the most popular scholarships is the Australia Awards Scholarship, which is funded by the Australian government and provides full tuition fees, living expenses, and other allowances to recipients from eligible countries in Asia, the Pacific, the Middle East, and Africa.

Another notable scholarship is the

Australia Scholarship, Destination which provides financial support to both domestic and international students studying in regional Australia. Other scholarships available to international students in Australia include the Endeavour Scholarships and Fellowships, which provide funding for research or professional development in a range of fields, with business management and information technology being the most preferred subjects.

The country offers three intakes per year: February, July, and November, each with unique benefits and limitations. The major intakes in Australia are in February, followed by July, and finally, November.

The initial step to applying would be shortlisting universities based on the subjects one might want to pursue. Business and Information Technology are currently among the most preferred subjects for international students. Sydney and Melbourne are the popular destinations for Bangladeshi students to pursue their higher studies.

While selecting universities, it is crucial to consider their employment prospects. Among the leading Australian universities Charles Sturt University is considered one of the best for graduate employment. Around 90 percent of its undergraduates secure full-time jobs within four months of graduating. Moreover, the average earning of Charles Sturt University graduates is AUD 64,100 per year.

An aspiring admission seeker should prepare a statement of purpose, letters of recommendation, and academic transcripts as per the requirement of the specific university, standardised test scores (GRE, GMAT, SAT if necessary) and proof of English proficiency. The new migration policy

of Australia has renewed visa policies to increase the minimum score

requirements and the score requirement for a student visa from 5.5 to 6.0. Highlighting the interests and relevant experiences in the required essays can complement previous academic

performance and increase one's chances of getting into their desired programmes. Once accepted, students should start preparing the necessary documents for their visa application. To start the application, one needs to provide the letter of offer and confirmation of enrolment they received from the university upon acceptance. Genuine Student requirement consists of an array of information, including the details of a student's current circumstances, ties to family, community, employment and economic circumstances, reasons behind applying to Australian universities, history of study in Australia (if any) and other relevant information for screening.

To meet the requirements for a student visa, one must provide proof of financial savings required to cover the costs and expenses associated. International student visa applicants must provide proof of at least AUD 29,710. provide International students also need to have Overseas Student Health Cover (OSHC) for the duration of their stay. They may also need

to undergo a health examination to meet the student visa health requirement. There are also certain character requirements that an international student must meet before coming to study in Australia. In some cases, a student may also need to provide a police background check.

After preparing these documents, a student needs to open an ImmiAccount. The best part of this seemingly complicated process is that a student can also take a professional guidance and advice from any registered expert under any particular university.

The two things international students need the most are information and research. If you are armed with these two, you are ready to dive into this new exciting chapter of studying in Australia.

SPY CHARGES **Russia starts** trial for WSJ reporter

A shaven-headed Evan Gershkovich went on trial behind closed doors vesterday in a Russian court where the US journalist is facing accusations of espionage.

Prosecutors say the Wall Street Journal (WSJ) reporter gathered secret information on the orders of the US Central Intelligence Agency about a company that manufactures tanks for Russia's war in Ukraine. If convicted, he faces a sentence of up to 20 years.

Gershkovich, his newspaper and the US government all reject the allegations and say that he was just doing his job as a reporter accredited by Russia's Foreign Ministry to work there.

"His case is not about evidence, procedural norms, or the rule of law. It is about the Kremlin using American citizens to achieve its political objectives," the US embassy in Moscow said in a statement, calling for Gershkovich's immediate release.

PROTESTS IN KENYA President backs down on tax rises

Kenya's president yesterday withdrew planned tax rises, bowing to pressure from protesters who had stormed parliament, launched demonstrations across the country and threatened more action this week.

William Ruto said he would not sign a finance bill including the hikes a day after violent clashes between police and protesters at the assembly and nationwide left at least 23 people dead and scores wounded, according to medics.

"Listening keenly to the people of Kenya who have said loudly that they want nothing to do with this finance bill 2024, I concede. And therefore, I will not sign the 2024 finance bill, and it shall subsequently be withdrawn," he said in a televised address.

'There are no safe centimetres left in Gaza'

UN aid worker narrates trauma of desperate civilians

AFP, Geneva

A UN humanitarian worker described the suffering she witnessed first-hand in Gaza, where she saw children mutilated and families bombed out of their homes, in an emotional testimony Tuesday.

Speaking to journalists in Geneva following a three-month stint in the territory, Yasmina Guerda of the UN humanitarian agency OCHA described the desperation from the viewpoint of civilians under the Israeli military's assault.

"You have 10-15 minutes to evacuate your building because it's going to be bombed. Your little kids are sleeping... You wake them up," she said. "You take one last look at your room and say a permanent goodbye, because you know it will be dust."

As horrifying as that sounds, she stressed that this is the "best-case scenario", since many others are not warned before an attack.

Heavy rainfall triggered landslides and flash floods in Nepal, killing at least 11

US seeks deeper ties with Maldives Blinken tells his Maldivian

US Secretary of State Antony Blinken met with his counterpart from the Maldives on Tuesday and said Washington sought a deeper partnership with the Indian Ocean island state and stood with it in ensuring a free-and-open Indo-Pacific region and in dealing with climate change.

Maldives Foreign Minister Moosa Zameer's Washington visit comes two months after the party of President Mohamed Muizzu won a landslide in elections. Muizzu has pivoted ties towards China and away from India, a key US regional partner in standing up to China in the Indo-Pacific.

The US opened an embassy in Male in 2023 to boost engagement with the low-lying archipelago of about half a million people in the face of China's efforts to spread its regional influence.

After the April election, Washington said ties were being strengthened in areas including economic development, education, security cooperation, and climate-crisis response.

"For us, the Maldives is an important partner, and we want to make sure that we're a good partner to the Maldives," Blinken told Zameer. "We stand together in working to make sure that we have a free and open Indo-Pacific region," he

"While each of us has different views on the particulars of various economic policies, we all agree that Joe Biden's economic agenda is vastly superior to Donald Trump," the economists state in their letter.

She wished Assange, who turns 53 on July 3, an early happy birthday as she released him due to time already served in a British jail.

Speaking to The Daily Star, an officer involved in the search and arrest, said the four managed to make a hole in the ceiling using only a small screwdriver and an iron-sheet scrap for 20 days.

During this time, they did not allow any cleaners into their cell, he said, adding that police found the screwdriver and the iron scrap hidden about their person.

About how they may have gotten the tools, Additional Inspector General (Prisons) Col Sheikh Sujaur Rahman, who visited Bogura Jail yesterday, said, "We're currently investigating all the jail personnel and officers here to know if they had any role to play. Once the probe is complete, appropriate actions will be taken."

SP Sudip Kumar Bogura Chakraborty yesterday told reporters that the four inmates managed to escape at 3:05am. "The jail authorities informed us at 3:56am.

"After getting the information, all police outposts and patrol teams were put on high alert, and police managed to find and arrest them from the Chashi Bazar area around 4:30am.'



Sub-inspector Khorshed Alam, who led the search, said, "They were planning to cross the Korotoa river through Chelopara bridge.'

However, before police could reach the spot, the four convicts were initially apprehended by a group of young men.

Describing the incident, Parimal Chandra Das, councillor of Bogura Municipality Ward-6, told The Daily Star, "Around 3:50am, a group of boys were sitting on the rail tracks near Chashi Bazar, as there was no electricity in their homes and it was very hot last night. Suddenly, they noticed a pack of dogs surrounding four individuals. The boys - Saeed, Rabbi, Kabya, Dukhu, Nayan, Tinku and Bappi – suspected that the four men were criminals and apprehended them then and there. They then called SI Khorshed Alam and informed him.'

Police sources said Nazrul Islam and Amir Hamza were sentenced to death on February 16, 2021. Farid Sheikh received the death penalty on July 10, 2023, and Zakaria, son of Kahaloo upazila mayor and upazila BNP's acting president Abdul Mannan, was sentenced to death on January 15, 2017.

Combined, the four had five murder cases and seven other cases on various charges against them, filed at different times in separate districts. They were also brought to Bogura jail at different times, but sent to the condemned cell together on June 1.

Bogura Deputy Commissioner Saiful Islam told The Daily Star that a six-member probe committee, led by the additional district magistrate, has been formed. He also requested the jail authorities to place six more security posts in front of and behind the jail building.

About the jail's vulnerable security system, Additional IG Col Sujaur told this correspondent, "The jail was built in 1833. The security came

into question only today [yesterday] after the incident. We will check the system.

Speaking to The Daily (Investigation) Star. Inspector Shahinuzzaman Shaheen, of Bogura Sadar Police Station, said a case was filed yesterday afternoon against the four for escaping.

Bogura Sadar Outpost Inspector Sujan Mia, the investigating officer of the case, told this correspondent that the four were produced before a court and then sent back to jail. "We're thinking about whether they can legally be remanded as they are already death row convicts."

Meanwhile, Bogura jail authorities last night took action against eight prison guards who were on duty during the incident.

Speaking to The Daily Star, Jail Super Anwar Hossain said, "Three prison guards were dismissed while a departmental case was recommended against three others and a showcause notice was issued to the other two. Further measures will be taken according to the recommendations from higher authorities."

He, however, did not name the guards.

The price we pay for processed rice

Govt must formulate clear guidelines on rice processing

It is a truth universally acknowledged by now that laws and directives in Bangladesh are meant to be broken. It is no surprise, then, that millers across the country have been defying a 2023 ban on polishing rice and selling it under fake names, such as the popular variety "miniket." This processed rice comes at a steep cost: compromised nutrition, wasted resources, and potentially inflated prices.

The allure of miniket lies in its polished appearance, a characteristic achieved by removing layers of the rice bran, which is rich in essential nutrients: iron, calcium, and B vitamins. Studies reveal that excessive polishing strips rice of up to 70 percent of its zinc content, a crucial mineral for immune function and growth. Furthermore, this excessive polishing leads to significant rice wastage. Experts estimate that 16 lakh tonnes of rice are lost annually due to over-polishing. This not only impacts national food security, but also contributes to potentially higher rice prices for consumers. Alarmingly, as per a recent study by the International Food Policy Research Institute (IFPRI), over 30 percent of the rice sold in city markets in Bangladesh is refined into a different shape, size, and colour and branded as miniket.

While we laud the government for recognising the harmful impact of over-processing rice, we are at a loss to understand why the ban is yet to be implemented. There are as many as 4,000 automatic rice mills across the country, according to Bangladesh Auto Major and Husking Mills Owners Association (BAMHMOA). Millers say there are no clear guidelines on what an acceptable limit of processing rice is, while food controllers, who should be implementing the ban, say they have received no instructions from the government or high officials on what steps to take. This inaction, which not only undermines the law but also jeopardises the health of Bangladeshi citizens, is simply unacceptable.

The solution lies in swift and decisive action. The government must expedite the issuing of clear rice polishing guidelines, establishing acceptable limits, and outlining enforcement mechanisms. Rice millers also have a role to play here. They must embrace responsible practices and prioritise the wellbeing of the nation over short-term profit gains. Additionally, public awareness campaigns are crucial to educate consumers about the misleading nature of the miniket label. It is truly mind-boggling that we are allowing our staple to be stripped of its nutrients under the ignorant belief that white, processed rice is better than nutrient-filled coarse rice, and even paying a steeper price for it!

Don't ignore startups in the budget

They need govt support now more than ever

When the country is struggling with a number of economic challenges, it is not unexpected that the government would propose conservative measures in the new budget to stem e outflow of money. However, it does not explain wh measures would be proposed for startups-a key sector that can give our economy the push it so desperately needs right now. According to a report in this daily, the government not only has no plan to offer relief to the startups in these trying times, but it actually plans to discontinue the existing benefits. According to the report, startups in Bangladesh have already been feeling the bite of a declining fund flow. Investment plummeted 70 percent quarter-on-quarter in January-March this year due to the ongoing global funding downturn; compared to the same period last year, the decline is even steeper at 82 percent. Under the circumstances, the government is looking to suspend the existing benefits and impose more duties. The finance minister recently announced that investors and developers at the hi-tech parks would no longer be given the 10-year tax waiver on their earnings come the next fiscal year. Moreover, in government hi-tech parks, a one percent duty will be imposed on capital machinery imports. Meanwhile, the government has not addressed any of the concerns and demands raised by the startups. For example, the demand from e-commerce and logistic startups for the withdrawal of the 15 percent VAT on parcel delivery and five percent VAT on online product sales have not been met in the proposed budget. These decisions are truly puzzling, especially when we consider the consequences. Industry insiders said withdrawal of the tax waiver would surely hinder the growth of the hitech parks as investors-particularly the foreign ones-may get discouraged when they are no longer allowed the benefits. And imposing additional duties will push the cost of doing business upward for the startups. We urge the government to see reason and facilitate the growth of startups, instead of stunting it by employing growth-averse policies. Given the current fund crunch, it could arrange for soft loans on easy terms for startups. It must also come up with incentives that would draw in more investors for the sector. In order to create a smart economy and realise the vision of a smart country, we must smoothen the way for the startups, not create obstacles for them.



Economists online that some level of informality is expected in a growing economy like Bangladesh, where an effective business governance system and procedures are yet to be established. There are several reasons for the widespread informality in the country. Studies have suggested that the ineffectiveness of public services like registration, licensing and tax processing of businesses are among the main reasons. On the other hand, lack of clear incentives to formalise, limited understanding of the process of formalisation, and limited employment opportunities are other impediments.

The consequences of the high informality are severe: low tax to GDP ratio, widening inequality, stagnant industrial competitiveness in sectors other than ready-made garment (RMG) and low labour productivity, and low product and service quality. Informality also hinders the potential of the industrial sector to participate and benefit from growing international value chains and export market opportunities. These are extremely critical as Bangladesh prepares to graduate from LDC status and enters the global market on the basis of competitiveness and productivity. While the prioritisation of

formalisation in the Industrial Policy 2023 is a welcome step, there is a dearth of studies on the potential positive impact of formalisation and Bangladesh's capacity to formalise to inform policymaking. Furthering the formalisation agenda is imperative for the country if it is to achieve the ambition of economic diversification and modernisation of the private sector to become competitive globally. The implementation of the policy requires an integrated effort from the whole of the government, the private sector, and workers' organisations. The success of ongoing labour sector and social protection reforms are also key to addressing informality.

The informal sector, which comprises cottage, micro-, small and medium enterprises, not only operates closest to local communities, but plays a crucial role in creating local jobs, especially for women and youth in Bangladesh. As we commemorate the Micro-, Small and Medium-sized Enterprises Day today, we recognise that it is a vital sector at the heart of our societies with tremendous potential to accelerate decent job creation and achievement of the SDG goals.

To fully harness its potential, a transition to formalisation is necessary to ensure that the millions of workers in the sector do not end up like Bilaldestitute after a fully productive working life.

While fiscal and monetary policy implications system around 2020-2022. The exchange of the FY2024-25 budget are easy to untangle, one needs to drill down deeper to decipher the true stance and direction of trade policy, as immersed in the budget.

As a trade economist, a focus on the government's articulation of trade policy under the rubric of annual budgets has been my raison d'etre for a post-budget column for the past several years. This time is no exception. But it took on greater importance this time in light of the fact that the economy is faced with a number of critical challenges that deserve immediate attention. Regrettably, trade policy has often not been on the radar.

It is fair to say that the domestic side of the equation has been adroitly addressed through a combination of fiscal restraint and a constricted fiscal deficit to complement the inflation-reduction stance of the monetary policy already under way. On the external side, restoring stability in the balance of payments was partly addressed in the weeks preceding the budget presentation by moving to a flexible exchange rate regime-the crawling peg-along with a modest depreciation of the taka on top of the massive depreciation macroeconomic stability, both internal and already enacted over the previous 18 months. external, in order to move forward on a path All eyes have been glued to the one salient macroeconomic indicator of external stability: official foreign exchange reserves.

reserves was the move by the central bank to

rate became significantly overvalued making exports uncompetitive. One indication of this overvaluation was the appreciation of the Real Effective Exchange Rate (REER), a measure of export competitiveness, by over 50 percent compared to 2011.

In FY2022, the dam broke, as it were, and Bangladesh Bank could not avoid letting the exchange rate depreciate a massive 30 percent during 2023, and another six percent in a pre-budget adjustment in May 2024. Such a significant one-time depreciationrather than gradual depreciation over several years-is disruptive and causes a shock to various parts of the economy. The shockinflation, depleting forex reserves, import curbs, balance of payments volatility-had to be mollified with bold measures to restore macroeconomic stability. Unfortunately, for the economy, those measures came late in the day, only in the last three to six months, with the finishing touches to be expected from the FY2025 budget. Indeed, there is a hint that this might be in the offing as the finance minister's budget speech highlights the formulation of National Tariff Policy 2023, which, if implemented in whole or in part, could open the doors for export diversification, enhance product competitiveness, and rationalise tariffs for reducing anti-export bias and ensuring balanced development of import substituting industries. As no implementation programme for NTP 2023 was noticeable in the budget speech, perhaps the programme will be undertaken subsequently, as media reports suggest. If anything, tariff rationalisation was modest as Regulatory Duty (RD) and Supplementary Duty (SD) were withdrawn from 110 tariff lines. The surprising element was the reduction of SD on 172 RMG tariff lines, from 45 percent to 30 percent. Why not completely eliminate SD on RMG imports? Do we really need protective tariff for RMG when we are the second largest apparel exporters in the world? The budget also lays down some feeble tariff rationalisation measures in light of the impending LDC graduation when what was needed was aggressive action. For instance, as 90 percent of SD are applied for protection purposes (higher rates on imports, lower or nil SD on domestic production), this could run afoul of WTO compliance. Though we can hope for some "due restraint" supply, approaching a fixed exchange rate emerges from the high tariff protection on the part of WTO members following second orientation of trade policy? Moreover,

My reading of the support measures seems to suggest that the preferred policy is geared to the former dispensation. Although export-oriented sectors are also on the radar, the budget seems to focus on promoting several import substituting industries with protection support-raising output tariffs and lowering input tariffs-in a classic demonstration of raising effective protection and, thereby, discouraging exports of the same products via anti-export incentive bias. This is where history of trade and development diverges. The first strand of trade policy, by focusing on the domestic market, has never given growth rates of seven to eight percent on a sustained basis anywhere in the world. There is no historical or cross-country evidence of this happening. No matter how large the domestic market is, it is no match to the size and scale of the world market. It is the second strand of trade policy that has the potential to generate seven, eight, nine percent or even higher growth rates by harnessing the demand of the massive global market. China, Vietnam and several other East Asian countries are classic examples of turning around poor economies into highgrowth, high-income economies within a few decades. Should Bangladesh not opt for the

a cliffhanger on November 24, 2026-the date for graduation out of the LDC status. A crisis always presents opportunities to be seized. In 1990, when the economy faced a macroeconomic and balance-of-payment crisis, the country's policymakers chose to go for radical trade policy reforms, investment liberalisation, and market-oriented reforms. These reforms, though ostensibly incomplete, still gave the impetus for two decades of rapid growth and poverty reduction. Given that the economy is once again faced with heightened degree of macroeconomic and balance-ofpayment challenges, and LDC graduation is imminent, one would be looking for another round of structural reforms at least in the long overdue trade and tax policy arenas in order to restore macroeconomic and balance of-payment stability and resume its long-run rapid growth path. With regard to a medium-term development strategy, the budget may not be the end game. There are signs of change in trade policy directions, but our hope was for more clarity and aggression in moving forward with change. Maybe that part of the agenda for action has been left for postbudget activities. It is important to recognise that trade has been the handmaiden of Bangladesh's development. It will remain so for the next decade and beyond. So, adopting the most dynamic trade policy for future progress is a national imperative now.

The persistence of anti-export bias

Assange is free, but justice has not been done

Julian Assange is free. As of this writing, he is en route to Australia from the Northern Mariana Islands, a remote US territory in the western Pacific, after finalising a plea deal with the US government which will see him sentenced to time served in Belmarsh Prison. Importantly, according to experts I've seen commenting on this astonishing new development, it doesn't appear that his plea deal will set any new legal precedents that will be harmful to journalists going forward. Joe Lauria reports the following for Consortium News:

"Bruce Afran, a US constitutional lawyer, told Consortium News that a plea deal does not create a legal precedent. Therefore Assange's deal would not jeopardise journalists in the future of being prosecuted for accepting and publishing classified information from a source because of Assange's agreeing to such a charge."

I've obviously got a lot of big feels about all this, having followed this important case

so closely for so long and having put so much work into writing about it. There's so very, very much work to be done in our collective struggle to liberate the world from the talons of the imperial murder machine, but I am overjoyed for Assange and his family, and it feels good to mark a solid win in this fight.

None of this undoes the unforgivable evils the empire inflicted in its persecution of Julian Assange, however, or reverses the worldwide damage that has been done by making a public example of him to show what happens to a journalist who tells inconvenient truths about the world's most powerful government.

So while Assange may be free, we cannot rightly say that justice has been done.

guaranteeing that Washington could never again use its globe-spanning power and influence to destroy the life of a foreign journalist for reporting inconvenient facts about it, and issuing a formal apology to Julian Assange and his family.

Justice would look like the arrest and prosecution of the people whose war crimes Assange exposed, and the arrest and prosecution of everyone who helped ruin his life for exposing those crimes. This would include a whole host of government operatives and officials across numerous countries, and multiple US presidents.

Justice would look like a hero's welcome and a hero's honours from Australia upon his arrival, and a serious revision of Canberra's obsequious relationship with Washington.

Justice would look like formal apologies to Assange and his family from the editorial boards of all the mainstream press outlets that manufactured consent for his vicious persecution-including and especially The Guardian-and the complete destruction of the reputations of every unscrupulous "presstitute" who helped smear him over the years.

If these things happened, then we could perhaps argue that justice has been served to some extent. As it stands, all we have is the cessation of one single act of depravity by an empire. We all still live under a globe-spanning power structure which has shown the entire world that it will destroy your life if you expose its criminality, and then stand back and proudly call this justice.

So, I personally think I'm just going to take this one small victory in stride. There is still so much to do, and vanishingly little time to do it. The fight goes on.

'BEGUM'S BLUNDER' shines in Wilde splendour

Begum's Blunder is a clever adaptation of Oscar Wilde's Lady Windermere's Fan. The play transports the Victorian setting to the imaginary Behrampur, the heyday of the Nawabs in India. With Naila Azad Nupur's direction, and Sadaf Saaz working her behindthe-scenes magic as the producer, the production by Kaleidoscope projects lights on the prism of Wilde's 1892 play to find their contemporary refractions and reflections in colonial India.

The play reminds the Dhaka audience that the gossip-mongering Victorian upper class, with their deceitful moral stance, is no different from their own. Human behaviours are uncannily the same across time and space, making Wilde our contemporary. The proximity is further heightened by the choice of location and the ambience created for the staging. The immersive theatrical experience, which was performed at Aloki in the upscale part of town before a select upper-class audience, has a fourth wall effect. The cabaretstyle seating at the venue became an extension of the stage where the main action takes place.

The characters join the birthday party of the protagonist, Begum Mumtaz Nizamuddin (i.e., Lady Windermere), through the aisle that divides the audience. The herald announces their names, and the characters enter the stage, interacting





with the audience, who, in turn, have become extensions of the attendees. The set design and choreography provide a backdrop against which the drama unfolds. The immediate intimacy between the audience and the characters highlights the central theme of the play: the manipulation of appearances to navigate societal expectations. The plot pivots around a disgraced character, Amirun Nahar Khatun (i.e., Mrs. Erlynne), who is trying to buy her way into her former society through deceptions. Almost all of the characters in the play are unaware of her motives. This irony serves as a piston that propels the narrative story forward.

The play more of less retains the original dialogue, with changes primarily in the names of characters and places. It would be almost sacrilegious for any script writer to try to tweak Wilde's texts. Wilde's crunchy dialogues often feel like nuts in a nutrient bar that mixes love with betrayal and righteousness with common sense under the masks we wear in society. Naila Azad was smart to leave Wilde's words alone, as they have the reputation of being an omnibus of quotable quotes. However, the to authenticate its adapted location. The most notable aspect of the play is the professionalism displayed by a group of brilliant amateur performers. Their superb acting and almost flawless enunciation have given the play its elan. The cast delivers their lines with a finesse that captures the cultural and contextual nuances of Wilde's play. The transition between scenes is seamless. a testament to the hard work that has gone into its making.

The producer Sadaf Saaz mentions that Kaleidoscope, a BHN Experiences venture created with Jatrik and with support from Asiatic EXP, is a multidimensional platform that wants to elevate the experience of theatre, the arts, and more. Jatrik, responsible for organising massive events such as Dhaka Lit Fest, has always strived to create a creative space that nurtures local talents. Begum's Blunder's actors come from a diverse range of backgrounds, and it was the director's brilliance that brought out the best in the characters by highlighting their uniqueness and peculiarities as part of the drama's overall effect. Jatrik will stage the play for seven more shows at the Mohila Samity in the coming weeks. The grandiose immersive effect that Aloki offered in its premier show is likely to be missed at the other venue. Nevertheless, kudos to Kaleidoscope for bringing Oscar Wilde's wit and wisdom to the Dhaka stage, as well as for offering a delightful evening of theatre that is both thought-provoking and entertaining.

It's hard not to recall our many conversations about literature as I try to summarise Shah Tazrian Ashrafi's debut collection of short stories. They were always short discussions, opening and closing off in spurts, as happens over text. Exclamations over a new essay collection by Zadie Smith, or a new novel by Isabel Allende.

As an undergraduate student, he majored in International Relations at BUP, but it's his growth as an artist that's been so fulfilling to witness. In 2021, he worked on his short stories under Karan Mahajan in the Write Beyond Borders mentorship programme; in 2023, he was mentored by Sonia Faleiro in the South Asia Speaks fellowship programme. Between working on his debut book and publishing fiction and nonfiction in Himal South Asian, The Diplomat, Caravan, TRT World, The Aleph Review, Six Seasons Review, Dhaka Tribune, and The Daily *Star*, Tazrian also got accepted into the MFA in Creative Writing Program at UW Madison, due to start in Fall 2024.

The Hippo Girl and Other Stories (Hachette, 2024) plays with all those themes that have percolated in his essays and reviews over the years. The book stays often in the shadows of war, but illustrates moments of humour, friendship, and bravery between characters who are seldom on the upper end of a hierarchy. We hear from a dog who watches his human suffer through the Liberation War, a housemaid who must abandon her mentally ill sister in the calm streets of a fictionalised Baridhara. The textures of life in Bangladesh appear as they are in this collection, sans nostalgia or elitist gloss. It's a rare joy to recognise our familiar streets, customs, histories, and relationships depicted with such loving attention to detail in a book that will reach readers across South Asia.

What inspired these stories? Were you drawing ideas or information from any particular sources?

Gappah and Jamil Jan Kochai's short stories. > We move through different classes in your book, from slums and working class families to diplomatic residential areas. But in all cases, we're focusing on the outliers in each of these spaces-the bullied, the marginalised. What are your stories trying to accomplish through these gazes?

> By giving the outliers the centre stage, I wanted to establish that some people are outliers in a society because of their helpless circumstances. My intention was to explore how certain factors intimidate and ridicule them and further consolidate their marginalised positions, as if to say they (the outliers) do not deserve a shot at life and redemption.

favourite thing about the book-is your choice of narrators. Nearly every narrator in the book comes with a distinct personality, they have their biases, their joys and resentments, even when you're writing a third person omniscient narrator. Some of the more fascinating narrators appear when you write in the first person collective. Tell me about your choice of narrators (the adults, the children, the animals). How did you want them to shape the stories you were telling? And how did you develop their voices?

I had a lot of fun writing in the first-person collective voice. I have always wanted to do that ever since I read NoViolet Bulawayo's story, "Hitting Budapest". I enjoy the limitless fluidity that this mode of narration gives me.

Writing in this as well as other modes of narration, one thing I hoped to accomplish was to give my narration a blend of humour, cynicism, and unreliability with generous doses of unforgiving observations. For example, my narrator in "Brother" was not only someone who constantly groaned about the Pakistani military's occupation, but he was also someone who derived small joys from playing hide and seek with his friends and seeing the physical altercation between two women. I wanted him to be a character who, despite living in gloomy conditions, is in touch with his typical teenage characteristics from before the war. Like him, I wanted my other characters throughout the book to be defined by a myriad of other things besides their cruel fates. Some of them love reading, some love writing, some are academic high achievers, some refuse to let go of their intrinsic generosity even in the face of harshest conditions, and so on.

Assange back home as a free man

WikiLeaks founder Julian Assange landed to an ecstatic welcome in Australia yesterday after pleading guilty to violating US espionage law in a deal that sets him free from a 14year legal battle.

Assange disembarked from a private jet at Canberra airport just after 7:30 pm (0930 GMT), waving to waiting media and cheering supporters before passionately kissing his wife, Stella, and lifting her off the ground.

He embraced his father before entering the terminal building with his legal team.

Assange has not spoken publicly since being released and did not appear at a Wikileaks press conference at a hotel in Canberra, where Stella Assange said it was too soon to say what her husband would do next.

"Julian needs time to recover, to get used to freedom," she said. "I want Julian to have that space to rediscover that freedom."

A team of detectives from Dhaka yesterday arrested two men suspected of being involved in the murder of Jhenaidah-4 lawmaker Anwarul Azim Anar.

Faisal and Mustafiz were arrested in Khagrachhari where they had been masquerading as devotees at a remote Kali Temple for 23 days, said Harun Or Rashid, additional commissioner (Detective Branch) of Dhaka Metropolitan Police.

60 Palestinians killed as Israeli forces pound Gaza

Israeli forces pounded several areas in north and south Gaza yesterday, and residents reported fierce fighting between Israeli troops and Hamas fighters in Rafah in the south of the Palestinian enclave.

Residents said fighting intensified in the Tel Al-Sultan neighbourhood in western Rafah, where tanks were also trying to force their way north amid heavy clashes. The armed wings of Hamas and the Islamic Jihad said fighters attacked Israeli forces with anti-tank rockets and mortar bombs.

Since early May, ground fighting has focused on Rafah, abutting Egypt on Gaza's southern edge, where around half of the enclave's 2.3 million people had been sheltering after fleeing other areas. Most have since had to flee again.

Beit Lahiya, an Israeli air strike destroyed a house, killing four Palestinians and wounding several others, medics said.

The health ministry in Hamasrun Gaza said yesterday that at least 37,718 people have been killed during more than eight months of offensive. The toll includes at least 60 deaths over the past 24 hours, a ministry statement said.

More than eight months into the Erdogan said yestersday that

Delhi for early democratic transition in Myanmar Says Jaishankar

India's foreign minister said he voiced concern about the impact of continuing violence in Myanmar in a meeting with his counterpart from the Southeast Asian nation yesterday.

Myanmar plunged into turmoil after a 2021 military coup seized power from an elected government, sparking a protest movement that has evolved into a full-blown civil war, in which the military has lost control of large swathes of territory.

India has maintained its relationship with the ruling junta, even as armed resistance to the military has expanded, and it has an infrastructure project in Myanmar's western Rakhine state where heavy fighting has raged in recent months.

Indian Foreign Minister Subrahmanyam Jaishankar said he sought a commitment to protecting India's ongoing projects in Myanmar in the meeting with counterpart Than Swe.


