#### Iran warns Israel of 'obliterating' war

Iran yesterday warned that "all Resistance Fronts", a grouping of Iran and its regional allies, would confront Israel if it attacks Lebanon.

The comment from Iran's mission to New York comes with fears of a wider regional war involving Israel and Lebanon's Iran-backed Hezbollah movement. The two sides have engaged in near-daily exchanges of fire since the offensive on Gaza began.

In a post on social media platform X, the Iranian mission said it "deems as psychological warfare the Zionist regime's propaganda about intending to attack Lebanon".

But, it added, "should it embark on full-scale military aggression, an obliterating war will ensue. All options, incl. the full involvement of all Resistance Fronts, are on the

#### **US** military destroys seven drones, vehicle in Yemen

American forces destroyed seven drones and a control station vehicle in Houthi-controlled areas of Yemen over 24 hours, the US military said Friday.

The strikes were carried out because the drones and the vehicle "presented an imminent threat to US coalition forces, and merchant vessels in the region," the US Central Command said in a statement on social media platform X.

The Iran-backed Houthis have been targeting vessels in the Red Sea and Gulf of Aden since November 2023.

Friday, Houthi military spokesperson Yahya Saree claimed responsibility for attacks on four vessels, including a "direct hit" on the Delonix tanker in the Red Sea after an operation involving a number of ballistic missiles.

# Thousands displaced as Israel pummels north Gaza

Explosions, air strikes and gunfire rattled northern Gaza yesterday, the third day of an Israeli military operation that has uprooted tens of thousands of Palestinians and compounded what the UN called "unbearable" living conditions in the territory.

An AFP correspondent reported ongoing explosions from the Shujaiya area near Gaza City, with a resident saying bodies were visible on the streets.

Israel's military yesterday said its operations were continuing in Shujaiya where fighting "above and below the ground" left a "large number" of Hamas fighters dead.

A resurgence of fighting in the area comes months after Israel had declared the command structure of Hamas dismantled in northern Gaza.

Last Sunday Israeli Prime Minister Benjamin Netanyahu said the "intense phase" of the offensive was winding down after almost nine months, but experts see

a potentially prolonged next phase.

Israel's offensive has killed at least 37,834 people, also mostly civilians, according to data from the health ministry in Hamas-run Gaza. It reported at least 69 deaths over the previous 48

Mohammed Harara, 30, said he and his family, young and old, felt as though they would become part of that toll.

He said they fled from their home in Shujaiya with nothing, "due to the bombardment by Israeli planes, tanks and drones" that they barely survived.

"We couldn't carry anything from the

house. We left the food, flour, canned goods, mattresses, and blankets," Harara said.

Israel's military on Friday said it was conducting "targeted raids" backed by air strikes against Hamas in the Shujaiya area.

The United Nations humanitarian agency OCHA estimated that "about 60,000 to 80,000 people were displaced" from the area this week.

AFPTV images yesterday showed men moving belongings on a donkey cart. Some people were pushed in wheelchairs. Children walked with backpacks past piles of dusty debris.

"I saw a tank in front of the Shuhada mosque firing" at targets, said Abdelkareem al-Mamluk. "There were martyrs in the street."

Elsewhere in the coastal territory, the civil defence agency yesterday said four bodies were pulled from an apartment after an Israeli strike in the central region.

### Far right scents power as France braces for polls

A divided France braced for high-stakes parliamentary elections that could see the antiimmigrant and eurosceptic party of Marine Le Pen sweep to power in a historic first.

The candidates ended their frantic three-week campaigns at midnight Friday, with political activity banned until the first round of voting

Yesterday, voting began in France's overseas territories that span the globe, with residents of the tiny archipelago of Saint Pierre and Miquelon, located off the coast of Canada, casting their ballots from 1000 GMT.

They will be followed by voters in France's islands in the Caribbean and the South American territory of French Guiana. Voting will later start in territories in the Pacific and then in the Indian Ocean before it gets underway on the mainland

Most polls show that Le Pen's far-right National Rally (RN) is on course to win the largest number of seats in the 577-member National Assembly, parliament's lower house, although it remains unclear if the party will secure an outright

#### **UK GENERAL ELECTION** Sunak slams racist slur by Farage party campaigner

British Prime Minister Rishi Sunak said on Friday evening he was hurt and angry that a supporter of Nigel Farage's right-wing Reform UK party had been recorded making a racial slur about him, saying it was too important for him not to speak out.

Britain's first ethnic-minority prime minister, Sunak was responding to comments broadcast by Channel 4 News, by a man named as Andrew Parker calling Sunak a "\*\*\*king Paki" - a British racial slur for people of South Asian descent.

Sunak, currently campaigning for a July 4 national election that his Conservative Party is tipped to lose after 14 years in power, was born in the southern English port city of Southampton to Hindu parents of Punjabi Indian descent.

"My two daughters have to see and hear Reform people who campaign for Nigel Farage calling me an effing Paki. It hurts and it makes me angry, and I think he has some questions to answer," Sunak told reporters. "I don't repeat those words lightly, I do so deliberately because this is too important not to call out clearly for what it is," he added.

## Panama court acquits 28 in 'Panama Papers' trial

A Panamanian court on Friday acquitted 28 people charged with money laundering in connection with the now-defunct law firm Mossack Fonseca, the epicenter of the "Panama Papers" international tax evasion scandal.

Among those acquitted were the firm's founders, Jurgen Mossack and Ramon Fonseca, the latter of whom died in May in a Panamanian hospital. During the trial, which was held in

Panama City in April, the prosecution asked for 12 years in prison for the duo, the maximum sentence for money laundering.

However, Judge Baloisa Marquinez

acquitted the pair and 26 others after football star Lionel Messi, Argentina's finding that evidence taken from the law firm's servers had not been gathered in line with due process, raising doubts about its "authenticity and integrity," a court statement said.

The judge also ruled that "the rest of the evidence was not sufficient and conclusive to determine the criminal responsibility of the defendants," the court statement said.

Leaked documents from Mossack Fonseca in 2016 revealed how many of the world's wealthy stashed assets in offshore companies, triggering scores of investigations around the globe.

British premier David Cameron, Russian President Vladimir Putin,

then-president Mauricio Macri and Spanish filmmaker Pedro Almodovar, to name but a few.

Panamanian prosecutors had alleged that Mossack and Fonseca helped create opaque companies in which executives of the German multinational Siemens deposited millions of euros outside the company's official accounts.
