Talks on Chinese loan proposals will be at the fore during Prime Minister Sheikh Hasina's upcoming visit to Beijing.

During her visit, Bangladesh may seek around \$5 billion in budget support in addition to loans for a number of large projects, said a finance ministry official on condition of anonymity.

While visiting Bangladesh in October

2016, Chinese President Xi Jinping promised about \$20 billion -- the largest amount committed by a bilateral partner of Bangladesh -- over the following four years to implement 27 projects.

Bangladesh is again expecting Chinese financing at a time when it is facing pressure to maintain adequate foreign currency reserves.

Hasina's is likely to be in China on July 8-11.

Seeking anonymity, a top official of

the Economic Relations Division (ERD) said they have received proposals for large projects from different ministries which suggest taking loans.

The government has been in talks with China about the projects. However, nothing has been finalised yet, the official said.

One of the projects under consideration for Chinese funding is the construction of a broad-gauge rail line from Bhanga to Kuakata via Barishal and Payra Port. It

is estimated to cost about \$5 billion. Another project

under consideration is the MRT Line-2, Gabtoli from Narayanganj to via Gulistan with branch line from Gulistan to

Sadarghat.

The underground and elevated metro rail is estimated to cost around \$5 billion. Besides, Bangladesh has already sought more than 36 billion yuan, equivalent to \$5 billion, as soft loans from China for

# **Two S Alam firms evaded** Tk 3,500cr in VAT: NBR

With penalty, they owe govt Tk 7,000cr; S Alam Group official says they didn't 'evade even a single taka in VAT'

S Alam Vegetable Oil Ltd and S Alam Super Edible Oil Ltd have unpaid value added tax (VAT) and consequent penalty worth over Tk 7,000 crore, as they allegedly evaded VAT through various means, including by presenting lower purchase and sales data in VAT returns between 2019 and 2022, according to an audit by the NBR's VAT wing.

During the period, the two companies "evaded" Tk 3,538 crore in VAT, for which they were fined another TK 3,531 crore, the audit report says.

The audit was carried out by the field office of Customs, Excise & VAT Commissionerate. Chattogram, and was subsequently reviewed by a five-member committee headed by an

Commissionerate, which drew the same conclusion.

Of the amount, S Alam Vegetable Oil Ltd allegedly evaded Tk 1,917 crore and S Alam Super Edible Oil Ltd Tk 1,621 crore in three years from the financial years 2019-20 to 2021-22, according to the audit report submitted in October 2023 and the subsequent review report submitted in May 2024.

The two companies denied any wrongdoing. The regulator came up with the unpaid VAT claims after analysing the VAT returns and the financial statements audited by the two companies' CA firm as well as their written response to the VAT Commissionerate.

The field office audit team submitted its report on October 2 last year. Later, the field office formed a five-member committee to SEE PAGE 2 COL 1

# Cybercriminals breach NBR server again

Use login credentials of customs official in a bid to get container of cigarettes released at Ctg port

A "cybercriminal gang" attempted to release a container of cigarettes from Chattogram Port after breaching the server of the National Board of Revenue with the login credentials of a customs official

Acting on a tip-off, customs officials seized the container loaded with 50 lakh sticks of Mond cigarettes, worth about Tk 5 crore, at the port on Thursday, hours after a ship carrying the container reached the port.

The breach of the server came to light on Saturday after the officials launched an investigation into the incident. They found that Hamko Corporation Limited imported the cigarettes by providing false declaration and fake LC (letter of credit) documents.

The "gang" used the login ID of Mohammad Zakaria, deputy commissioner of Chattogram Customs Hous

# **8YRS OF HOLEY ARTISAN ATTACK** Militants turning to apps to draw new recruits

With the so-called Islamic State trying to regroup in Syria and beyond, Neo JMB, a Bangladeshi ISinspired group, is becoming active again.

Since June last year, at least 315 people accused of militancy have been released on bail, and around 70 of them are suspected Neo JMB members, said officers of the Counter Terrorism and Transnational Crime (CTTC) unit of Dhaka Metropolitan Police.

Many of these suspects who know how to make bombs and have combat training are now a cause for concern, they added.

## **US PRESIDENTIAL RACE Top Democrats** rule out replacing Biden

Top Democrats yesterday ruled out the possibility of replacing President Joe Biden as the Democratic nominee after a feeble debate performance and called on party members to focus instead on the consequences of a second Donald Trump presidency.

After days of hand-wringing about Biden and outcome of November 5 election, Democrat leaders firmly

their party to choose a younger presidential candidate. Biden, 81, was huddling with family members at the Camp David presidential retreat, with his political future a likely topic of discussion.

But the drumbeat of calls for Biden to step aside continued, and a postdebate CBS poll showed a 10-point jump in the number of Democrats who believe Biden should not be running for president, to 46 percent from 36 percent in February.

## Diesel, kerosene prices lowered by Tk 1 Petrol, octane prices unchanged

The government has reduced diesel and kerosene prices by Tk 1 per litre while keeping petrol and octane prices unchanged at Tk 127 and Tk 131, respectively, for the month of July.

The new price will be effective from July 1 (12:00am), said a gazette of the Ministry of Power, Energy and Mineral Resources.

As per the gazette, the prices of diesel and kerosene were set at Tk 106.75 a litre, which was Tk 107.75 in June.

The government has been adjusting local fuel prices in parallel with the international market since March this year.

On February 29, the Bangladesh Petroleum Corporation (BPC) issued a notification on Automatic Fuel Oil Pricing Guidelines.

According to the notification, the prices of all petroleum fuels - petrol, diesel, octane, kerosene, furnace oil, jet fuel, and marine fuels - will be set automatically based on the international market price.

In May, the government hiked diesel price by Tk 1 per litre, and petrol and octane prices by Tk 2.50 per litre.

In April, the price of diesel and kerosine was reduced by Tk 2.25 per litre but the petrol and octane remained unchanged.

In the first adjustment of March, diesel and kerosene prices decreased by Tk 0.75, Octane dropped by Tk 4 and petrol by Tk 3.

review the audit findings. The review report, submitted in May 21, said the "VAT dodging allegations have been proven beyond doubt.

On June 9, the Customs, VAT & Excise Commissionerate, Chattogram, in its adjudication orders asked the companies to pay the "evaded VAT" worth Tk 3,538 crore along with the penalty to the tune of Tk 3,531 crore and applicable interest to the state coffers within 15 working days.

The deadline ends on July 3 and if the companies do not appeal against the order, the regulator will "take steps to realise the evaded VAT, penalty and interest as per the law," NBR officials said.

S Alam Group Executive Director (Finance) Subrata Kumar Bhowmik told The Daily Star on June 27 that they did not "evade even a single taka of VAT" and that they will appeal the decision.

The two sister concerns of the business conglomerate have 90 days to appeal by paying 20 percent (over Tk 700 crore) of the VAT claim.

Md Mustafizur Rahman, S Alam Group's company lawyer, told The Daily Star on June 29 that before they file any appeal, they are seeking an in-person hearing with the VAT authorities to present their full response and the relevant documents that the regulator

The amount is Tk 8,100.39 crore less than that shown in the company's own financial statement.

"It is clear from the comparative analysis of its audited financial statements and VAT returns that in order to evade VAT, soybean and palm oil was sold after producing the item with ingredients procured from local sources or collected by any other means," the report says.

"In the company report audited by a CA firm, there is information of sales without processing ingredients (CDSO [Crude Degummed Soybean Oil] and RBD palm olein).

"It is clear from data that Tk 8,100.39 crore worth of raw materials have been procured locally against which the company failed to submit any VAT chalan or Bill of Entry.'

During the period, 7.5 percent VAT rate was applicable on such local purchase, and as such "the total amount of unpaid VAT is Tk 607.52 crore, which is collectable from the firm.'

As for the other company -- S Alam Super Edible Oil Ltd -- its raw material procurement value was shown Tk 11,171.42 crore during the three years, but the VAT returns and other related documents submitted by the company to the VAT authorities put the purchase had sought during the audit and review. value at Tk 5,206.53 crore.

companies and asked them to appear in a hearing on October 30, 2023. In the hearing, both companies submitted a written response and sought more time for a detailed written reply.

office The Commissionerate allowed time extension for both companies three times since, and the companies submitted its written response on December 28 last year, seeking withdrawal of the charges after a review.

#### 'PROVEN BEYOND DOUBT'

Following the written submission by the two companies and their appeal for a review of the unpaid WAT claims, the Customs, Excise & VAT Commissionerate formed a fivemember committee, which submitted its report on May 21 this year after examining the audit report by the field office and other related documents as well as the response submitted by the two firms.

"All things considered and having analysed everything, it is clear that the allegations of VAT evasion worth Tk 1,917.39 crore by S Alam Vegetable Oil has been proven beyond doubt," the review report says, drawing the same conclusion about S Alam Super Edible Oil whose total unpaid VAT is Tk 1.621.92 crore.

#### **RESPONSE TO REVIEW TEAM**

Both companies in their written response to the VAT authorities said the allegation of VAT dodging and

the "market demand is much lower than the sales value presented" in their financial reports. They also maintain that the findings by the NBR's VAT wing that

they procured raw materials from local sources is "incorrect". "Because, all the raw materials to

produce edible oil is import-based. As such, no raw materials have been procured locally. So the demand for

VAT at source is not right."

**'CRIMINAL OFFENCE'** The VAT authorities' review report says that purchases and sales data of any firm should be the same in all its commercial documents submitted to regulators, bank, income tax and VAT authorities. This means, it is a legal obligation on the part of the firm concerned that its purchase and sales data presented to VAT office, income tax office, banks and in the financial reports audited by CA firms should all be the same.

"It is clear from analysis of the written response from the firm that the said entity concealed information of actual sales/procurement and VAT at source," the review team said in case of both the companies.

Also, the company authorities "did not provide any proof/documents to support their written response" although they were requested and sales as well. "But some of these sales granted opportunities more than once eventually did not take place, and we to submit proofs against their claim. returned the money to the buyers who

#### **RESPONSE TO THE DAILY STAR**

S Alam Group company lawyer Mustafizur Rahman said, "The VAT auditors had legal obligations to inspect the factory to assess the sales records and hear us out. But they reached the decision without doing any of these. That is why there has been a misunderstanding. It is solely because we were not given the opportunity to be heard. They would have gotten a clearer picture if they heard us.

He admitted that the VAT authorities communicated with them several times in writing during the audit and review and allowed them time to offer their explanations in personal hearing and in writing.

"But that was not enough. They gave us way less time than what we sought. It was not sufficient for us to prepare all the documents that date back to 2019 and a detailed response in a matter as serious involving such a huge VAT claim," he told The Daily Star on June 29.

About the discrepancies in sales records presented in their financial statements and the VAT returns, he said the financial reports audited by their CA firm contained advance

trade facility.

At present, Bangladesh has about \$22 billion trade deficit with China. Once received, the \$5 billion policy loan will help the country ease the ongoing pressure on foreign currency reserves.

The ERD official said they were in alks with China regarding the policy loan and that a deal could be signed during Hasina's visit.

Although China had promised to lend about \$20 billion in 2016, as of January this year, the two sides managed to sign agreements on only nine projects, involving \$8.08 billion, figures from the RD show.

Of the \$8.08 billion, Bangladesh could utilise only \$4.91 billion, less than a quarter of the money promised by China.

Red-tape on both sides is largely to blame for the slow loan disbursements, said officials and experts.

The ERD official said this time, loan agreements are expected to be signed under a model different from the one used after 2016.

After China promised the \$20 billion, agreements were signed on a project-by project basis.

This time, officials are expecting that the loan agreements would be signed during Hasina's visit.

Speaking to The Daily Star, Zahid Hussain, a former lead economist at the World Bank's Dhaka office, said what the Chinese president had announced was a promise.

He thinks that red-tape on both sides has been responsible for the slow progress and low fund disbursements. Kazi Shofiqul Azam, a former secretary to the ERD, said there were bottlenecks on both sides, causing delays in loan-deal finalisation and implementation. "The countries need to follow a number of formalities, and they are timeconsuming sometimes. This has been the main reason behind the delays a project face ..

allow us adequate time, we will be able to convince them that their unpaid VAT claims against us do not reflect the reality," he said, adding that they applied for a full hearing on June 6, three days before the VAT authorities asked them to pay the unpaid VAT, but were not allowed the opportunity. FIELD OFFICE AUDIT FINDINGS

The VAT office came up with the findings by comparing the sales data given in the VAT returns and the annual financial statements from 2019-20 to 2021-22 that the companies submitted to the income tax office in the port city.

In its report on S Alam Vegetable Oil Ltd, the VAT Commissionerate said the company showed "deflated sales in its VAT returns" than that in its annual reports, audited by a Chartered Accountancy (CA) firm, submitted to the tax authorities by the company itself.

"As per the audited reports from the financial years 2019-20 to 2021-22, total sales of the company were Tk 12,725.95 crore. On the other hand, the reported sales by the organisation in the VAT returns during the period were Tk 2,401.92 crore," the report says.

This means, the company did not present sales worth Tk 10,324 crore in the VAT returns. By concealing actual sales in VAT returns, the organisation did not pay VAT amounting to Tk 1.346.61 crore during the period which is realisable," it says, citing the 15 percent VAT rate on sales of edible oil applicable at the time.

The other company -- S Alam Super Edible Oil Ltd -- did the same, but only on a different scale, the audit found.

During the same period, this company's "sales value in its audited financial statement was Tk 12,850.48 crore. But in the VAT return, the figure was Tk 3,620.63 crore, which is Tk 9,229.84 crore less than that presented in the audited financial report," the report says.

Besides, both companies "evaded" revenue by showing lower value of raw material purchase in VAT returns than that reported in their annual reports during the three financial years.

For example, S Alam Vegetable Oil Ltd in its financial statement showed "purchase value of raw materials worth Tk 11,245 crore during those three years. But the VAT returns and other related documents submitted by the company to the VAT authorities show the purchase of raw materials was

chalan or Bill of Entry," the report says, adding that the total amount of unpaid VAT in this case was Tk 447.36 crore. TheCustoms, VATCommissionerate. Chattogram, also compared the procurement data of goods and services provided in the annual financial statements and VAT returns in the years from 2019-20 to 2021-22 and found that "S Alam Vegetable Oil paid lower VAT at source, known as VAT Deducted at Source (VDS), than the required amount against its

purchase during the period." The company's unpaid revenue against VDS on goods and services, on which 5 percent to 15 percent VAT is applicable, was Tk 5.63 crore in those

three years, the report says. During the same period, S Alam Super Edible Oil had unpaid revenue against VDS worth Tk 1.78 crore.

The Commissionerate report on both the companies says "these sorts of activities of the organisations are a clear violation" of 10 sections of the VAT and Supplementary Duty Act 2012, and six Rules of VAT and Supplementary Duty Rules 2016.

The field office of the NBR also slapped a penalty of Tk 1,911 crore and Tk 1,620 crore on S Alam Vegetable Oil and S Alam Super Edible Oil respectively for "non-compliance" of VAT rules.

"Legal steps can be taken to realise the evaded VAT against the company under sections 85 and 111 of the VAT and Supplementary Duty Act 2012," the report says about both firms.

During its audit, the field office sought explanations from the

"We have been carrying out business by paying all sorts of applicable VAT as per laws and regulations," the two companies said in an identical response.

"Every year, we deposit crores of taka in revenue to the state coffers. But bank loans are needed to operate this large company. We have been carrying out business and producing goods with bank loans. For availing bank loans, we have to show excess transactions which is why excess sales and purchase of raw materials have been shown in the financial reports audited by the CA firm," read both the letters.

"Excess sales value has been presented in the audited reports by the CA firm to get loans from banks. But [VAT] returns have been filed as per the actual sales and VAT has been paid accordingly."

The two companies also said it was "not even possible to produce the goods shown in their audited financial statements with the raw materials that were imported from 2019-20 to 2021-22."

"If import and input-output coefficient and imported raw materials data are analysed, it will be clear that the sales data shown in the annual reports audited by our CA firm is not correct. Rather, the sales data presented in the returns and the amount of VAT paid against the sales are correct," both companies said.

Further, they informed that "the machinery and workforce of the respective companies also do not have the capacity to produce the goods shown in the audited report" and that

team made such requests in writing to the companies, the review report says.

"They claim that in order to avail loans from banks, they prepared the report by incorporating inflated purchase and sales data. If this is true, they have clearly committed a criminal offence.

"On the other hand, the audit firm that has prepared this report has demonstrated professional dishonesty and aided the accused firm to commit a criminal offence," the review report says, again about both firms.

The related bank has also "acted very unprofessionally" if it sanctioned loans based on an "imaginary and untrue" financial statement, it added.

"To accept such claims by an accused firm will be to patronise its criminal activities, which no government agency can do.

"The related income tax circle has determined tax liabilities of the firm based on the audited financial reports submitted by the firms. It has no relations with bank loans. So the claim that the report has been prepared to get bank loans cannot be acceptable."

Howladar Yunus & Co, which audited the financial statements of these two companies for two of the three years in question, said they were the "auditor of the companies, not preparer of the accounts."

"Our mandate was to audit the accounts along with notes to the accounts prepared by the management. We followed the international auditing standards to conduct the audit and concluding our audit opinion. The question of cooperating with anybody

were not delivered the goods. We did not conceal anything. We have bank documents showing that we returned the money."

Regarding the VAT authorities' findings that the two companies sourced certain volumes of goods from the local market and "dodged relevant VAT" in the process, he said, "The goods in question are not available in local markets, they can only be imported. And the VAT authorities' own report says that they found our import data correct. So the claim that we procured raw materials from local markets is based on assumption."

#### 'LAME EXCUSE'

Mushfequr Rahman, Syed commissioner at Customs, Excise & VAT Commissionerate, Chattogram, said they allowed the two companies "multiple opportunities for hearing" which are minutely recorded in the adjudication order.

On the June 6 appeal by the two companies for a fresh hearing, he said they already appeared for hearing and made their submissions during the audit.

"Later, we formed a committee to examine their submissions. Based on the committee reports, we asked them to appear before the hearing twice but they failed. Then when we issued the order, they sent another letter for hearing which couldn't be entertained. All these details are recorded in my adjudication order."

On the question of sales figure, he said sales are final figures as per their own audited annual reports.

"We didn't create any figures. Based on their audited reports, they have paid the income tax, but failed to show the same in VAT returns. If any refunds were made to buyers, how come it was not reflected in their financial statements audited by their CA firms? This is an absolutely lame excuse," he told The Daily Star on June 29.

On the question of sourcing raw materials, the commissioner said companies are supposed to import the raw materials.

"But they can be procured locally from other manufacturers, which is the only plausible explanation for the higher sales volumes in their financial statements compared to their imports. That is why, we have imposed VAT that is due to be deducted by the two S Alam companies at source while buying from local sellers.

### STATUS OF 27 PROJECTS

Twenty-seven projects were supposed to be funded with the \$20 billion initial commitment. Of those, two projects have been struck off the list.

the Two projects digital connectivity project of Bangladesh Telecommunication Company Ltd (BTCL) and the Info Sarker-3 of the Bangladesh Computer Council involving \$388 million have been implemented.

Seven other projects received \$7.7 billion and their implementation is ongoing.

The Karnaphuli Tunnel, built under a \$707 million project, has been opened to traffic.

The \$550 million Single Point Mooring with a double pipeline project and the \$2.67 billion Padma rail link project are nearing completion.

The expansion and strengthening of the power system network (\$1.4 billion), the power grid network project (\$977 million), the Dhaka-Ashulia elevated expressway project (\$1.12 billion), and Rajshahi Wasa surface water treatment plant project (\$276.25 million) -- are in various stages of implementation.

The loan applications have been sent for two projects. The loan agreement for the establishment of digital connectivity involving \$473.75 million is likely to be signed this year.

Negotiations for commercial contracts to convert the Akhaura-Sylhet rail line to dual-gauge from metre gauge, involving \$1.3 billion, and expansion and modernisation of Mongla port, costing \$354 million, were underway.

# **Final justice yet** to be delivered

Although eight years have passed since the horrific militant attack on the Holey Artisan Bakery in Dhaka's Gulshan, justice is yet to be finalised for the families of the victims

The High Court bench of Justice Shahidul Karim and Justice Md Mostafizur Rahman on October 30, 2023, delivered a verdict in the case filed over the attack, commuting the death sentences of seven militants to jail sentences until their deaths.

But the HC bench is yet to release the full text of the judgement, which is needed to move any appeal before the Supreme Court.

The judges are now writing the judgement of the Holey Artisan attack case.

According to court sources, it cannot be specifically said when the full text of the verdict will be

released and when appeals will be moved, heard and disposed of before the apex court.

Ariful Islam, a defence lawyer for the convicts, told The Daily Star on June 29 that his clients wanted to move their challenge appeals. But they have not been able to do so as the full text is yet to be released, he said.

Contacted, Attorney General AM Amin Uddin said the state will decide, after receiving the full text of the judgement, whether any appeal will be moved before the Appellate Division seeking enhancement of the convicts' sentences.

On July 1, 2016, five militants with firearms, machetes, and grenades stormed the bakery and held the diners hostage before killing three Bangladeshis, seven Japanese people, nine Italians, and one Indian.

# Metro fares won't go up from today

Despite the NBR not extending the VAT exemption on metro rail fares, the metro rail authorities have decided not to increase fares from today.

The Metro authorities said they are yet to receive a reply from NBR regarding their appeal seeking a review of the revenue authority's decision to impose 15 percent VAT from Monday.

We are waiting for their [NBR] reply... We have to talk to them about some technical issues even if we have to impose VAT on fare," MAN Siddique, managing director of Dhaka Mass Transit Company Ltd (DMTCL), told The Daily Star.

Another DMTCL official, wishing not to be named, said even if DMTCL decides to impose VAT, they would not increase metro rail fares without giving a prior announcement.

The Higher Secondary Certificate and its equivalent exams began nationwide yesterday, except in Sylhet division, where exams were postponed until July 8 due to severe flooding.

The government made this decision on June 20, in response to the ongoing flood impacting the region. Exams scheduled from July 9 onwards in Sylhet will continue as planned.

On the opening day, nearly 10,000 students from nine general education boards remained absent, according to the Secondary and Higher Secondary division of the education ministry.

Exams are being conducted with a reduced syllabus, a measure that was implemented during Covid-19 pandemic and continued for 2021-2023 academic years.

# Padma Bridge project now complete

# PM to formally conclude muchtalked-about project July 5

The Padma Multipurpose Bridge Project came to an end yesterday, around 17 years after it was taken in August 2007, giving great relief to tens of thousands of users daily.

Although Padma Bridge, the largest bridge in the country with roadway on the top and railway on the bottom, was inaugurated in June 2022, some works, including river training, remained incomplete then.

So, the authority extended the deadline up to June 30 this year, with a one-year defect liability period.

"Yes, the much-talked-about project is going to be completed today," Project Director Shafiqul Islam told The Daily Star yesterday. Prime Minister Sheikh Hasina will formally conclude the project through a programme at Mawa end of the bridge on July 5, he said.



When the project was taken in August 2007, the cost of the project was Tk 10,161 crore and it was supposed to be implemented with foreign loan.

The project went through a major revision in January 2011, when the rail line was incorporated into the bridge, bringing the project cost to Tk 20,507 crore.

The project went through several revisions afterwards and the cost rose to Tk 32,605 crore. However, some Tk 1600 crore may not be required, Shafiqul said, adding that the cost of the project would be around Tk 31,000 crore.

The cancellation of World Bank loan, changes in bridge design and the pandemic shrouded uncertainty over the long-cherished project but the project was completed with the government's funds, directly connecting the capital with the southwestern region.

## Mother dies in road crash while taking deceased son home for burial

# ASP sent to forced retirement over

An assistant superintendent of police has been sent to forced retirement after allegations of misconduct and corruption were proven against him, according to a circular signed by Md Jahangir Alam, secretary of the Public Security Division under the home ministry.

The circular said Yakub Hossain, ASP of the Bangladesh Police Academy in Sarda, Rajshahi, formed a team in 2019 with the intention of making financial gains.

The other members of the team included former sub-inspector Jiban Biswas, constables Al Amin and Abdus Sabur, driver Samiul, and runner constable Anik.

According to the circular, on January 19, 2019, Jiban, Al Amin, and Sabur entered the house of a ward councillor in Kushtia. They handcuffed two individuals, Ashraf Hossain and Shamim Reza, who were present at the time, and beat them up under the pretence of criminal allegations. They had to pay Tk 1 lakh to the ASP's team through a mobile financial service agent for their release.

Ashraf and Shamim then filed a complaint, leading to the investigation that found ASP Yakub guilty.



# Matiur's wife seeks withdrawal of travel ban

Laila Kaniz Lucky, wife of former member of National Board of Revenue Matiur Rahman, yesterday applied to a Dhaka court to withdraw a travel ban imposed on her for alleged corruption.

The same court on June 24 issued a travel ban on her, her husband and their son Ahmed Taufiqur Rahman Arnob.

Laila, also upazila parishad chairman of Narsingdi's Raipura, in her application, said she is suffering from different ailments, including heart disease, for which she has taken treatment from India, Canada, USA and Dubai. The application said the travel ban needs to be lifted as

she requires regular check-ups in those countries. ACC Public Prosecutor Mir Ahmed Ali Salam opposed it

saying that she will flee if the court allows her to go abroad. Judge Mohammed Ash-Shams Joglul Hossain of the Metropolitan Senior Special Judge's Court of Dhaka set July 27 for a hearing on the issue. On June 24, the ACC placed an application to the

court and said Matiur, also former president of the NBR's Customs, Excise and VAT Appellate Tribunal, and his family members were trying to leave the country, so a travel ban should be needed to prevent them for going abroad.

Moreover, they are also trying to launder money abroad, it said.

Earlier, the ACC formed a three-member committee to probe into the allegations brought against them over amassing a huge amount of wealth through illegal means.

The controversy regarding Matiur's wealth surfaced after his son Mushfiqur Rahman Ifat posted a photo of a sacrificial goat on social media and claimed to have bought it for Tk 12 lakh.

The process is incredibly demanding – we're talking about potentially watching over 1,000 hours of content. I've learned to be efficient, dropping projects that don't meet the mark early on. It's about balancing quantity with quality of assessment. Given my background, I pay special attention to the screenplay but I strive

to consider all aspects - cinematography, direction, acting - to give a holistic evaluation.

How do you maintain objectivity in your critiques when you have personal preferences as an audience?

It's a delicate balance. Previously, film critics afraid to explore new territories. The capital-

conflicts of interest, but this is changing. Personal tastes inevitably play a role - I prefer fantasy and horror and usually avoid the crime genre. But as a critic, it's crucial to step back and evaluate each work on its comprehensive market research to understand own merits. I believe in specialised criticism; experts in cinematography, for instance, can offer deeper insights. If critics evaluate films based on their expertise, we can elevate cinema. and diversify the role of

film critics. We cannot survive wearing only one hat in the evolving media landscape; we must

wear multiple hats. The key is acknowledging our biases while striving for a comprehensive assessment.


You've worked with major Hollywood studios. Any standout experiences?

The relentless pace in Hollywood makes it hard to dwell on any single project. I'd say working on To the Bone was a highlight. It's currently on Netflix, starring Keanu Reeves. Interestingly,

my least favourite project also starred Reeves *Siberia*, which I haven't brought myself to watch vet.

Bangladesh's OTT platforms are buzzing with content, but there seems to be a lack of diversity in storytelling. What's your take on the current state of Bangladeshi cinema?

> How do you view the representation of women in Bangladeshi cinema, both onscreen and behind the scenes?

It's a complex issue. Globally, there's a rise in femaleled projects, but Bangladesh is lagging. Even acclaimed films like Rehana Maryam sometimes Noor receive underwhelming audience reception. Ironically, films with misogynistic themes often perform better, even with female viewers. It's disheartening, but producing quality, progressive content may gradually shift audience preferences.

What advice would you give to aspiring filmmakers and critics in Bangladesh? Do your research. Analyse films, understand the grammar of screenwriting, and then make it your own. No one's born a genius - it takes consistent hard work, expert feedback, and constructive criticism to improve. Remember, cinema is for the audience. And please, avoid shortcuts.

According to the report, Mismanagement by government authorities and local recruiting agents led to over 3,000 workers failing to reach Malaysia before the deadline of May 31.

Bangladesh Association of International Recruiting Agencies (Baira) initially estimated that 3,000 to 4,000 Bangladeshi workers could not reach the Southeast Asian country within the deadline, set by Kuala Lumpur in early March.

On May 31, several hundred workers waited for hours at the Hazrat Shahjalal International Airport to catch flights. Many of them went there without tickets after receiving assurances from local recruiters that they would be given tickets on time, the report added.

Prof Habibur Rahman, president of the Rajshahi University Teachers' Association, said, "Our demand is based on the fact that those who join as teachers in July will face problems in the future. We've clarified our stance by holding a press conference during the movement. But the government did not respond to our demands."

Earlier, FBUTA, citing a recently published gazette, said teachers who will be appointed in public universities from July 1 will fall under the new pension scheme instead of the current pension facilities offered by the universities.

# Hospital generators to run out of fuel in 48 hrs

Warns Gaza health ministry as much of electricity infrastructure decimated by Israeli attacks

Gaza's few functional hospitals and health facilities could lose power in 48 hours if they don't receive fuel, causing life-saving medical equipment to stop working. "We appeal to all relevant, international and humanitarian institutions to intervene quickly to bring in the necessary fuel," the Hamas-run health ministry

said in a statement. With much of Gaza's electricity infrastructure decimated by Israeli attacks,

hospitals are largely dependent on generators, powered by fuel, for life-saving operations. Recurring fuel shortages have frequently caused hospitals to go dark, putting patients' lives at serious risk.

Meanwhile, explosions, air strikes and gunfire rattled northern and southern Gaza esterday, the fourth day of an Israeli military operation that has uprooted tens of thousands of Palestinians. Mohammed Harara, 30, who cited the Palestinian embassy in Cairo.

**Russia downs** 36 Ukrainelaunched drones

Russia's air defence systems destroyed 36 drones that Ukraine launched overnight targeting several regions in Russia's southwest, the Russian defence ministry said vesterday.

Fifteen drones were destroyed over the Kursk region that borders Ukraine and nine over the Lipetsk region, several hundred kilometres south of Moscow, the defence ministry said on the Telegram messaging app.

Four drones were destroyed each over the Voronezh and Bryansk regions in southwestern Russia and two each over the nearby Oryol and Belgorod regions.

The governors of the Lipetsk and Bryansk regions said on their Telegram channels that there were no injuries or extensive damage as a result of the attacks, reports Reuters.

Kyiv has said attacks on Russia's military, transport and energy infrastructure are in response to Moscow's attacks on Ukraine's territory since the start of Russia's invasion of Ukraine in 2022.

Meanwhile, Russia yesterday also claimed two more east Ukrainian villages as its forces have had the upper hand over Kyiv on the battlefield for months. Moscow has claimed new villages in the east

of Ukraine regularly for weeks, as outgunned and outmanned Ukrainian forces struggle to hold them back.

Some of these groups have over 500 members or followers, who are possibly looking for an opportunity to stage a subversive act, they add.

"Our research suggests that only 10 percent of the militants on bail have been deradicalised ... The militants on bail are supposed to appear at the respective police stations every month. We do not have the capacity to monitor each of them, but we are trying our best," says CTTC chief Asaduzzaman.

to register the consignment with the NBR server, said customs officials involved in

the investigation. However, the importer and Zakaria denied their involvement in the incident. Chattogram House Commissioner Mohammad Fyzur Rahman has sent a primary report on the breach of the server to the NBR chairman with a recommendation that an investigation committee consisting of IT experts be formed to identify the

"cybercriminal gang". The report said cigarettes were imported from Thailand with a declaration of importing water purifiers. The consignment was registered with the server at 11:45pm on May 20 by using the ID of Zakaria. The data on the consignment was accessed again by the same user at midnight on May 21 to complete the clearing process. According to officials, an authorised individual can

access the NBR server only from a specific IP address. Once the individual uses his user ID to log into the server, an OTP (one time password) is sent his mobile phone for verification. This is done to restrict any unauthorised access to the server.

However, in this particular case, the "gang" accessed the server from a different IP

addresses and no OTP was sent to the mobile phone of the official concerned, said investigators.

Commissioner Mohammad Fyzur Rahman said, "The NBR had taken some steps after a large numbers of consignments were cleared from the port by using the IDs of customs officials to evade tax. Use of the particular IP and sending OTP to mobile phone are among those.

"After the latest incident of breaching the server, it seems that those measures are not enough," he told The Daily Star.

Mamunor Rahman, manager (supply) of Hamco Corporation, told The Daily Star, "We are not sure who used our company's name to import the consignment of cigarettes. We have requested the customs officials to probe the incident to identify the culprits."

The use of the login credentials of customs officials to release imported goods is not a new phenomenon.

Over the last three years, at least 38 imported consignments of goods were released illegally by using the IDs of at least eight revenue officials.

Commissioner Customs Fyzur said, "I hope if an investigation committee consisting of experts is formed in this regard, we will get the real picture."

## Provision granting amnesty for black money holders is a disgrace

We condemn the parliament's decision to once again approve a provision allowing black money holders to legalise undisclosed wealth without any scrutiny by paying a 15 percent tax, despite protests over the past few weeks. The provision is set to come into effect from July 1. While the country's highest income tax rate stands at 25 percent, allowing black money holders-many of them accumulating their wealth through corrupt means-to legalise it at a much reduced rate is truly befuddling. Experts, anti-graft watchdogs and even some lawmakers had strongly opposed the move which would send a wrong message to both individuals amassing black money and honest taxpayers.

The message is simple: the law is set in such a way that it favours black money holders over honest taxpayers. The former will no doubt be encouraged by it. And when those who earn their money legally are made to pay higher taxes compared to those who do so illegally, why should they, too, not try to game the system? Because the Awami League government has regularised this budget provision over the years, citing scenarios that defy logic, honest taxpayers (belonging to the higher tax slabs) may be forgiven for thinking they would be better off by not filing regular taxes, and making use of this provision later to pay a reduced tax. When laws are designed to create such discrepancies and encourage immoralities, it is not difficult to understand the moral standards of those arguing for these laws.

Given how widespread corruption has become in the country, the provision would come as a huge relief for the corrupt. They would be assured to know that despite massive public outcries, many in key positions are still willing to bend the rules in their favour. Not only that, they are even willing to undermine Article 20(2) of the constitution to do so. Except in 2020-21 (during Covid-19), the amount of black money whitened through this process has been a drop in the ocean compared to the estimated size of our black economy. The data clearly debunks the government's narrative that providing such a facility is going to bring significant amounts of black money into the mainstream. But even if it did, why would lawmakers accept money made from drug dealing, human trafficking, or other criminal activities being legalised under a special provision in the first place?

Having provided this facility repeatedly, has the government succeeded in reducing the size of the shadow economy? Has it improved its tax system or revenue collection as advertised? Has it managed to reduce corruption and strengthen rule of law? The answer to all these questions is a resounding "No". The government should, therefore, immediately withdraw the provision, and make sure black money holders-particularly those involved with criminal and corrupt activities-are held to account.

# A monument to systemic negligence

## Chattogram testing lab remains inoperative even after nine years

It is disheartening that Chattogram's Modern Food Testing Laboratory-a Tk 34.4 crore project funded by the Asian Development Bank-has remained non-operational despite its completion in 2015. The facility, intended to enhance food afety, began trial testing in January 2016. However, according to a report by this daily, the lack of a signing authority has rendered its results useless, as no official certifications of food safety can be made. This is a glaring testament to the systemic negligence and inefficiency that so often stymie the functionality of government facilities. The laboratory, divided into two sections, is equipped to test a wide range of food items including milk, meat, vegetables, edible oil, etc. It's a pity that such an important and expensive facility would sit idle year after year just because no one in the administration cared to provide the support necessary to make it fully operational. Normally, the first order of business in any such project would be appointing an appropriate signing authority, since no actionable steps can be taken without one regardless of how dire its findings. The second priority would be having adequate and properly motivated manpower. Reportedly, out of the 24 officials initially appointed in the laboratory, only seven remain due to delays in regularising their jobs. So the question is, why would these basic issues remain unresolved even after nine years, and despite receiving operational approval in as far back as 2016? Unfortunately, we have seen too many cases of vital technical or medical projects languishing after completion of construction to consider the Chattogram case as an isolated one. In fact, the government has a rather unenviable reputation when it comes to operationalising such public-interest initiatives. Among the issues that new projects usually suffer from are staff shortages, lack of equipment, lack of power supply, coordination issues among the relevant institutions, etc.-all of which can be attributed to bureaucratic inertia and mismanagement. The gap between the completion of projects and their actual operationalisation can be overwhelming. We, therefore, urge the government to remove all barriers to the seamless operation of the food testing laboratory in Chattogram so that it can serve its intended purpose. As well as the problems mentioned above, another issue delaying its operation is that the Chattogram City Corporation has yet to assume control of the lab despite this transition being scheduled post-2021. All this should be addressed urgently.

The report mentions that better methodology and tools such as the Integrated Primary Education Information Management System (IPEIMS) may have helped to correct past data biases, and that the improved tools as well as verification through post-enumeration check should be applied to maintain data quality. These are reasonable advice and deserve serious attention to come out with reliable educational input data regarding students, teachers, and institutions.

These are based more on general discourse on education equity, quality and inclusion issues, rather than extracted specifically from the census findings. They include: targeted interventions to engage all primary school-going children more effectively in education; expanding access to pre-primary education for equitable participation across genders; strengthening special needs education

with improved resources and teacher training; community engagement; and professional development

opportunities for teachers. These are sound general advice with which few would disagree. But how can these be acted upon with practical strategies, plans, and actions? Along with the input data from the APSC (which needs to be more inclusive and accurate), we also need to have reliable and inclusive outcome information in the form of learning achievements of students, derived from practical learning assessment tools.

In fact, the National Student Assessment exercise that takes place periodically (roughly every two years) since 2011 can be seen as such an revealed that almost half of the students children should not continue.

So, should we not be concerned in Classes 3 and 5 had below gradelevel competencies in Bangla, and only a third of the students achieved expected grade-level competencies in mathematics. Periodic assessment of learning and annual reporting on inputs have not been undertaken systematically at the secondary level, which is under the jurisdiction of a different ministry. But available evidence suggests that learning outcomes at secondary level could not be any better. A reason, it may be plausibly argued, is that poor foundational learning of children at primary level has knock-on effects on later stages of education.

A pragmatic, relatively simple and easily implementable assessment of learning known as Annual State of Education Report (ASER) has been pioneered in India by the NGO Pratham, and replicated in Pakistan, Nepal and a number of African countries. An NSA or ASER model, with adaptation as necessary, developed and applied systematically to school education can be a way to better understand the interplay of learning inputs and learning results. Thus, policy and action can be better guided and implemented to ensure basic education for all children with equity, quality, and inclusion.

# Bangladesh on the renewable energy race track

A country's energy mix may even one day override all other issues given the climate crisis we face. Here I look at progress made by five garment exporting countries-China, Bangladesh, Vietnam, Pakistan, and Turkev-in their transitions to renewable energy sources.

#### China

China, the world's largest energy consumer, has made significant strides in renewable energy development. The country's energy mix is still dominated by coal, accounting for more than 50 percent of its energy consumption in 2021.

However, China is the global leader in renewable energy capacity, with extensive investments in solar, wind, and hydropower. As of 2023, China has over 500 GW of solar and wind capacity combined, with ambitious plans to reach 1,200 GW by 2030.

### Bangladesh

Bangladesh's energy mix is heavily reliant on natural gas, which accounted for about 62 percent of its total energy consumption in FY 2021-2022. Bangladesh has made remarkable progress in solar home systems, with over five million installations serving rural households. Despite this, renewables contribute only around three percent to the national grid as of 2023.

This has to improve if we are to remain internationally competitive. Our customers will demand that it does. To this end, the government has set a target to generate 10 percent of its electricity from renewables by 2030, but achieving this goal requires significant investments and policy support. The energy mix also includes imported oil and coal.

#### Vietnam

Vietnam, the third largest exporter of clothing after China and Bangladesh, has a diverse energy mix, with coal being the predominant source. accounting for more than 40 percent

**RMG NOTES** of the total energy consumption in 2023. Hydropower is also significant as Mostafiz Uddin well as natural gas and oil.

Vietnam has seen a dramatic increase in its renewable energy capacity, particularly in solar and wind power, thanks to favourable government policies, including feedin tariffs and tax incentives. The wind energy sector is also growing, with projects like the 99.2 MW Bac Lieu wind farm. Vietnam aims to have 30 percent of its electricity generated from renewables by 2030.

#### Pakistan

Pakistan's current energy mix is dominated by fossil fuels, with natural gas, oil, and coal making up the majority as of 2023. The renewable energy sector is still in its early stages, but the country has significant potential, particularly in wind and solar power.

As of 2023, renewable energy accounts for about six percent of Pakistan's total energy mix, with plans to increase this share to 30 percent by 2030. Key projects include the Quaide-Azam Solar Park and various wind farms in the Sindh province.

Government initiatives and international support have been crucial in advancing these projects. However, Pakistan faces challenges such as bureaucratic hurdles, financial constraints, and a need for more robust policy frameworks to attract private investment.

#### Turkev

Turkey's energy mix is quite diverse, with natural gas (27 percent), coal (25 percent), and oil (29 percent) being the primary sources of energy in 2022. Renewables including wind, solar power and hydro also makes significant contributions

The country has implemented various incentives, including feed-in tariffs and purchase guarantees, to encourage investment in renewable energy.

However, the transition is challenged by economic instability and fluctuating policy environments, which can impact investor confidence.

Overall, the renewable energy transition in China, Bangladesh, Vietnam, Pakistan, and Turkey highlights diverse paths and challenges. China's leadership in capacity and investment sets a global benchmark, while Vietnam's rapid adoption showcases the potential of favourable policies and incentives.

Pakistan's journey emphasises the need for policy and financial frameworks, and Turkey's balanced approach reflects a strategy of building energy security through renewables.

But what about Bangladesh? We must improve the supply of renewable energy available to our industrial base. Our government, regional authorities, garment manufacturers and international fashion brands must collaborate on this issue to better understand the current state of our energy mix, decide how it can be shifted heavily in favour of renewable energy and then work out what this will cost-and, most importantly, how it will be funded.

Bangladesh has a chance to lead on this issue, but China, Pakistan, Turkey, Vietnam and other garment producing countries will also be looking to boost their own renewable energy use. The race is on.

I really don't know if I had made any significant impression on him, but it seemed enough for him to continue to meet and carry on the discussion for investing in a new language English newspaper. He was a nononsense person and thought about whether I would really leave my tenured UN job-at that time posted in Bangkok,

Thailand-to plunge into the uncharted waters of Bangladeshi media, which in the 1990s had very few new investors. I think it was our meeting at my apartment in the Thai capital in January 1990 that convinced him that my determination was for real. From then on, our friendship grew and we soon became partners in giving journalism in Bangladesh a new life, with SM Ali, our founding editor, at its helm.

It was in the initial board meetings of Mediaworld Ltd, the owning company of The Daily Star. that the true commitment of Shamim Bhai to independent journalism




Exactly 169 years ago, in the jungles of what is now the Indian state of Jharkhand, Bengal Army sepoys fired the final shots in what became known as the 'Hul', or uprising, of 1855. The last of about two thousand Santal fighters died in the Hul's last, anonymous clashes. For six months Santal bands had roamed the jungles of Bengal, burning, plundering and murdering those who had oppressed them. The Hul remains the central event in the recorded history of the Santal people of India and Bangladesh, the subject of songs, poems and stories and later novels and even films, a heroic episode more celebrated than analysed.

Though of great importance to the Santals, the Hul has been the subject of just a handful of books, though many anthropologists refer to it in explaining how Santal culture has evolved, especially in relation to the nations of which they are a part, of India and Bangladesh. In 2022, my own book on the uprising appeared Hul! Hul!: the Suppression of

the Santal Uprising, Bengal 1855, published in India by Bloomsbury: its first military history. I tried to explain the failure of the Hul by drawing upon an historical source never before used by its historians the vast and detailed records of the Bengal Army.

I consulted the existing sources (including precious Santal accounts of the Hul), visited some of the sites

where the Hul occurred and especially read the huge number of detailed accounts of the rising as it is revealed in unpublished British records. That gave me a new and challenging view of it. Was I merely repeating British accounts? I don't think so: read on.


But what right, you might ask, did I, an Australian historian, have to write about an event of such importance to Santal people especially when I have not a word of Santali? I must admit that my research might seem to be surprising; even offensive. I can only reply that I think that the Hul deserves to be accorded the respect of being treated like the major conflict it clearly was. The Hul was and remains important to Santals, and Santal authors should be writing about the Hul, drawing upon the communal and cultural sources only they can obtain. I offer a perspective that can only help to illuminate Santal historical experience.

But the Hul was and is not just important to Santals alone. It was an event of importance in India's colonial history. The rebellion which consumed the Santal country in 1855 was (after the great mutinyrebellion of 1857) the single largest rebellion faced by British India's rulers until the great independence movement began in the late nineteenth century.

In describing the Hul, many authors quote Vincent Jervis, a British officer of the Bengal Army, who famously described an incident in the suppression of the rising as not war ... it was execution'. The

incident he was describing, when sepoys of the 56th Bengal Native Infantry trapped a party of Santals in a house in Narainpore (now Narayanpur, West Bengal), was a matter of simply killing men who simply would not surrender. But should Jervis's description be applied to the Hul as a whole? Was the suppression of the Hul merely a matter of 'execution'? The more I read the British records, the more I saw the Hul as an insurgency fought by both sides. not be seen merely as the victims British repression. of They rose in rebellion in the monsoon 1855, finally of unable to stand the oppression of the landlords, merchants and moneylenders who oppressed them (most of whom Bengalis). were They rebelled not so much against the rule of the East India Company (though they were disillusioned at how poorly its officials protected them from exploitation) but it was the forces of the East India Company's Bengal Army which acted swiftly, efficiently and often brutally to suppress The Hul began late in June 1855 in the Rajmahal Hills. The hot weather had rumours circulated, reports of supernatural portents of a coming apocalypse. No

The Santals, I realised, should the uprising. Indeed, more than a tenth of the entire infantry strength of the Bengal Native Infantry was deployed against the Santal Hul: this was a major challenge to the stability of British India. one anticipated the scale of the spontaneous outbreak of rebellion (certainly not the district's British officials, who had no idea of Santal grievances). It began with the killing of a darogah – a police official who had been notable for his

sparked a mass movement, in which thousands of Santals joined.

Columns of Santals moved out of the Rajmahal hills, killing the merchants, zamindars and petty rajahs who had oppressed them. Reports of atrocities they committed - a measure of their desperation and despair - reached the British authorities, who reacted swiftly. Within a week, sepoy regiments began marching toward the disturbed region.

At first, the Santals experienced military success. At Peer Pointee, just south of the Ganges, on 16 July, they routed a force of Hill Rangers sent from Bagulpur. Inspired by the charismatic brothers of Bugnadihee (today Bugnadee, Jharkhand), especially the Santal heroes Sidhu and Kanhu, they believed that sepoys' musket balls would turn to water. Some British officials panicked and refugees, British and Bengali, fled from the approaching Santal bands. For several months a huge swathe of Bengal from

English sources, though Santal songs and stories may record them. These included the six-day Santal siege of the post at Koomerabad (Kumrabad, now covered by the waters of a dam on the Mayurakshi River), and the fight at Bissohuwa, somewhere in eastern Jharkhand. There, on 1 August the two sides clashed, at a place I could not identify, but the fight was described by the British officers, and drawn by a surveyor accompanying the force. The officer wrote of Santals who 'arose as if by magic', charging the sepoys even as they fired volleys at them. Many other skirmishes occurred at nameless places. Though often the only accounts of them were written by the British officers – never before published – they give valuable insights into the Santals'

cruelty against Santals. The killing usually never been published in the slow-moving sepoy columns, moving at the speed of their elephant transport. While at first trusting in sorcery, Santal leaders learned how to direct their bands to stand and fight, even using bows and arrows against musket volleys. They learned the tactics of jungle insurgency: these brave men were not simply the victims of 'execution'.

The Bengal Army 'Field Forces' which responded to the Hul also learned. Sepoys learned how to move and live in the jungle, adopting 'light infantry' tactics, search-and-destroy patrols, bringing in cavalry and even using rockets in pursuing Santal bands. They used river steamers and Bengal's first railway to move troops, supplies and intelligence around the region. British records show that they saw the Santals as an enemy whose courage they came to respect. A British civilian who witnessed Santals attacking wrote admiringly that they 'never dodged but stood' even as he shot at them.

> The Hul was a war, and a 'dirty' war at that. For every report of

Bagalpur in Birhar to Suri in West Bengal, and east to the Bagiruti River, was out of British control. Soon, though, the Bengal Army exerted its power. The 7th Bengal

Native Infantry marched from Berhampore and as early as 15 July attacked a large Santal force at Moheshpore (now Mahespur, Jharkhand). Sepoys arrived on elephants (provided by the Nawab of Morshedabad, anxious for his security) and met Santal charges with musket volleys, a fight in which perhaps 200 Santals died. In that battle three of the Bhugnadihee brothers were wounded, bravely leading their followers. Sepoy columns advanced into the Santal country from Suri in the south, Bagalpur in the north and from Berhampore to the east. While for a month or so the two clashed almost accidentally, each side then developed a sort of strategy.

Lacking coherent leadership, the Santal bands roamed around the region, looting and living off villages, driving off tens of thousands of refugees, many Bengalis. Gradually, they moved towards the south-west, seeking to cross the Grand Trunk Road towards their ancestral lands in Chota Nagpore. When British movements frustrated this impulse, diehard Santals gathered in rugged jungle-clad hills on the borders of what were then Bhagalpur and Beerbhoom districts, holding out even as they suffered from starvation and disease.

After initial indecision and even panic, the British strategy blocked Santal movements by holding chains of military posts, combined with aggressive forays (which they called 'dours') under energetic younger officers, and then in November and December declared martial law and launched a concerted 'drive' to destroy and disperse the last Santal bands.

The Hul saw many fights between small sepoy forces and large Santal bands, the names of which have able to move more swiftly than

experience of rebellion, including making clear why so many risked so much for their communities.

The Santals acted out of desperation, hampered by many serious shortcomings: they had no warrior tradition or military organisation or political program; their only arms were hunting weapons – bows and arrows. Crucially, they had no accepted commanders, besides the four brothers of Bhugnadihee, whose charismatic leadership inspired the outbreak of the Hul but proved unable to control it.

While the Hul failed largely because the Santal bands abandoned their villages and fields and increasingly suffered from disease and starvation in huge, improvised jungle camps, Santals learned how to fight an insurgency as they went. They used their assets well – they knew their own country and were

Santal 'savagery' - they took bloody revenge on those who had oppressed them there was a report of the troops' 'severity'. Eventually, after the end of the monsoon, columns of sepoys conducted 'drives', advancing across the Santals' lands, breaking up their bands and killing or capturing those still resisting. By the end of 1855 the rebellion had been extinguished, at a cost of about 10,000 Santal lives, most dead of hunger and illness: many women and children.

Although the rebellion failed, it did bring change for the Santals. Recognising that a tribal people needed protection, the Company created the Santal Parganas, governed by British officials whose paternal care contrasted with the indifference that had provoked the Hul. They ruled through the very village leaders who had been instrumental in the Hul.

The Hul was largely forgotten by India's British rulers - they published almost nothing about it. But the Santals never forgot, creating a rich seam of songs, stories and poems about it. In due course, as India's freedom movement grew, Indian nationalist historians re-interpreted the Hul as a rebellion against British rule, one suppressed by 'British' troops. In fact, the Santals rebelled against the oppression of Bengalis, the Hull suppressed overwhelmingly by Indian troops - under British command.

Regardless of how it may be viewed, the Hul deserves to be better known, and not just among Santals. My book Hul! Hul! offers a new view of the Santal uprising, inevitably largely from the perspective of those who fought against it. But even the British records shed new light on the Santals' bravery, ingenuity and resolution in fighting to defend their interests as a people.

# Reliance on gamechanger Bumrah key in India's triumph AGENCIES

Jasprit Bumrah was one of the main architects of India's T20 World Cup triumph and he capped off his tournament as the player of the tournament after the Men in Blue won the final by seven runs against South Africa on Saturday.

Bumrah's campaign will go down in history as one of the greatest individual displays ever seen in the event's history.

Collecting 15 wickets at an average of 8.26, Bumrah finished with an astonishing economy of just 4.17, by far and away the best rate of those to bowl a minimum of 20 overs at the tournament. He joins teammate Virat Kohli (a two-time winner) as India players to claim the Player of the Tournament award.

"I honestly think he's the best seam bowler who has played white ball cricket," former England captain Michael Vaughan told Cricbuzz vesterday.

"If you can tell me a better seam bowler. I know Wasim Akram was special and there have been many others to mention but I just think he's got this amazing action ability and he's got the pace, he's got all



the different skill sets and he does it under pressure day in and day out. It's not just two or three times at the World Cup. It's pretty much every single game."

Vaughan put it neatly as Bumrah delivered outstanding displays of his acumen throughout the tournament and propelled his reputation to newer heights.Hewasimmaculateinallthree phases of play. He bowled unplayable deliveries with the new ball, disrupted the opposition's momentum in the middle overs, nailed vorkers as well as slowers to knock the wind out of the opposition's sails in the latter stages, and was skipper Rohit Sharma's goto option whenever India were in a bothersome position. One could hardly point out an occasion when a batter tried to take Bumrah on as most, if not all, tried to see off his overs and look for scoring opportunities elsewhere. His economy rates of 4.07 in the Powerplay, 4.75 in the middle overs, and 3.78 at the death were also instrumental in Bumrah winning phases of play. And that assurance he brought gave Rohit and India the belief of winning games from any situation.

# **WIMBLEDON** prepares for new era

Defending champion Carlos Alcaraz and world number one Jannik Sinner will take their simmering rivalry at the top of the men's game to Wimbledon, where the two young guns will look to prolong seven-times winner Novak Djokovic's trophy drought in 2024.

Even before the tournament begins, however, Djokovic's quest for a record 25th Grand Slam title is under a cloud with the Serb building match fitness after undergoing knee surgery three weeks ago for an injury that prematurely ended his French Open.



Fellow 37-year-old and former champion Andy Murray is also in a race to be ready for what is likely his Wimbledon swansong after the injuryplagued Briton went under the knife last week for a back issue.

With Roger Federer retired and Rafa Nadal skipping Wimbledon to focus on next month's Paris Olympics, the potential pullout of Djokovic would ensure the first Wimbledon without any of the Big Three since 1998.

All eves would then be on Alcaraz and Sinner as they usher in a new era at Wimbledon.

"I don't feel more pressure about playing a tournament that not one of the Big Three is playing in," Alcaraz said last week before Djokovic arrived in London on Sunday to give fans hope.

Meanwhile, for Virat Kohli and Rohit Sharma, two modern-day greats of India and world cricket, the final was their chance to bid adieu to the shortest format as world champions. But after tasting the ultimate success so early in their respective careers, the





France's far right won the first round of pivotal legislative elections vesterday with the centrist forces of President Emmanuel Macron coming in only third behind the left after the highest turnout in over four decades, estimates said.

But it remained unclear if the far-right National Rally (RN) party of Marine Le Pen would win an absolute majority of seats in the

firms gave the RN 34.5 percent of the vote, compared to 28.5-29.1 percent for the leftwing New Popular Front alliance, and 20.5-21.5 percent for Macron's centrist camp.

The polling agencies projected this would give the RN a majority of seats in the 577-seat National Assembly after the second round and a possible absolute majority.

The corrupt individuals should be dismissed from their jobs, said former foreign minister AK Abdul Momen, adding that they are enemies of the people and the country.

"Transferring the officials accused of corruption cannot be an effective punishment. Rather, there should be an actual account of the

assets of the person accused of corruption; the assets need to be confiscated and auctioned off and the individual promptly sacked," he wrote on Facebook yesterday

"Remember, the government job is their biggest and most powerful asset," wrote the chairman of the Parliamentary Standing Committee on the Ministry of Foreign Affairs.

Asked about his Facebook post, Momen said corruption had been so pervasive that it was a matter of shame for the country.

The laws are framed in a way so as to not hold government officials accountable. A section of government officials don't serve the people unless they are bribed, he said.

All government officials need to report their income and expenses every year, he said.
