Pension protest brings public univs to halt

Faculty, staff strike over new pension scheme; students hold quota demo

STAR REPORT

Teachers went on an indefinite strike over pension benefits vesterday, paralysing public universities across the country.

Also, students at Dhaka and Jahangirnagar universities took to the streets, demanding quotas for government jobs be abolished.

The teachers' strike began yesterday with the academics demanding abolition of the new Prottoy Universal Pension

No classes, exams, or admissionrelated activities were done, most classrooms and libraries were locked, and barely any university buses left the sheds at the 35 universities where teachers and 34,382 staff at 50 public universities that

and allows encashment of earned leave provisions that are unclear or missing in the new scheme.

A finance ministry official said pension schemes like these are common across the world, adding that single-handedly paying the pension was a burden for the government.

After the government announced the scheme in May, teachers associations termed it "discriminatory" and called for its abolition.

The teachers have also been demanding a new pay scale and the inclusion of professors in the "super"

staffers were on strike.

As yesterday was also the first day of a three-day strike by the Inter-University Officers' Federation over pensions, no administrative work was done.

'We will not return to the classrooms until the demands are met," Prof Zeenat Huda, general secretary of Dhaka University Teachers' Association, told a rally on campus.

The protests follow a government decision to implement Prottoy pension scheme for recruits joining on or after July 1 the autonomous, self-governing, nationalised, statutory, or such organisations and their subordinate institutions.

Under the scheme, 10 percent of the monthly basic salary of an employee, up to Tk 5,000, will be deducted and given to their pension fund. The organisation will contribute the same amount to the fund, and interest will be added to it. There will be no one-time gratuity for the retiring employee.

At present, no money is deducted from the salary

The current system includes a 5 percent annual increment in pension

At Dhaka University, the teacher's association shunned the institution's 103rd founding anniversary celebrations

DU teacher Nizamul Hoque, secretary general of the Federation of Bangladesh University Teachers' Association, said the pension scheme robbed them of their sense of jubilation.

Addressing a rally, Prof Chandra Nath Podder said the new scheme was imposed without consulting the teachers.

The situation was similar at BUET, Chittagong, Rajshahi, Jahangirnagar and other universities.

At Rajshahi University, teachers demonstrated in front of the Senate Bhaban and the staff association near the administrative building.

At a rally on an otherwise empty Jagannath University campus, Prof Shaikh Masrick Hasan said there should be no disparity between current and future teachers.

GOVT OFFICIALS HC directive sought for disclosure of assets

In light of media reports about certain government officials amassing property, a Supreme Court lawyer filed a writ petition with the High Court yesterday, requesting that the government take steps to disclose the movable and immovable properties owned by public servants serving in civil capacities, as well as their family members.

Advocate Nandi Das submitted the petition as a public interest litigation to the HC, also appealing to the court to direct the authorities concerned with the government to adopt guidelines or policies or to enact proper legislation to prevent the accumulation of illegal wealth (movable or immovable) through corruption by the public servants serving in civil capacities and their family members.

Sylhet, Sunamganj brace for another spell of flood

People of Sylhet and Sunamganj are facing flood for the third time this year due to heavy rainfall in the region and upstream India.

The water of the Surma, Jadukata, Kushiyara and Sari rivers are flowing above danger level at different points at the time of filing the report.

Around a hundred villages in the low-lying areas of Sylhet's Kanaighat, Zakiganj and Jaintiapur upazila; and Sunamganj's Tahirpur, Chhatak, Dowarabazar and Sadar

upazila are submerged. In the next 48 hours, heavy to very heavy rainfall is expected in the North, North-eastern and adjoining upstream parts of the country, said a bulletin of Flood Forecasting and Warning Centre yesterday.

"As a result, the water level of the rivers in North and Northeastern regions may rise rapidly in a particular time," said the bulletin released at 9:00am yesterday.

Rain and thundershowers are expected over the next five days, said another bulletin from the Bangladesh Meteorological Department yesterday.

Earlier on Sunday, the Bangladesh Water Development Board (WDB) warned of a short-term flood in Sylhet.

The Surma River was flowing 102 centimetres above the danger level in Kanaighat Upazila at 6:00 pm yesterday, while the Kushiyara River was flowing 28cm above at Zakiganj's Amolshid and 88 cm above the danger level at Fenchuganj upazila at the same time, according to the

On July 1, 2024, Dhaka University celebrated its 103rd anniversary. University life is an experience in itself. Besides the education and the bonds of friendship people share, a notable aspect that shines in every person's heart is campus food.

We spoke to a few students and DU graduates about their favourite campus eateries and here's what we found.

Campus Shadow

The tiny shop is well known for its lemonade, but the best item there is the luchi-daal, which is only served in the



afternoon. The luchi is always served hot, straight from the fryer! If you walk by Mall Chattar in the afternoon, the aroma will certainly lure you towards this simple place.

"Praner Mela" (carnival of life) -- is the phrase used to describe TSC. If you ever had the opportunity to be here for any occasion, you would know that it's a



befitting name.

One of the reasons for the popularity of TSC is the affordable food it offers. Whether it's the khichuri or the chicken with rice, students line up all the same. Besides lunch, breakfast and snacks are also served here and the place is almost always jam-packed. Taking a sip of their lemon tea while strumming a guitar is a common sight here.

Hakim Chattar



Standing beside the central library, Hakim Chattar is more popular for its location than the food. The usual khichuri, soup, and snacks such as shingara and pakora make up the menu here. And of course, there is tea.

It is hard to find a time when this place is not crowded. Many students prefer to come here from the central library for a quick bite. On other occasions, it's just a convenient place to sit for a quick meal under the shade of

Mama Hotel

It is difficult to find someone who studies at Dhaka University but has not been to Mama Hotel. Located just outside of the DU campus, the hotel is always bustling with students. The owners have formed a bond with the students and make them feel welcome. As a result, whether it's a special meal

with beef, brain, shrimp, or just a regular dinner with a dash of jhal fry, bhorta, and bhaji -- students of DU rush to Mama Hotel whenever they feel like having a feast.

Charukala Gate

This particular eatery is a temporary shop that only operates in the afternoon. At the Charukala gate, one can find fried chicken. Every day, people line up to get a taste of this snack. With a little bit of sauce, it is a decent offer, given the reasonable price. However, to treat yourself to a piece of this famous fried chicken, you will have to battle through a crowd.

Honourable Mentions

ACC finds 12 heads of Brahman cattle in Sadeeq Agro Goat priced Tk 15 lakh found

The Anti-Corruption Commission yesterday raided a farm of Sadeeq Agro in Savar's Bhakurta and found five Brahman cows and seven calves.

ACC Assistant Director Abul Kalam Azad who led the drive, told reporters that they would investigate how the cattle were brought to the farm as there is a ban on importing such cattle.

He added that they found the goat worth Tk 15 lakh there, whose price is now the talk of the

Earlier in the day, the nine-member ACC team went to Central Cattle Breeding and Dairy Farm (CCBDF), Savar, to enquire about 18 Brahman cows that were seized and kept at the farm for rearing. Sadeeq Agro imported them without

permission three years ago.

CCBDF Director Monirul Islam told The Daily Star that three of the 18 cows died. Dairy Farmers Association bought 15 cows from the fisheries and livestock ministry on condition of selling the meat at fair price during Ramadan.

Sadeeq Agro owner Imran Hossain is the president of the organisation.

Asked whether the cows were slaughtered, Monirul said they were not tasked with supervising it. "We handed over the cows to them as per

ACC Assistant Director Azad said they would probe allegations against Imran of selling the same kind of cattle before Eid-ul-Azha. It would also be investigated whether any CCBDF official is involved in Sadeeq Agro.

Australia doubles foreign student visa fees

Australia said yesterday it had more than doubled the visa fee for international students, the latest move by the government to rein in record migration that has intensified pressure on an already tight housing market.

From July 1, the international student visa fee has risen to A\$1,600 (\$1,068) from A\$710, while visitor visa holders and students with temporary graduate visas are banned from applying onshore for a student visa.

Transport expert Hadiuzzaman said taking up a project without a feasibility study is not a good example.

"It is not possible to know the traffic demand, best locations of stations and the best possible links with roads without a proper study. Investing such a huge amount in a project without a study is questionable," he told The Daily Star vesterday.

As the BR invested money without assessing the traffic demand, they are operating only one train now which is not bringing enough returns for their investment, said Hadiuzzaman, a

The Tungipara Express, which

was launched in 2019, operates from Gobra of Tungipara to Rajshahi via Rajbari. The BR could have invested this

money in other projects if a proper study was conducted beforehand, he

THE PROJECT

The rail line from Kalukhali of Rajbari to Bhatiapara Ghat of Gopalganj was constructed in 1932 but the line became inoperative in

The government in 2010 approved a project to revive the 75.5km section and build 32.35km of lines between Kashiani and Gopalganj to bring Tungipara, the birthplace of the father of the nation, under the railway network.

The project was supposed to be completed by June 2013. But it was completed in December 2018 with 330 percent time extension and 91.61 percent cost escalation, shows IMED

The IMED report said that the project saw time and cost overruns as it was taken up without a feasibility

tests while 35 on practical activity. Meanwhile, SSC exams, which take

place at the end of the 10th grade, will be conducted by the existing education boards at different exam centres, but the evaluation process will be under the new curriculum, according to the NTCB. When publishing the report card

of SSC, there will no longer use a GPA system. Instead, there will be seven scales to describe the level of competency, with "initial" at the bottom and "unique" at the top.

From now on, SSC students will be allowed to advance to the HSC level even if they fail up to two subjects.

They will, however, receive a mark sheet showing their scores and will need to retake and pass the failed subjects in subsequent examinations to obtain full marks.

Turkey arrests 67

AFP, Istanbul

Turkish police were holding 67 people yesterday after a mob went on the rampage in a central Anatolian city after a Syrian man was accused of harassing a child.

A group of men targeted Syrian businesses and properties in Kayseri on Sunday evening, with videos on social media showing a grocery store being set on fire.

President Recep Tayyip Erdogan condemned the latest bout of violence against Turkey's large community of Syrian refugees.

"No matter who they are, setting streets and people's houses on fire is unacceptable," he said, warning that hate speech should not be used for political gains.

Interior Minister Ali Yerlikaya said the Syrian national, identified only by his initials as I.A., was caught by Turkish citizens and delivered to the police.

The court also asked them why the commissioner of the Chattogram commissionerate should not be asked to dispose of the matter by strictly following sections 73 and 85 of the Value Added Tax and Supplementary Duty Act, 2012.

The HC bench of Justice Zafar Ahmed and Justice Sardar Md Rashed Jahangir issued the rules after two writ petitions were filed by the two companies.

The bench also fixed July 15 to

hold a hearing on the rules.

During yesterday's hearing, the companies' lawyer Ahsanul Karim told the bench that his clients on June 4 sought time from the commissionerate for their senior counsel to appear for hearings.

He said his clients were not heard before the adjudication orders were issued. The commissioner of the Chattogram commissionerate violated the principle of natural justice in passing the orders by not allowing his clients to defend themselves against allegations made in show-cause notices issued on October 4 and December 27 last year and on March 18 this year, the lawyer

Deputy Attorney General Nawroz MR Chowdhury representing the government told the court that the companies were given time on several occasions over the last one year to submit their statements before the commissioner to uphold the principle of natural justice.

But they had not done it. They cannot be given unlimited time under the relevant law, he said.

At one stage, Deputy Attorney General Samarebdranath Biswas told the HC that the companies' intention was not to pay the VAT.

Lawyer for the companies, Ahsanul said his clients never said that they would not pay the VAT.

According to an audit by the VAT wing of the National Board of Revenue, the companies have unpaid VAT and consequent penalties of over Tk 7,000 crore. They evaded VAT by presenting lower purchase and sales data in VAT returns and other means between 2019 and 2022.

Chattogram VAT Commissionerate, which also arrived at the same conclusion. The two companies denied any wrongdoing.

Total 11,450 Bangladeshis in foreign jails **Hasan Mahmud** tells JS

total of 11,450 Bangladeshis including migrant workers are in jails in 31 countries, Foreign Minister Hasan Mahmud told parliament yesterday.

The foreign minister who is visiting Saudi Arabia, came up with the statistics while replying to a query from the ruling Awami League MP from reserved seats for women, Farida Yasmin.

In a scripted answer, the foreign minister said, according to information by different provided missions abroad, highest number incarcerated Bangladeshis are in Saudi Arabia (5,746).

Meanwhile, Portugal, Japan and Belgium have the lowest number of jailed Bangladeshis -- two each.

Transparency International Bangladesh (TIB) has criticised the government's approach to handling corruption within public service, arguing that measures such as transfer, dismissal, and compulsory retirement are inadequate deterrents and may inadvertently foster a culture of impunity.

Rain brings fresh dengue concerns

44 dead, 3,651 hospitalised this year; experts say situation to worsen in July

HELEMUL ALAM

So far, the country has already recorded 44 deaths and 3,651 hospitalisations from dengue this year. With ongoing intermittent rains, experts fear the situation could worsen if immediate actions are not taken.

Data from the Directorate General of Health Services reveals a worrying trend: last year, dengue cases skyrocketed from 5,956 in June to 43,854 in July.

With the monsoon rains, dengue cases will start rising now, typically peaking this month," said Prof Kabirul Bashar, an entomologist from Jahangirnagar University. He said rain water is accumulating on

rooftops and at balconies of many buildings and also on the streets of Dhaka, creating

'We are getting a huge number of Aedes mosquito larvae in and around houses at Goran, Khilgaon, Mugda, Manda, Rasulpur, prevent rainwater accumulation, which can

Public health expert Mushtaq Hossain stressed the importance of proper solid waste

also become mosquito breeding sites," he said. He emphasised the need for a nationwide cleaning drive to tackle the dengue outbreak and other health issues.

Community engagement is crucial, with the government leading and providing resources, Mushtaq said.

He also called for a reformed healthcare management system to reduce dengue fatalities, proposing a three-tiered approach: primary, secondary, and hospital care.

The primary healthcare approach for dengue patients involves establishing local healthcare facilities in every city wards to provide initial diagnosis and treatment, enabling early detection and reducing the burden on hospitals, he explained.

He also pointed out the lack of manpower, medicines, and diagnostic facilities at village and upazila levels, which hampers early dengue detection and treatment.

Nasir Uddin, however, claimed that they did not approve the structures built on croplands on both sides of the Outer Ring Road.



Dhaka for taskforce to stop workers' harassment in KSA

Bangladesh has proposed forming a task force to ensure transparency in recruitment and stop harassment of migrant workers by vested quarters in Saudi Arabia.

The proposal was made during the second political consultation between Dhaka and Riyadh in Saudi Arabia yesterday.

Foreign Minister Hasan Mahmud led the Bangladesh side, while his Saudi counterpart Prince Faisal bin Farhan Al Saud led the other side, according to a foreign ministry statement.

Hasan Mahmud requested Saudi authorities to provide special scope for Bangladeshi businessmen to register their businesses there. He also requested special privileges for importing oil from Saudi Arabia.

They discussed strengthening bilateral and political

relations and intensifying bilateral and multilateral coordination on issues of common concern, alongside regional and global development. They stressed the need for the Bangladesh-Saudi

Arabia Joint Business Council to step up its activities to strengthen commercial relations between the two

Bangladesh and Saudi Arabia also explored enhanced investment in economic zones and offshore banking.

At the meeting, the Saudi foreign minister assured cooperation regarding Rohingya repatriation, while both sides emphasised united efforts from the Muslim world to stop Israel's brutality in Gaza.

The upcoming visit of the Saudi crown prince to Bangladesh was also discussed at the meeting.

They decided to adopt a joint action plan for the proper celebration of the golden jubilee of Saudi-Bangladesh diplomatic relations next year and to elevate the meeting of Bangladesh-Saudi Arab Joint Commission to a ministerial level.

Now govt can appoint administrator for UPs

Local govt amendment bill passed in parliament

STAFF CORRESPONDENT

The Local Government (Union Parishad) (Amendment) Bill, 2024 was passed in Parliament yesterday, introducing a provision for appointing administrators to union parishads after the elected representatives' five-year tenure expires.

LGRD Minister M Tazul Islam presented the bill, which was passed by voice vote. The new legislation stipulates that the government can appoint administrators for up to 120 days after the end of a Union Parishad's tenure.

With the proposed change, no Union Parishad chairman can remain in office beyond their term on any pretext. The current loophole allowing chairmen to stay in office past their term will be eliminated.

The post of UP secretary has been changed to "UP Administrative Officer" under the new law.

Under the new legislation, a competent officer or person will be appointed as an administrator to perform a Union Parishad's functions until a newly-elected council is formed.

This measure is expected to curb the practice of delaying elections through litigation.

The bill emphasises the Union Parishad's role in managing village courts and maintaining law and order, aiming to expand the effectiveness of village court activities.

475 workplace deaths in last six months Says Safety, Rights Society data

At least 475 workers died in 420 accidents at various workplaces across the country in the first six months of

Safety and Rights Society released the data yesterday after conducting a survey based on news published in 15 national and 11 local newspapers.

In the same period in 2023, around 389 workers died in 287 accidents.

SRS has found that the highest number of workers were killed in the transport sector.

Of the total number, 250 transport workers died in this period, 74 died in service establishments (such as workshops, gas, electricity supply establishments), 66 in agricultural sector, 52 in construction, and 33 died in factories and other manufacturing institutes.

SRS Executive Director Sekender Ali Mina said Bangladesh's production and employment depend on the informal sector, where labour laws are largely unenforced, making it challenging to control workplace accidents.

Supervision by relevant authorities must be increased to control workplace accidents, he added.



New roads put agriculture at stake

120 hectares of cropland being used for commercial purposes

Mohammed Sohel, 37, of Golichipa connectivity, there has been a boost Para in the North Halishahar area of Chattogram city, is planning to work as a transport worker as the four-acre land he used to cultivate as a sharecropper has been turned into a truck terminal and cold storage depot.

"The land owner rented out the land for the truck terminal and coal storage depot, thereby compelling me to look for an alternative livelihood," he told this correspondent recently.

Sohel is not alone. Over a hundred farmers, whose lives solely depended on agriculture, were forced to change their profession after at least 120 hectares of arable land were turned into transport terminals, cattle farms, and factories.

These lands, located in North Kattali, North Pahartali, South Kattali, Halishahar, and Patenga areas, used to be cultivated to produce different crops, including tomato and watermelon, according to the metropolitan agriculture office in Chattogram.

link roads in the region to enhance to business activities in the region, which in turn has made agriculture no longer attractive to landowners.

The 12.5-kilometre Port Link Road connecting Faujdarhat and Halishahar, which opened in 2007, paved the way for this transition.



Later, the 15.5km Outer Ring Road, which opened in 2021, connecting Faujdarhat and Patenga, further boosted connectivity and depleted agricultural land.

This correspondent recently visited several points of the Outer Ring Road and observed that many commercial structures have been built on the east side of the road.

"Earlier, after every seasonal harvest, the markets used to be

After the construction of two flooded with an array of different crop varieties. But those days are no more," said Ataur Rahaman, 55, a vegetable vendor in Foillatoli Bazar under Halishahar area.

Jahangir Alam, a farmer from North Kattali, said, "Before these two roads were constructed, I used to earn my living by growing crops. Now, I am struggling to make ends meet after the agricultural lands were lost to commercial activities."

The six-acre land he used for cultivation now houses a workshop. At least 70 vehicles can be kept at the workshop at a time.

Elias Mistree, owner of the workshop, said, "After the road opened, most Chattogram Portbound vehicles started using this road, which convinced me to set up the workshop here."

Any structure can be built on agricultural land after getting permission from the local ward councillor of Chattogram City Corporation.

CHT PEACE ACCORD Govt not making progress in its implementation

Says PCJSS report

Since the Chittagong Hill Tracts Peace Accord has not been properly implemented yet, the situation in CHT has worsened and become very sensitive, said Parbatya Chattogram Jana Samhati Samiti (PCJSS) in its half-yearly report yesterday.

Despite being in power for 16 years now, the Awami League government has not paced forward with the accord's implementation process, said the report, adding, "At present, the government has put the implementation process to a total halt."

On December 2, 1997, the then AL government and PCJSS signed the CHT peace accord to solve the CHT crisis through political and peaceful means.

On April 30 this year, in the ninth meeting of CHT Accord Implementation and Monitoring Committee, it came up with evidential proof that the government did not undertake any initiative towards the implementation of the decisions adopted in the earlier meetings, the report also said.

From January to June this year, 107 incidents of rights violations were reported in CHT, while at least 5,448 Jumma people, including 5,000 men and women from the Bawm community, fell prey to human rights violations.

In such a way, the government has been turning the committee into a mere institution of nomenclature, it added.

The report further said the CHT has been experiencing human rights violations in various forms, such as suppression and oppression by administration and security forces, activities of armed terrorists, illegal land occupation, eviction and communal attacks, sexual harassment, violence, rape and killing, and development aggression.

From January to June this year, 107 incidents of rights violations were reported in CHT, while at least 5,448 Jumma people, including 5,000 men and women from the Bawm community, fell prey to human rights violations, it said.

The report said on April 23, a Rangamati court dismissed the case regarding the abduction of Kalpana Chakma.

Âfter 28 years, the dismissal order of Kalpana Chakma's abduction case in the lower court has effectively granted impunity to the administration from its responsibility to uncover her whereabouts and the details of her kidnappers, the report



AMTALI UPAZILA HEALTH COMPLEX

Manpower shortage cripples health service

SOHRAB HOSSAIN, Patuakhali

Patients in Barguna's Amtali upazila are deprived of proper treatment facilities as the upazila health complex is plagued with various problems including shortage of doctors and other staff.

The upazila health complex serves as the lone government hospital for nearly 2.5 lakh residents of different unions under the upazila.

Only three doctors, including two medical officers, are currently serving at the 50-bed health complex.

At least 28 posts of doctors, out of 31 posts, are lying vacant for a long, hampering health service of thousands of people in the upazila.

Apart from the doctors, about 60 out of 90 posts of Class II staff, including statistician, cashier, store keeper, and 19 out of 33 posts of Class III employees, including ward boy, gardener, cook, security guard and cleaner are lying vacant for nearly three years, disrupting overall activities of the government

According to the hospital sources, though Dr Faizur Rahman, a resident medical officer joined the hospital on February 29 this year, he has remained absent at his workplace since the next

The hospital authorities served him explain the reason behind his absence, complex for long.

and withheld his salary, but he is yet join the health complex.

Local residents said as the upazila health and family planning officer (UHFPO) remains busy with different administrative works, it is quite difficult to manage so many outdoor, indoor and emergency patients with only two medical officers.

In case of any medical emergency, patients need to be taken to Patuakhali Medical College Hospital, about 35km away, or Barisal Sher-e-Bangla Medical College Hospital, which is about 75 km from Barguna's Amtali upazila, they

During a recent visit to the hospital this correspondent saw Rushia Begum from Haldia village, who came to the hospital with itching problem, was wondering what to do as there was no

doctor at the hospital then. "We are poor people and can't afford more money to go elsewhere for treatment," she said.

While talking, Amtali UHFPO Dr Chinmoy Howladar said they have informed their higher authorities on several occasions in this regard, but nothing has been done so far.

Contacted, Barguna Civil Surgeon Dr Pradeep Chandra Mandal said usually, doctors posted from distant areas do not two show-cause notices, asking him to want to stay at the remote upazila health

Palestinian prisoners face 'all kinds of torture'

Says Gaza hospital chief after release from Israeli detention centre

The head of the Gaza Strip's biggest hospital said yesterday after being freed from more than seven months of detention that he had been "tortured" by Israel.

Al-Shifa hospital director Mohammed Abu Salmiya was among more than 50 Palestinians released and returned to Gaza for treatment, according to an Israeli minister and a medical source in the besieged territory.

Salmiya said he was put through "severe torture" during his detention, which left him with a broken thumb.

"Prisoners are subjected to all



kinds of torture," he told a press conference. "Several inmates died in interrogation centres and were

deprived of food and medicine." "For two months no prisoner ate more than a loaf of bread a day," said Salmiya.

"Detainees were subjected to physical and psychological humiliation."

The medical chief said no charge had ever been made against him. Israeli forces detained Salmiya during one of a number of raids on Al-Shifa.

The hospital has largely been reduced to rubble by successive raids since Israel launched its assault on Gaza.

Salmiya and the other freed detainees crossed back into Gaza from Israel just east of Khan Yunis, a medical source at the Al-Aqsa hospital in Deir al-Balah told AFP.

Spain SC denies amnesty for Catalan separatist

Spain's top court yesterday refused to grant an amnesty to Catalan separatist leader Carles Puigdemont on a charge of misusing public funds, maintaining arrest warrants over his failed 2017 secession attempt.

Spanish MPs in May passed an amnesty law aimed at drawing a line under years of efforts to prosecute those involved in the botched secession bid.

Blocking the amnesty for Puigdemont could complicate life for Spain's Prime Minister Pedro Sanchez, who relied on Catalan parties to secure a new term in November.

Japanese official among 11 arrested for price gouging

Myanmar arrested four executives of supermarket chains, including an official of a Japanese joint venture, for selling rice at inflated prices, state media said yesterday, as the war-torn country's ruling junta struggles to stabilise its economy.

The impoverished Southeast Asian country has been in turmoil since its military deposed an elected civilian government in February 2021, sparking widespread protests that have morphed into a nationwide armed resistance.

Authorities said they arrested 11 people, including rice traders and officials of mills and retailers, accusing them of inflating prices by 31 percent to 70 percent from prescribed levels, the Global New Light of Myanmar newspaper said.

In Tokyo, Japan's chief cabinet secretary, Yoshimasa Hayashi, said police in Yangon were questioning a Japanese national. "The Japanese government intends to continue taking appropriate steps while urging local authorities for his early release," he told reporters.



The ease and frequency with which cybercriminals continue to breach the National Board of Revenue (NBR) server is disquieting. According to a report by this daily, a cybercriminal gang attempted to release a container of foreign cigarettes from Chattogram Port after breaching the NBR server with the login credentials of a customs official. Acting on a tip-off, officials seized the container loaded with 50 lakh sticks of cigarettes worth about Tk 5 crore. The breach of the server came to light on Saturday after an investigation into the incident.

Despite the successful intervention, what worries us is that the breach could have led to something far more sinister. It shows once again the vulnerability of the NBR server to hacking which is proving increasingly difficult to address. Reportedly, following previous incidents of server breach, the NBR took some steps like the use of particular login IP and sending OTP to mobile phones of officials with proper authorisations. However, the latest breach has demonstrated that these measures are not enough. Criminals somehow managed to use the login credentials of a deputy commissioner of Chattogram Customs House to register the consignment with the NBR server, and also to access the server from a different IP address, while no OTP was sent to the mobile phone of the official

Over the last few years, at least 38 imported consignments of goods were released illegally by using the IDs of at least eight revenue officials. Investigators said a cybercriminal gang was involved in those incidents; however, they failed to identify the gang. After a few such incidents in 2022, it was discovered that earlier measures taken by the NBR had been insufficient to prevent its servers from being breached. The institution itself admitted that its technological safeguards could not thwart them. Even though these concerns have been well-known. the fact that the authorities have been unable to address them since is unacceptable. Another major concern is that despite repeated breaches, the probe committees that have been formed failed to identify the perpetrators or answer many critical questions raised by the incidents.

The entire security system of the NBR seems to be way below par, and the danger that it poses to our national security is disturbing. Against this backdrop, the NBR should urgently stamp down on such breaches by strengthening the security of its servers. Customs officials and others should be more vigilant about cybercrimes. And considering the gravity of the threat posed by such crimes, the authorities should consider involving independent experts who can look into what's really happening and suggest solutions.

Protect Tengragiri forest at all costs

We can't afford to lose the 'second Sundarbans' to timber thieves

We are outraged to learn that another reserved forest is being plundered by timber thieves who are felling and stealing trees indiscriminately, with no visible steps to stop them. According to a report by Prothom Alo, an organised criminal gang has been stealing trees from the Tengragiri mangrove forest and setting the stumps on fire to destroy evidence, in the process causing damage to the trees that still remain standing. Locals complained that this has been going on for a long time, alleging that these thieves are working in cohort with forest officials.

The Tengragiri forest, situated along the coast of the Bay of Bengal, stretches from Taltali upazila of Barguna to Kuakata in Patuakhali, covering 13,644 acres of area, according to data from the Forest Department. In 1960, it was designated as a reserved forest based on a survey done in 1927. Home to an incredible biodiversity system, Tengragiri is the second largest mangrove forest in Bangladesh, and is thus known as the 'second Sundarbans.'

Such an invaluable gift of nature-which, much like the Sundarbans, acts as a natural barrier to calamities and protects the locals—already faces a host of threats to its survival, such as the rising sea level and increasing salinity due to global warming, erosion, etc. Its chances of survival are being further jeopardised because of the greed and recklessness of local influentials. A recent visit has revealed that 3,000 trees have been felled and stolen in the forest's Behular Char area. According to the *Prothom Alo* report, in March, a fire broke out there and burned as many as 10,000 trees, damaging a lot of others. What really puzzles us is that after the fire was reported, it took local forest officials 18 hours to reach the scene and bring the fire under control. Another fire incident happened in the Disirkilla area in April, but that was put out quickly enough, so the damage was minimal.

When asked about their failure to prevent tree robbery and frequent fire incidents, forest officials in Tengragiri cited lack of manpower and necessary resources. This seems to be their go-to excuse whenever there are reports of timber theft from reserved forests. We must ask: how difficult is it to ramp up the capacity of the Forest Department so that it can protect at-risk forest areas? Or is the concept of "reserved forest" lost on them? This lackadaisical attitude is totally unacceptable, especially considering Bangladesh's fast-depleting forest coverage. We urge the authorities to ensure that no further damage is done to what's left of our precious forests.

Bangladesh's economy has witnessed remarkable growth, solidifying it as one of the fastest growing economies worldwide. According to the Bangladesh Economic Review 2023, the construction sector significantly contributes to this growth—approximately 6.41 percent in 2023. Construction's share within the industry sector and growth is on the rise, with the growth rate increasing to 8.71 percent in FY2021-22, compared to 8.08 percent in FY2020-21.

As the construction sector expands, it demands more labour. According to the Labour Force Survey 2022, construction is the fifth largest industry in terms of employment in Bangladesh, with about 5.44 percent of the employed population working in this sector. A study conducted by Bangladesh Institute of Development Studies (BIDS) projects that the construction industry is expected

to require approximately 90 lakh workers by 2030. But among the top five employment-generating industries, the construction sector ranks second to last in terms of female employment. Only 0.4 percent of women are employed in this sector, compared to 8.18 percent of men. With female labour force participation in Bangladesh increasing from 36.3 percent in 2016-17 to 42.7 percent in 2022, the expanding construction presents a significant opportunity to accommodate more female workers.

Additionally, with the country's LDC graduation and the anticipated decline in RMG exports, exploring sectors like construction is crucial for accommodating the expected

structural shift in labour dynamics. The rise of automation and Fourth Industrial Revolution (4IR) technology highlights the need to focus on technology and skills-based occupations for women.

According to the Labour Force

participation in the labour force, industry stakeholders perceiving there are no gender-specific policies in the construction sector. The Public Procurement Rule, 2008, and Occupational Health and Safety Policy, 2013 ensure workplace safety but lack gender provisions. The labour

Survey 2016-17, females in the construction sector are primarily concentrated in lower tier jobs: 31.23 percent as civil engineering labourers, 22.15 percent as building construction workers, and 18.27 percent as bricklayers. Studies found that women also work in senior management and administrative roles, accounting for approximately 7.1 percent and 4.3 percent of total female employment in the sector, respectively. Across all occupations, most female workers are either unskilled (53 percent) or semiskilled (17 percent). According to the findings in the Construction Industry Skills Council (CISC) Employers surveys in 2018 and 2020, female workers are considered less productive than males.

The construction sector is highly informal; 78.42 percent of female workers are employed as per verbal agreements. Only 0.3 percent of female employees have access to toilets and sanitation facilities, and 1.88 percent have maternity leave benefits. This sector is inherently hazardous due to the nature of its work, yet only one percent of female workers have access to safety gear. Additionally, just 0.78 percent receive transportation and food subsidies, and 0.66 percent benefit from daycare facilities.

Despite policies to boost women's

law addresses critical women's issues like hygiene, maternity leave, medical facilities, and working hours, but enforcement is challenging in informal sectors like construction.

Women are largely confined to unskilled jobs like brick-breaking and excavation due to a substantial skills gap and lack of access to training programmes. The sector's high informality-characterised by irregular recruitment, work hours, and payment methods-limits job stability. Additionally, mobility and transportation issues, coupled with inadequate on site infrastructure and security concerns, deter women from long term-roles. The work environment is often abusive, with frequent conduct violations, resistance to female leadership, and harassment. Unsafe conditions and inadequate accommodations, such as the lack of separate bathrooms and resting areas, further exacerbate these difficulties. Gender based violence, including sexual harassment and physical assault, remains a significant barrier, with limited avenues for complaint. Wage exploitation is prevalent, with female workers often paid less than their male counterparts for similar work. Societal norms and gender bias further discourage female participation, with

women as less productive and costlier due to additional safety and security needs. Barriers related to marriage pregnancy, and care work, combined with a lack of role models and representation in workers' unions, further limit women's opportunities and perpetuate their marginalisation in the construction sector.

To increase female participation and to create a more inclusive environment in the construction industry, several essential actions should be taken to overcome the challenges. Firstly, establishing a comprehensive workforce database, gradually formalising the sector through structured recruitment, fair wages, standard work hours, proper implementation of well-defined health, safety, and compensation policies, and an institutional body addressing workplace abuse and harassment are

Secondly. promoting participation through skills training incentives and creating a gender responsive ecosystem with standard wages, safety measures, maternity benefits, and flexible work hours are also extremely important. Ensuring that training programmes include 30 percent female participation as mandated by the government and declaring minimum wages for entrylevel jobs should be considered.

Thirdly, streamlining the labour hiring processes for contractors and subcontractors, maintaining a worker database with national ID numbers to identify wage gaps, and adding specific clauses to labour laws addressing the construction sector-related concerns are vital. The Ministry of Women and Children's Affairs should play a significant role in this regard, with private actors and labour organisations advocating for workers' needs. Finally, state owned insurance companies should offer workers injury packages.

The construction sector has the potential to increase female workforce participation, ensuring gender parity and aligning with three Sustainable Development Goals (SDGs 1, 5, and 8). Occupations in this sector are predominantly male-centric across all tiers, underscoring gender bias and stigma, necessitating considerable attention from the government and policymakers. Implementing the above recommendations can help make the construction sector a leading example of gender parity and inclusivity. driving sustainable development and economic progress in Bangladesh.

The WikiLeaks project was always going to put various noses out of joint in the journalistic profession. Soaked and blighted by sloth, easily bought, perennially envious, a good number of the Fourth Estate have always preferred to remain uncritical of power and sympathetic to its brutal exercise. For those reasons, the views of Thomas Carlyle, quoting the opinion of Edward Burke in his May 1840 lecture that "there were Three Estates in Parliament; but in the Reporters' Gallery yonder, there sat a Fourth Estate more important far than they all" seem quaintly misplaced, certainly in a modern context.

The media response to the release of WikiLeaks founder Julian Assange from his scandalous captivity after pleading guilty to one count of conspiracy to obtain and disclose national defence information under the US Espionage Act of 1917 provides a fascinating insight into a ghastly, craven and sycophantic tendency all too common among the plodding

Take, for instance, any number of journalists working for the Australian Broadcasting Corporation, official national broadcaster and devotee of the safe middle line. One, a breakfast news anchor for the network's meandering twenty-four-hour service, has a rather blotted record of glee regarding the mistreatment of Assange over the years.

Michael Rowland, torturously insipid and ponderously humourless, had expressed his inexpressible joy when the Ecuadorian government cut off Assange's access to the Internet while confined to the country's London embassy. "A big gold star to Ecuador," he chirped on March 28, 2018. Andrew Fowler, another journalist and far more seasoned on the rise of WikiLeaks, reproached Rowland on Twitter, as the X platform was then called. "Why would silencing a fellow journalist be supported?" For Rowland, the matter was as clear as day. "That remains a disputed opinion, Andrew. Publisher and activist yes. But you put yourself in a small camp calling him a journalist."

These points matter, because they go to the central libelling strategy of the US government's prosecution so casually embraced by mainstream outlets. In such a generated smokescreen, crimes can be concealed, and the revealers shown to be those of bad faith. Labels can be used to partition truth, if not obscure it altogether: a publisher-activist is to be regarded more dimly than the establishment approved

There is certainly no discussion of the extensive redacting efforts Assange had made, as many of his collaborators testify to, prior to the release in November 2010.

Bridging the nutrition gap

Integrating top-down budgeting and local nutrition plans

Joint Action for Nutrition Outcome (JANO) project, implemented by CARE Bangladesh, in association with The Daily Star organized a roundtable, titled "Assessing Public Expenditure in NPAN-2 & 8th FYP" on May 16, 2024. Here we publish a summary of the discussion.



Dr Ikhtiar Uddin Khandaker, Deputy Country Director-Program (Acting) CARE Bangladesh This study, commissioned by CARE, provides an opportunity to examine how public expenditure is

being used for nutrition. The JANO project, a consortium with Plan International and ESDO, funded by the European Union and Austrian Development Cooperation, is implemented directly in Nilphamari and Rangpur districts and indirectly in seven sub-districts. The project focuses on nutrition governance and the rollout of the second National Plan of Action for Nutrition (NPAN-2).

The modifications in the multi-sectoral approach applied through the current structure are some noteworthy changes. For example, the District Nutrition Coordination Committee and the Upazila Nutrition Coordination Committee, established by the government, ensure multi-sectoral engagement by involving different ministries at the district and sub-district levels. These committees follow the second national plan of action, guided by the Bangladesh National Nutrition Council. We aim to identify future directions, including the upcoming third national plan of action and the eighth fiveyear plan, through this process.

Modeling (SANEM), along with myself, worked on a report on NPAN-2 and the JANO project. Our study aims to analyse investment patterns, identify financial gaps, and pinpoint challenges in health financing and NPAN-2 implementation, focusing on the project.

The government has tried to address these challenges through planning documents, notably NPAN-2 (National Plan of Action for Nutrition 2016-2025). The JANO project, within the framework of NPAN-2, proposes a different type of planning based on local-level planning involving the Union Development Coordination Committee (UDCC), Upazila Nutrition Coordination actions and budget allocations. However, Committee (UNCC), and District Nutrition Coordination Committee (DNCC). The aim is to enhance community involvement and supplement central budgeting and planning.

The Bangladesh National Nutrition Council (BNNC) plays a crucial role in monitoring, evaluation, and policy guidance for the 3M (multisectoral, multistakeholder, and multi-level) strategy in NPAN-2, requiring competent human resources and consistent budget support. Our study observed that the 3M approach applied in the Nilphamari and Rangpur regions saw an overall improvement in nutrition-related budgets in areas under these core ministries, UNCC, UDCC, and other aspects. Extending the 3M approach to other contexts would lead to better outcomes.

However, the allocated budget is inadequate compared to global standards, likely needing to triple to align with best practices. Data shows that only seven of the Ministry of Health and Family Welfare projects align with NPAN-2, and the nutrition budget allocation is very small. Additionally, the implementation rate is low, with 71 percent of the allocated budget utilised.

Of 21 nutrition-related projects under the Ministry of Food, 12 have been completed, one is ongoing, and eight show no progress. Out of the nine Ministry of Agriculture projects, two are completed, five are ongoing, and two show no progress. Nutritional budgetary allocation for these important ministries is only around 2.2 crore.

The Ministry of Local Government, Rural Development, and Cooperatives has 76 projects, with 31 completed, 29 showing no progress, and 16 ongoing. The Ministry of Women and Children Affairs (MOWCA) and the Ministry of Education also have nutrition-aligned projects, although their allocation is not very high. The Ministry of Fisheries and Livestock has an impressive record, but data shows less than 50 percent utilisation in some ministries, such as the Ministry of Education and the Ministry of LGRD.

Comparing Bangladesh's nutrition profile, financial allocation, budgeting, and socioeconomic status with countries like India,



Nepal, Lao PDR, and Indonesia is essential to understand the current situation. Lao PDR spends significantly on nutrition-related activities. India has targeted programmes, such as the malnutrition-free initiative, covering 12 ministries and 4.8 lakh joint activities, while Nepal follows a need-based approach. Stunting is a major problem for Indonesia and Bangladesh, and Indonesia's approach to stunting reduction can be

The bottom-up approach advocated by NPAN-2 starts with the Community Support Groups (CSGs) and moves upward. However, budget disbursement in Bangladesh follows a top-down approach, limiting local autonomy. In Bangladesh, 98 percent of the budget is allocated to nutrition-sensitive programmes, with only 2 percent for nutrition-specific interventions.

Monitoring the political agenda of local representatives is also important, as political economy plays a key role. The desired partnerships and coordination between NGOs and the government are missing among NGOs and different ministries. There is also a lack of data, consistency, and flexibility in the budgeting process, which needs addressing.

Bangladesh's nutrition policies, including NPAN and NPAN-2. outline necessary

implementation suffers from a lack of necessary financing and dedicated human resources. Coordination, overseen by the Deputy Commissioner (DC) at the district level and the union chairman, is hampered by their existing workload and the need for constant reminders. While infrastructure development is prioritised, human and social development-such as nutrition, health, and education-remains underfunded and overlooked. Addressing these issues requires increased offices, human resources, and a focus on the cultural and social importance of education, health, and nutrition.

In 1974. Bangabandhu Sheikh Mujibur Rahman emphasised improving nutrition by establishing the "Pushti Parishad Council." Effective implementation

of the 3M approach through increased personnel at district, upazila, and union levels can drive significant progress. DCs cannot manage all tasks alone; dividing responsibilities and scheduling meetings efficiently is crucial. Currently, per capita expenditure in the health sector is low, and it is even lower in the nutrition sector. This needs to change. Adequate human resources and clear role definitions are essential. We need a proper budget to hire and assign people effectively.

Chairman, Kursha Union Parishad, Kaunia, Rangpur In Rangpur, traditional dishes like 'sholka' and 'shajne pata bharta' have gained recognition for their nutritional and medicinal

benefits, thanks to JANO's initiatives. However, human resource constraints hinder the realization of our aspirations across all 21 villages under my purview despite our best efforts.

I urge policymakers to expand JANO's initiatives nationwide and consider additional support through dedicated departments or NGOs to address nutritional deficiencies effectively.



Dr Nusrat Zahan Mithen, Deputy Director, Bangladesh National Nutrition Council (BNNC) A 2019 study with BNNC reviewed today confirms recommendations from 2019 to 2024 remain

consistent, indicating we are on track. To achieve our objectives efficiently, we must address issues such as data deficiencies and incorrect portals, and accelerate our efforts.

In Nilphamari and Rangpur, local incomegenerating activities related to nutrition have led to self-sufficiency, a model worth replicating nationwide. We must develop NPAN-3 through learning from NPAN-2.

RECOMMENDATIONS

- Nutrition should be a top priority for the government to achieve SDG, FYP, and NPAN-2 goals.
- >> Budgetary allocations for the nutrition sector should be increased, properly utilized, and aligned with local-level nutrition plans.
- >> Dedicated human resources should be employed, particularly at the local level, for the effective implementation of nutrition programmes.
- >> Engaging community members, from local pharmacists to religious leaders, to raise awareness about nutrition is crucial.
- >> Conducting nutrition expenditure tracking and promoting transparency among stakeholders are vital.
- >> Continuous monitoring and reliable data collection are vital for effective planning and resource allocation.
- >> Decision-making power must be decentralised to understand the needs at the grassroots level.
- >> New media should be explored to raise awareness.

Despite our focus on nutrition, we have not put any emphasis on the health and well-being of farmers, who are the key

figures when it comes to ensuring nutrition for the entire country. During my time at FAO. I observed a lack of budget allocation for farmers' well-being. This should have more focus in our planning and discussions. Previously, NGOs like UNICEF funded projects to measure children's well-being, but such funding has dwindled.

Implementing a digital system that integrates nutrition and agriculture into a telecommunication

toll-free hub would enable people to call with any queries related to these topics. Additionally, promoting lifestyle modification through awareness-building campaigns can effectively address nutritionrelated issues.



Amit Dey, Manager Food Security, Action Aid Bangladesh

Instead of focusing on fertilisers, importing we should employ more resources to develop local sources, such as vermicompost. Subsidies primarily benefit fertiliser consumption, favouring wealthier farmers, despite the greater contribution of small farmers to nutrition-related fields.

Ineffective implementation due to capacity limitations within departments and ministries prioritises project completion over quality. Nutrition garden funds disproportionately benefit men despite our women's significant nutritional contributions. Shifting this mindset is crucial for enhancing our nation's nutritional landscape.



Syed Md. Nuruddin, Advisor, CSE – PLAN

International Bangladesh The loss in the nutritional sector in our country is substantial, amounting to almost BDT 2 Billion, according to WFPO. The

well-being of individuals in society is more closely related to social dynamics and available resources than to institutional setups. We need to shift our investment towards social mobilisation, an area currently receiving minimal budget allocation. Knowledge dissemination fosters sustainability, and investing in this area now can maximise the benefits of our demographic dividend.

introduction "health and well-being" in our curriculum aligns with the issue of nutrition and the prime minister's directive to create smart citizens for the future. It covers the issues of nutrition, health and soft life skills to lead a better life. "Better health, better education," is the motto we believe in. However, coordination among the nine ministries dedicated to this issue is lacking, leading to sporadic initiatives with incomplete follow-through. Currently, almost half of the budgetary allocation remains unutilised, despite the government's best intentions. We need to figure out a way to coordinate and create a chain effect with our work.

FPMUPeople from all walks of life must internalize the notion of good food and good health. On this,

people with influence can be the examples of their healthy lifestyles for ordinary people to follow their footsteps besides creating awareness among them.

Our honourable prime minister has emphasised the need to increase investment in the food sector, build food banks, and raise awareness, especially youth engagement, to combat this crisis. The State is already working on 'Nutritious food for all'.

Quality over quantity in budget allocation is crucial, supplemented by private investments. Despite challenges, we have progressed significantly, ranking 81st in the 2023 hunger index, whereas our neighbouring India and Pakistan stand at 111th and 102nd respectively. Individual awareness of consumption and social event food protocols are essential. The government's food-based dietary guidelines could be a great source of information on consuming nutritious food. Cohesion among bodies and aligned goals, coupled with mindset shifts, are paramount for holistic progress.

We can get a lot of people to volunteer for this issue owing to our culture of community dependency.

We aim to implement a real-time tracking system for local budget allocation and spending, improving coordination among NGOs with a bottom-up approach. If we streamline the projects and operations of multiple NGOs with a bottom-up approach, we will get better outcomes. NPAN-3 will be people-oriented, focusing on community needs and past lessons to shape a better future.

The nutrition community in the country is vibrant and growing. Implementing a mandatory reporting system for nutrition budgeting could be beneficial. Such a system would align with the recommendation for a public expenditure review, promoting transparency across departments and organisations.

NPAN2 will expire in 2025, and we need to identify the key takeaways from this plan for NPAN3. The Country Investment Plan 3 will also

expire in 2025, and we have emphasized the importance of a resilient, nutrition-sensitive food system in that plan as well. There are some key focus areas for NPAN3 and CRP that we can consider. Battling anemia and child obesity are two of the fifteen health indicators where Bangladesh is lagging, so we should prioritize these issues in the next plan.

There are inconsistencies in the costing of NPAN2, and we need to address those and determine the costing for NPAN3. Some food and nutrition-related work can be decentralized to the union level, with the central government providing policy-related support. In addition to projects, revenue channels, awareness building, and relevant human resources can be strengthened to achieve better outcomes. The budgetary allocation must reflect local-led demands. Lastly, mobilizing efforts to halve per capita out-of-pocket health expenditure from \$64 to \$30 by 2030 is imperative for goal

Will BCB's World Cup 'discussions' make any difference?

Bangladesh Cricket Board (BCB) is set to sit down for a board meeting today to discuss the just-concluded T20 World Cup performances. Such meetings, however, have barely contributed to an improved show in global events.

Apart from World Cup performances, which are routine discussions following ICC or other major events, BCB will also discuss the appointment of an international contractor for a new stadium alongside other matters.

"There is also a standard procedure that after the Bangladesh team returns from playing any major ICC or ACC event, the performances are discussed," BCB CEO Nizamuddin Chowdhury told reporters yesterday regarding the meeting.

"It's a routine matter and there are also financial matters to discuss regarding the structure of Game Development and Ground and Facilities. Mainly those are the areas that are to be prioritized," he added.

The board remains content that the Tigers were able to make it to the second round of the tournament, the Super Eight stage, beating Sri Lanka, Nepal, and the Netherlands to secure their berth from a tough group. However, the Super Eights revealed the gap in quality the team has with the big sides in mega events.

Bangladesh did not show the approach



Ecuador finished level with Mexico on four points after the teams drew 0-0 in Group B but Sanchez's side secured a place in the knockout stages thanks to their superior goal difference.

Venezuela advanced as group winners while Mexico and Jamaica were eliminated.

Argentina had a solid start to their title defence, with their forwards Lautaro Martinez and Julian Alvarez scoring all five of their goals in the group stage. With skipper Lionel Messi out injured in their final group game against Peru, Argentina faced no problem as Martinez's brace paved way for smooth sailing and showed reigning world champions are productive even without their magician Messi.

'We know it is an unmatched opponent, and we know how tough it's going to be," Ecuador coach Sanchez was under illusions about the scale of the take they face in the last eight against Group A winners Argentina at the NRG Stadium in Houston, Texas on Friday.

"It is yet another final for us, and we will try to compete against the world's champion and the world's best team ... I believe that our team is going to be extremely motivated to play a good match."

Colombia the balance they needed, their run including wins over Spain, contender to win the Ballon d'Or and Germany and a dramatic fightback against Brazil when winger Luis Diaz scored a late brace to secure a shock win days after Colombian guerrillas freed his kidnapped father.

Playing an attractive style of attacking football with a relentless pace and physicality, Colombia started the Copa America by beating Paraguay and Costa Rica and topped the group with a draw against Brazil.

Beating the five-time world champions would send a statement that South America has a new force to be reckoned with.

"I know our fans are excited and

who am I to give advices to people's emotions. We are also excited, so let's enjoy it," Lorenzo said after his team beat Costa Rica 3-0 on Friday.

Brazil are struggling after a heartbreaking penalty defeat by Croatia in the 2022 World Cup quarterfinals.

Under the guidance of new manager Dorival Junior, Brazil's Copa America debut was disappointing -- a goalless draw against Costa Rica that was their fifth straight competitive game without a win, their worst run in 23 years.

They bounced back with a 4-1 win over Paraguay thanks to a stellar performance by forward Vinicius Jr., who showed why he is a strong after guiding Real Madrid to a LaLiga-Champions League double.

"Colombia are a stone in our shoe which we're going to try to get it out of our way in the next game," Brazil midfielder Bruno Guimaraes told a press conference on Sunday.

"They have a lot of players who can decide things individually, they're a very physical team, good to play against. This is the Brazilian national team shirt we are talking about.

"It's going to be a great test for us, a great game that we want to win to finish first (in the group). That's what is required when you wear Brazil's shirt."

U19 coach Naveed looks beyond World Cup success

Bangladesh Cricket Board (BCB) reappointed Naveed Nawaz -- the ICC Under-19 World Cup winning coach with Bangladesh -- last month for a second stint, hoping to develop new talents and form another successful batch.

In his first stint, Naveed nurtured a team that won the world title in South Africa in 2020 and youngsters like Towhid Hridoy and Shoriful Islam from that side have already made their mark in international cricket.

Given Bangladesh national team's current difficulty in producing results in ICC events, perhaps following the template that served the U19 team so well could be an option.

Naveed's U19 team played several matches in foreign conditions leading up to the World Cup and their preparation served them well in the tournament.

Thus, when Naveed, who arrived in Mirpur yesterday to officially take over, was asked whether the U19 template can be followed in the national team, he felt there was a case for it.

"I am sure [template can serve BCB]. All the planning that's going on, there is room for that," the Sri Lankan told The Daily Star following

his press conference. However, Naveed sees difficulty in devising a programme just like the U19s due to the ICC FTP calendar and sees value in the team touring abroad and allowing players to play franchise cricket in other countries.

"That's something [playing abroad or taking part in franchise cricket] that people have improvised with and thought about on what they want to do and which areas they want to develop," said Naveed, who rejoined the Bangladesh U19 team following his stint as Sri Lanka national team's assistant coach.

The U19 team's success in South Africa is arguably Bangladesh's greatest achievement in cricket. However, Naveed did not want to get buried under expectation.

"Me coming back after having won a World Cup in 2020, of course there is expectation. I think I have to focus on other things rather than something that passed four years ago. Tournaments are not won just because you have won it in the past," said Naveed at yesterday's press conference.

But above all, he spoke about the need to nurture talent, using leg-spinner Rishad Hossain as an example who couldn't make the cut in the U19 World Cup winning squad in 2020 but made a great impression in the recent ICC T20 World Cup.

"You got to work on technical and mental issues, you can't hold onto them [problems] for long. That's something BCB will be looking to do at in their HP and age-group programmes.

"Look at him [Rishad] now. It's important that U19 is running well but it's also important that we look after the bigger group of our players as well."

Wary Dutch look to recalibrate

The Netherlands might have emerged from a disappointing performance in the group phase of the European Championship with a favourable pairing but they will be wary of Romania when they meet on Tuesday in Munich in the round of 16. The Dutch finished third in

in Berlin, but it could have turned out a lot worse after they avoided a potential meeting with England and got Romania in the first knockout round. Romania are 40 spots below

their group after losing to Austria

seventh-placed Netherlands in the FIFA rankings and have won only two of 19 games played in six Euros finals appearances. Romania have also only won

once in 14 past meetings against the Dutch, losing 10. Their sole success was a Euro 2008 qualifier, won 1-0 in Constanta.

There will be no inferiority complex, however, from Romania, who have little to lose and face a struggling Dutch side trying to find some sort of rhythm after tepid showings in Germany.

There has been much soulsearching from the Netherlands his players. after their three games, with



captain Virgil van Dijk making an astonishing admission that perhaps they had over-estimated their own

Romania, who topped Group E with four points, made an impressive start with a 3-0 win over Ukraine but lost 2-0 to Belgium and topped the group despite drawing against Slovakia.

Defensive discipline is the cornerstone of coach Edward Iordanescu's on-field approach, and he has worked hard off-field, too, in order to create a positive team spirit and instil self-belief among

The Dutch, whose defence were game today.

sloppy against Austria, will be wary of the quick counter-attack, with

Denis Dragus the lone target man. Romania are without left back Nicusor Bancu who is suspended after collecting two yellow cards.

Dutch coach Ronald Koeman's own concerns will be about his midfield where Joey Veerman was unceremoniously replaced after 35 minutes in the last game.

A return to the line-up for the speedy Jeremie Frimpong is likely but calls for a switch to a back five, as employed under Louis van Gaal at the World Cup in Qatar where they got to the last eight, were rejected

Forward Cody Gakpo has scored twice and Memphis Depay once in the tournament and substitute attacker Wout Weghorst has often proved to be the man for the big occasion when needed.

Playing in the back of Dutch minds, however, will be what happened three years ago at the last Euros when they were similarly fancied to beat the Czech Republic in the last 16 in Budapest but suffered an ignominious exit.



around 7:45am. "Now it is producing more than 500 megawatts of electricity," he said

around 11:15am. Earlier, the PDB officials said the Adani authorities found a leak in a valve of the circulating water pump of the plant, which is why they forcibly shut down the

unit of the plant. Another unit of the plant went into routine maintenance during the Eid holidays, which is supposed to resume this week.

Trump has immunity for official acts

US top court rules

The US Supreme Court yesterday found that Donald Trump cannot be prosecuted for official actions taken as president, but can for private acts, in a landmark ruling recognising for the first time any form of presidential immunity from



The justices, in a 6-3 ruling written by Chief Justice John Roberts, threw out a lower court's decision rejecting Trump's claim of immunity from criminal charges involving his efforts to undo his 2020 election loss to Joe Biden.

The court's six conservative justices were in the majority and its three liberal justices dissented.

"We conclude that under our constitutional structure of separated powers, the nature of presidential power requires that former president have some immunity from criminal prosecution for official acts during his tenure in office," Roberts wrote.

"At least with respect to the president's exercise of his core constitutional powers, this immunity must be absolute. As for his remaining official actions, he is also entitled to immunity," Roberts added.

Roberts said Trump's case will be sent back to the lower courts for further review.

Hamas ally fires rockets into Israel

Most launches intercepted; Israeli tanks advance in north, south of Gaza

The Palestinian Islamic Jihad group fired a barrage of rockets into Israel vesterday, in an apparent show of force as Israeli tanks pressed their advance deeper into Gaza amid fierce fighting, residents and officials said.

The armed wing of Islamic Jihad,

an Iranian-backed ally of Hamas, said its fighters fired rockets towards several Israeli settlements near the fence with Gaza in response to "the crimes of the Zionist enemy against our Palestinian people".

The volley of around 20 rockets caused no casualties, according to the Israeli military. Most launches were intercepted. But it showed the group still possess rocket capabilities almost nine months into Israel's offensive it

against it. In some parts of Gaza, Hamas fighters continue to stage attacks on Israeli forces in areas that the army

says is aimed at neutralising threats

had left months ago.

Yesterday, Israeli tanks deepened their incursions into the Shejaia suburb in eastern Gaza City for a fifth day, and tanks advanced further in western and central Rafah, in southern Gaza near the border with Egypt, residents said.

The Israeli military said it had killed a number of fighters in combat in Shejaia yesterday and found Arab mediators' large amounts of

weapons there. Hamas said that, in Rafah, its fighters lured an Israeli force into a boobytrapped house in the east of the city and then blew it up,

causing casualties. Also in Rafah, the Israeli military said that an airstrike killed a Hamas fighter who fired an anti-tank missile at its troops.

The health ministry in Hamas-run Gaza said yesterday that at least 37,900 people have been killed during nearly nine months of offensive. The toll includes at least 23 deaths over the past 24 hours, a ministry statement said.

India replaces colonial-era criminal laws Critics say new laws could

create confusion REUTERS, New Delhi

India replaced colonial-era criminal laws with new legislation yesterday, which Prime Minister Narendra Modi's government said would make the country more just, but the opposition said risked throwing the criminal justice system into disarray.

The new laws were approved by parliament in December in Modi's previous term with the government saying they aim to "give justice, not punishment". It says they were needed as colonial laws had been at the core of the criminal justice system for more than a century.

Among the key changes is replacement of the sedition law frequently used as a tool of suppression, after its enactment under British colonial rule to jail Indian freedom fighters.

Under the new laws - which replace the Indian Penal Code, the Indian Evidence Act, and Code of Criminal Procedure - sedition is replaced with a section on acts seen as "endangering the sovereignty, unity, and integrity

"About 77 years after independence, our criminal justice system is becoming completely indigenous and will run on Indian ethos," India's Home (interior) Minister Amit Shah told reporters. "Instead of punishment, there will now be justice."

Criminal cases registered under the repealed laws before yesterday will continue to follow them, Shah said,
