'2 killers went to Kolkata on medical visa'

Says DB in report to court

'Waste of time, money to place such a bill'

MPs criticise placement of trade, tariff commission bill

Trade and Tariff Commission The Bangladesh (Amendment) Bill, 2024 was passed in Parliament yesterday to further amend Bangladesh Trade and Tariff Commission Act, 1992.

The amendment bill was placed to change the name of the "secretary" post of Bangladesh Trade and Tariff Commission to "director".

State Minister for Commerce Ahasanul Islam Titu moved the bill, and it was passed by voice vote, however, multiple lawmakers criticised it.

Jatiyo Party MP Hafiz Uddin Ahmed said the work of the commerce ministry is to control commodity prices.

If the ministry brought any law to control the market, or if they had brought any law to break syndicates, then it could be said the commerce ministry is doing a good job, said Hafiz. "It [commerce ministry] tries to control the market at times, and things become fine then. But things return to how they were after the ministry leaves.

Independent MP Pankaj Nath said the bill is not in the interest of the people. People's interests would be served if the Tariff Commission was tasked with determining the prices of consumer goods, daily commodities, availability in the market, coordination of imports and production and making it easy for the people, he said.

He criticised bringing the bill to parliament just to change a word, saying, "It is a waste of time and money to call 350 MPs of parliament to change the name of the position from secretary to director."



Several people were injured after two separate officers' organisations of Barisal University clashed over taking part in a human chain against the Universal Pension Scheme yesterday afternoon. New curriculum, same old craze for guidebooks

Despite government efforts to promote a new curriculum focusing on critical thinking, guide books aligned with the old memorisation-based approach continue to dominate book markets.

As subject-based six-month assessments for grades six to nine are scheduled to start today, the sales of these supplementary materials have surged in recent

According to the National Curriculum and Textbook Board Act, only books published or approved by the board can be prescribed as

textbooks in schools. Additionally, the Prohibition Act of 1980 completely bans the printing and marketing of unauthorised notes or guidebooks.

While visiting several book markets in the capital, guidebooks aligned with the new curriculum were found to be displayed and openly

Rashed Mia, owner of a bookstore in Farmgate, said, "Despite the introduction of the new curriculum, the demand for guidebooks remains steadfast. Parents and students regularly seek these materials."

Another shop owner in Nilkhet said Mathematics guides for class 9 published by Panjeree Publications are being sold at Tk 430, English at Tk 360, and History and Social Science at Tk 320, among others.

Guidebooks are similarly prevalent in book markets across Rajshahi, Kushtia, Jhenidah, Khulna, and several other districts, as found by our local correspondents.

A teacher from Rajdhani High School in the capital said the new curriculum has the potential to reduce students' reliance on guidebooks, but it would take

"Until then, parents will continue seeking such resources, as the guidebooks offer additional chapters and exercises for their children," the teacher added.

Even different online platforms are selling guidebooks of major publishers like Panjeree, Lecture

Publications, and Royal Publications.

This newspaper reviewed an English guidebook for class

nine, spanning 558 pages. Upon analysing several chapters, it was observed that each chapter begins with instructions for students,

teachers, and guardians. The guidebook provides step-by-step guidance on how students should approach activities after studying a

topic in the original textbook

It also includes additional examples, questions, and answers relevant to each subject.

WHAT AUTHORITIES SAY Prof Moshiuzzaman, acting chairman of NCTB, said,

"Regulations alone cannot eliminate guidebooks from the market. What we need is a systematic change, which is exactly what the new curriculum aims to achieve."

"When parents realise that guidebooks offer limited support unless students engage in class activities or assignments, their demand will naturally decline," he Jahurul Islam, a parent in Jhenidah, said, "My added.

MURDER OF EX-MP'S WIFE Daughter killed her to conceal affair: PBI

Shubal Kumar Roy, an electrician by profession, was a frequent visitor to former MP Shamsuddoha Khan Mailish's house.

He engaged in an affair with the lawmaker's daughter, Shamima Khan Majlish alias Poppy.

When MP's wife Selima Khan Majlish came to know about it, she restricted Shubal's entry to the house. In response, Poppy allegedly stabbed her

mother to death to conceal the affair, then attempted to stage the murder as an accident by electrocuting Selina with Shubal's assistance. Banaj Kumar Majumder, the chief of Police Bureau of Investigation, yesterday confirmed the

arrests of Shubal, Poppy, and house help Aarti Sarkar in connection with the murder, which took place 13 years ago. On June 14, 2011, Selima was found injured at

her home in Savar. She died at Combined Military Hospital on June 18.



3 IEDs from Rupganj flat recovered

Anti-Terrorism specialised unit Police, yesterday recovered improvised explosive devices (IED) from a flat of a four-storey residential building at Narayanganj's Rupganj upazila and defused them later through explosion.

ATU started the drive at 10:30am, which lasted six hours.

Mohammad Sanowar Hossain, SP (Operation) of ATU, said, "The flat was rented by militants as a hideout. Two men and one woman, along with two children, were living in this flat for a few months. Those three adults have connections with Ansar-Al-Islam."

However, ATU didn't reveal their names.

Md Shahnewaz, a tenant of the building, said, "The building's owner is a Saudi expatriate. The flat was rented out to a couple a few months ago."
