Didn't think a director could ruin his own creation: Bobby

This Eid-ul-Azha, Eamin Haque Bobby starrer film Moyurakkhi was released nationwide. Shortly after, the actress expressed disappointment in her portrayal, claiming it did not match what was promised. She also accused the film's director, Rashid Polash, of not paying her full remuneration.

In addition to her acting career, Bobby has ventured into the restaurant business, opening Bobstar Dining in Gulshan, Dhaka. However, the business has faced financial losses.

Recently, a case was filed against Bobby at Gulshan Police Station, accusing her of attempted murder, theft, assault, and intimidation related to her restaurant business. Bobby discussed these issues with The Daily

Could you share with us the issue between 'Moyurakkhi's' director Rashid Polash and you?

The story of the movie is beautiful, and those who have seen it can attest to this. It could have been even better, but the director [Rashid Polash] failed to portray my character properly. Many beautiful sequences were not included in the released version. I never imagined a director could treat his creation in such a way. As a result, the movie seemed disorganised.

over all payments to the director, but he did not properly pay the remunerations of all the artistes. He also told the producer he needed money to shoot specific scenes but never filmed them.

Just a day before Eid, we were told the film would be released in 15 theatres, but it ended up in only two. When we confronted him, we argued, and something happened that I should not detail.

The director claimed that he paid your remuneration completely and also said you were not on time on set.

They scheduled me for about 17 days, but I only shot for six. Many of the scenes I shot were not included in the film. Despite taking money from the producers in my name, I did not receive my full payment as per the agreement. The director should provide evidence for his claims.

> You have been accused of attempted murder, theft, physical assault, and intimidation. What do you have

to say about these allegations? These are all false. I am an artiste, and these actions are intended to damage my image. Those behind this thought I would remain silent, out of fear of losing my reputation. However, I have always believed in standing up against injustice. In my decade-long career, no one has ever made negative remarks against me. I am now addressing

this legally. Since false cases have been filed against me, I have also filed a case stating the truth and everything that has happened.

For the past three months, I have tried to resolve this matter but couldn't find a solution. After the attack at the restaurant, I had no choice but to speak out. These incidents have caused me extreme mental and financial distress. I have lost around Tk 75 lakh. Additionally, Muhammad Sakib Uddoja, AGM of YN Centre, has filed a false case against me and my business partner, Mirza Abul Bashar.

What are your expectations from this case now?

believe the real truth will come out soon. Circumstances are not always favourable for everyone, but I have never encouraged anyone to fabricate something to gain attention in any legal case. All the recognition I have received so far is through my work. The production company handed I believe that justice will be served.

## Road damaged before nanding over

Carpeting of a four-kilometre-long newly renovated road in Barguna's Patharghata upazila is getting damage at different points even before handing over the road resurfacing work.

Local people, however, blamed use of sub-standard materials in the construction work and lack of supervision by the authorities concerned as well.

During a recent visit this correspondent found the newly constructed road, stretching from in front of Patharghata Upazila Health Complex to Haringhata Eco Park, has developed numerous cracks at different spots withing three months of the road resurfacing work.

According to Patharghata Local Government Engineering Department (LGED), a tender was called to construct the four-kilometre road, under Road Widening and Strengthening Project, in 2022-23 fiscal year.

Abul Kalam Azad, a contractor from Patuakhali, got the Tk 6.72 crore work order that started in June 2023 and was responsibility to repair the damaged scheduled to the completed by June this

However, two local contractors from Barguna -- Mohammad Shahin and Shahidul Islam Mridha -- took the subcontract of the work and implemented it. repair work is done.

Local resident Mojibur Rahman said they were happy to see the road work done, but soon got disappointed after seeing the newly resurfaced road collapsing at many points within three months of its construction.

Patharghata Sadar Union Parishad (UP) Chairman Alamgir Hossain said the situation arises due to lack of proper supervision and carelessness by the authorities concerned.

Although LGED has been informed about the irregularities on several occasions, but to no avail, he added.

Despite repeated attempts this correspondent could not contact one of the sub-contractors Shahin for his comment in this regard as he did not receive the mobile phone.

While talking, another subcontractor Shahidul said construction of the road has been done as per the work schedule.

Patharghata LGED Upazila Engineer Chandan Chakraborty said the contractor concern is yet to hand over the project officially and it is his portion of the road.

Contacted, Sultana Nadira, lawmaker from Barguna-2 constituency, said the upazila LGED engineer has been asked not to pay the final bill until the road

of Jamura in Sunamganj's Chhatak upazila, returned home from the shelter centre barely a week ago; now her house has been submerged once more. "Before I could repair the

house, another flood hit my village, forcing me to move back to the shelter centre," she said in a frustrationfilled voice.

Meanwhile, communication with Sylhet's Companiganj and Gowainghat, and Sunamganj's Dowarabazar, Tahirpur, and Bishwambharpur has been snapped.

In Moulvibazar, sections of a road that serves as a dyke for the Kushiyara River got breached at Hamorkona village in Sadar upazila, inundating vast areas.

The latest round of flash floods hit in the early hours of yesterday, and the situation is rapidly deteriorating due to the relentless rain.

In 24 hours till yesterday morning, Sunamganj town recorded 300mm of Sylhet recorded rainfall, 294mm, Sunamganj's Chhatak recorded 233mm, Sunamganj's Tahirpui recorded 211mm, and Tahibayar's Sherpur

recorded 183mm. At the same time, Meghalaya's Mawsynram recorded 207mm of rainfall, while Cherrapunji recorded 141mm in the 24 hours till last morning, according to the Indian Meteorological Department.

In the next two days, there is a possibility of light to moderate rainfall over all the country along with heavy to very heavy rainfall in some areas, according to the Bangladesh Meteorological Department.

The IMD also predicts very heavy rainfall in Assam and the neighbouring state of Meghalaya until Friday.

Owing to the constant rain, the Surma, Kushiyara, Sari, Gowain, Juri, and Manu rivers are all flowing above the danger level and rapidly rising, the Water Development Board reported vesterday

Aftab Ahmed, chairman of Tahirpur upazila, said, "The upazila has been affected, with residents of Tanguar Haor, Shanir Haor, and Matian Haor losing their homes to the recent flood."

Prime Minister Sheikh Hasina has urged all concerned, including civil administration. to prepare for potential floods across the country in order to protect citizens from the consequences and devastation.

Contacted, Divisional Commissioner Abu Ahmed Siddique, said, "The region is experiencing a third wave of flooding due to heavy rainfall here as well as in neighbouring India's Meghalaya and Assam states. The coming days could be critical, depending on the
