Ensure govt staffers comply with provision for asset disclosure **HC orders authorities**

The High Court vesterday directed the authorities concerned to strictly ensure compliance with the relevant provisions of the law for time-to-time monitoring of the disclosures of movable and immoveable properties of government officials serving in civil capacity.

It also directed them to submit progress reports to this effect before the court in three months.

The HC bench of Justice Md Nazrul Islam Talukder and Justice Kazi Ebadot Hossain also issued a rule asking the respondents to explain why their failure and inaction to adopt guidelines or policies or to enact proper legislation to prevent accumulation of illegal wealth (movable or immovable) through corruption by the public/government servants serving in civil capacity, and their family members, should not be declared illegal.

116 killed in stampede at India religious event

Most of the dead are women, children; many others injured; death toll may rise

At least 116 people, many of them women and children, were killed in a stampede at a Hindu religious gathering in north India vesterday, authorities said, in one of the country's worst such tragedies in years.

The stampede happened in a village in Hathras district, about 200 km (125 miles) southeast of the national capital New Delhi, where authorities said thousands had gathered in sweltering late afternoon

"The incident happened due to overcrowding at the time when people were trying to leave the venue," Ashish Kumar, administrator of the Hathras district of Uttar Pradesh, India's most populous state, told reporters.

Chaitra V, another senior state official, told broadcaster India Today that people may have lost their footing as they sought water in the heat.

"There was wet mud at one place where people may have slipped. Also because of the heat, people may have made their way to the spot where water was kept and that could have caused the incident as well," she said. Video clips recorded by news agency

ANI showed bodies piled into the back of trucks and laid out in vehicles. Purses and bags covered in dust, were

heaped up at the venue, with people sitting on their haunches sifting through them to identify their belongings.

Mobile phones were similarly piled together, waiting to be claimed by their

A video on social media showed a large crowd packed into a tented area, standing and listening to devotional tunes as they waved their hands in the direction of the religious leader who sat on a stage.



It also showed some women hanging on to the bamboo poles holding up the canopy to get a better view above the heads of the large crowd.

"There must have been about 50,000 people...at the gate on the highway, some people were going left and some people were going right, the stampede was caused in that confusion," Suresh Chandra, a witness who was at the gathering, told local media.

Seema, a woman who travelled from a town almost 60 km away to attend the event, said she was leaving the venue when the stampede occurred. She was accompanied by three relatives, two of whom were killed.

FLOOD IN SYLHET Thousands marooned in three districts

to continue their protest around 3:45pm yesterday. The demonstration lasted an hour, causing severe traffic congestion in nearby roads.

At a time when Sylhet is still reeling from the devastation caused by last month's deluge, the region is now experiencing a fresh round of flooding triggered by the nonstop rain over the last few days, plunging thousands deeper into despair.

Low-lying areas of eight upazilas in Sylhet, including parts of the city, five upazilas in Sunamganj, including parts of the municipality, and two upazilas in Moulvibazar have been newly inundated.

witnesses Sylhet large-scale destruction to life and property every monsoon due to flooding in its vast network of rivers.

Last month, flash floods displaced more than 22 lakh people during two rounds of flooding in the region, affecting hundreds of areas and causing untold suffering to the dwellers.

The flood waters left behind a trail of destruction, submerging villages, destroying crops and wrecking homes. This time, the ongoing flood

situation is expected to worsen, with more rainfall predicted in the coming days, according to the weather department and the Flood Forecasting Warning Centre

Israel pounds Gaza after evacuation order

Thousands flee their homes in Khan Yunis; 25 more Palestinians killed

Israeli forces bombarded several areas of the southern Gaza Strip yesterday and thousands of Palestinians fled their homes in what could be part of a final push of Israel's intensive military operations in nine months of offensive. Eight Palestinians were killed and dozens wounded in Khan Yunis,

health officials said. Israel's military said that two soldiers had been killed in battle a day earlier.

Israel's leaders have said they were winding down the phase of intense fighting against Hamas, and would soon shift into more targeted operations.

Later yesterday, Palestinians were killed in Israeli tank shelling of a street in the densely populated Zeitoun neighbourhood in Gaza City in the north of the Strip, medics said. Footage on some Palestinian social media showed the scene at a

local market, with bread scattered on a floor stained with blood. The Israeli army had ordered residents of several towns and villages in eastern Khan Younis to evacuate their homes on Monday evening, prior to tanks re-entering the area the military had left

Thousands who had not heeded the call were forced to flee their homes in the dark overnight, as Israeli tanks and planes bombed Karara, Abassan and other areas that had been named in the evacuation orders, residents and Hamas media said.

"Where will we go?" said Tamer, a 55-year-old businessman, who has been displaced six times since October 7.

"Every time people go back to their homes and begin to rebuild some of their lives even on the rubble of their houses, the occupation sends the tanks back to destroy what is left," he told Reuters via a chat app.
