PM'S VISIT TO CHINA

Dhaka to seek \$20b fresh loans from Beijing

Bangladesh will seek fresh loans amounting to \$20 billion during Prime Minister Sheikh Hasina's upcoming visit to China, which Beijing hopes would be a "game changer" in the bilateral relationship.

Of the sum, \$15 billion would be for infrastructure projects and \$5 billion -- which would be disbursed in yuan -- would be to facilitate payments for imports from China, according to the officials involved in preparing the proposals.

"We have reached consensus on several aspects but are yet to finalise it — we will finalise it by July 7," one of the officials told The Daily Star

The foreign ministry yesterday held an inter-ministerial meeting for finalising the joint statement that will be adopted by Bangladesh and China during the PM's visit from July 8 to

The visit comes just two weeks after Hasina's first state visit to India after she was sworn in as the PM for a fourth straight term.

The trip to China, Bangladesh's largest trading partner, is viewed as a balancing act by Hasina, who hopes to be in the good books of two competing regional powers.

Bangladesh will seek Chinese support for the Southern Integrated Development Initiative (SIDI) centring

the Payra Port in Patuakhali, according to finance ministry officials. This will be an integrated development plan for the southern region involving projects on transport and communication, ICT, power and energy, logistics and a special economic zone.

SIDI will see the establishment of an electric vehicle plant, a hi-tech park and a logistic hub at a strategic location, said a finance ministry official.Japan is supporting the Moheshkhali-Matarbari Integrated Infrastructure Development Initiative (MIDI) and the BIG-B Initiative (The Bay of Bengal Industrial Growth Belt).

"Similarly, Dhaka wants Beijing to support SIDI," said a foreign

Bangladesh earlier sought a loan in Yuan worth \$5 billion to facilitate importers to make payments for goods and services procured from China amid Bangladesh's strained dollar stockpile.

What's the harm if India given transit? **Asks PM in JS**

Prime Minister Sheikh Hasina yesterday said Bangladesh cannot keep its doors shut in this era of globalisation and she wondered what the loss would be if India is given transit facilities.

"There are objections about why we gave transit facility to India. We have already given this facility. What is the harm in this? Rather, we are getting tolls for the use of roads. The people of our country are having benefits. We are earning some money," she said in her concluding speech of the budget session in parliament.

Blasting those who criticised her recent visit to India, Hasina said the opposition parties continue saying many things about her tour.

She said Bangladesh needs to join Trans-Asian Highway. "We have also secured transit facilities from India for [carrying goods to and from] Nepal and Bhutan."

Labour predicted to eject Tories as UK goes to polls

Britain's political leaders made a final push for votes yesterday on the last day of an election campaign expected to return a Labour government after 14 years of Conservative rule.

Ex-premier Boris Johnson staged an 11th-hour rallying call for the flagging Tories but an ally of Prime Minister Rishi Sunak conceded their party was staring at an landslide' "extraordinary defeat.

Voters will cast ballots from 7:00am (0600 GMT) today, with polls predicting that Labour will win its first general election since 2005 making its leader Keir Starmer prime minister.

That outcome see Britain swing leftwards back to the centre ground after almost a decade and a half of right-wing

Conservative governments. Starmer was crisscrossing the UK on Wednesday with visits in England, Scotland and Wales in a bid to shore up Labour support and

warn against complacency in the campaign's "If you want change, you have to vote for it,"

the 61-year-old told reporters, adding that he was "not taking anything for granted".

ACC sues Rajuk official, his wife over illegal assets

The Anti-Corruption Commission yesterday filed two cases against Rajuk Director Mobarok Hossain on charges of acquiring assets through illegal means.

In one case, filed under section 109 of the penal code, his wife Shahana Parveen is the main accused and he is the second accused. The other case, under the Anti-Corruption



Mobarok Commission Act-2004, was filed only

against Mobarok. Asif Al Mahmud, the commission's assistant director at the Dhaka Integrated District Office-1, filed the cases, ACC Public Relations Officer Aktarul Islam told The Daily Star.

In the wealth statements submitted by Mobarok, the ACC found evidence of acquisition of assets inconsistent with his income of Tk 41.46 lakh, according to a case statement.

It said Mobarak declared that he has movable and immovable assets worth Tk 1.86 crore in the wealth statement he submitted to the ACC. By reviewing the records obtained during the verification, the ACC found authenticity in the wealth statement submitted.

NORTHERN MYANMAR Clashes break out near military regional command

Clashes broke out near a regional military command in northern Myanmar yesterday, residents and local media said, in what appeared to be a widening offensive against junta

Gunfire has rocked the northern Shan state town of Lashio, home to the military's northeastern command, since late Tuesday, one resident told AFP.

"Since last night we have been hearing shooting targeting the regional military command... we dare not to go outside," they said, requesting anonymity.

Fighting was happening outside the town, another resident told an AFP correspondent, who heard one explosion down the phone.

She said the military had closed all roads into Lashio but that some shops in the town were still open.

Videos uploaded to social media showed a wooden building destroyed and partly in flames, and local media reported six civilians had been killed in shelling.

India given transit?

Noting that Bangladesh brings fuel from India's Assam to the Parbatipur depot through a pipeline, the leader of the House said this enabled Bangladesh to purchase fuel at a cheap rate.

Hasina, also the Awami League president, said the government has a plan to bring fuel to Natore through a pipeline.

She described how the interest of the country was neglected during the rules of military dictators Ziaur Rahman and HM Ershad, and also during the tenure of Khaleda Zia's government.

The PM said Zia had opened Bangladeshi market for Indian goods. She said Zia and Ershad did nothing to resolve the enclave and Tin Bigha Corridor issues with India.

She said Khaleda forgot to raise the Ganges water-sharing issue during her visit to India in 1990s.

Hasina said she objected to selling gas to India ahead of the 2001 general election, but Khaleda agreed to it.

'As a result, my party Awami League could not win a large number of seats despite securing larger percentage of votes.

"We couldn't form the government because of my unwillingness to sell gas. So, who sells the country? Khaleda Zia, HM Ershad and Ziaur Rahman did it. Awami League doesn't do it."

However, the VAT Commissionerate passed an order on 09.06.2024 without affording these two companies the opportunity of hearing which is a clear violation of section 73 read with 85 of the VAT and Supplementary Act, 2012 as well as of principles of natural justice. Interestingly, the Commissioner in his orders both dated 09.06.2024 totally suppressed the fact of filing of application by these companies on 4.06.2024 only to justify his order. These two companies

never evaded any amount of VAT whatsoever and we are confident that if we are given a proper opportunity to produce our explanation along with the supporting documents, we will be able to establish the fact that no VAT has ever been evaded. These two companies challenged the said orders of the VAT Commissioner by filing two writ petitions before the Hon'ble High Court Division of the Supreme Court of Bangladesh on 30.06.2024. The Hon'ble High Court Division vide order dated 01.07.2024 was pleased to issue Rule Nisi in the said two Writ Petitions. We already informed the newspaper authority about the pendency of the said two Writ Petitions at 02:00 PM on 30.06.2024. However, the Daily Star published the said news report on their online edition at 4.25 P.M on 30.06.2024 and subsequently published in print version on 01.07.2024 totally concealing the fact that the said order passed by the Commissioner of VAT was already sub-judice before the Hon'ble High Court Division. This amounts to frustration of administration of justice and therefore, is a serious contempt of the Hon'ble High Court

7. We strongly deny and object to the said false, frivolous, baseless and motivated news report published in The Daily Star. We reserve our right to take appropriate legal action against the said false news report.

OUR RESPONSE Firstly, the content of our news report was based on findings of an audit by the field office of NBR's Customs, Excise & VAT Commissionerate, Chattogram, and a subsequent review by a five-member committee headed by an additional commissioner, Chattogram VAT Commissionerate. The Daily Star simply reported on the VAT Commissionerate's findings that the said two companies have unpaid VAT and consequent penalty worth Tk 7.000 crore.

So the claim in the second paragraph of the rejoinder that "all the above allegations are absolutely false, frivolous, baseless and the said report has been published with ulterior motive" is totally untrue. The Daily Star published the story in public interest, and with no other motive whatsoever.

During the audit and review process, the two S Alam firms were given the opportunity to explain the discrepancies in sales and purchase data they presented in their audited annual financial reports and in their VAT returns. This mismatch between two sets of data, presented by the two companies themselves to the authorities, were discovered by the government's VAT wing, and not by The Daily Star.

> In its own admission to the VAT authorities, the two companies said that they "presented inflated values in their audited financial reports to avail bank loans," to which the NBR review committee said that "if this is true, they have clearly committed a criminal offence." The review report further said that the related bank has also "acted very unprofessionally" if it sanctioned loans based on an "imaginary and untrue" financial statement.

> We reported these findings and observations of the revenue collector, and not a single word more.

> As is our practice in line with internationally accepted standards, we approached their parent company on June 27, 2024, three days before we went online and four days before we ran the report in version. Between our first contact and the publication, we have spoken to S Alam Group Executive Director (Finance) Subrata Kumar Bhowmik and the Group's legal counsel Md Mustafizur Rahman multiple times over the phone and exchanged eight text messages via WhatsApp. Md Mustafizur Rahman also sat with The Daily Star at its office on June 29, 2024, to offer their explanations. The

> meeting lasted about 80 minutes. In fact, much of the explanations offered in paragraph 3, 4 and 5 of this rejoinder have been included in our story, quoting Mustafizur. We even sent a draft of his comments before publication, asking him to see if it reflected the company's version, and he said by phone "it's okay" and did not suggest any changes, deletion or addition.

> To be clear, we dedicated 442 words for the Group to clarify their position in our story. This is only from our telephonic and face-toface conversations with the Group representatives. If we count the 347 words that we also have incorporated in our story from the NBR's VAT wing report as their explanation on the VAT evasion allegation, we have dedicated 789 words for the Group in our 2830word story.

> About two hours before we were ready to go online, S Alam Group sent a notice asking us not to publish the story since they have filed writ petitions against the orders of the VAT Tribunal. Since we did not comment upon or discuss the merits of the writ petition, we went ahead with our publication which reports on the findings of the NBR field office as provided in its orders.

> The Daily Star never engages in "motivated" reporting as the last paragraph of the rejoinder falsely claims. We repeat, we publish stories in public interest, and a story on allegations of VAT evasion worth Tk 3,538 crore and consequent penalty amounting to another Tk 3,531 crore have huge public interest.

The rejoinder does not dispute any facts or present any proof to counter the content of our story. We stand by

A team of Chinese Exim Bank yesterday met with officials of the Economic Relations Division, the finance ministry wing that negotiates foreign loans, to discuss the terms and conditions for the loan, The Daily Star has learnt from officials informed with the proceedings.

The other projects for which Dhaka will be seeking loans from China include: the Dhaka Mass Rapid Transit Development Project (Line 2), the Bhanga-Kuakata rail line, bridge over the Kocha river at Pirojpur, the renovation of Dhaka Medical College Hospital, and Maheshkhali-Matarbari Bakhrabad 3rd parallel gas transmission pipeline.

An announcement on starting negotiations for a free trade agreement may also come up during the visit as Bangladesh is eager to boost exports to hina to reduce the trade gap.

Beijing wants to upgrade the relationship with Dhaka to a "comprehensive strategic cooperative partnership" from partnership" that was declared during the visit of Chinese President Xi Jinping in 2016, according to officials involved with the proceedings.

Stakeholders, however, advised putting national interests at the centre of the negotiations.

Bangladesh wants to sign FTAs or

other deals with China but it needs to negotiate efficiently to serve the national interests, said Rumana Islam, a commissioner of the Bangladesh Securities and Exchange Commission.

"We have a number of bilateral trade treaties, but mostly they protect the interests of the foreign investors. They don't speak much about Bangladesh's interests," she said at a roundtable on the future of China-Bangladesh relations organised by the Bangladesh Foundation for Regional Studies yesterday.

China can support Bangladesh in the development of state-of-the-art hospitals that are in high demand here, said Imtiaz Ahmed, executive director of the Centre for Alternatives.

"Several lakh Bangladeshis abroad for treatment every year, a trend that could be reversed with Chinese investment in the health sector," he

There are opportunities for China, India and other countries to work on the Teesta project.

"It is important that the Teesta project implementation begins soon as 29 million people are suffering because of the water deficit in the Teesta. It is time for us to turn geopolitical conflicts into cooperation," Ahmed said at the event moderated by Shah Ali Farhad, a former special assistant to Hasina.

Besides, all teachers should have better packages during their service as well as in retirement, so that the best minds are attracted to the profession, they say.

The finance ministry in a gazette in March announced a scheme titled Prottoy for recruits autonomous. joining the governing, nationalised, statutory, or such organisations, including public universities, on or after July 1.

Under the scheme, 10 percent of the monthly basic salary of an employee, up to Tk 5,000, will be deducted and given to their pension fund. The employing organisation will contribute the same amount to the fund. The government will pay the authorities managing the pension. There will be no one-time gratuity for the retiring employee.

The government will investment the money, and the proceeds will be added to the fund.

Under the existing pension system, employees do not need to contribute to their pension funds. Faculty and staff recruited before July 1 this year will be

under the current pension scheme. Finance Minister Abul Hassan Mahmood Ali announced in his budget speech on June 6 that government officials, including bureaucrats, would be under a new pension scheme, which the finance ministry later said would be named Shebok. Employees joining after July 1 next year would be under this scheme.

The government has yet to publish

terms of Shebok. University teachers, meanwhile, are concerned that their retirement benefits will be cut by Prottoy while government officials under Shebok will be better off, said Prof Muhammad Shahadat Hossain Siddiquee who teaches economics at Dhaka University.

He is also a member of a committee the protesting teachers formed to review the new pension scheme.

TEACHÊRS' DEMAND IS LOGICAL

It is good that the government is heading towards a system in which the employee contributes to the pension funds, said AB Mirza Azizul Islam, former adviser to a caretaker government.

The government must manage the fund carefully and meticulously so that it does not turn into a losing concern.

Retired employees should not be kept waiting for the monthly pension.

The government spending in pension and gratuities was Tk 4,395 crore in fiscal year 2009-10 -- 4.3 percent of the budget. For the 2024-25 fiscal year, the government allocated Tk 36,902 crore, which is 4.63 percent of the total budget,

according to the Ministry of Finance. Azizul, also a former chairman of Bangladesh Securities and Exchange Commission, said, "The teachers'

demands seem logical." There should be no discrimination and division in the pension of public servants, added Azizul, also a former

Although under the Prottoy scheme pensions will be provided after employees reach the retirement age of 60, the retirement age of university teachers is 65. The National Pension Authority press release said the government will make corrections in the rules.

The new scheme will not provide any one-time pay after retirement, but the monthly allowance will be multiple times higher than that of the existing system.

Rashed Ahmed, a former student of Rajshahi University, was provisionally recommended to become an assistant judge following the final results of the 16th Bangladesh Judicial Service (BJS) exams.

After getting the recommendation, Rashed thought his days of uncertainty and anxiety would finally come to an end, as he would be joining a government job, which would help him finally start providing

But to his utter dismay, even after nine months of the results being published, he has yet to join the office due to the delay in publishing the official gazette.



Over 37 lakh cases are pending in the country. If the recommended candidates could join their positions sooner, it would help alleviate some of this backlog.

Due to that, a total of 104 candidates have yet to join their positions as assistant judges, despite being provisionally recommended.

Bangladesh Judicial Service Commission (BJSC), which is responsible for overseeing the appointment of assistant judges, published the recruitment notice for the 16th BJS on February 7 last year.

According to the BJSC website, the preliminary exams were held on March 18, followed by written exams from May 21-31. Oral exams were completed on September 19 and the final results were published on

Despite the completion of these stages, the final step -- publishing the gazette -- remains pending, causing significant distress among the

NEW CURRICULUM Questions of half-yearly exams 'leaked'

The question papers and their answers to the half-yearly assessment for classes 6 to 9 have been allegedly leaked on social media before the exams.

The recently introduced assessment process began yesterday involving approximately one crore students.

The leaked questions, centrally prepared by the National Curriculum and Textbook Board (NCTB), were found to be identical to those used in yesterday's assessments.

Prof Md Moshiuzzaman, acting chairman of the NCTB, admitted that the papers had been found on social media.

"These [question papers] were sent directly to the IDs of the headteachers around noon before the exam. Unfortunately, these questions were shared by the headteachers, leading to their distribution among the students."

"You can't call it a question paper leak," he said, explaining that during last year's evaluation, such papers were published on the official website about two weeks before the exams.

"As the evaluation process is activitybased, students won't get any advantage, even if they get the questions a week in advance. They have to perform and do tasks in front of their teachers during the evaluation," he said.


Regarding steps taken to address the leak, he said an urgent notice has been issued to headteachers, warning of strict action against anyone found responsible for future leaks.

Four to die for killing B'baria AL leader in 2012

Judge Mohammad Halim Ullah Chowdhury gave the verdict. The death row convicts are Rafiq Uddin Thakur, Mafuz Ali, Mokkarm Ali Sohel, and Ismat Ali.

Public Prosecutor Ashok Kumar Das said the court sent the convicts -- all leaders and activists of AL and its associate wings -- to jail.

Iqbal Azad was stabbed and hacked to death by his political rivals on October 12, 2012. The PP said Iqbal was murdered in a planned way so that the convicts could grab tender businesses and others political benefits.

SUNDARBANS Mangroves along rivers to be restored

The Forest Department has taken an initiative to reforest the lost mangroves on the banks of 52 rivers and canals adjacent to the Sundarbans in Khulna, Bagerhat, and Satkhira.

Under the initiative, only the plants that grow naturally in the Sundarbans will be planted on the banks of the rivers and canals that flow through Sharankhola, Morrelganj, Mongla, Dacope, Koyra, and Shyamnagar upazilas of the districts.

The International Union for Conservation of Nature (IUCN) Bangladesh and the Forest Department will jointly implement this initiative titled "Upper Sundarbans Restoration Programme" funding from the French Development Agency.

It will be implemented following the model of mangrove afforestation done across five acres of land on the banks of the lake at Sheikh Russel Eco Park in Khulna's Batiaghata upazila.

Dr Abu Nasser Mohsin Hossain, divisional forest officer, said from July 6 to 8, officials of the department, members of the French Development Agency and IUCN Bangladesh will visit the cyclone-affected areas and the mangrove model created in the eco park.



Encroachment, pollution killing **Burai beel**

MIRZA SHAKIL, Tangail

Burai Beel, an important natural swamp in Tangail district town, is quickly shrinking due to pollution and illegal encroachment.

Once a vast waterbody, locals used it to commute to the district town from adjoining areas. It also served as a natural reservoir of native fish species, providing livelihood to local fishermen.

Tangail municipality, which is responsible for protecting waterbodies in the areas under its jurisdiction, has been dumping municipal wastes into Burai through several drains, thereby polluting its water. Moreover, some local influential people, including those with political backing, have been encroaching the swamp by filling it with different structures and claiming ownership using forged documents.

As a result, the swamp is now on its death bed. It can no longer drain away the accumulated rainwater of

the town during monsoon, leading to waterlogging in neighbouring areas.

"We used to bathe in Burai's clean water decades back. Now the water is as polluted and dirty as it gets. It was also full of indigenous fish species," said Rafiqul Islam, a local.

Gautam Chandra divisional coordinator of Bangladesh Environmental Lawyers Association, said Burai Beel and waterbodies in Tangail are disappearing due to people's greed and authorities' irresponsibility.

Ratan Ahmed Siddique, general secretary of Committee to Protect Waterbodies in Tangail, said many areas in the town have become prone to waterlogging due to poor drainage system, and loss of waterbodies.

Contacted, SM Sirajul Haque Khan Alamgir, mayor of Tangail municipality, said they are aware of the issue and steps are underway to recover and protect all waterbodies in the town.

3 killed, 2 hurt in road accidents

Three people were killed and two injured in road accidents in two districts yesterday, according to reports from our correspondents.

In Tangail, two people were killed and two others injured in a collision between a bus and a truck in Mirzapur upazila.

The accident occurred on Dhaka-Tangail highway in Gorai area around 5:00am when the Dhaka-bound passenger bus from Nilphamari hit a pole-laden parked truck, said Mohammad Anisuzzaman, sub-inspector of Gorai Highway Police Station.

Mugni Miah, 35, supervisor of the bus; and Forina Begum, 55, a passenger from Dimla, Nilphamari, died on the spot.

Police seized both the vehicles after the accident, said the SI.

peanut cultivation

KONGKON KARMAKER, Dinajpur

Severe flash floods across Rangpur division since mid-June have dealt a blow to peanut cultivation in the region.

Peanut, or groundnut, is a vital cash crop for the marginal farmers in the division who cultivate it on the sandy shoal lands of Teesta river basin.

Torrential rainfall in the upstream in India caused the Teesta to swell, inundating vast stretches of croplands across five districts in the division
-- Rangpur, Dinajpur, Kurigram, Lalmonirhat and Nilphamari.

According to the Department of Agricultural Extension in Rangpur, 5,512 hectares of land in the division have been brought under peanut

At least 2,315 hectares of land have been affected by floods.

Peanuts cultivated on 315 hectares of land were completely damaged in the flood, said DAE sources.

This year, the production target for peanut was set at 12.600 tonnes.

Pirgachha, and Kaunia upazilas of Rangpur district, this correspondent observed acres of sandy land used for peanut cultivation have become waterlogged following the flash floods.

"Peanut is harvested around June. The flash floods inundated our Visiting the shoals of Gangachara, croplands when we were gearing up

for harvesting our produce. My crops were washed away right before my eyes," said Foyzur Rahman, a farmer from Shibdeb Char under Pirgachha.

"I had planted peanuts on three acres of land after borrowing money from a local lender. How am I going to pay my debts now?" he lamented.

Abed Ali, a farmer from Kaunia upazila, said, "Even if we managed to harvest some of our produce, we could not save those due to a lack of drying space after the floods.'

Many other farmers echoed them, predicting that this year's production target is unlikely to be achieved due to the disaster.

Obaidur Rahman, deputy director of DAE in Rangpur region, said, "Peanut on 315 hectares of land has been damaged while over 2,300 hectares of land used in peanut cultivation have been affected due to floods."

He, however, expressed optimism that the overall production will not be affected much.

Robbery accused found dead in police station

The hanging body of a youth, accused in a robbery case, was found inside the lockup of Chandgaon Police Station in Chattogram vesterday morning.

my brother was involved in mugging and theft incidents. But he recently pledged to my mother that he gave up left all the crimes and started living a crime-free life as an auto-rickshaw driver."

"His rickshaw was stolen at Kotwali a few days ago, and the owner of the rickshaw put a lot of pressure on him over money. A few days prior to his arrest, he tried to take his own life," she added.

Four to walk gallows for killing man

A Chattogram court yesterday sentenced four persons to death and another to life term imprisonment for killing a man in Raozan upazila eight years ago. Judge HM Shafiqul Islam delivered the verdict,

court sources said. The death row convicts are Mithu Chowdhury, Sumon Chowdhury, Md Delwar Hossen and

Ershad Hossen. Delwar is on the run.

Another accused Sudip Chowdhury was given life term imprisonment. The court also acquitted another accused Eliash Ilu from the charges.

Victim's lawyer Sudip Kanti Nath said the court also fined the death row convicts Tk 50,000 each and Sudip Tk 10,000. The court sent Sudip to jail and issued arrest warrants against the others.

According to the case, the convicts murdered Sulal Chowdhury, 55, a quack, on June 25, 2016 following a feud over properties. Later, they dumped the body in a local ditch.

Meanwhile, another Chattogram court sentenced a man to life term imprisonment for killing his wife in the city's Bakalia area.

According to police, Md Jamal, 37, from Cumilla strangled Parvin Akhter, 24, over a family

A family torn apart by the sea

One brother dies, another goes missing in the bay within two years

Cyclone Remal left the Choto Masua village of Pirojpur's Mathbaria upazila devastated in its wake. With no support coming from the government, many fishers were forced to head out to the sea, despite an active 65-day fishing ban, to feed their families.

Al Amin, the only earning member of his family of six -including his elderly father, blind mother, wife and two children -was one such fisherman.

A total of 12 fishermen started their voyage on June 23 from the village.

However, tragedy struck mid

Monday morning, around 10-

12 kilometres from Mahipur of Patuakhali's Kalapara upazila, Noor Islam, also died after going leaving five fishermen -- including out to sea one year back. Al Amin -- missing.



WDB higher officials have already visited the erosion affected areas, he said, adding that dumping of sandfilled geo-bags will be done to check erosion soon.

Univ teachers likely to sit with govt

under the banner of the Federation of Bangladesh University Teachers' Association (FBUTA) have been refraining from work since Monday demanding reinstatement of the previous pension facilities instead of the newly introduced "Prottoy" scheme of the Universal Pension System.

FBUTA Secretary General Nizamul Haque Bhuiyan yesterday said Road Transport and Bridges Minister Obaidul Quader spoke to them over holding a meeting this morning to discuss their demands.

"We will join the meeting, but our movement will continue," he told The Daily Star.

Teachers have been demonstrating since May 26 protesting the government decision to include all officers and employees, joining the service of autonomous, self-governing, nationalised, statutory, or similar organisations and their subordinate institutions on or after July 1, 2024, under the Prottoy pension scheme.

Teachers said that the newly recruited teachers will suffer financial loss and many people will not take up teaching at universities if the new pension scheme is

They also demanded a separate pay scale for university teachers and inclusion of professors in the pay grade equivalent to that of a senior secretary.

PROTESTS CONTINUE Skipping classes and exams, Dhaka University teachers under the banner of Dhaka University Teachers'

Association (DUTA) staged demonstrations for the third straight day yesterday. Addressing a sit-in in front of the arts faculty building, the teachers rejected the finance minister's statement

and a press release from the National Pension Authority regarding the universal pension system. Prof Zeenat Huda, general secretary of DUTA, called

upon the finance minister to sit down for talks. "Why is the finance minister avoiding discussion?" she

Boycotting administrative activities, staffers under the banner of Dhaka University Karmakarta Karmachari Oikya Parishad held a sit-in in front of the administrative building.

As a result, many former and current students of the university could not collect their certificates and mark

No classes and exams were held at BUET, Rajshahi, Jahangirnagar, Chittagong, Jagannath and other universities yesterday. The university authorities either kept the transport service suspended or significantly reduced trips to and from campuses.

Meanwhile, 107 university teachers under the banner of University Teachers' Network yesterday called for scrapping of the "Prottoy" pension scheme and urged the authorities concerned to implement a separate pay scale for them.

In a statement, the teachers' platform said imposing a new pension scheme on the teachers without any discussion or consultation with the stakeholders is vet another "blatant display of the current government's arbitrary behaviour".

Over 50,000 stranded as flood hits new areas No provision for staying conviction

At 6:00pm, the Kushiyara was flowing 142cm above the danger



Anti-quota demos rage on across the country

The demonstrations began around 2:30pm in front of Dhaka University's Central Library. They marched to the Shikha Chirantan and then to the TSC and Dovel Chattar.

The procession reached Shahbagh at 3:45pm and blocked the intersection, disrupting vehicular movement on key roads leading to Bangla Motors, Science Lab and Kakrail.

Hasib Al Islam, an organiser of the "Boishommo Birodhi Chattrra Andolon" (Anti-Discrimination Students Movement), said, "The High Court recently declared the 2018 quota cancellation circular illegal. The government has filed a writ petition, and the court is set to deliver a verdict on the quota system tomorrow [today]. We're waiting for that. If the quota system is reinstated, we will wage tougher movements.

A significant number of police personnel were present at the intersection ahead of the protesters' arrival.

Our journey towards independence under the visionary leadership of our Father of the Nation Bangabandhu Sheikh Mujibur Rahman was inspired by the same yearning for freedom and self-determination.

The central role of the people, of each and every American citizen, is deeply enshrined in our democracy. Our Constitution, signed almost 250 years ago, gives the idea that the basis of

government derives from the people. The preamble of that document says, We, the people of the United States of America, in order to form a more perfect union, establish justice, ensure domestic tranquility, provide for the common defense, promote the general welfare, and secure the blessings of liberty to ourselves and our posterity, do ordain and establish this Constitution for the United States of America.

In his very first speech as President of the United States of America, George Washington re-emphasized the point. He declared that the continuation of America's democracy was entrusted to the American people. Democracy in the United States is not, never has been, nor will ever be perfect. We are not above reproach. We must strive continually to achieve our more perfect union. Our Declaration of Independence boldly declared that all men are created equal. That was simply not the case in 1776. It took us until 1865 to abolish slavery. Women did not have the right to vote until 1920. In 1964, we finally outlawed major forms of discrimination against racial, ethnic, national, religious minorities, and women. And only in 2015 did our Supreme Court affirm the constitutional right of LGBTQI plus couples to marry.

Clearly, our democratic journey has been winding path, reflecting aspirations and imperfections that come with the pursuit of a more perfect union, and a more perfect democracy. 2024 is an unprecedented year for elections. More people are voting this year than at any time in history. In fact, national elections this year will involve nearly one-half of the world's population. As we know, Bangladesh's elections have already taken place, and ours will take place in November of this year. As those elections take place, it is important to ensure that the voice of the people is heard and that everyone be committed to the idea of striving for ever more perfect democracy.

Today I would also like to express the desire to build an ever more perfect relationship between the United States and Bangladesh. Both of our nations were founded on the principles of democracy, human rights, and national sovereignty. Both of our nations earned our independence through the sacrifice of brave patriots. And both of our countries need brave patriots to help us consolidate and advance our democracies.

But who are these brave patriots? They are the dissidents. They are the journalists. They are the human rights activists. They are the opposition politicians. They are civil society activists. In short, they are anyone willing to challenge the status quo, to point out our shortcomings, and to fight for change. Just because they disagree does not mean that they are disloyal.

As we celebrate American independence tonight in Bangladesh, I am reminded that we are on a collective journey. As a partner, and with humility, the United States has cooperated with Bangladesh over the past 53 years to advance the rights, wellbeing, and prosperity and security of our respective peoples, and we will continue to do so.

Labour set to surpass 1997 landslide in election: poll

The UK Labour party is 99 percent "certain" to secure more seats in today's general election than when it won a landslide victory in 1997, a major new poll said on Tuesday.

centre-left The opposition party of power since 2010 -- is predicted to claim 484 out of a total of 650 seats in what would be an unprecedented victory in modern British history, pollster Survation said.

Meanwhile, the rightwing ruling Conservatives and the centrist Liberal Democrats (Lib Dems) are in a close race to come a distant second and form country's official opposition, it added.

The prediction is the latest in a series of socalled MRP polls -- which use large national samples to forecast results for every UK constituency -- that estimate Labour will win emphatically today.

Such a scenario would see its leader Keir Starmer replace the Conservatives' Rishi Sunak as prime minister.

Labour has led the Tories in the polls by double-digit margins for nearly two years, and the gap has failed to narrow during a sixweek election campaign widely seen as having gone badly for Sunak.

Survation said its data indicated that Labour would win around 42 percent of the overall vote, ahead of the Conservatives on 23 percent.

However, due to the UK's winner-takes-all electoral system in each of its 650 constituencies, that would see the Conservatives capture just 64 seats, with the Lib Dems predicted to claim 61.

Labour's estimated 484 seats would exceed the 418 won by ex-prime minister Tony Blair in 1997, and even top the Tories' landslide haul of 470 in 1931.

The pollster also predicted that Labour would again become the largest party in Scotland, winning 38 of its 57 seats.

2024 UK ELECTION

Sunak: Conservative leader still hoping for unlikely win

The UK Conservatives hoped Rishi Sunak would stabilise the party and country when they made him leader following his predecessors' chaotic tenures. Instead, he has led them to the brink of electoral

The party's MPs installed the 44-yearold former financier in October 2022, after Liz Truss's 49-day premiership imploded when spooked markets moved against her tax-slashing plans.

Sunak succeeded to a point in stabilising

the country's economy, but failed to stop bitter Tory infighting, or to make a dent in the persistent polling lead held by the opposition Labour Party. Buoyed by rare pieces of economic good news, Sunak called today's election in late May, despite not having to face the voters until early 2025.

He hoped the shock announcement would catch right-wingers Reform UK by surprise, and Labour's 20-point polling lead would shrink during the campaign.

But Sunak's campaign has lurched from one disaster to another. By far the most damaging was Sunak's decision to leave early from D-Day commemoration events in France, provoking unilateral outrage and alienating right wing whose votes he desperately needs.

Starmer: Britain's next prime minister?

Labour leader Keir Starmer is a former human rights lawyer turnedstate prosecutor whose ruthless ambition and formidable work ethic look set to propel him to Britain's highest political office.

The 61-year-old, named after Labour's founding father Keir Hardie, is the centreleft opposition party's most working-class leader in decades.

"My dad was a toolmaker, my mum was a nurse," Starmer tells voters often, countering depictions by opponents that he is the epitome of a smug, liberal, London elite.

With his grey quiff and black-rimmed glasses, Starmer remains an enigma in the eyes of many voters, who are

predicted to propel him to Downing Street after today's general election. Detractors label him an uninspiring opportunist, but supporters insist he is a managerial pragmatist who will approach being prime minister the same way he did his legal career: tirelessly and

"Politics has to be about service," Starmer said in a recent campaign speech, repeating his mantra to put "country first, party second" following 14 years of Conservative rule under five different

Sometimes appearing uncomfortable in the spotlight, the devoted Arsenal fan, who came to politics late in life, has struggled to shed his public image as buttoned-up and boring.

Key issues at stake in UK polls

Here are some key issues at stake in the UK general

WILL JADED VOTERS TURN OUT?

The main opposition Labour party is widely predicted to win and has been determined not to take any risks, making for a lacklustre election

For the past two years, polling has suggested that Labour is 20 points ahead of the Conservatives, and no amount of campaigning has managed to shift the dial. But if that indicates a desire for change after 14 years of Tory government, there does not appear to be much enthusiasm for Labour's plans.

Indeed, Labour has repeatedly warned that it does not have a "magic wand" to change the country overnight.

The apathy extends to both leaders, with 72 percent having an unfavourable opinion of Tory leader Rishi Sunak and 51 percent of Labour's Keir Starmer, according to a YouGov poll this month.

That has prompted questions about whether voters will turn out in large numbers spurred on by the promise of change or remain at home jaded by years of chaos and no great love for party leaders.

LUCKY NUMBER EIGHT FOR FARAGE?

An unexpected addition to the campaign, Nigel Farage — the Brexit figurehead who has now become the spokesperson of hard-right, antiimmigration views — entered the race as the leader of Reform UK.

Despite a surge in the polls, the UK's first-pastthe-post system makes outright victory for the 60-year-old former European parliamentarian and his party unlikely.

If he succeeds at his eighth attempt to get a seat in parliament as the MP for Clacton-on-Sea in east England, Farage -- a Donald Trump ally -- will have even more visibility.

If he fails, his startup Reform UK party, currently polling around 19 percent, would still play a decisive role in the race between the Tories and Labour in several constituencies.

TORY WIPEOUT?

Several polls suggest the party of Winston Churchill, Margaret Thatcher and Boris Johnson will win fewer seats than the 141 it secured in 1906, in what would be the worst result since its creation in 1834.

Speculation has already started about who would succeed Rishi Sunak to lead the fragmented party. It remains to be seen how many big names will save their seats and what direction the party, which was centrist under David Cameron (2010-2015) and then drifted to the right, can take. In the event of Reform's success, some Tories would not object to an alliance.

WEAKENED SCOTTISH NATIONALISTS?

Nothing seems to be going right for the Scottish National Party (SNP), which has dominated the devolved nation's politics for the last 15 years.

The surprise resignation of first minister Nicola Sturgeon in 2023 destabilised the party. Her successor Humza Yousaf only lasted a year.

The left-wing party is still the target of a probe into its finances in which Sturgeon's husband was implicated and does not have a viable strategy to deliver independence, a fight that was revived by Brexit but blocked by London.

First Minister John Świnney insists that winning in a majority of Scotland's 59 constituencies would be a green light for him to launch fresh negotiations on another referendum with the new government

Russian forces advance in Ukraine's eastern region Kill five in Dnipro strikes; dozens injured

said yesterday its forces had captured a district in the key hilltop town of Chasiv Yar near Bakhmut in eastern Ukraine, where Moscow has been pressing for months.

The claim from Moscow came just after Kyiv said that Russian strikes on the industrial city of Dnipro had killed five people and wounded nearly three dozen more including a 14-year-old girl.

The defence ministry said its troops had "liberated" the Novy district of Chasiv Yar, but it was unclear if it was claiming its forces had crossed a canal which runs through the eastern part of the town.

The capture of Chasiv Yar -- a prized

military hub that was once a sleepy town home to some 12,000 people -- would pave the way for Russian advances towards the last Ukrainian-controlled civilian centres in the Donetsk region.

Russia's capture of the district was also reported by the DeepState military blog, which has links to the Ukrainian army.

It said the area had been flattened by Russian bombardments, and that withdrawing was "a logical, albeit difficult decision." There was no immediate reaction from officials in Kyiv.

The Russian attack on Dnipro prompted Ukraine's President Volodymyr Zelensky to call on allies to help bolster its air defences and provide more long-range weapons to thwart Russian strikes.

CENTRAL ASIAN SUMMIT

Putin, Xi vie for influence

The leaders of Russia and China were in Kazakhstan yesterday for a regional summit, seeking to harden anti-Western alliances and press their influence in the strategic Central Asian region.

Russian President Vladimir Putin touched down in the Kazakh capital of Astana yesterday morning for a meeting of the Shanghai Cooperation Organization (SCO) -- a Beijing-led regional bloc that covers Central Asia, India and Iran.

Moscow and Beijing have deepened their political, military and economic ties since Russia launched its invasion of Ukraine in February 2022.

Alongside Chinese leader Xi Jinping, who arrived in Kazakhstan on Tuesday, the pair see the SCO as a key forum for advancing their strategic interests across Eurasia. "We attach great importance to partnership cooperation within this organisation," Kremlin aide Yury Ushakov told Russian state media outlets ahead of Putin's arrival.

"We believe that the SCO, as well as the second major association of BRICS, are the main pillars of the new world order, a locomotive in the context of establishing genuine multilateralism in world affairs," he added.

Both Russia and China have railed against what they call a US-led "hegemony" on the world stage.

China's Foreign ministry spokeswoman Mao Ning said earlier this week that Beijing believed the SCO summit would "help build more consensus among all parties and make contributions to promoting security, stability and development of member countries", and advance "lasting peace and common prosperity in the world".

80pc of Gaza people now displaced

Says UN coordinator

The UN humanitarian coordinator for Gaza said Tuesday that 1.9 million people - 80 percent of the territory's population -- were now displaced, adding she was "deeply concerned" by reports of new evacuation orders for Khan

The United Nations has estimated that up to 250,000 people are impacted by the Israeli military order for civilians to leave parts of Khan Yunis and Rafah in Gaza, which has a total population of 2.4 million.

"Palestinian civilians in Gaza have been plunged into an abyss of suffering -- their home lives shattered, their lives upended," the UN coordinator for Gaza, Sigrid Kaag, told the Security Council.

"Over one million people have been displaced once again, desperately seeking shelter and safety, (and) 1.9 million people are now displaced across Gaza," she said. "I'm deeply concerned about reports of new evacuation

orders issued in the area of Khan Yunis," Kaag added. 'The war has not merely created the most profound of humanitarian crises. It has unleashed a maelstrom of

She said that not enough aid was reaching the war-torn strip, and that the opening of new crossings, particularly to southern Gaza, was necessary to avert a humanitarian disaster. Kaag said the Rafah crossing between Gaza and Egypt should be reopened, and also pleaded with the

international community to do more to fund relief efforts. Aid volumes entering Gaza had "dropped significantly" since the start of the Israeli operation in Rafah, she added.

UN Secretary-General Antonio Guterres's spokesman said "yesterday's orders for the evacuations of 117 square kilometers in Khan Yunis and Rafah governorates apply to about a third of the Gaza Strip, making it the largest such order since October."

"An evacuation of such a massive scale will only heighten the suffering of civilians," said the spokesman, Stephane Dujarric.

Another bad precedent in public service

Loosening service rules, and the grip of accountability, raises fresh concerns

In another questionable move with the potential to exacerbate corruption, the government seems set to allow public servants to engage in stock market trading, reversing a decades-old prohibition. According to a report, the law ministry has positively vetted an amendment to the Government Servants (Conduct) Rules, 1979 forwarded by the public administration ministry. If or once approved, employees will be able to legally buy or sell primary shares and bonds of registered companies. This is one of the several changes billed as necessary for a "modern and time-befitting" code of conduct. But given past experiences, we must say this is the wrong way to go about it as allowing officials to trade stocks may open a Pandora's box of unethical practices.

We don't need to go that far back to understand why. Matiur Rahman, a top NBR official now under investigation for corruption, allegedly made a fortune through stock market investments, using insider information, which is illegal. He is not alone in such pursuits. Many government employees, despite current prohibitions, are believed to be engaged in stock trading. Many have already demonstrated their willingness to exploit their positions for personal gain. Against this backdrop, legalising stock trading could widen the scope for corruption. The speculative nature of stock markets means that losses are inevitable, and when faced with losses, employees might be tempted to recoup them through illegal means.

The proposed amendment, therefore, will further weaken, rather than fortify, the ethical framework governing public officials. Unfortunately, the public administration ministry seems to be going in the opposite direction. In another editorial not long ago, we commented on its proposal to relax another provision in the Government Servants (Conduct) Rules requiring officials to submit wealth statements every five years, and how the removal of such an important layer of scrutiny could encourage dishonest officials to commit crimes with little fear of detection. Over the years, we have seen how such anti-graft rules and regulations have been relaxed, sometimes even lightening penalties for proven corruption.

As we write this, news has emerged of another top official, a former additional IGP, and his wife who illegally amassed wealth worth Tk 30.35 crore while concealing information of wealth worth Tk 36.91 crore—adding to the recent disclosures of scams involving former and current security and revenue officials. The list will only grow, whether it comes to light or not, unless we tighten relevant rules, enhance existing oversight mechanisms, and enforce stricter penalties for violations. Government employees, because of the power they exercise, must be held to the highest standards of conduct. We, therefore, urge the public administration ministry and other authorities to refrain from further relaxing service rules.

Sad plight of BSMMU specialised hospital

Govt must ensure unimpeded operation of health facilities

When it comes to public healthcare in a poor country particularly hard as it deprives millions of low-cost medical care. This is why it is hard to accept what has been happening at the Bangabandhu Sheikh Mujib Medical University's (BSMMU) super-specialised hospital.

Inaugurated in September 2022—with world-class facilities capable of providing stem cell therapy, gene therapy and robotic operations, and a capacity to treat 5,000 patients a day—the hospital now receives less than 500 patients. This is due to shortage of doctors, technicians and support staff, and the corruption involved in their recruitment. We have commented on it before, and sadly, the situation has not changed much even in a year. What's more disheartening is that 90 percent of the medical equipment bought from South Korea with \$33 million remains unused because of the manpower shortage. The warranty period of some of the machines is nearing expiration, requiring additional maintenance cost. Add to that the burden on the public to repay the Tk 1,047 crore loan that the government had taken from South Korea to build this state-of-the-art hospital.

In short, far from providing world-class, low-cost health service as advertised, it's turning into a white elephant. A country where out-of-pocket health expenditure is among the highest in the world, and where approximately 800,000 people travel to foreign countries for medical treatment, this super-specialised facility could have been a beacon of hope. That hope has turned into despair because of systemic negligence and corruption, with visiting patients not getting to see doctors on time or having simple diagnostic tests done there. They even have to pay almost the same doctor fees as in private hospitals.

This is not the first time that public trust in the health sector has been betrayed. Thanks to the problems mentioned above, we have often seen how well-intentioned projects like this one turned into a debacle in their operation phase. It seems the projects are valued more for the money that can be spent rather than the return on investment, or the benefits owed to the public. How else can the purchase of medical equipment without even recruiting technicians to operate them be justified? We urge the higher authorities to critically look into the case of BSMMU's super-specialised hospital and make it fully operational. Longstanding issues in public procurement and recruitment that are also plaguing other health-sector projects must be resolved too.

Coasting on the 'highway to climate hell'

According to Copernicus, the European Union's climate monitoring service, average global temperatures reached record highs for 12 consecutive months since June, 2023. The Director of Copernicus warned that unless planet-warming pollution caused by greenhouse gases is slashed, "This string of hottest months will be remembered as comparatively cold." The worse is yet to come, he said. Indeed, we are pummelled by the second round of blistering heatwaves across the globe that is threatening to leap to a whole new level.

This "shocking but not surprising news" has alarmed António Guterres, Secretary General of the United Nations, to the extent that in a bareknuckled speech in New York timed for the World Environment Day (June 5), he compared humans to meteors that wiped out the dinosaurs. Moreover, he called the fossil fuel conglomerates the "godfathers of climate chaos."

In response to Guterres' fiery speech about the future of our planet, US congressman John Curtis, a Republican from Utah, sarcastically quipped, "I'd be curious to ask him how he got to work in the morning. How he gets around when he flies,

because as far as I know, there aren't any electric planes." Then again, how does Mr Curtis commute from Salt Lake City to Washington DC? Certainly not by a stagecoach, bicycle, or walking!

As a self-proclaimed "better steward "of climate change and founderof the Conservative Climate Caucus in the US House of Representatives, Curtis thinks "false narratives" that equate fossil fuels with greenhouse gas emissions are duplicitous. He speaks for approximately 75 percent of Republicans who hold that the economy should be given priority, even at the risk of ignoring climate change.

Presumably, that is why Guterres also said: "We need an exit ramp off the highway to climate hell." His reference to hell may have been metaphoric, though our closest neighbour and the brightest planet in the solar system, Venus, often called Earth's evil twin

Against the ambivalence of China, Russia, the United States, and other countries equally committed to their fossil fuel industries, are we really coasting on Guterres' "highway to climate hell?" In a paper published last year in the journal Astronomy, scientists at the University of Geneva and France's CNRS laboratories in Paris and Bordeaux suggested that because of escalated global temperatures and the evaporation of water from seas and oceans, Earth could become an "uninhabitable hell" similar to Venus in just a few

centuries, or even sooner. Arguably, the general trend of catastrophic climate change we are witnessing currently is a bad omen for runaway greenhouse effect. Therefore, combating this threat to preserve Earth's climate stability and avert cataclysmic consequences requires urgent and collective efforts to stop the rapacious extraction and consumption of fossil fuels without further delay. However, world leaders and business magnates with stakes in the fossil fuel industry seem intent on continuing to gain morbidly vast wealth at the expense of every human and other creatures on our planet. Meanwhile, the average temperature will continue to rise, and millions of

people will die as a result. Finally, we cannot give our children

The amount of carbon radiation Earth emits back into dioxide that will be released in the process could be enough to push the planet over the tipping points, which are critical thresholds that, if exceeded, will trigger devastating and doubled in the past 20 years, raising irreversible changes in the surface as a dead ball of rock.

What is wrong with business law education in Bangladesh?

Imagine a business professional who does not know the laws that govern their industry in the country they operate in. How can they make smart decisions, avoid legal troubles, or lead their company effectively? The truth is, they can't. This is why business law education is so crucial. Yet, in Bangladesh, the business education system is falling short. Our business schools are not preparing students to handle the legal challenges they will face in their careers.

So, what is wrong with business law education in Bangladesh? Firstly, there's the curriculum. Business law courses in Bangladesh heavily rely on Indian textbooks about Indian laws. Sounds odd, right? It is. Because why would Bangladeshi business schools teach Indian laws? These books focus on Indian laws, which are not relevant to Bangladeshi students. Imagine learning about laws you will never use in your career. It is like training for a cricket these students enter the workforce, schools. This negative perception leads

they struggle with compliance issues because they have not learned the laws that apply in Bangladesh, and they are not taught how to freshly learn the laws that apply to themselves. While it is true that there is lack of good books on business law in Bangladesh, teaching Indian textbooks based on Indian laws cannot be a solution.

Secondly, who are the people teaching these courses? Surprisingly, it is not law academics. Instead, business academics, who may know a lot about business but not as much about law, are teaching these courses. This gap means students miss out on vital legal knowledge and updates that could be crucial for their careers. Because in the commercial justice sector, regulations are updated, or new regulations are introduced almost every year. Moreover, in many business schools, teaching business law is viewed as a less desirable assignment, akin to a "punishment posting" for match with football equipment. When full-time faculty members in business

to a lack of enthusiasm and investment in delivering up-to-date, engaging, and practical education.

Thirdly, we are missing the point of teaching business law as a core course of the business curriculum in Bangladesh. Currently, business law courses are too theoretical and contentious. They focus on disputes and litigation rather than practical, everyday business transactions and compliance. Instead of learning how to avoid legal pitfalls, students are taught how to fight them in court. Shouldn't we be preparing them to avoid these problems in the first place? Moreover, there is a lack of practical training. Students do not engage in simulation exercises or real-world scenarios. Business students need similar practical exposure to understand how to apply legal principles in real-world situations.

Now, can we fix this? If yes, then how? We need a major overhaul of how business law is taught in business schools. The pedagogy for business law in business schools must be significantly different from that of law schools because these are two different ballgames.

The business law curriculum in business schools should be based on laws relevant to Bangladesh. This way, students learn what they will need in their careers. Hiring law academics to teach business law should be the way to go as they are the people

who know it best. They can provide accurate, up-to-date information and practical insights. Shifting from purely theoretical teaching to include practical exercises is crucial as well. Simulations, case studies, and realworld scenarios can help students understand how to apply what they

And why does this matter? Think about the impact a heightened awareness of the legal doctrine can have on the business environment in Bangladesh. Well-informed business leaders can drive compliance and ethical practices. This leads to a more stable and robust corporate sector. Wouldn't you prefer to work in a business environment where leaders understand the laws and navigate them confidently? By revamping business law education, we are not just improving individual careers, we are strengthening the entire business landscape in Bangladesh. Informed leaders can avoid costly legal mistakes, foster ethical practices, and ensure compliance. This contributes to the country's economic growth and stability. Isn't that what we all want?

Revamping business law education is more than just an academic exercise; it is a strategic move for the future of Bangladesh's corporate world. Let's equip our future leaders with the right legal knowledge and skills. Let's prepare them to lead with integrity and legal acumen.

> In addition to the socio-economic and casteist rhetoric surrounding the public marginalisation of the hijra community, a discourse on disability based on their putative genital status has emerged since their legal recognition as third sex and continues to perpetuate their discrimination. Labelling the hijra community as genetically disabled is baseless and confusing for the state and wider public. The hijra community themselves question being labelled as disabled, when they do not suffer from any physical, mental or sexual impediments. The government's decision to retain the term is unclear and ambiguous, as it is rhetoric around disability that has led to the group's marginalisation. Legal and state negligence toward the hijra community and a lack of motivation to bring grassroots change for the group is evident in policy implementation.

The hijra community are a systemically and constitutionally persecuted group, and the consistent attacks on them have prevented them from enjoying basic human rights. The intricacy with which these social structures are entangled require a comprehensive approach to solving the issue and a desultory legal recognition without social inclusion tools, autonomy and security, and a rights-based approach will continue to jeopardise the lives and safety of hijra people. However, this cannot be achieved without departing from the government's tokenistic approach toward them. As of now, neither the legal recognition nor the cultural understanding of the "other" has led to a communal acceptance of prostitution, which is legal in the group. In contrast, the hijra is perceived to be in a ridiculed state of liminality and are reduced only to their genital deficiencies. Bangladesh has displayed its incompetence and impassivity by doing exactly that and a prime example of the country's inadequate and vapid policies lies in the first school it opened in 2020 for the transgender community. The aim was to provide education and eventual employment opportunities to release the group from a life of sex work, dancing, singing, or begging. However, the curriculum included only religious teachings and vocational subjects. The decision to not include subjects like Bangla, Mathematics, English, and Science only sets up the hijra community for

In the last few years, Bangladesh has opened a handful of Islamic curriculum schools catering solely to the hijra community. However, does a separate school for this community truly work toward integrating them into larger society or does it further disparage and relegate them to the margins? Does the existence of a separate institution for hijra not label them as incapable and unworthy of mingling with larger society? A structurally inbred segregation inadvertently reinforces existing social biases and exacerbates the prejudices against the hijra community by alienating them from the mainstream education system. To effectively create space and equal opportunities for this community, the government needs to firmly enact anti-discrimination policies, build an inclusive curriculum and educate the masses to ensure the inclusion of hijra in mainstream institutions, and provide legal consequences for discrimination against the group.

Discrimination across education and economic spaces inevitably bleed out to all extremities of the hijra community's existence, including their access to healthcare. Data shows that the community experiences extreme discrimination within the medical space, and impediments to accessing healthcare

and schools. It is naive and negligent to assume the complex barriers that have precluded the hijra community from gaining access to education, a family structure, basic needs, and equal employment opportunities can be addressed by the simplistic recognition of the third gender, without any additional work to address the bone deep prejudices extant in society. Family members prefer to completely sever ties with their hijra relatives, and this inevitable displacement makes them even more vulnerable and susceptible to violence faces a similar predicament in school, where they are physically



BOOK REVIEW: POETRY Speaking up for the intellectual resurgence in noncosmopolitan Bengal


Review of Bibhas Roy Chowdhury's 'Poem **Continuous: Reincarnated** Expressions' (Hawakal, 2024), translated by Kiriti Sengupta

"My reader, I dip into the water just for you." Bibhas Roy Chowdhury

How does a poet capture a boatman singing words to the gentle wind, a child bewildered by war, and a woman identified with rain? Bibhas Roy Chowdhury is a legendary poet who is known for the strength and diversity of his Bengali poetry. The translator into English, Kiriti Sengupta, has achieved an immense feat in bringing 60 poems into a 10th anniversary edition. Roy Chowdhury writes a nuanced Bangla, often focusing on rural Bengal, haunted by memories of Partition, and remains a highly private person. Poem Continuous: Reincarnated Expressions is a fortuitous title as it gestures towards the challenging act of translation and the desirable creativity of a refined translator.

One can offer a specific example by commenting on the exquisite poem, "In the Monsoon", which begins with the lines, "The algae float in the song of my tender age. / I wonder if the river / is nearing death." Bengal's dramatic kaal baishakhi and barsha defy any easy description—and here, the association with algae, which is a parasite, and water, which is an element associated with the final rites of ash immersion, are collocated to yield a magnificent spectrum. This short poem ends with a startling image: "In the song of my younger age / two blind come / across each other quite often", packing a cryptic



coding

"blind" relations among people. Is the Monsoon downpour from heaven a witness to social interludes, the maya or illusion of action? Such a poem is open to multiple interpretations, and I present mine as an example of the complexity of Roy Chowdhury's writing and Kiriti's translation.

If water, earth, and fire are the core elements defining human existence-as in the poems "I can Leave, but Why", "Lunatic", "The Lighthouse". among others, do the poems take a philosophical stand in re-casting this eternal interdependence? Perhaps the answer is in the negative because Roy Chowdhury never repeats himself, nor does he preach. The book's "Epilogue" comprises a significant interview between the author and translator. Kiriti asks: "Your poems mostly deal with agony and emotions...Why is this agony an essential component of your poems?" Roy Chowdhury answers obliquely, "Let my poetry capture the journey of the refugee boy from extreme distress to where I stand now. I have let my life ply behind the metaphors.

Metaphors are the greatest challenge to translators, and several poems build upon a key phrase or word. "The Poetry of a Hibiscus Flower" is a striking example, and if one reflects upon the lines, "The hibiscus lives in solitude as expected. / Lost people do exist, more or less in a similar way", a plethora of cultural references will show up. Though a common flower, the hibiscus, called 'joba' in Bangla, is sacred to Maa Kali and offered in worship at the temple; Santhal women often wear it in their hair, and Jaba-Kusum is a popular cosmetic brand. These allusions float in the literary aura of the word. Roy Chowdhury astutely associates the hibiscus with a lost mother-perhaps pre-Partition Bengal-isolation, abandonment, yet hardy survival. Interestingly, the translator, Kiriti Sengupta, has independently written a poem, "Hibiscus", with the lyrical lines: "I'll bloom / like a hibiscus: / the blush will endorse / my bloodline" that I read in the Amethyst Review. My point is that metaphors are powerfully suggestive, and insightful poetry hints at a backstory through a key image and allows the reader to ponder over the consciousness it generates.

Only once in this century have we seen them lose a quarterfinal fixture at this tournament, when they hosted this event in 2011 and were beaten on penalties by Uruguay (5-4).

Meanwhile, Ecuador are capable of pulling off an upset on their day but will have to outdo themselves to stand any chance against Scaloni's troops.

Despite being on the back foot for a good portion of their previous encounter, Ecuador did enough to hold off the Mexicans and claim a spot in the knockout phase on goal difference.

It is the second successive time that La Tri have qualified for the last eight of this tournament, while they have now made the quarterfinals in three of the previous four Copa Americas.

Crown-favourite Gauff on redemption run

Coco Gauff did not look at her imperious best under the roof on Wimbledon's Court One on Wednesday, but she was always in control of an error-strewn second-round 6-2, 6-1 victory over Romanian qualifier Anca Todoni.

The US Open champion slipped and fell twice on the slick court and muttered to herself during the one-hour, six-minute match against an opponent ranked 140 places below her.

Second seed Gauff, a crowd favourite at Wimbledon after announcing her arrival on the big stage with a fourth-round run as a 15-year-old five years ago, produced 16 unforced errors in the short match and managed to land only 43% of her first serves.

But her nervous opponent, at 19 six months Gauff's junior, hit 23 unforced errors and could not find her range against the fleet-footed American, who wrapped up the match with a drop shot that Todoni could only send wide.

"Overall, I just learned about life a lot. What I do, I'm very passionate about but it's not ever that serious," she said.

The Taskin scenario and its timing

Before an important board meeting on Tuesday, which was set to shed light on how Bangladesh Cricket Board (BCB) assessed the just-concluded T20 World Cup performances of the national team, news broke that pacer Taskin Ahmed had missed the India game for having overslept.

A series of poor performances in World Cups is nothing new, and an explanation for the team's poor approach, especially in the Afghanistan game, should have been a top priority for the board. The timing of the news about Taskin was curious, as it took the limelight away from what was, in fact, a poor World Cup performance despite securing a place in the Super Eights.

What happens inside the team environment usually stays out of public knowledge, but this time the news about Taskin was leaked quite some time after the World Cup game in question.

Shakib Al Hasan, meanwhile, who usually keeps mum regarding anything inside the team's environment, had talked about Taskin missing the team bus on Tuesday evening before leaving

Thus, when BCB president Nazmul Hassan attended the press conference following the board meeting on Tuesday, it could be surmised



that the board felt content with what the team achieved despite carrying 'new' players. In fact, after questions related to the team's performances came one after another, Hassan said they were not willing to be too critical.

Inevitably, the question of Taskin came up. The BCB chief remarked: "I also heard that he missed the team bus. Why he didn't come on time, until I ask him directly... but I feel this report should come from the concerned department.'

Why the board has not yet discussed the team's disciplinary issues before sitting down for a meeting is anyone's guess. If one were to venture a guess, it would be that the board has not sought an explanation seriously enough.

KURIGRAM Over 50,000 stranded as flood hits new areas

The flood situation in the northern districts deteriorated yesterday due to heavy rainfall and the onrush of water from upstream.

Vast tracts of low-lying areas were inundated due to the rise in the water level of the Teesta, Brahmaputra, Dharla, and Dudhkumar rivers.

"Brahmaputra-Jamuna and Ganges-Padma rivers are on a rising trend, which may continue in the next 72 hours," a bulletin from the Flood Forecasting and Warning Centre (FFWC) said yesterday.

In the next 24 hours, the water level at some points of the Jamuna River along Jamalpur, Gaibandha, Bogura, and Sirajganj districts may rise and cross the danger levels," it added.

The flood situation in the lowlving areas in Kurigram along the Brahmaputra River may deteriorate at the same time, the bulletin warned.

No provision for staying conviction if appeal pending HC says in full verdict STAFF CORRESPONDENT

The High Court has observed that there is no provision for staying the conviction of an individual in a case while an appeal against it remains pending.

A conviction can either be scrapped, affirmed or modified upon disposing of the appeal, said an HC bench in the full text released yesterday of a judgement.

The bench on March 18 delivered the verdict scrapping the Labour Appellate Tribunal's stay order on the conviction and sentence of Grameen Telecom Chairman Prof Muhammad Yunus and directors Ashraful Hassan, Nurjahan Begum, and M Shahjahan and granted them bail in a case filed under the labour law.

The bench of Justice Md Nazrul Islam Talukder and Justice Kazi Ebadot Hossain, however, stayed their sentences and fines until disposal of the appeals filed by the Nobel laureate and three others, challenging the verdict of the Third Labour Court in SEE PAGE 6 COL 4

Many Palestinians were seeking shelter vesterday after fleeing their homes in southern Gaza and complained of water shortages as Israel pressed on with its military offensive in the densely populated enclave.

Israeli forces carried out new military strikes in the southern city of Rafah amid fierce fighting Hamas with fighters overnight, residents said. At least 12 people were killed in new strikes in central and northern Gaza.

Israel's leaders have said they are winding down the phase of intense

fighting against Hamas, and will soon shift to more targeted operations in the nearly nine-month-old offensive in Gaza.

But fighting continued overnight in two locations at the centre of Rafah, where tanks have seized several districts and advanced further west and

north of the city in recent days, and concerns about the plight of hundreds of thousands of displaced people are growing.

The Israeli military said its forces had continued targeted, intelligence-based operations in Rafah, dismantled several

sites and killed Hamas members. Hamas' armed

Scientists discover moss can grow on Mars

Scientists have discovered that a type of desert found in Antarctica

can survive the extreme conditions of making it a promising

candidate colonising the planet.

Syntrichia caninervis, was already known to be able to withstand drought conditions, but tests by researchers at the Chinese Academy Sciences revealed

that it can also tolerate temperatures as low as -196°C similar levels of gamma radiation to that found on the Martian surface.

"Our study shows that the environmental resilience of Syntrichia caninervis is superior to that of some of the highly stress-tolerant microorganisms and tardigrades," the researchers

"Syntrichia caninervis is a promising candidate pioneer plant for colonising extra-terrestrial environments, laying the foundation for building biologically sustainable human habitats beyond
