### Ctg hospital shut over irregularities

The Directorate General of Health Services (DGHS) has directed to close Central City Hospital at Parbartak Intersection in Chattogram city due to various irregularities.

The DGHS issued notification Wednesday, signed by its Director (Hospitals and Clinics) Abu Hussain Md Moinul Ahsan, in this regard.

According notification, the hospital has been operating without a licence from the health directorate and without certificates clearance from the Department of Environment.

Additionally, hospital lacks adequate and qualified doctors and nurses, as well as necessary equipment.

Speaking to reporters Chattogram vesterday, Civil Surgeon Mohammad Chowdhury said, "As per the direction of health directorate, issued instructions to stop all operations of the hospital yesterdav [Thursday]."

He also mentioned that if there are any admitted patients in the hospital, they must be referred to an appropriate hospital by Monday.

## They make jute braids to send their kids to school

Women from Rajpur, Khuniagach, and Gokunda unions along the Teesta river in Lalmonirhat Sadar upazila have been crafting jute braids for the past five years to supplement their family incomes.

impoverishment exacerbated by recurrent floods and erosion, approximately 60 percent of families in these unions have lost their lands and homes, relying on government lands and dykes for shelter. Tulsi Rani, 27, took

matters into her own hands in Madhuram village, and inspired around 3,000 women along the way to weave jute braids during their free time after household chores. "I started making jute braids to earn

some money to help my family. Later, I engaged some other women to work with me," said Tulsi

"Different handicraft establishments provide me jute fibres. I weigh and deliver the fibres to

women, and they make braids and submit those to me. I would then weigh and send the braids to the establishments," she added.

Different other jute products, including bags, floor-mats, and rugs are also made by them.

their craftsmanship, these women have transformed adversity into opportunity, showing resilience and entrepreneurial spirit in challenging

circumstances. With the money these women are earning, they are now able to send their children to school and meet the expenses, they added.

Each woman earns between Tk 24 to Tk 90 per braid, depending on its thickness, producing an average of 3-4 kilogrammes of braids daily.

Karla Rani, for instance, earns Tk 100-150 daily. She has recently used her savings for her daughter's wedding.

Meanwhile, the income has helped women like Mina Rani and Jannati Begum send their children to school. They praised Tulsi Rani for leading the

Earlier on March 7, DB arrested 10 Indian nationals linked to a cross-border smuggling group allegedly involved in trafficking Indian goods, including stolen mobile phones.

Last December, Indian authorities dismantled a syndicate smuggling stolen mobile phones into Nepal and Bangladesh, recovering 153 devices from a mobile repair shop in Ghaziaba.

The gangs primarily target high-priced cell phones in Bangladesh and smuggles them to India, Malaysia, and Thailand.

High-end phones like iPhones, known for their hard-to-alter IMEI numbers, are risky to sell locally, so criminals smuggle them to a different country.
