Hasina, Xi pledge to boost strategic ties

DIPLOMATIC CORRESPONDENT

China has promised to provide economic support to Bangladesh in the form of grants and three types of loans including interest-free ones.

The pledge came yesterday as Prime Minister Sheikh Hasina wrapped up her China visit, holding talks with Chinese President Xi Jinping.

China also offered Bangladesh one billion Yuan (about \$140 million) as economic assistance, Foreign Minister Hasan Mahmud said at a press briefing in Beijing prior to Hasina's departure for Dhaka last night.

Beijing said it attaches utmost importance to its relationship with Dhaka and assured Bangladesh of continued support for its journey of development.

At the meeting with Hasina, Xi said China wants to invest more in Bangladesh and work with it on the international stage.

"China and Bangladesh will work together to establish global peace and prosperity," Hasan Mahmud said.

"I know that you have sheltered millions of Rohingyas who were displaced from Myanmar. This is a burning issue for you. We will do our best to help you resolve it," Hasan Mahmud quoted Xi.

China will play an important role towards solving the Rohingya crisis by holding talks with the Myanmar government, and even with the Arakan army if necessary, he mentioned.

Technical committees from both the Xi brought up the Rohingya issue, the countries will sit together to decide how

QUOTAS IN GOVT JOBS

Protesters won't back down despite SC status quo

STAR REPORT

Amid the apex court order for a status quo on the issue of quotas in government jobs, students yesterday vowed to continue their protests against the quota system.

Around 12 noon, the Appellate Division of the Supreme Court ordered the status areas." quo for four weeks.

This means the recent High Court verdict that reinstated the quota system in government jobs will not be in force for a month, and the 2018 government circular abolishing the quotas will stand for the

said period. The protesting students, however, announced they will press on with their demonstrations until the government forms a commission to reform the quota system and the parliament passes a law to

Sargis Alam, an organiser of the anti-quota campaign, said, "We'll relent only if we get word from the highest executive position that the quota system will be reformed through a commission.

"We want the parliament to enact a law reforming the quotas," he told protesters at the Shahbagh intersection last evening.

Asif Mahmud, another organiser, announced that today's blockade will begin at 3:30pm.

"Students from universities and colleges across the country will block major intersections in Dhaka along with highways and railways adjacent to their

After a day's break, the protesters yesterday resumed the "Bangla Blockade" around 10:30am, occupying intersections, major highways and rail lines

in Dhaka and other parts of the country. Road and rail communications were snapped, leaving commuters in utter distress. The traffic in Dhaka stood still for long hours, while around 30 trains from the capital ran behind schedule.

Actual export, NPL data to be available now: **BB** governor



Israeli strikes hit UN agency building in Gaza

29 killed at camp for displaced **Palestinians in Khan Younis**

Israeli forces launched more deadly strikes across Gaza yesterday, according to medical sources and the military, which said it targeted Hamas members operating from inside a UN agency building.

The Israeli army also said it was reviewing an attack on Tuesday night in which hospital sources said at least 29 people were killed in a nearby school in the southern Khan Yunis area -- the fourth attack on a school building

Early yesterday, four people were killed and one critically wounded in the bombing of a house in the central town of Nuseirat, a hospital source said.

And two people were killed and six injured in another strike on a home in Bani Suhaila, near Khan Yunis,

according to another hospital source. Israel has stepped up air and ground attacks in Gaza City and southern Gaza since issuing evacuation orders for tens of thousands of people in the Palestinian territory.

The army yesterday dropped leaflets on Gaza City urging all residents to leave for safe zones. The thousands of leaflets, addressed to "everyone in

Militant leader who fled N'ganj raid arrested

The Anti Terrorism Unit (ATU) of police has arrested a leader of banned militant outfit Ansar al Islam who fled before the officials carried out a raid at a militant hideout in Narayanganj's Rupganj upazila on July 2.

A team of ATU arrested Javed alias Abir alias Enamul from Tongi area around 10:30pm on Tuesday, Mahfuzul Alam Rasel, superintendent (media) of ATU, told The Daily Star yesterday.

He fled from the Narayangani den just before ATU officials carried out the drive, he said.

Parts of South Sudan 'on brink of famine': charity

Parts of South Sudan are on the "brink of famine" as the nation braces for a "horror scenario" ahead of the worst floods in decades, a British charity warned yesterday. Since it gained independence in 2011, the world's newest nation has remained plagued by instability and violence, despite rich oil reserves.

South Sudan is expected to "suffer its worst floods in 60 years that will drive parts of the country to the brink of famine," Save the Children said.

Hasina left for China on July 8 following a state visit to India just two weeks before. She returned home from Beijing early today.

Experts say the back-to-back visits are a way of balancing the relationship with the Asian powers that are vying for influence in the Indian Ocean region.

Hasina last visited China in 2019. Back in 2016, Xi visited Dhaka when Bangladesh joined the Chinese Belt and Road Initiative (BRI) and elevated the relationship to "strategic partnership of cooperation".

Yesterday, the two leaders elevated the relationship to "comprehensive strategic cooperative partnership".

Xi said, "We, the two countries, are going to celebrate 50 years of diplomatic relations next year. Marking the celebration, we want to take the existing strategic relations to the second step."

Hasina invited the Chinese president, the prime minister and others to visit Bangladesh next year to celebrate the 50 years of diplomatic relations between the

two countries. "You stood firm against foreign This not only interference. demonstrates stand upright against the pressure, but also the courage of the Bangladeshi people as an independent people," Xi told Hasina according to a pool report made available to this newspaper.

He said China consistently opposes interference in other countries' internal affairs under any pretext, and firmly supports Bangladesh in its pursuit for a development path that suits it.

Xi expressed his readiness to work with Hasina to improve bilateral relations based on a strategic and long-term perspectives, deepen political trust, and carry forward the

traditional friendship. He called for joining hands to boost Belt and Road cooperation, collaboration in various fields, and establish the "comprehensive strategic cooperative partnership" between the two countries.

Xi also expressed his desire to contribute to the development of South Asia and the Global South, according to the pool report.

Hasina reassured Xi about Taiwan Park, mentioning that Bangladesh Beijing's most sensitive issue --

saying "Bangladesh firmly adheres zone for Chinese investors. to the one-China principle, supports China's position on the Taiwan issue, and resolutely opposes external forces interfering in China's internal affairs", reported South China Morning Post.

Hasina said she faced many problems in holding elections and that there were some quarters who always try to disrupt the polls.

"...I always enjoy the people's support and with the people's support, we won the election. This is my fourth consecutive term. So, I feel that I have big responsibility for my people," she said thanking Xi for always supporting her.

"And after the elections, your message gives us more enthusiasm," she said.

Hasina thanked the Chinese president for helping Bangladesh build some iconic structures, including the Padma Bridge and Bangabandhu Tunnel.

Xi assured Bangladesh of providing assistance in the development of its southern part as Hasina sought support towards this

She raised the issue of trade imbalance between the two countries and called upon China to mitigate the gap. In 2022-23, the bilateral trade was \$24 billion, but your conviction Bangladesh exported to China goods worth less than \$700 million.

> In response to Hasina's request for Chinese assistance in developing Bangladesh's agriculture sector, Xi assured her of providing technical support and necessary training.

Xi stressed the need for more cultural exchanges and people-topeople contact.

Noting the deepening relations between the Awami League and the Chinese Communist Party, he said, "Good governance needs good party."

Earlier in the day, Hasina had a delegation-level meeting with Chinese Premier Li Qiang.

She requested her Chinese counterpart to import leather products, jute products, pharmaceutical goods, and ceramic products from Bangladesh.

Hasina invited more Chinese investments in 100 special economic billion Yuan and more will follow as zones and Bangabandhu Industrial evident in Xi's words.

She stressed the need for Bangladesh's inclusion in BRICS in any form. In response, Li Qiang assured her of Chinese support.

Hasina also sought Chinese cooperation so that Bangladesh could enjoy the LDC facilities at least for three more years after it graduates to a middle-income country in 2026. The Chinese prime minister gave a positive response.

Both the leaders put emphasis on celebrating the Golden Jubilee of their diplomatic relationship in a befitting manner.

Bangladesh and China also signed 22 instruments and made seven announcements.

The instruments involve the banking sector, trade and investment, digital economy, infrastructure, disaster management, export of agricultural products from Bangladesh, and people-to-people connectivity.

On Tuesday, Hasina attended a trade and investment summit participated by businesses from both countries.

Bangladeshi and Chinese companies signed 16 MoUs to boost collaboration in textiles, electric vehicles, solar power, financial technology, and other technology.

Four of these MoUs will bring in nearly \$500 million in investments.

Hasina also met Asian Infrastructure Investment Bank (AIIB) President Jin Liqun and requested him to cut the interest rates on its loans for Bangladesh and finance infrastructure, river dredging, and climate-resilient houses.

According to former ambassador to China Munshi Faiz Ahmad, elevating the relationship "comprehensive strategic cooperative partnership" means the two countries will now cooperate in all sectors and further deepen their bilateral relationship.

31 named people, including a former assistant director of PSC, and 50 to 60 others unnamed.

The five arrested officials and employees were suspended by the PSC on Tuesday.

"At least 50 people were involved in the question leak of the recruitment test of the railway. Among them are several current and former PSC officials," a high official of the CID told The Daily Star yesterday requesting anonymity.

According to investigators, many people have passed PSC exams after having leaked questions, and they are now working as BCS cadre civil servants.

Those who passed the PSC exams after paying for leaked questions are now in fear of actions against them, sources said.

CID officials said the syndicate leaked questions to at least 10 candidates of the 33rd BCS exam and three of them are currently serving in different cadres of the civil service. Besides, the names of several other cadre officials, including those selected in the 28th and 35th BCS exams, came up during the investigation.

Of the 17 arrestees, six made confessional statements before a Dhaka court on Tuesday.

In his statement, PSC dispatch rider Khalilur Rahman said that he leaked questions to 10 candidates of the 33rd BCS examination. Six of them passed the written test, but three could not pass the viva voce exam. said court sources.

Khalilur also said that he used to introduce the jobseekers to a former top PSC official.

If he was given the go-ahead by that official, the final decision regarding how much the jobseeker would have to pay for getting selected for government jobs.

recruitments of some assistant upazila education officers and railway employees, said investigators.

During the 33rd BCS exam in 2012, a case was filed against Khalilur with Shahbagh Police Station over question leak. A departmental case was also filed against him.

At that time, the Rab arrested him. He got out on bail. He was also suspended from the job.

In March 2022, the charges brought against him were withdrawn due to lack of evidence. Since then, Khalilur has been working as a dispatch rider of the PSC. Investigators said Khalilur was able to

get involved in leaking questions due to the backing from the PSC top official. Touhidul Islam, special superintendent of the CID's cyber investigation and operations, told The Daily Star yesterday,

"Legal action will be taken against those found involved in leaking questions." Meanwhile, the PSC yesterday wrote to the Anti-Corruption Commission asking it to investigate the five arrested PSC officials and employees in connection

with amassing illegal wealth. The five are deputy directors Abu Zafar and Jahangir Alam, assistant director Alamgir Kabir, dispatch rider Khalilur, and office assistant Sajedul Islam.

The PSC also asked the ACC to inform it about their wealth.

Meanwhile, sacked PSC driver Syed Abed Ali and several other accused told investigators during interrogation that obseekers were brought to the "reading booth" two nights before the July 5 recruitment test.

The jobseekers were kept in a rented house in Savar and a warehouse in the capital's Paltan so that they could memorise the answers to the leaked

Abed rented the house for Tk 40,000 a month in Radio Colony of Savar. He took the leaked questions and answers from Sajedul.

Around 50 jobseekers memorised the answers in the house. Abed took Tk 7 to 8 nkh from each of them, said CID sources.

Before another recruitment test held several months ago, Abed rented another house in the capital's Mirpur and took 44 jobseekers there. The syndicate collected Tk 4 lakh from each of the candidates.

According to investigation sources Sajedul in his confessional statement before a court said that he got the question papers for the railway recruitment test from a chest of a PSC member. He said he sold the question paper to Abed and Khalilur for Tk 75 lakh.

The apex court asked the petitioners to file separate leave-to-appeal petitions and fixed August 7 for a hearing on those.

The chief justice asked the agitators to

go back to class and focus on studies. He expressed hope that all vicechancellors and heads of the educational institutions will take their students back.

"They [protesting students] took to the streets and raised slogans ... What they've done can't be appreciated but I think they've done it out of a misunderstanding. They're our children. On the first day, I said a judgement can't be made based on

slogans," he said while passing the order. "Considering what has happened so far, enough is enough. ... We'll evaluate the High Court judgment properly if it's placed before us.

"Only the Appellate Division has the right to examine whether the High Court verdict is correct or not. Why isn't anyone explaining this to the children? University teachers, who are in prominent positions, [vou] tell them [the students] – 'this is not the way, you must go to the court. If you go to court, the court will see to it \dots But we can't do anything until the [HC]

verdict is placed before us."

He thanked the DU students' lawyer Shah Monjurul Hoque for moving a petition before the Appellate Division against the HC verdict.

Attorney General AM Amin Uddin,

after the order was passed, told reporters that the HC verdict, which declared illegal the cancellation of quotas in first and second-class government jobs, will not remain effective. Writ petitioners' lawyer Md Munsurul

Hoque Chowdhury told The Daily Star that the government now cannot implement a quota system as per the SC order.

SUFFERINGS **ALL AROUND**

People, especially patients and the elderly, bear the brunt of nationwide blockades

The ongoing student protest against the quota system in government jobs caused severe disruptions in Dhaka and other parts of the country, leaving people in severe misery. Students have taken to the streets in at least eight districts, blocking roads and train routes.

With public transport at a standstill in many areas in the capital, people resorted to walking long distances. Commuters and office-goers faced challenges at key

intersections, as buses could not ply through them. Key intersections, such as Gulistan, Shahbagh, Banglamotor, Karwan Bazar, Farmgate, Science Lab, Agargaon, and Mohakhali, were blocked, which

particularly affected the elderly and patients. Jahanara Begum, who had just received treatment at a government hospital in Tejgaon, was returning with her mother when they got stuck at the Karwan Bazar rail gate area and had to walk to the intersection.

Bus driver Salam Hossain said he got stuck around 11:30am at Farmgate. "All the passengers got off. There's no way to turn the bus around. My day's earnings are lost."

At Kalshi intersection in Mirpur, Soniya Akhter waited over an hour for a bus but couldn't find any public transport. "Even when a bus came after a long time, there were so many passengers that I couldn't get on. I don't know how I'll get to the office," she added.

Nusrat Jahan, stuck at Panthapath intersection, said, "I had urgent work. But the jam has extended to Dhanmondi. People are suffering a lot. I've been sitting on the road since 11:00am, and it's now 2:00pm."

EVICTION IN DSCC

16 hurt as councillor's men, harijans clash

STAFF CORRESPONDENT

At least 16 people were injured as supporters of the local ward councillor clashed with harijans in Dhaka's Bangshal area yesterday afternoon.

The people of Miranzilla Harijan Colony alleged that Md Awal Hossain, councillor of Dhaka South City Corporation's ward-33, and his supporters went there to evict them violating a court order.

As they were prevented from entering the colony, they threw brick chunks at the colony people, who then retaliated, triggering the clash, said locals.

Sima Datta, president of rights body Nari Mukti Kendra, who was present during the incident, said when the DSCC magistrate entered the colony, the councillor and his supporters tried to get it, but they faced obstruction.

The injured took first aid at Dhaka Medical College Hospital, said Bacchu Miah, an inspector of the hospital's police outpost.

On June 10, the DSCC tried to evict the harijans from the colony saying that many of them are living there illegally. But the DSCC retreated in the face of protest by the harijan people.

The harijans have been living in the colony for generations, a refuge built by their ancestors during the British era.

The DSCC wants to expand its existing kitchen market in the

Community leaders claimed that DSCC Mayor Sheikh Fazle Noor Taposh assured them that only 20 families would be evicted. However, they later learnt from DSCC officials that over 87 families would be evicted.

DSCC Executive Magistrate Md Moniruzzaman told The Daily Star on the spot that they did not have any eviction drive yesterday and they did not inform anybody about

He along with contractors and engineers of newly constructed buildings in the colony went there to learn about the problem of utility services of the buildings and solve those.

245 iron bridges or death traps?

A tragic accident led to the death of nine people after an iron bridge collapsed and caused a microbus to fall into the canal in Haldia Bazar area of Barguna's Amtali upazila on

In the wake of the incident, the authorities of Local Government Engineering Department in Barguna made a list of 245 iron bridges in six upazilas of the district that are in a vulnerable condition and risky for vehicular movement.

The bridges have become dilapidated as those have not been renovated over the years after being constructed by LGED in Barguna under its Light Traffic Movement Project in FY 1997-98.

According to Barguna LGED.

2008, and no initiative was taken to maintain and repair the bridges as the project was not extended.

As such, these bridges have now become death traps.

Accidents happen frequently when pedestrians and vehicle use the bridges. Many of the bridges are



unfit for vehicular movement and are only being used by locals to cross by foot, that too after reinforcing their the project was operational till structure with wood and bamboo.

"We have so far identified 245 risky iron bridges in the district -99 in Amtali upazila, 61 in Barguna Sadar, 28 in Taltali, 25 in Bamna, and 16 each in Betagi and Patharghata upazilas. However, the number may rise further," said Mehdi Hasan Khan, executive engineer of LGED in Barguna.

"We will further identify how many of these can be repaired and how many have to be replaced, and send the list to the ministry concerned with a budget for allocation to this end," he added.

Contacted, Golam Sarwar Tuku, lawmaker of Barguna-1 constituency, confirmed that the chief engineer of LGED had informed about the risky bridges in the district.

Deadline keeps on extending

The project to construct Kalurghat-Chaktai road on the bank of Karnaphuli river in Chattogram began in July 2017 with a deadline to be completed by June

However, eight years on, the project is still incomplete, despite several extensions of deadline as well as increase in cost of the project.

In fact, with 26 percent of the construction work still remaining, the

Chattogram Development Authority, which implementing project, the has applied to the Planning Commission another year's

extension.

Rajib Das, director of the project and executive engineer of the CDA, confirmed the development when contacted by this correspondent.

"Due to a shortage of funds for land acquisition, we failed to complete the work on time," he claimed.

According to project documents, the project's deadline has been already extended three times, with the last deadline being June this year. The project's cost also went up from Tk 2,275.52 crore to Tk 2,310.24 crore.

Now, CDA wants to extend the deadline to June 2025 without increasing cost any

This project does not require fresh allocation, but if the allocated funds are received on time, we will be able to complete the work quickly," said Rajib

The project includes construction of the 8.5-kilometre road and embankment with 12 regulators on the mouths of canals, with an aim to reduce traffic congestions and mitigate waterlogging.

Visiting the project area recently, this correspondent saw while 10 of the 12 regulators have already been

constructed, however, major portion of the road work, from Chaktai Kolpolok Residential Area, remains incomplete.

"Spectra

Engineers Limited, the contractor firm, has been stopping work frequently over the past six months citing fund crunch," said Jamal Uddin, a worker of the project. Rajib Das admitted that they were

forced to stop work at times due to a shortage of funds. Experts blamed CDA for its failure to

complete the project on time.

"Lack of proper study ahead of taking up the project in turn extended its duration and increased the cost. The government should identify those responsible and take action against them," said Md Delwar Hossain Mazumdar, an urban planner and executive member of the Forum for Planned Chattogram.

Rain increases flood woes in the north

With the ongoing flood already making the lives of Kurigram residents miserable, more downpour further added to their woes

"As floodwater inundated our house, five of us in the family left for the embankment on Tuesday with our belongings, two cattle, three goats and some hens to seek shelter there. Since then, we have been living under this polythene wrapped shanty. The rains make it very hard for us to live in this condition," said Amena Bewa, 68, of Rajarvita village on Brahmaputra's shoal in Kurigram's Chilmari upazila.

"The floodwater is not receding, so we cannot return to our house. We have to struggle to find pure water for drinking, sometimes treading the floodwater for miles to find a source. We have no food. There is no work in the area. No one has come to

us with any assistance or relief vet. added. Who knows how long our miseries will continue," she added.

Amena's neighbour Kohinoor Bewa, 70, echoed her.

Amena and Kohinoor are not alone. Several hundred families had to take shelter on BWDB dam in Chilmari upazila and are going through a similar ordeal.

Amid the flood and rains, there is an acute lack of work for labourers, leaving many of them unemployed and struggling to remain afloat with their families.

"Our house is submerged under four feet of water. There is no work in the area, no food in our house, and no assistance came from government or private initiatives. We are in dire straits," said Ayub Ali, 60, a day-labourer from Putimari village of Ranigani union.



Dhaleshwari erodes bridge approach road

The erosion by Dhaleshwari river caused the approach road of Charabari Bridge in Tangail Sadar upazila to collapse on one side, snapping the road link between five unions in the shoal areas and the upazila headquarters.

As such, thousands of people from the shoal areas are suffering with their

According to locals, around 50 metres of the approach road collapsed within a short time due to erosion early on Tuesday, halting movement of all vehicles through the bridge.

The Local Government Engineering Department constructed the 170.64-metre-long bridge in 2006 connecting Tangail-Torabganj road.

The road is the only route for about one lakh people from five unions in shoal areas -- Katuli, Hugra, Kakua,

and Mahmud Nagar unions in Sadar upazila and Bharra union in Nagarpur upazila -- to reach the district town, said Tofazzal Hossain Tofa, chairman of Tangail Sadar upazila parishad.

Many students of Mawlana Bhashani University of Science and Technology in Santosh area also use the route to reach their campus, he said, adding that agricultural products, raw materials of textile industry, and daily necessities are also transported using

Contacted, Rafiqul Islam, executive engineer of LGED in Tangail, said the bridge and the connecting road became vulnerable as the river's course had changed due to illegal sand extraction and its flow through Charabari area became stronger over

Preparations are underway to address the issue, he added.

Fodder crisis hits cattle farmers

Although the bank approved 100 percent interest waiver, the couple did not repay the loan. Now the recoverable amount of that money stands at Tk 88.89 crore, bank sources said.

The bank authorities declared Zakia and Sirajul as defaulter and filed a loan default case with a Patuakhali court in 2004.

SY HUQ Bangladeshi origin producer making it big in Japan

Sy Huq, despite his films earning critical acclaim and festival awards, encountered challenges while directing his debut film Things That Fall'. The project faced setbacks twice before coming to fruition.

Sy Huq, a young filmmaker, has become the first Bangladeshi-American creative executive in Japan's anime industry. He secured a prestigious role at D'ART Shtajio, Japan's first Black-owned anime studio, and boasts a reputation as a fourtime Oscar-qualified director and producer. Intrigued by his backstory and what inspired him to pursue filmmaking, I wanted to learn more about his journey.

A traveler at heart and filmmaker by passion, he discovered his love for Japanese films at a young age. He frequented public libraries to watch VHS tapes, drawing inspiration from Kurosawa's liveaction movies and Hayao Miyazaki's animations. His imagination and creativity were further fueled by writing and drawing comics.

"Production was never something I thought was within reach for someone like me, especially at the Hollywood level. While backpacking overseas, I realised the profound impact and community-building power of bringing people

It was this realisation that led to discussions with D'ART about joining as lead



executive producer. At D'ART Shtajio, I will focus on developing, creating, and writing large-scale anime projects, expanding their portfolio to impact animation enthusiasts worldwide with our unique storytelling style that blends Eastern and Western influences," shared the young producer.

While he has roots in Bangladesh, he has not had much exposure to the Bangladeshi animation industry. He is eager to learn more about it from industry professionals in the country to deepen his understanding of its production.

"There is a project I've been creating and developing since I filmed the primary story in documentary form in Bangladesh in 2022, based on my father's experiences during the Liberation War as a child in 1971, in the countryside. It's been an exciting journey, gaining attention within my trusted circles. We're taking our time to ensure the project is as impactful as possible while allowing it to creatively evolve. I look forward to seeing it come to life to represent the beauty of Bangladesh, frame by frame, in the future." said Sy.

An anime enthusiast, he is also a four-time Oscar-qualified director and producer. His debut as a director, Things That Fall, was eligible for the 92nd Academy Awards for Best Live Action Short Film. He served as executive producer for The Boys:Diabolical, which qualified for the 94th Academy Awards in the same category. Sy also produced two short films, *The Stranger* and Panorama, both qualifying for the 95th Academy Awards for Best Live Action Short Film.

"Through that film, I learned the power of empathy and the importance of championing meaningful causes, such as hiring with authenticity and representation in mind. We incorporated sign language, cast deaf talent for deaf roles, collaborated with mental health organisations for authentic portrayal, and experimented with new sound technology. It was a bold approach that underscored the impact of innovative storytelling and dedication, particularly as we navigated the journey from festivals to the Oscars," explained

After Things That Fall qualified for the Academy Awards, Sy Huq realised his responsibility to address real issues through his narratives. He aimed to create films that would impact audiences and provoke reflection.

"My goal was to contribute to improving lives in some way. After four qualifications, I realised that the next step in my career was to scale up and significantly increase the impact I could make in my community," shared the filmmaker.

"My short films, like **Things That Fall**, draw inspiration from animated shorts such as Paperman. They utilise silent film principles to resonate with audiences, focusing on actions over dialogue and the power of non-verbal storytelling. Short films provided a rich education in bringing stories to life, and animation allows imagination to flourish with fewer limitations," Sy explained.

Currently, he's involved in undisclosed larger projects. However, he mentioned collaborating with Arthell Isom on D'ART's first Congolese anime feature, **MFINDA**.

method of contraception. If the supply is not uninterrupted, it will be difficult to meet that target, Mainul said.

"If unmet needs increase, unwanted pregnancies, abortions, maternal deaths -- all will rise.

Besides, achieving the total fertility rate of 2.1 will be difficult too, Mainul

Assuming there are no migration flows and that mortality rates remain unchanged, a total fertility rate of 2.1 children per woman generates broad stability of the population. It is also referred to as the "replacement fertility rate" as it ensures replacement of the woman and her partner with another 0.1 children per woman to counteract infant mortality.

Meanwhile, Nato allies have reached agreement on the summit declaration that includes a pledge by the alliance to continue to support Ukraine "on its irreversible path to full Euro-atlantic integration, including Nato membership", a source told Reuters yesterday.

The declaration goes on to reaffirm that Nato will "be in a position to extend an invitation to Ukraine to join the alliance when allies agree and conditions are met", according to the source in the alliance.

Ready to help restore peace in Ukraine **Modi tells Austrian Chancellor Nehammer**

India stands ready to give all possible support to restoring peace to war-torn Ukraine, Prime Minister Narendra Modi said yesterday in Vienna after a Kremlin visit criticised by Kyiv.

Modi arrived in Vienna late Tuesday after talks with Russian President Vladimir Putin in Moscow, where the Indian leader urged "peace through dialogue", saying that "war cannot solve problems".

"This is not an age of war. Problems cannot be solved on the battlefield," Modi told reporters in Vienna alongside Austrian Chancellor Karl Nehammer.

Modi said India and Austria stand "ready to provide all possible support" to "rapidly restore peace and stability". Nehammer said both countries shared "common goal" to achieve a "comprehensive and lasting peace, in accordance with UN Charter".

India has no right to develop contested region: China

India has no right to carry out development in the area China calls South Tibet, China's Foreign Ministry said yesterday in response to a Reuters report on New Delhi's plans to speed up hydropower projects in the border state.

"South Tibet is China's territory," a foreign ministry spokesman said in a statement. It said India had no right to carry out development there and the establishment of what India calls Arunachal Pradesh on Chinese territory is "illegal and invalid".

Reuters reported on Tuesday that India plans to spend \$1 billion to expedite the construction of 12 hydropower stations in the northeastern Himalayan

India's foreign ministry did not immediately respond to a request for comment on China's statement.

India says its remote state of



Arunachal Pradesh is an integral part of the country, but China says it is a part of southern Tibet, and has objected to Indian infrastructure projects there.

Last week, India Foreign Minister Subrahmanyam Jaishankar met his Chinese counterpart Wang Yi in Kazakhstan where the two agreed to intensify efforts to resolve issues along their border.

India plans to spend \$1 billion to expedite the construction of 12 hydropower stations in Arunachal Pradesh, two government sources said.

The federal finance ministry under Nirmala Sitharaman recently approved up to 7.5 billion rupees (\$89.85 million) in financial assistance to each hydropower project in the northeastern region, the

Under the scheme, about 90 billion rupees will likely be allotted for the 12 hydropower projects in Arunachal Pradesh, said the sources, who have direct knowledge of the matter.

The scheme is likely to support northeastern states and help them finance equity holdings in the projects they host. Having state governments on board generally helps in expediting regulatory clearances, rehabilitation and negotiations on sharing electricity with the host state.

The plans for the hydropower stations are expected to be announced in the 2024/2025 federal budget that Prime Minister Narendra Modi's government will unveil on July 23, the sources said.

Macron urges MPs to agree broad coalition

President Emmanuel Macron put the onus on the French parliament yesterday to negotiate a broadbased coalition, after snap elections failed to give a majority to any one party.

Time short for Biden decision on 2024 bid: Pelosi

Democratic Party heavyweight Nancy Pelosi said yesterday that time is running out for US President Joe Biden to make a final decision on his reelection bid, but stressed the call was his to

Despite Biden insisting he is staying in the race, Pelosi -- the former speaker of the House of Representatives and an influential voice in the party -- suggested the president still could step aside amid a Democratic divide over his candidacy.

"It's up to the president to decide if he is going to run," she told MSNBC. "We're all encouraging him to make that decision because the time is running short.'

Pelosi stopped short of advocating either way on the Biden question. "I want him to do whatever he decides to do, and that's the way it is," she said. "Whatever he decides, we go with."

Biden, 81, has corralled much-needed support from some top Democrats, but several lawmakers in the party have publicly expressed concerns about his mental fitness after his disastrous debate performance last month against White House challenger Donald Trump.

37 Chinese aircraft skirt Taiwan on way to drill

Taiwan's defence ministry said 37 Chinese aircraft were detected around the self-ruled island yesterday as they headed to exercises with an aircraft carrier in the western Pacific.

China claims democratic Taiwan as part of its territory and maintains a near-daily presence of fighter jets, drones and warships around the island, which is 180 kilometres (110 miles) from the southern Chinese coast.

Taiwan is also a crucial part of a chain of islands that military strategists say serve as a gateway from the South China Sea -- which China claims in nearly its entirety -- to the Pacific Ocean.

At around 9:30 am (0130 GMT) yesterday, Taipei said that "since 0520 today, the Ministry of National Defence detected a total of 37 Chinese aircraft", including fighter jets, bombers and drones.

Thirty-six of the aircraft crossed the sensitive median line of the Taiwan Strait - which bisects the narrow waterway separating the island from

"(The aircraft) headed to the Western Pacific via our southern and southeastern airspace to cooperate with the aircraft carrier the Shandong in conducting 'joint sea and air training'," the defence ministry said in a statement.

Defence Minister Wellington Koo told reporters the Shandong "did not pass through the Bashi Channel", the area off Taiwan's southern tip where Chinese ships typically transit en route to the Pacific Ocean.

Instead, it "went further south through the Balingtang Channel towards the Western Pacific," he said, referring to a waterway just north of the Philippines' Babuyan Island -- about 250 kilometres south of Bashi.

12 children killed in South Africa blaze

Twelve children were killed in South Africa vesterday when a minibus taking them to school near Johannesburg overturned and burst into flames after being hit by another vehicle, authorities said.

The driver of the minibus was also killed and seven other children were rushed to hospital, according to officials in Johannesburg's Gauteng province.

Television showed that the minibus was totally destroyed by the fire in the early morning crash in Merafong, more than 70 kilometres (45 miles) west of the city.

Develop a patient referral system

Ease pressure on tertiary facilities, re-imagine healthcare system

It is unfortunate that 53 years since independence, we have failed to develop a functional referral system, with a staggering three out of five patients directly referring themselves to specialists and tertiary hospitals, according to a recent study. This inevitably overwhelms tertiary facilities, leads to long waits, and deprives critically-ill patients of due attention and care. Unlike in countries such as the UK, where patients are required to see a general practitioner before being referred to a specialist, it is common practice in Bangladesh for patients to directly visit specialists even for minor ailments. This has created a lop-sided system, where the tertiary hospitals bear an overwhelming brunt of the pressure, while primary and secondary facilities remain underutilised and underdeveloped.

A well-designed referral system can help streamline the healthcare network, and create an effective linkage among three tiers of healthcare services. Primary healthcare facilities, which should be the first point of contact for any patient, should be fully equipped to take care of basic cases, referring only the complex cases to specialists. A 2023 study found that a referral system can filter as many as 65 percent of patients at primary and secondary healthcare facilities at upazila and district levels, freeing up tertiary facilities to focus on their core functions. Given the obvious advantages of such a system, the question is: why have we not implemented this system so far?

There have been various discussions over the decades about instituting such a system, but previous attempts to implement it have stumbled for various reasons. A referral system for Rangpur was announced in 2014 by the then health minister Mohammad Nasim, but it failed as a result of inadequate logistical support and unavailability of qualified physicians and auxiliary workforce at primary healthcare centres. Attempts to get the system going in 2016 and 2019 also fizzled out in the end. What is obvious is that ad hoc attempts at implementation will not work without a radical reimagining of the healthcare system and appropriate investments and capacity-building to ensure a successful transition.

The good news is that Bangladesh already has primary healthcare infrastructure in rural areas, with community hospitals and community clinics, but their systemic issuesshortage of staff, equipment and inefficiencies in operationsneed to be addressed if they are to play their due role within the referral system. Meanwhile, tertiary facilities have mushroomed in urban areas at the cost of primary and secondary facilitiesan imbalance that must first be addressed.

If we are to move forward, we need political will and a welldefined policy about how to implement a well-designed referral system. The system must be built on a strong foundation of well-equipped primary healthcare facilities, a sufficient number of trained specialists at all levels, and a public that trusts and understands the system.

Punish kidney racket mastermind

Arrest of Bangladeshis involved in illegal transplants a wake-up call

We are horrified to learn of a cross-border racket of illegal kidney transplant in India that has been sourcing the organ from Bangladesh for years. According to a report by The *Indian Express*, police recently arrested seven individuals in Delhi, including three Bangladeshis and an Indian doctor, in connection with this racket. Delhi Police also said the mastermind of the racket is a Bangladeshi national, and those involved with this illegal operation are all suspected to have links with Bangladesh. This racket is a part of a larger interstate network in India involving Bangladeshi patients in Rajasthan and Haryana, sources at Delhi Police say.

The racket, according to Delhi Police, targeted kidney patients by visiting dialysis centres in Bangladesh. They found donors from poor and marginalised backgrounds, luring them to India under the pretence of employment. It also arranged to falsify documents under the name of Bangladesh High Commission in Delhi to show that the donors and recipients were related by blood—a requirement for kidney transplant per the Indian law. Dr Vijava Kumari, who was employed at the Delhi-based Indraprastha Apollo Hospital (IHS), facilitated the transplants even when she knew about the donors and recipients not being blood-related. The now suspended doctor performed 15-16 such illegal transplants between 2021 and 2023 at the Noida-based Yatharth Hospital.

Police also found documents carrying records of transactions that took place for the transplants from one of the Bangladeshi accused. Donors were paid four to five lakh rupees for their kidneys, while recipients were charged 25-30

While we are glad that police nabbed the culprits, we are disturbed that so many illegal transplants took place with no one being the wiser. The Bangladeshi trio who were arrested in Delhi had been arrested on the same charges last month. How did they get out and continue their nefarious activities? We urge both the Bangladesh and Indian authorities to coordinate and delve deeper into the matter and uproot the entire network. On the Bangladesh side, a thorough investigation must be conducted to find the mastermind of the racket and all its members, and bring them all to book.

Has poverty-alleviation spending made any difference?

One critical question raised the context of poverty alleviation in Bangladesh is whether poverty reduction spendings have made any dent on poverty in the country. Sometimes, we generalise the responses to this question. Sometimes, the responses are based more on rhetoric, rather than hard facts. And sometimes, the responses are partial, rather than comprehensive. But an objective response to the question requires an understanding of the dynamics of poverty in Bangladesh, the nature of poverty alleviation spendings. It requires familiarity with poverty and inequality data, and a sense of the magnitude of the poverty alleviation expenditures.

Poverty in Bangladesh has many dimensions. At one level, it can be structural, rooted in the structure of the economy. It can also be transient, which has more of a seasonal nature. Thus, people can be permanently trapped in poverty, or they can

A careful review of the poverty data of Bangladesh clearly indicates that over the years, the incidence of poverty has come down significantly. The 2022 Household Income and Expenditure Survey, published by the Bangladesh Bureau of Statistics puts

Higher values within the range indicate higher inequality. A Ginicoefficient value close to 0.5 would mean high inequality. Inequality is also manifested in Bangladesh in other non-income dimensions. For example. in the area of child malnutrition, while 38 percent of the children in the poorest households are stunted, the comparable figure for the richest households is 20 percent.

Inordertomakepublicexpenditures on poverty reduction more efficient, macroeconomic and sectoral poverty reduction programmes and projects should be formulated with a concrete focus. A sensible implementation plan with an achievable timeline will safeguard against resource leakages. The effectiveness of such programmes and projects in alleviating poverty can also be enhanced if they are solidly anchored in Bangladesh's overall development plans aligned with its overall goals and objectives, and if the macroeconomic framework and sectoral policies are poverty-sensitive. Linking poverty alleviating measures with employment generation, social services, and pro-poor economic growth would make public resources for poverty reduction more effective.

Was Iran's election a smokescreen?

During Iran's latest presidential elections, the hashtag #electioncircus was trending among the Iranian community on X. This may be due to the illusion of a political competition that is encouraged by the Velāyat-e faqīh, or Supreme Leader, Ayatollah Ali Khamenei, in an established theocratic system, where presidential elections are mostly a facade because ultimately, the decision-making power rests with the Supreme Leader.

So, how do presidential elections work in Iran? The Shourā-ye Negahbān (Guardian Council) handpicks the most suitable candidates from a pool of presidential candidates, who then compete against one another. To secure victory, a candidate needs more than 50 percent of the people's vote. If no candidate achieves this majority, a run-off ensues a week later between the two candidates who received the highest number of votes in the initial

And what is the Guardian Council? It constitutes 12 members who are directly/indirectly appointed by the Supreme Leader, who hold power to vet/veto legislation, and oversee elections. The Guardian Council can bar candidates from standing in elections to parliament, the presidency and the Majles-e Xobregân-e Rahbari

(Assembly of Experts). For example, Ali Larijani, an ex-parliamentary speaker and former Commander of the Islamic Revolutionary Guard Corps, was disqualified during the 2021 presidential elections by the Guardian Council, possibly owing to his centerright ideology. Noteworthy to mention, disqualified candidates are disallowed from protesting the council's rejection.

Among the seven candidates who were selected by the Guardian Council for the 2021 presidential elections was the to-be president, Ebrahim Raisi, a far-right hardliner, known as the "Butcher of Tehran" for his role in allegedly carrying out mass executions of up to as many as 30,000 political prisoners in 1988, as thethen Deputy Prosecutor General of Tehran. Following Raisi's death after a helicopter crash on May 19, 2024, new presidential elections took place shortly after, which culminated on July 5, 2024.

This time, out of 80 candidates, 74 were disqualified by the Guardian Council, which included four female candidates, as has been the case for all presidential elections since the Islamic revolution—a testament to the accusation that Iran is a gender apartheid state. According to Iran's Ministry of Interior, there was a record-

the Islamic Republic, where only 40 percent of the more than 61 million eligible Iranians voted during the first round, which evidences that most do not support clerical rule. I will skip any comment on the speculation that even these embarrassing numbers are fabricated, as has been the claim, given the staggering majority's decision to abstain from voting.

Among the six selected candidates this time around, Dr Masoud Pezeshkian was the only so-called "reformist"—a widely circulated theory that has thrown dust in the eves of many non-Iranians. It won't be too absurd to assume that Pezeshkian's approved candidacy by the Khamenei-controlled Guardian Council was a ploy to increase political participation. Pezeshkian won against ultra-conservative Saeed Jalili, but one wonders what moderate reforms he will he bring about without challenging the state's theocratic system, especially when he himself has given a public statement declaring that confronting Iran's power elite of clerics will never be part of his agenda.

Anyone who understands Farsi can easily find Pezeshkian's stance on women's rights. In an interview, an elderly Pezeshkian proudly states that even before the first Supreme Leader, Ayatollah Khomeini, established the mandatory hijab law in 1979, Pezeshkian enforced women to wear long trousers, the longsleeved manteau (a long overcoat), and the hijab at the Tabriz University of Medical Sciences (where he was pursuing an MBBS) as well as at the hospital across the medical college. One alumna of the university recounts incidents from 1979, when Pezeshkian

low turnout since the inception of and his comrades, whom she dubs as "terrorists," attacked and harassed women who didn't comply, and even carried weapons, such as knives and chains, as scare tactics.

Should a reasonable skeptic, who relies on the independent investigation of the truth, believe that the same man who didn't believe in women's right to freedom of choice is now a changed "reformist" under the same regime that has committed human rights violations in relation to the Zan, Zendegi, Azadi (Woman, Life, Freedom) movement in Iran? Should I, a Bangladeshi citizen belonging to the Iranian diaspora, believe that Pezeshkian will, for instance, make any legislative amendments to dismantle gender apartheid? Or will he be able to ensure a stop to persecutions against non-Shiite religious minorities such as the Baha'is, who are barred from having tertiary education and government jobs, whose properties are confiscated, whose dead are denied the right to dignified burials?

Even if Pezeshkian is given the benefit of the doubt, what power does he hold at the end of the day? None, really. It is therefore disappointing to see every international news portal misleadingly labeling the new president as "reformist" or "moderate" or to see clickbait titles such as the BBC's "Iran's new president gives hope to some women and younger voters," when the content of the article itself goes on to say: "...with Ayatollah Khamenei having final say over government policy - there is little chance of real change," and "... regardless of Dr Pezeshkian's win, the supreme leader remains the 'puppeteer' in Iran."

Bangladesh needs inclusive data for an equitable future

Today is World Population Day (WPD), and this year's theme is "Embracing the power of inclusive data towards a resilient and equitable future for all." Inclusive data means collecting data for all people, regardless of location, ethnicity, gender, or age. It involves representation, disaggregation, intersectionality of identities, multiple sources, privacy, and support of human resources and technical capacity. It is about closing the data gaps required for a fair and equitable society, and it is more than numbers where every person is seen, heard,

The key messages for the WPD 2024 as circulated by the United Nations are: (i) in a world of uncertainty and upheaval, we can achieve a peaceful and prosperous future by building resilient systems and societies using evidence-based solutions and reliable, inclusive data; (ii) data collection and analysis tools have vastly improved; yet these changes have also exposed significant information gaps and potential risks, including the misrepresentation or misuse of data; and (iii) countries and societies must champion data collection that counts people as they are, in all their complexity.

This year the world will celebrate the 30th anniversary of the landmark International Conference on Population and Development (ICPD). Since adopting the ICPD Programme of Actions (PoA) in 1994 and the Sustainable Development Goals (SDGs) in 2015, countries worldwide have been developing the necessary statistical data to track the goals and indicators developed by the United Nations. To measure progress of SDGs, inclusive data is crucial to enables us to see where change is required, allowing us to reach everyone and support them in realising their rights. The SDG progress report demonstrates where a country currently stands on inclusive data

The SDG tracker of Bangladesh shows that almost two-third of all indicators used to monitor the 17 SDGs currently should be made available, but only one-third are updated or readily available. It will take less than six years to reach the SDGs benchmark, but more data will be needed—especially disaggregated data for development. More than half of the data are unavailable for specific goals like SDG 12 (responsible consumption and production) and SDG 14 (life below water). The number of updated data was reduced in 2023 but increased in 2024, which needs a causal explanation from the government. The Bangladesh government is implementing the SDGs at the district and upazila levels. The cabinet approved 39+1 priority indicators in 2018 to localise the SDGs because 39 were deemed necessary at the local level in the nation and had reinforcing effects on other targets. Another priority indicator was left in place to ensure that "no one is left behind," aligning with the requirements of a particular district or upazila and considering the specific circumstances of that geographic area. About five of these 39 priority indicators still need to be updated in the tracker. Another issue with this online tracker is that reviewing the data availability status of each goal's indicator can be confusing because the information is not synchronised. Many of the indicators are only partially mentioned. All these problems must be addressed and resolved immediately for this SDG tracker to function correctly.

While improvements in data collection have been made, data gaps have also been exposed. Significant gaps persist in the availability, quality, accessibility, and use of data in Bangladesh. For example, marginalised groups, such as people with disabilities, are not counted accurately in the latest population and housing census in 2022 leading to the possibility that more people will remain invisible to decision-makers. Inclusive data on disability means collecting data primarily on disability, sex, and age and incorporating other dimensions, such as income, ethnicity, location, and other factors. We need to analyse and critically use the data to develop policies to reach those who are most marginalised or are being left behind. The urgency of addressing these data gaps cannot be overstated, as it is crucial for the

future of our society. Another example can be given regarding the accuracy of the maternal mortality ratio (MMR) in Bangladesh, an essential indicator of SDG-3 (good health and well-being). There has been no large-scale maternal mortality and health care survey after 2016. The MMR data, reported from Bangladesh Bureau of

our common agenda, keeping the population and its sub-groups at the development centre. For example, Bangladesh should prioritise data on the most vulnerable communities, like adolescent mothers (ages 15-19), as adolescent childbirth is common in practice (24 percent, Bangladesh Demographic and Health Survey, BDHS 2022).

More robust data systems drive diverse benefits, improving quality of life and livelihoods and leading to greater efficiencies in social programmes. An analysis published in September 2022 by the Global Partnership for Sustainable Development Data states that every dollar invested in strengthening data systems generates \$32 in economic benefits. This underscores the potential for significant positive change achieved through strategic investment in data systems. Thus, the United Nations (UN) recommends increasing domestic funding for data and statistics by 50 percent by 2030, along with urging donor agencies to raise the share of official development assistance for data to at least 0.7

Although several SDG targets have been partially met, achieving full realisation is essential for expediting overall progress in Bangladesh. A few significant challenges to achieving the SDGs in Bangladesh are the unavailability of baseline data, lack of monitoring, and lack of coordination among the national targets stated in the national policies and the SDG target. Thus, establishing a national data repository or information bank that consolidates relevant data from each concerned organisation is necessary, and it can be linked with the SDGs tracker.



Statistics' (BBS) Sample Vital Registration System (SVRS) that records vital events such as births, deaths, and causes of death, does not truly reflect the figure due to a shortage of the required sample size. As a result, reporting the MMR and its disaggregated figure from there for policy design and interventions is not appropriate. Thus, urgent efforts must be made to make quality data for all indicators available through effective multisectoral partnerships, coordination, and integration among stakeholders to strengthen and improve the country's data capacity. Decision-making depends heavily on data; obtaining high quality data is crucial for reaching the SDGs. Bangladesh needs more investment in inclusive data for a resilient and equitable future. Our country faces enormous challenges, but we can tackle them. Strong political commitment and the effective and timely implementation of such commitment are essential. Significant policies related to population and development need to be reformed and updated using the SDGs framework. We should pursue the SDGs and

Bangladesh has a population of more than 173 million (SVRS, 2023, BBS). This is a big number with big opportunities, and big challenges. A population of 173 million means there are over 173 million opportunities for a healthier Bangladesh empowered by rights and choices. Adequate and updated population data based on gender, ethnicity, class, religion, disability, etc, are necessary for inclusive development. There is evidence of adopting an inclusive approach to data collection in Bangladesh-data on transgender or Hijra were included in the 2022 Population and Housing Census. The key is to ensure equal access to opportunities and removing barriers to opportunities to harness the potential of all Bangladeshis, including marginalised or disadvantaged populations like women, young people, older people, people with disabilities, and migrants. The best way to cultivate demographic resilience is to support human rights, including individuals' rights and choices-that is the ultimate development.



Vision for an AI law in Bangladesh

We may not notice it at first glance, but the world is going through a technological renaissance in the form of Artificial Intelligence. In the bustling heart of South Asia, Bangladesh also stands on the cusp of this technological renaissance. As artificial intelligence (AI) is transforming industries worldwide, the nation is facing an urgent call to draft forward-thinking AI policy guidelines. Imagine a future where Dhaka's traffic is managed by smart systems, farmers use AI to boost crop yields, and healthcare is revolutionised by predictive analytics. In the current situation, this thought might be farfetched, but this promising horizon can come sooner rather than later if Bangladesh can establish a policy guideline that can navigate its set of challenges and responsibilities. Bangladesh must utilise the AI wave with a blend of ambition and caution, ensuring that innovation does not eclipse ethics and inclusivity.

Crafting Bangladesh's AI policy is a bit like preparing the perfect biriyani: it requires just the right mix of ingredients to create something truly remarkable. The focus should be on blending robust international cooperation to ensure trustworthy AI, with a generous helping of digital infrastructure to provide the computing power needed for innovation. Stir in public awareness and civic engagement to keep society informed and involved, sprinkle generously with investments in public research capabilities, and don't forget to season with education and skill development to prepare the workforce for future challenges. Finally, top it off with initiatives to boost connectivity and digitalisation, and a strategic vision aligned with the Fourth Industrial Revolution (4IR) to ensure sustainable growth. When these elements come together, Bangladesh can set up a tech policy that's not only cutting-edge, but also inclusive and forward-thinking. So, what elements should be on the radar of policymakers when crafting this pivotal piece of legislation?

First of all, AI's transformative potential can only be fully realised if there's a skilled workforce to harness it. Thus, the AI Act must prioritise comprehensive education and training programmes. Integrating AI into school curriculum, establishing vocational training programmes, and offering scholarships for AI-related fields are essential steps. This not only prepares the next generation for AI-driven jobs but also ensures that the current workforce is not left behind.

To position Bangladesh as a leader in AI innovation, substantial investments in AI research and development (R&D) are crucial. This involves funding interdisciplinary research collaborations universities, research institutions, and private industries. The goal should be to advance AI capabilities in key sectors like healthcare, agriculture, and manufacturing. Think about AI research centres and innovation hubs sprouting across the country, nurturing a vibrant ecosystem of startups and entrepreneurs. We need to build a digital infrastructure. For example, we can talk about the recent policy on AI that was adopted by Vietnam. Within 2030, they want to build an "AI ecosystem." It means a fluid incorporation of AI in the commercial and research sectors. This ecosystem may include various components that work together to foster innovation, ensure ethical standards, and drive the economic and societal benefits in the country. Most importantly, to foster AI innovation in Vietnam, the government is taking a comprehensive strategy focusing on human resource development, organisational construction, research and development, and investment in AI

enterprises. This includes deploying basic AI and data science skills through short and medium-term training courses for students and career-changing workers, attracting both domestic and foreign resources to build training centres, and establishing key research hubs at leading universities. Ultimately, the Vietnamese government wants to promote and attract investment capital for the growth of AI enterprises and brands in Vietnam.

Similarly, for AI to flourish, Bangladesh needs to prioritise investment in highspeed internet connectivity, cloud computing services, and data centres. This infrastructure will provide the necessary computing power and data storage capabilities for AI applications across various sectors. Building this infrastructure is another difficult but manageable task with the right collaborative efforts. If the government can encourage collaborations between itself, the private sector, and academia then Bangladesh can create a fertile ground for AI advancements tailored to local needs. And not only through local collaboration, but Bangladesh should also establish partnerships with other countries, international organisations, and tech companies to develop shared principles and standards for trustworthy AI. This can also position the country as a trustworthy player in the global AI landscape, attracting international investments and collaborations. We have to remember that, in the

current AI-driven world, data is the new oil. However, with great data comes great responsibility. Ensuring a robust data security infrastructure is paramount. The AI Act should mandate the use of cutting edge encryption technologies, continuous monitoring systems, and regular security audits to protect sensitive information from cyber threats. This is not just about safeguarding individual privacy but also about building trust in AI systems. A data breach in a healthcare system powered by AI could have catastrophic consequences, undermining public Therefore, a comprehensive focus on data security is non-negotiable. Another thing to note is that AI is

a double-edged sword. While it has the potential to drive unprecedented progress, it also poses significant ethical challenges. The AI Act should establish clear guidelines for ethical AI deployment, ensuring transparency, accountability, and fairness. It is very easy to misuse AI and promote misinformation or biases. Nowadays, AI can create realistic but fake images, videos, and audio (deepfakes), which can be used to spread misinformation, manipulate opinion, or damage reputations. It also increases fraud and scams because there are no established guidelines to use of AI systems. AI can perpetuate and amplify biases present in their training data, leading to discriminatory practices in hiring, lending, law enforcement, and more. So, establishing data protection laws to safeguard personal information and fostering transparency in AI decision-making processes are critical steps toward ethical AI.

All in all, crafting an AI Act for Bangladesh goes beyond technicalities, it centres on people and public engagement. Essential initiatives include public awareness campaigns to educate citizens on AI's benefits and risks, and involving diverse stakeholders-civil society, academia, and industry-in policymaking to ensure transparency and accountability. The Act should also align with Fourth Industrial Revolution (4IR) principles which emphasises innovation, digitalisation, and interconnectedness. By balancing innovation with regulation and addressing local needs while adhering to global standards, Bangladesh can harness AI's transformative power for an inclusive, ethical, and sustainable digital future.





MESSI ENJOYING 'last battles' for Argentina

Lionel Messi said he was enjoying his "last battles" with Argentina after the 37-yearold found the net in a 2-0 win over Canada on Tuesday to book a place in the Copa America final.

After a lacklustre display against Ecuador in the quarterfinals, Messi looked back to himself again, connecting with Angel Di Maria and strike partner Julian Alvarez, who also scored.

"I'm living it like I lived it in the last Copa America, in the last World Cup....these are the last battles and I'm enjoying them to the maximum," he told TyC Sports

after the win set up a meeting with

Uruguay or Colombia in the final.

Messi, now playing with Inter Miami in Major League Soccer, has yet to indicate whether he will continue to play with Argentina in the 2026 World Cup.

But asked about Messi's "last battles" comment, Argentina coach Lionel Scaloni asked for calm.

"We have to leave him alone, he knows that we will not be the ones to close the door on him. He can stay with us as long as he wants, even when he retires...Let him decide what he wants," he said.

Messi has chance to win a third straight major title with his national side following their 2022 World Cup triumph and their 2021 Copa America win.

The eight-time Ballon d'Or winner

referenced veteran team-mates Di Maria and Nicolas Otamendi and said that the success was validation for the difficult barren years the team had suffered.

"The truth is that it's crazy what this group has done, what the Argentina national team has been doing," Messi said on TyC Sports.

"It's not easy for us to be in a final again, for us to compete again to be champions," he added.

Messi also added that it has been a difficult tournament for Argentina.

"It's a difficult Copa, evenly matched, with very bad pitches, with high temperatures, very tough teams, and for us to be in a final again is something to enjoy," he said.

HP squad formed with eye on future **Australia Tests**

Bangladesh Cricket Board (BCB) yesterday named a few Test cricketers in their four-day High Performance (HP) squad for the upcoming tour in Australia, keeping in mind their 2027 Future Tours Programme (FTP) schedule.

Shadman Islam, Mahmudul Hasan Joy, and Shahadat Hossain Dipu, all part of the current Test setup, are set to tour Australia for their maiden outing in the Oceania region.

The national team is not accustomed to touring Australia regularly, with their last and only Test tour occurring in 2003 which featured two Tests and three ODIs. In 2008, Bangladesh toured Australia again, but only for a threematch ODI series. Since then, the Tigers have fared in Australia for two global tournaments: 2015 ODI World Cup and 2022 T20 World Cup.

As HP team are also scheduled to play a 50over series and a T20 tournament involving Big Bash teams and a Pakistani side, the selectors included several white-ball cricketers in their squads: Tanzid Hasan Tamim, Afif Hossain, and Shamim Hossain, alongside some budding cricketers fit for the formats.

Although BCB's plan to send some of their Test cricketers to gain experience on Australian soil is receiving applause from different corners,



questions remain on whether their selection for the white-ball matches is justified. Afif, who was a traveling reserve during Bangladesh's recent T20 World Cup campaign, hasn't played a game for Bangladesh since December last year, while Shamim's last outing in national colours came during last year's New Zealand tour.

A 28-year-old pacer, Abu Hider Rony, also found his place in both white-ball squads despite his last international match for Bangladesh being in 2018. National selector Hannan Sarkar claimed they formed the squads prioritising players for specific formats and picking some players who could go on to represent them at top level.

"We have a few Test cricketers in our fourday team. As we are scheduled to play Tests in Australia in 2027 according to our FTP schedule, we want to prioritise these players," Hannan was quoted in a BCB video released yesterday.

"Similar goes for one-day and T20 teams. I think it's a very good stage where the players can express themselves and gather experience," he added.

HP chairman Naimur Rahman Durjoy earlier insisted that they have arranged the tour for pipeline cricketers' betterment to "give gametime opportunities", and now it's up to them to "utilise the opportunity and take themselves to next level".

"We want to continue the process and increase the facilities from the board," he added.

Whether the series will have a significant impact on Bangladesh cricket in the future remains to be seen.

Krejcikova sets up Rybakina clash

Barbora Krejcikova reached her first Wimbledon semifinal on Wednesday with a 6-4, 7-6(4) win over Latvian 13th seed Jelena Ostapenko in the battle of former French Open champions.

The Czech 31st seed kept her composure from the back of the court to force her opponent into in the other quarterfinal. 35 unforced errors

UNHRC adopts resolution for Rohingya return

The United Nations Human Rights Council yesterday unanimously adopted a resolution emphasising on sustainable solution to the Rohingya crisis through their repatriation by creating a congenial environment in Myanmar's Rakhine and ensuring justice and accountability for them.

The resolution was adopted during the ongoing 56th session of the council in Geneva, according to a statement issued by the Permanent Mission of Bangladesh to the UN Office and other international organisations in Geneva.

The statement says Bangladesh took the initiative for the resolution titled "The situation of human rights of Rohingya Muslims and other minorities in Myanmar" and it was placed on behalf of all member states of the Organisation of Islamic Cooperation.

The resolution was adopted following intense and long

Shanchita Haque, acting permanent representative of the Bangladesh mission, said with limited resources and different challenges, it is not possible for Bangladesh to give shelter to the huge number of Rohingyas for an indefinite period.

"The international community should support Bangladesh in the repatriation by realising the importance of the causes of Bangladesh's concerns," she added.

Pakistan's ISI gets power to intercept calls

Paki1ed tracking to criminal and activities and government would ensure it did not infringe people's lives and privacy.

'The federal government in the interest of national security and in the apprehension of any offence, is pleased to authorise officers ... to intercept calls and messages or to trace calls through any telecoms system," said the notice, seen by Reuters.

Govt stock nearing exhaustion

The government's family planning efforts are likely to be seriously hindered as supplies of contraceptives at the field-level offices are running dangerously low.

At present, there is no injectable contraceptive in any upazila and the stock of birth control pills will run out in a few months, according to officials of the Directorate General of Family Planning (DGFP). The stock of implants has also run out.

The reason for the supply running low is a halt in procurement for months due to a legal battle at the High Court.

Although the legal battle has ended recently and the procurement process has resumed, the DGFP officials cannot give a timeline for when

the birth prevention materials, which are distributed for free, will be available at the field

Subsequently, the DGFP has started rationing and redistributing the current stock, they added.

The eligible couples in Bangladesh are provided seven options for contraception:

- No injections at any upazila
- DGFP started rationing contraceptive materials
- 37pc of eligible couples receive contraceptives

permanent system for male and female, intrauterine devices, implants, oral pills, condoms and injectables.

At the end of May, there is no stock of the oral contraceptive pill Sukhi (3rd gen) in 287 upazilas, according to the DGFP stock status report. There is no stock of Sukhi (2nd Gen) in 414 upazilas

The stock of the other oral contraceptive pill Apon is 13.33 million cycles and was projected to run out in June, according to the

While procurement of 45 million cycles of Sukhi (3rd gen) is under process, it will take several months to get the supplies in hand, according to DGFP officials.

There are no injectables in 462 upazilas. The stock of 0.151 million vials was supposed to run out soon, too.

The current stock of condoms is 20.32 million, and this stock can be used up to November.

Population experts fear that the scarcity of birth control materials will increase mother and child mortality rates as eligible couples might go for an unintended pregnancy causing abortion.

AFP that ethnic minority fighters were in control of "most" of Naungcho.

Myanmar's northern Shan state has been rocked by clashes since late last month when an alliance of ethnic armed groups renewed an offensive along the highway that runs from second city Mandalay to China's Yunnan province.

Naungcho is around 50 kilometres (30 miles) along the highway from the former British hill station of Pyin Oo Lwin, home to the military's elite officer training

Another road from the town leads to Taunggyi, the capital of Shan state. AFP was unable to reach a junta spokesman for

Myanmar's borderlands are home to myriad ethnic armed groups who have battled the military since independence from Britain in 1948 for autonomy and control of lucrative resources.

Ukraine will stop Putin

Biden tells Nato in forceful speech, promises new air defences for Kyiv

US President Joe Biden pledged to forcefully defend Ukraine against Russia's invasion at the Nato summit in Washington on Tuesday evening, using the global stage to try to show allies at home and abroad that he can still lead.

Biden, 81, has endured 12 days of withering questions about his fitness for office as some of his fellow Democrats on Capitol Hill and campaign donors fear that he will lose the November

5 election after a halting debate performance on June 27.

"(Vladimir) Putin wants nothing less, nothing less, than Ukraine's total subjugation ... and to wipe Ukraine off the map, Biden said in his welcome to Nato member states to the summit, referring to the Russian president. "Ukraine can and will stop Putin.'

Biden spoke off of a teleprompter with a strong and confident voice and largely avoided the verbal flubs and signs of confusion that marked his debate performance.

"Today Nato is stronger than it's ever been in its history," he said. Biden also announced a major package of air defences for Ukraine.

The air defences "will help to protect Ukrainian cities, civilians, and soldiers," Biden said in a joint statement with other leaders, adding that they would look to

send dozens more shorter range systems in the coming months.

The US pledge comes on top of two new Patriot systems already being given by Germany and Romania, and one the Netherlands has said it is putting together with parts from other allies, reports Reuters.

The centrepiece of the Nato summit is set to be new commitments of military and humanitarian aid to Ukraine. US Secretary of State Antony Blinken said the

summit would "further strengthen" the war-torn country's path to Nato

membership. Zelensky, who arrived in Washington on Tuesday

and is due to meet with Biden today, has said Ukraine needs a minimum of seven Patriot systems. "We are fighting

for additional security guarantees for Ukraine and these are weapons and finances, political

support," he said on social media. Ukraine ultimately wants to join Nato to ward against further future attacks by Russia but candidates have to be approved by all of the alliance's members, some of which are wary of provoking a direct conflict with Russia.

Some members want the alliance to make clear Ukraine is moving toward Nato "irreversibly" and are keen for language in a summit statement beyond the alliance's pledge last year that "Ukraine's future is in
