### **MYANMAR CONFLICT** Junta 'trying to destroy country' Warns UN special rapporteur

AFP, Bangkok

Myanmar's junta appears to be "trying to destroy a country it cannot control", the UN special rapporteur to the country warned yesterday.

Clashes between an alliance of ethnic minority armed groups and the military have shredded a Beijing-brokered truce in January.

The ceasefire had briefly halted widespread fighting in the northern part of the Southeast Asian nation since a military coup ended democratic rule in 2021.

"The junta is on its heels, it's losing troops, it's losing military facilities, it is literally losing ground," UN special rapporteur Tom Andrews said during a briefing to the national security body of neighbouring Thailand.

"It almost appears as if the Junta is trying to destroy a country that it cannot control."

The military's response to its losses has been to attack civilians, he said, adding there had been a substantial increase in the number of attacks on schools, hospitals and monasteries in the last six

### Govt free to alter, reduce or increase quota

recruitments to the posts of 9th grade (formerly 1st class) and 10th to 13th grades (formerly 2nd class), the appointments should be made on the basis of merit. It added that the existing quota system for direct recruitment to those posts was abolished.

On June 5 this year, the HC delivered the verdict following a writ petition filed by Ohidul Islam Tushar and six other children of freedom fighters, challenging the legality of the circular.

On that day, agitators started staging demonstrations at different educational institutions, including Dhaka University, protesting the HC

They took to the streets on July 1 demanding the reinstatement of the 2018 circular.

Students at different institutions

across the country intensified their movement on July 4 as the Appellate Division of the Supreme Court did not stay the HC verdict following a government petition.

The protesters are continuing the movement now, demanding reforms to the quota system by formulating a law.

the judgement released vesterday, the HC directed the respondents to the writ petition to restore the quota for the children and grandchildren of the freedom fighters. It also directed them to keep the quotas for district, women, people with physical challenges, ethnic groups and others, if there are any.

The HC further ordered the government authorities to publish a notification in this regard as soon as possible, preferably within three months from the date of receipt of its

Deputy Attorney General Sk Shaifuzzaman, who received a copy of the HC verdict's portion, told The Daily Star that the details of the findings and grounds, on which the HC delivered the verdict, would be known once the full text of the judgement is released.

He said no appeal can be moved before the Appellate Division challenging the HC verdict without the full text.

The full text is necessary so the Appellate Division can examine whether the verdict is correct."

On July 10, the Appellate Division issued a four-week status quo on the subject matter and the HC judgement

The status-quo order means the quota system will not remain in force until the Appellate Division's further order, legal experts told The Daily

### Names of some big fish come up in probe

involved in the question leaks of recruitment exams of banks and medical admission tests.

It all came to light after the Criminal Investigation Department arrested 17 people, including six officials and employees of the PSC, for their involvement in leaking questions of a railway recruitment test on July 5.

According to investigators, the racket, which began its activities back in 2002, has made huge sums of money over the years.

All the arrestees had multiple suspicious transactions in their bank accounts. The CID arrested PSC office assistant Sajedul Islam with bank cheques worth Tk 10 crore in his possession, they said.

Another arrestee, PSC dispatch rider Khalilur Rahman was found to own wealth worth around Tk 50-60

Probe sources further said the syndicate had supplied the questions of the railway recruitment test to at least 300 candidates. Abed Ali alone collected around

The CID is now listing the names of the candidates along with those of absconding syndicate members, including former and current PSC

CID Chief Mohammad Ali Miah, also additional inspector general of police, told The Daily Star yesterday, "We're conducting drives to arrest those who went into hiding after the 17 were arrested.

Saha, also vice-chairman of Bangladesh Leasing and Finance Companies Association (BLFCA), said the loans that were disbursed in the last one or two years are regular.

## Quota protests heat up

However, police yesterday said that they would take legal action if the protesters continued to block roads and cause public sufferings even after the Supreme Court "directed to maintain status quo in respect of subject matter".

League President Saddam Hossain in a press briefing at Dhaka University said Chhatra League was ready to face those trying to use the movement to gain political mileage.

mobilised Police yesterday additional forces and kept riot cars and water cannons in Shahbagh and some key intersections in Dhaka.

Law enforcers put barricades at Shahbagh intersection, but several thousand students coming in from Dhaka University breached it around 5:00pm.

The law enforcers, however, surrounded them and did not let them go beyond the Birdem Hospital, sparking a tussle. The students chanted "bhua" (fake) towards the police and eventually took position at Shahbagh intersection.

Somov TV reporter Twoha Khan Tamim and cameraperson Prince Arefin were attacked at Shahbagh, the media outlet reported.

Another group of demonstrators, mostly from Dhaka College and Eden Mohila College, marched towards Shahbagh but were halted by police in New Market area.

They held a brief rally in front of Dhaka College and vowed to continue with their demonstrations.

A section of Jagannath University students joined the protesters at

the university main gate.

During their march towards Shahbagh, police attempted to stop them at Shankhari Bazar, in front of the CMM Court, and at Tantibazar, but failed.

#### **CLASHES**

In Cumilla, at least 10 students, including journalists Anon and Around the same time the police Sourav of Comilla University, were made the announcement, Chhatra injured as police charged truncheons Obaidul Quader urged the students

"Of the injured, six were released after treatment at the Cumilla General Hospital while the rest were undergoing treatment there," Fazle Rabbi, director of CGH, told The Daily

According to locals and witnesses, the protesters were chanting slogans against the police in Ansar Camp area near the university. Police charged baton to disperse them and the students retaliated by throwing brick chunks.

Police, later, fired tear gas shells, resulting in injuries, they said.

Nazmul Hasan, additional superintendent of police in Cumilla, said the police were there to save lives and properties.

In Chattogram city, at least five people were hurt in two clashes between the police and the protesters in Gate No-2 and Tigerpass areas.

Police charged truncheons on the agitators at Tigerpass around 4:40pm as the protesters tried to march defying barricades. Police used truncheons again when the protesters reached Gate No-2 area

around 5:00pm. Afterwards, the students blocked resume studies. the gate area until 7:30pm. CROSSING THE LINE

Shahbagh after breaking the lock on said the students were crossing the court would consider it ...," it said.

Asked if the government would take action if the students did not withdraw their protest programmes, the home minister, during a press conference, said, "They are educated and intelligent. Why would they go against the state? They should observe the situation and return."

The two sides agreed to deepen cooperation in trade, investment and finance, and to conclude the joint feasibility study on a China-

Bangladesh free trade agreement. "This will significantly boost trade between the two countries," said Kabir, also the president of Bangladesh Enterprise Institute, a non-profit, non-political research centre.

China is Bangladesh's largest trading partner by a wide margin, with bilateral trade amounting to upwards of \$25 billion. However, Bangladesh's exports account for less than 3 percent of the sum.

"China has completed the entry procedures for Bangladesh's fresh mango exports to China, and welcomes Bangladesh to expand exports of jute, leather, aquatic products and other high-quality special products to China. The two sides agreed to further strengthen communication on the export high-quality Bangladeshi agricultural products to China," the joint statement said.

Ahead of the three-day visit, there was expectation that Beijing would provide a \$5 billion loan in yuan for trade facilitation to help Bangladesh cope with the strain on

At a press briefing after Hasina's meeting with Li Qiang on Wednesday, Foreign Minister Hasan Mahmud said China has agreed to provide 1 billion yuan (about \$137 million) in assistance. However, the joint statement does not mention this assistance extended to

Bangladesh. China has now become more cautious in giving out loans after it was blamed for the economic crisis in some countries such as Sri Lanka, said Kabir, who served as Bangladesh's ambassador to Nepal and the US and the high commissioner to Australia.

In case of Bangladesh too, China is exercising the same caution.

For instance, China has decided to form a joint technical committee for assessing the projects proposed by Bangladesh, Kabir said.

"I would say that this visit is meant to build a relationship that is futuristic and expansive," he added.

China committed to provide about \$20 billion during Xi's visit to Dhaka in 2016 for a host of mega projects. Some of the projects are yet to be implemented. So Bangladesh did not get the full amount pledged.

"So, China wants better scrutiny this time -- Beijing would like to look at the nitty-gritty of the projects

currency reserves, and billions more this time," said Mahbub Uz Zaman, former ambassador to China.

Xi spoke about building party to-party relationship between the Communist Party of China (CPC) and the ruling Awami League in Bangladesh. He said "good governance requires good party".

Asked what this means, Imtiaz Ahmed, executive director of the Centre for Alternatives, said: "This is Chinese approach of building relationship, which they do everywhere. Through this, they find it easier to implement their policies.'

The Awami League can learn discipline and governance of the party from the CPC, said Ahmed, also a professor of international relations at the University of Dhaka.

Xi also assured Hasina of support for repatriating the more than a million Rohingya. However, analysts say how far it will work will depend on the situation in Myanmar, which is now going through a civil war.

Repatriation has not been possible in the last seven years despite several efforts including under a tripartite mechanism under Chinese leadership.

On this, Kabir said: "Chinese assurance is great and is required for the solution, but we will have to wait to see what happens in Myanmar, particularly in the Rakhine State in the days to come."

# Jubo League leader, two others sued
