A seven-year-long waterlogging woe



Rasulpur area of Tangail Sadar upazila has been experiencing waterlogging over the past seven

construction project was dumped at the mouth of a canal flowing through the area, obstructing its flow and hindering its ability to drain away

As such, students of Rasulpur Bachhiron Nechha High School and Rasulpur Government Primary School, traders at Rasulpur Market, and dwellers of numerous houses in the area have been suffering immensely due to waterlogging

In monsoon, their sufferings know no bounds

In 2017, when the road connecting Tangail with the Bangabandhu Bridge through Sadar upazila was turned into a four-lane one, the contractors dumped the debris at the mouth of

a persistent ordeal.

"Every time it rains, students are compelled to tread through muddy water while entering or leaving the school premises. In monsoon, their sufferings worsen as waterlogging becomes persistent throughout the season," said Md Abdul Mannan Sarkar, headteacher of Rasulpur Bachhiron Nechha High School.

Rashed Rahman, president of the school's managing committee, said, "We have written several times to the local lawmaker, Tangail's deputy commissioner, Sadar upazila parishad chairman, and Bangladesh Water Development Board executive engineer, seeking remedies to the problem."

Monir Majhi, another fisher, said that it costs Tk 3,000 including oil to go to river once. "Six of us went to catch hilsa, but we returned empty handed," he added.

Fisherman Md Jasim Mia said hilsas are avoiding the rivers as ships from Chattogram are using this river route.

Some other fishermen said siltation and pollution of the rivers and presence of a huge number of fishing trawlers are reasons why hilsas are not entering the rivers from the Bay.

Nuru Majhi, president of Mahipur Fishermen's Association, said there is no hilsa at Kuakata, Alipur and Mahipur fish landing stations. He said around 50,000 people in this region, engaged in hilsa catching and trading, are now in dire straits.

According to sources at the Divisional Fisheries Office in Barishal, there are 4.21 lakh registered fishermen in the division.

Although at least 2,000-3,000 maunds of hilsa were expected to arrive daily at the 25 fish landing stations in the division, even half of it has not been received, the sources also said.

"It is not true that there is no hilsa at all; the number, however, is much less than expected. The situation may change in a few days when more hilsa will enter the rivers once the temperature of water becomes favourable for laying eggs," said Nripendra Nath Biswas, deputy director of the Barishal divisional fisheries office.

DELAY IN MEDICAL REPORTS Probe, trial pending for 965 cases

Investigations into at least 965 cases filed with different police stations under Chattogram Metropolitan Police are currently halted due to delay in issuance of medical reports in connection with the cases by Chattogram Medical College Hospital.

As such, the trial procedures of the cases also remain pending with different metropolitan courts

According to medical, police and court staffers, these reports are crucial for any case, as they can change its whole merit.

Sometimes the medical staffers take bribes to manipulate the reports and thereby change police investigation.

The matter came to light after judicial magistrates openly spoke up about the matter at the policemagistracy conference on March 6, although investigation officers have been facing the issue for a long time.

This correspondent talked to at least 15 sub-inspectors and inspectors of 16 police stations under CMP in this regard.

The officers alleged that the IOs even have to bribe hospital officials Tk 500-5,000 based on the category and merit of the cases to get the necessary reports including post mortem, and DNA, forensic and medical certificates.

Most complaints regarding delayed issuance of medical reports and bribery are against the casualty and orthopaedic departments of CMCH.

casualty department provides reports on physical stabbing while the orthopedics department gives reports on broken limbs or other serious

The cases filed under the penal code with police stations and courts require medical certificates for police reports.

"I had to bribe medical staffers Tk 500-2,000 to collect medical certificates to submit my investigation report on time," said an SI of CMP's West Zone, wishing anonymity. Several other police officers of different zones of CMP echoed him.

In 2022, the CMCH authorities launched a probe into allegations of bribery against an assistant registrar of the casualty department. He allegedly used to take bribes from IOs on the basis of the case's merit.

"It is a critical issue. We are working together to resolve the assault, serious injuries or matter," said Nishkriti Chakma, deputy commissioner (crime and operations) at CMP Headquarters.

Constructing market by filling up two ponds

Habiganj mayor's move draws flak

Habiganj Municipality Mayor Ataur Rahman has announced to construct a multi-storey market in the town by filling up two ponds.

He said this in the latest municipal budget announcement for FY 2024-25 unveiled at a press conference on July 8.

The announcement has drawn flaks from different quarters, including town dwellers and environmentalists, as it comes

at a time when numerous areas in the town are facing a scarcity of freshwater alongside waterlogging problems.

Also, filling up of any waterbody is prohibited in the Water Conservation Act, 2000.

The two ponds, one being 60 in Tinkona area of the town in front of the Water Development Board's Habiganj district office.

Protesting the mayor's announcement, residents have organised various programmes.

Confirming the matter, SM Farhad, member secretary of Sacheton Nagorik Committee in Habiganj, said a memorandum has also been submitted to the deputy commissioner of the district for steps to prevent filling up the ponds for constructing market.

Shah Shaheda Akhter, coordinator of BELA in Sylhet, said they also sent a letter to the officials concerned on April 15.

Two die after falling sick in septic tank

Two people died and another was injured after falling sick inside a septic tank at

Daulatpur upazila of Kushtia yesterday. The deceased were identified as Liton Hossain, 30, a cleaner, and Rajon Hossain, 30, a neighbour who went to rescue Liton, said Mahabubur Rahman, officer-in-

charge of Daulatpur Police Station. The injured is Rajon's younger brother, Mizan Hossain, 18.

The incident occurred at the residence of Mosharraf Hossen of Bagowan village in Mathurapur union around 8:00am.

Locals and fire service members took them to Daulatpur Upazila Health Complex, where doctors declared Liton and Rajon dead.

"In the morning, Liton, who was working in the septic tank next to our house, started having difficulty breathing. My brother went to rescue him. Later, my brother also started having breathing difficulties. Then, I got injured while trying to rescue my brother. Later, we were rescued and taken to the hospital," said Mizan.

Police recovered the bodies and sent those to Kushtia Sadar Hospital for autopsy, added the OC.
