Krejcikova wins Wimbledon title

Barbora Krejcikova of the Czech Republic defeated Italy's Jasmine Paolini to win the Wimbledon women's title on Saturday for her second Grand Slam singles triumph. Krejcikova, the 31st seed, won 6-2, 2-6,

6-4 to add the 2024 All England Club crown to her 2021 French Open victory. Her win comes 26 years after her

mentor Jana Novotna, who died in 2017, claimed the Wimbledon title.

The result meant seventh-seeded Paolini had lost two Grand Slam finals back-to-back after coming off second best to Iga Swiatek at the French Open last month.

Krejcikova set the tone immediately by breaking the Italian in the opening game and backing up the advantage with

Summit's floating LNG terminal back in Bay after repairs

Summit's floating LNG terminal returned to the Bay of Bengal near Moheshkhali after repairs from the damages done by Cyclone Remal in May.

On May 27, a floating platoon hit the FSRU, causing damage to a ballast tank. After that, the supply of LNG to the national grid through that terminal was stopped.

In the absence of the floating storage and regasification unit (FSRU), LNG supply to the national grid dropped to half, resulting in patchy gas supply in various districts including Dhaka and

The supply of LNG to the national grid will return to normal from July 18, said Muhammad Nasir Uddin, deputy general manager of Rupantarita Prakritik Gas Company (RPGCL).

Meanwhile, one of the two LNG supply pipelines that was shut down on Tuesday

has resumed operations from Friday.

The RPGCL authorities shut down the pipeline after it started leaking. The leak was caused during soil testing for the construction of a jetty in the Chinese Economic Zone at the Anwara edge of

After three consecutive days of repair work, the supply of LNG through the 42inch diameter pipeline started again.

The stakeholders hope that the ongoing gas crisis in various districts including Dhaka and Chattogram will be alleviated to some extent from now on.

Finding hope in hair!

Dinajpur's hair-processing industry transforming lives of thousands

Farsia Ara was distraught when her van-puller husband, the sole earner of her family, left her and their three daughters two years ago.

Belonging to an ultra-poor family in Dinajpur's Nawabganj, she was struggling to support her children. Unexpectedly however, she found hope in hair!

joined the district's burgeoning loose hair processing industry as a detangler. Initially, she earned Tk 60 a day to smoothen out hair. But two years of her perseverance paid off and now she earns Tk 100 a day, making her Tk 3,000 a month.

Farsia finally found stability and married off her two elder daughters. Her youngest now works with her in the same hair processing factory, bringing their combined monthly income to around Tk 6,000 a month.

"This job has become a lifeline for my family. As I work from 7:00am to 1:00pm, I can also give time to them while maintaining my professional responsibilities ... We also get festival bonuses!"

Farsia's story is just one of many.

Often overlooked, the hair processing and wig manufacturing industry is making significant strides in improving the lives of the poor.

Across Dinajpur, especially in Nawabganj and Chirirbandar upazilas, thousands of women from ultra-poor families have found



employment in hair processing. Groups of 10 to 12 women work together in homes, sorting, cleaning, and preparing the hair.

Some of the women have been supporting their families for over a

decade through this work.

'Let others compete for nomination'

Two dozen former Democratic lawmakers ask Biden after gaffes

dozen former congressional Democrats published an open letter on Friday urging President Joe Biden to allow other candidates to compete for the party's presidential nomination ahead of November's US election.

The move is another blow for the 81-year-old Biden as he seeks to reassure voters that he is fit for office after his tumultuous debate performance in late June against Republican rival Donald Trump.

In the letter, the 24 signatories said Biden would "best serve the nation he loves" by releasing delegates who are pledged to vote for him at the Democratic National Convention -- which is otherwise set to cement his role as the party's official nominee -- and instead allow others to compete to lead the ticket.

"We are confident that one or more capable Democratic candidates would step forward. Excitement and optimism would ensue," read the letter addressed to the "American people" and reported by Politico.

In multiple public appearances this week, Biden has emphasized that he plans to stay in the race and become the Democratic nominee.

ASSEMBLY BYPOLLS INDIA bloc wins 10 out of 13 seats

The opposition INDIA bloc won 10 assembly seats, while the BJP clinched two and an Independent one, as votes were counted yesterday for the byelections held earlier this week on 13 seats in seven states.

In Punjab, Mohinder Bhagat of the ruling Aam Aadmi Party (AAP) won the Jalandhar West seat. In Tamil Nadu, the ruling Dravida Munnetra Anniyur Siva emerged victorious in the Vikravandi Assembly constituency.

On the four seats in West Bengal, Trinamool Congress (TMC) candidate Krishna Kalyani defeated BJP's Manas Kumar Ghosh in Raiganj, Mukut Nami Adhikari defeated BJP's Manoj Kumar Biswas in Ranaghat Dakshin, Madhuparna Thakur defeated BJP's Binay Kumar Biswas in Bagda, and Supti Pandey defeated

MARRIAGE CASE

Imran Khan to remain in jail despite acquittal

Former prime minister Imran Khan and his third wife were acquitted on charges of marrying unlawfully by a Pakistan court yesterday, but he will not be freed as authorities issued fresh orders to arrest

The ruling came a day after his Pakistan Tehreek-e-Insaf (PTI) party won more seats in

parliament, ramping up pressure on the country's fragile ruling coalition which is grappling to stabilise a broken

The couple were sentenced to seven years in February when a court found them guilty of breaking Islamic law by failing to observe the required interval between the divorce from a previous marriage of Bushra Khan, also known as Bushra Bibi, and her marriage to Khan.

They had filed an appeal against their convictions. "Both the appellants are acquitted of the charges," said an order by the appeal court seen by Reuters. "They are directed to be released forthwith if not required to be

detained in any other case." It said the prosecution failed to prove its case against

the couple. Khan's PTI party said authorities have issued fresh arrest warrants for him in three cases linked to violence SEE PAGE 6 COL 3

Euro, Copa finals promise pure thrills

Leave 10km inside border line to BGB HC suggests govt

The High Court in its full judgement in a smuggling has made suggestions for parliament, including declaring 10-kilometre land from the border line as the property of Border Guard Bangladesh.

The HC bench of Justice Md Ashraful Kamal gave the suggestion to ensure border security properly, bring down cross-border crimes to zero and to prevent revenue dodging.

In the verdict delivered on August 3 last year, the HC acquitted accused Zakir Hossain of smuggling charges and scrapped the three-year jail sentence handed to him by the trial court concerned.

The case was filed by BGB (formerly Bangladesh Rifles) following recovery of Indian sharis at the Jashore border during an anti-smuggling operation in 1987.
