Beginning his television journey with The *Life of Jalil* in 2019, he went on to elevate the industry with hits like the *Punorjonmo* series, Chirokal Aaj, Kaykobad, and Irina, among many others. His directorial OTT projects Redrum, The Silence, and Ami Ki Tumi -- are some of the remarkable ventures in his career. This Eid-ul-Azha, two of his directorial smallscreen projects were released-Tithidor and Hajot. Tomorrow, his short film Ekti Khola *Janala* will be released on Binge. The director dropped by The Daily Star to share insights on his way of direction, and spilled the beans on his future projects.

"If I am asked about my direction philosophy, I'll say that I have always remained honest with myself," shared the director. "During the initial stage of my career, many suggested that I should make popular genres such as comedy, however, I have always wanted to make gothic, dark, and psychological works, for which I had to wait. My never-compromising nature brought me where I am today."

## The poor priced out of fresh veggies

Farmgate, and Karwan Bazar kitchen markets echoed the same.

This has left the poor and the lowincome group to make do with the lowquality, stale vegetables.

vegetables Low-quality often exhibit signs of spoilage such as wilting, discolouration and a lack of flavour, making them less desirable for consumption. Thanks to the sudden spike in

demand for stale vegetables, even their prices have increased by Tk 10-15 a kg in the capital's kitchen markets.

"How will we survive if stale vegetables become dear?" said Ramii Ali, a rickshaw driver who buys lowquality vegetables from the Farmgate kitchen market.

Food inflation stood at 10.42 percent

in June, the third straight witness double-digit figures.

If the prices rise the way they have, Ramii might have to cut out vegetables from his diet, "Vegetables were the last option we had," he said.

Bablu Miah, who sells low-quality vegetables near the Ibrahimpur kitchen market, acknowledged that the prices have surged by Tk 10-15 a kg within one

He sells brinjal at Tk 80-100 per kg, whereas the fresh ones are selling at Tk 00-140 per kg. The long beans at his stall cost Tk

80-100 per kg; the fresh ones are selling for Tk 100-120 in the kitchen markets.

Bablu is selling stale spiny bitter gourd for Tk 80-90 per kg, whereas the highquality ones cost Tk 100-120 per kg.

He is charging Tk 70-80 a kg for the low-quality sponge gourd at his stall,

The vegetable wholesalers though maintain they have no other option but to give in to the law of demand and

"We used to bring vegetables from Manikganj but due to the continuous rains, all vegetable fields are submerged," said Mohammad Yeasin, a vegetable wholesaler at Karwan Bazar.

So the prices have gone up, he added. Nowhere was this more evident than in the case of green chilli, whose price have surged by as much as Tk 100 a kg in a week. Green chillies are now selling for Tk 240-320 per kg.

"We only received 20 kg of green chillies from Rangpur three days ago - we are now mostly dependent on imported green chillies," said Selim Hasan, a green chilli trader at Karwan Bazar.

But he had no answers in the Centre Court sunshine as the electric Alcaraz pounded him from the back of the court and treated the crowd to an array of his trademark drop shots.

Alcaraz seized the initiative in a first game of breathtaking quality lasting 14 minutes, taking advantage of his fifth break point.

The Spaniard settled quickly into his routine on serve and went up a double break when Djokovic doublefaulted in the fifth game.

The shellshocked Serbian, playing in his 10th Wimbledon final, held serve to love to close the gap to 5-2 but dumped the ball into the net to hand the Spaniard the first set.

Alcaraz was immediately on the front foot in the second set, forcing a break in the first game and fending off pressure on his own serve to take a 2-0 lead.

A Djokovic backhand into the net in the seventh game handed Alcaraz another break point and a double fault put the defending champion 5-2 up and on the cusp of a two-set lead.

The Centre Court crowd, including Catherine, Princess of Wales, looked on in disbelief as their hopes for a titanic tussle evaporated.

Djokovic fended off another of clutch of break points early in the third set to stay alive and showed signs that he was finding his range.

But the Spaniard carved out three break points in the ninth game, arrowing a passing shot past his stranded opponent to move 5-4 Alcaraz stepped up to serve for

the championship but squandered three match points, missing a straightforward drive volley as Djokovic broke for the first time in the match.

But he recovered his composure quickly as the set went to a tie-break. Djokovic went wide with a forehand to give Alcaraz a 5-3 lead and the Spaniard won the title with

his fourth championship point. The result means Djokovic has still not beaten a top-ten player this year and has yet to win a title.

The Serbian will now turn his attention to the Paris Olympics as he seeks to win gold for the first time.

### Frauds, criminals get govt jobs due to question leaks

Syed Abed Ali, who was arrested on July 8, mentioned the names of many others involved in the question-leak syndicate.

The HC bench said Abed Ali is not as powerful as those like (former IGP) Benazir Ahmed. "But those who are behind the leaks and sale of question papers are powerful.

"Does the investigating agency have the power to arrest them? If there is no power of arrest, then the order shall be made accordingly.'

DAG Shaifuzzaman said that around five lakh candidates participate in public examinations every year.

three months from the date of receipt of this order.

The court, however, said the government can change, reduce or increase the ratio or percentage of the quotas in public jobs, if necessary, and can fill the vacant posts from the general merit list if any quota in government recruitment is not fulfilled.

"We noticed that several writ petitions were filed to maintain the quota reserved for freedom fighters, by different freedom fighters and their children, and in all writ petitions, this hon'ble court clearly held that the 30 percent quota reserved for freedom fighters and their children should strictly be maintained.

.. Since the Appellate Division has already settled the matter and affirmed the judgment and order of the High Court Division with the modification as quoted above, the same is binding upon us as well as all authorities of the state machinery as per articles 111 and 112 of our constitution and violation of the same is contemptuous," said the HC bench of Justice KM Kamrul Kader and Justice Khizir Hayat in the 27-page verdict.

On June 5 this year, the bench declared illegal the circular, issued by the public administration ministry on October 4, 2018, which cancelled the quota system in government jobs, as it was issued without lawful authority.

The court delivered the verdict after a writ petition was filed by Ohidul

Thus, we are of the view that during the period of August 15, 1975, to 1996, the freedom fighters, their children and grandchildren have been suffering socially, economically and politically, which makes them one of the nost backward sections of the citizen of this country," the HC judges observed. They further said the respondents

(the government) may take necessary steps by making rules or guidelines to ensure participation of backward sections of the citizen in the recruitment process of the government.
