# New system applicable for all grades

Following SC order, govt circular says 93pc jobs to be given on merit

In a major reform to the quota system in public jobs, the government yesterday issued a circular, taking merit-based recruitment in civil service to 93 percent from the existing 44 percent. The rest seven percent will come from various quotas.

The new quota system, which came in line with Sunday's Supreme Court order, will come into effect immediately and will be applicable to all grades of the government, semi-government, autonomous, semi-autonomous, statutory bodies and corporations in case of direct recruitment through exams, according to the circular.

There are 20 grades in government jobs. Direct appointments are usually done in 9th-20th grade. However, such direct appointments are also done in case of a handful of posts in some top grades like 5th, 6th, 7th and 8th grades, according to public administration ministry officials. As per the circular, there will be five percent quota for the children

of freedom fighters, martyred freedom fighters and Biranganas. One percent quota has been reserved for ethnic minorities and another one percent for persons with disability and people of third gender.

If enough candidates are not available from the quotas, the vacant posts will be filled up from the merit list.

"We have implemented the apex court's verdict as is... It was mainly a movement to reform the quota and we have done it. The students should now return to their classrooms," Law Minister Anisul Huq told a press briefing, announcing the circular.

Four key organisers of the quota reform protest

rejected the circular, saying there should have been a discussion with the stakeholders before issuing the circular.

"Our movement will continue until justice is done about those killed and injured," said Nahid Islam, one of the organisers, about two hours after the law minister's announcement.

The circular came in the wake of an unprecedented violence centring on student protests for quota reforms.

According to The Daily Star's count, at least 150 people have been killed and several thousand wounded in clashes with law enforcers, joined in by alleged ruling party activists, since Tuesday.

The overall death toll may rise, as The Daily Star could not reach many hospitals in Dhaka and elsewhere where many critically injured were taken for treatment. Also, many friends and families reportedly took the bodies of their loved-ones from the scene and this newspaper could not contact them. The Daily Star's count of the death toll is based solely on hospital and police sources.

### 4 organisers of quota reform demonstration reject circular

Four key organisers of the quota reform demonstration have said the protests would continue after they rejected yesterday's government circular announcing the new quota allocation in government jobs.

"Before issuing the circular, the authorities should have held a dialogue with students and other stakeholders. We'll not accept the circular as the final resolution," Nahid Islam, a key coordinator, told a press briefing at Dhaka Reporters Unity yesterday.

The statement came two hours after Law Minister Anisul Huq briefed reporters on the circular at his residence around 3:30pm.

As per the government decision, 93 percent of the recruitment at government, semi-government and autonomous bodies will be based on merit.

## Another 1,100 arrested in police raids

At least 133 cases filed over violence centring on quota protests

Over 1,100 more people were arrested in the capital and other districts in the 36 hours till 6:00pm yesterday, as law enforcers continue their crackdown on those suspected to be linked to the recent violence across the country.

So far, at least 133 cases over violence

At least 2,657 people have been arrested in the capital and elsewhere over the last four days.

According to an analysis of 29 of them, 499 named and 74,055 unnamed people have been made accused in the cases lodged with 17 police stations on charges of attacking law enforcers, damaging and

torching state properties.

# 7-hour curfew break in Dhaka, 3 other districts

### Govt offices to stay open from 11am to 3pm

The government has decided to continue the ongoing nationwide curfew until further notice.

The curfew will remain in force in Dhaka, Narsingdi, Narayanganj and Gazipur with a seven-hour break from 10:00am to 5:00pm today and tomorrow.

It also decided to keep all government, semi-government and autonomous offices open from 11:00am to 3:00pm today after the three-day general holiday, according to public administration ministry officials.

In Dinajpur, curfew will be relaxed between 8:00am and 5:00pm, said Shakil Ahmed, deputy commissioner of the district.

In Chattogram, curfew will be relaxed from 9:00am to 6:00pm, said Chattogram DC Abul Bashar Mohammad Fakhruzzaman.

Meanwhile, Chief Justice Obaidul Hassan has instructed that the judicial functions of all the courts across the country, including the Appellate and
