HC rejects Prof Yunus' plea to scrap charge framing

after holding a hearing on the petition.

Speaking to The Daily Star, petitioners' lawyer Abdullah-Al-Mamun said his clients will move an appeal before the Appellate Division of the Supreme Court challenging the HC order.

He said the case was filed against his clients with an ulterior motive even though there was no allegation against them and they were not involved in any wrongdoing mentioned in the case.

The documents placed by the prosecution in the court did not have any prima facie evidence, he added.

ACC lawyer Khurshid Alam Khan told this correspondent that the HC summarily rejected the petition on the ground that the offences of misappropriation of funds and money laundering have been disclosed.

There is no legal bar to running the trial of the case against all the accused by the lower court concerned,

During the hearing on the petition yesterday, counsel Abdullah-Al-Mamun told the HC that his clients did not commit any offence of money laundering or embezzlement or fraudulence in running Grameen Telecom, which was established as a non-profit and charitable organisation under section-28 of the Companies Act, 1994.

All the transactions of the organisation were done properly under the settlement agreement between the company and its workers, he argued.

Mamun said his clients have paid the money to their workers in accordance with law.

He said the case was filed against the petitioners, including Prof Yunus, in order to harass them and the allegations brought against them are completely fabricated and baseless.

The ACC officials submitted the charge sheet of the case without approval from the graft watchdog and therefore, the charge sheet and charge framing order against the petitioners are illegal. That is why the trial proceedings of the case can be scrapped, the lawyer argued.

ACC lawyer Khurshid, Attorney General AM Amin Uddin, Additional Attorney General Sk Md Morshed and Deputy Attorney General AKM Amin Uddin Manik opposed the petition, saying that there are specific allegations against the petitioners.

During the trial of the case, the lower court concerned will examine whether the allegations are true, they argued.

Economy with deep scars limps along

Despite the pressure, most banks were able to provide services by and large, said Selim RF Hussain, chairman of the Association of Bankers Bangladesh.

The moribund stock market nervously resumed trade at 11:00am vesterday, but the key index of Dhaka Stock Exchange sank 1.76 percent, the steepest decline in almost two years.

Retail shops in Dhaka, the main hub of trade, reopened but salespeople were disappointed by the thin presence of customers. Alam Sheikh, a salesman at

clothing store at Nurjahan Supermarket, opposite to Dhaka

College, was one of them. "Customers seems to be afraid of the

risk of violence," he said. Between 10:30am and 1:30pm, Alam Sheikh's sales stood at Tk 3,000, a third of his sales revenue on a regular ousiness day.

All these bleak data point to Bangladesh's plunge into an economic stasis, however short-lived. Save for agricultural activity, trade, manufacturing and all other economic

In the months to come, consumer prices may go further up. New investments will be on hold and jobs will evaporate. Bangladesh also runs the risk of losing export orders and many companies will struggle to pay their employees on time.

"This is a huge loss for Bangladesh when the country is already facing an economic crisis. The latest unrest has a significant impact on the economy," said Ahsan H Mansur, executive director of the Policy Research Institute, sharing his estimate that the country lost around \$1 billion a day over the last few days.

"Supply chain disruptions will fuel inflation, which is already high," he

His grim prediction has a basis as annual inflation rose to 9.73 percent in fiscal 2023-24, the highest in 12 years, overshooting the government's target of containing it to 7.5 percent.

Ahsan Mansur, a former economist at the International Monetary Fund, warned that export orders might be diverted to other countries in the wake of the recent crisis in Bangladesh.

Zahid Hussain, another noted economist, described the crisis as the nation's double jeopardy: a real-life activities were almost suspended for a lockdown and a virtual lockdown.

"Its impact will be more severe than the Covid-19 pandemic, as people could run businesses at the time. During the pandemic, online payments were unhindered. But this week, everything was closed due to internet outage," he said.

The unrest killed at least 154 people, according to The Daily Star's count based solely on hospital sources, although it could be higher as this newspaper could not reach all the hospitals where many critically injured patients were taken for treatment. Also, many friends and families reportedly collected the bodies of their loved-ones from the scenes, and this newspaper could not contact them. Additionally, many hospitals did not even record the deaths, and asked the relatives to take them away.

All these will hit the confidence of foreign buyers and dent the image of the country which registered about 6 percent GDP growth over the last one and a half decades thanks to the political calm, Hussain said.

"The internet blackout was suicidal for the economy. How deep the injury is and how long it will stay remains to be seen," he said. "But we cannot count the loss of lives, which is countless.'

787 more arrested

27 cases were filed in Chattogram, 17 in Rajshahi, nine each in Narayanganj and Savar, eight in Natore and five in Tangail.

According to an analysis of 29 of the cases, 499 named and 74,055 unnamed people have been made accused in the cases lodged with 17 police stations on charges of attacking law enforcers and damaging and torching state properties.

The number of accused was not mentioned in 24 cases, which only stated "many unidentified accused".

Many of the arrestees were on remand and divulging important information about the financing behind the sabotage and those who gave the directives for the violence, said Biplob Kumar Sarker, joint commissioner (operations) of DMP, at a media briefing at the DMP headquarters yesterday.

The miscreants had attacked around 69 police establishments in Dhaka and set several traffic boxes on fire, he said.

DMP in a statement said they incurred a loss of Tk 61 crore due to the violence. The main targets of this attack

were the DMP and Bangladesh Police, according to Sarker.

The participants opined that the situation is satisfactory in all districts except Dhaka, Narayanganj, Gazipur, Narsingdi, and areas under the capital's two city corporations, Narayanganj City Corporation, and Gazipur City Corporation.

In other districts, primary schools may reopen in phases after the authorities evaluate Friday's situation, said the sources.

A minister present at the meeting said, "We want to bring primary school students back to the classrooms because the new activity-based curriculum requires their presence. We are considering opening schools everywhere except those in the four districts. We will decide about secondary schools afterwards."

Amid widespread violence, the government on July 16 announced closure of educational institutions.

The education boards later postponed the Higher Secondary Certificate and equivalent examinations scheduled

for July 18, 21, 23, and 25. After the meeting yesterday, Education Minister Mohibul Hassan Chowdhoury told reporters that the situation was not conducive to reopening universities.

Completing the HSC and equivalent examinations is the priority, he said.

Participants at the meeting talked about the judicial commission formed to probe the killings on 16 July during the quota-reform protests. The government would wait for the commission, led by High Court Judge Khondker Diliruzzaman, to file a report, and then take action.

"The government will bring those responsible for the killings to book, no matter who they are," a minister told The Daily Star, requesting anonymity.

The participants agreed that curfew should be lifted in all places, except the aforesaid districts, unless there is an unless an untoward incident. Duskto-dawn curfew may remain in the four districts.

Even if daytime curfew is lifted, there will be strong surveillance on Dhaka's Shonir Akhra, Demra, Rayerbagh, Mohammadpur, Mirpur-10, Savar and Uttara because these places witnessed fierce clashes which resulted in high number of causalities.
