

## GRAMEEN KALYAN HC verdict on two petitions July 30

The High Court yesterday fixed July 30 for delivering verdicts on two separate writ petitions that challenged the NBR orders over the reassessment of around Tk 600 crore as income tax from Grameen Kalyan for different tax years.

Grameen Kalyan is a non-profitable and charitable organisation founded by Nobel laureate Professor Muhammad Yunus.

Yesterday, the HC bench of Justice Muhammad Khurshid Alam Sarkar and Justice SM Maniruzzaman set July 30 as the date for delivering judgement after concluding the hearing on the matters.

Senior lawyer Sarder Jinnat Ali appeared for Grameen Kalyan while Assistant Attorney General Tahmina Poly argued for the state.

people, who died at point blank shooting or at their own home or rooftop, who were not in the protest be held accountable.

“On the other hand, the judicial commission will only investigate the six death incidents that happened on July 16. So, are the rest of the lives worthless? Should we accept dying by bullets at home and accept it as regular normal events?” TIB executive director added.

He also questioned the recent arrests and charges against the protesters and called upon the government not to turn it into a “festivity” of arrest and harassing people.

Citing media reports, TIB said the students who participated in the peaceful quota reformation protests are constantly under the fear of arrest, abduction, and physical mental torture.

“The responsible ones of the government, including the ministers, have admitted that no student has been involved in any atrocities. Despite this, illegal abduction of the students by the law enforcement agencies is nothing but a total disregard for the constitutional right to civilian protest

and movement,” said Iftekharuzzaman.

The anti-corruption watchdog also called upon the government to immediately stop repressive measures against the students and announce acceptance of all the students’ legitimate demands.

In addition, TIB called for holding a dialogue with the full group of coordinators of the student movement to develop a mutually agreed road map for enforcement of the government’s commitments.

He also said the shutting down of internet to repress the movement is a suicidal decision. TIB urged the government to immediately resume the internet service of mobile and broadband in full swing to revive trade and commerce and ensure the free flow of information.

The organisation said the arson attacks, which took place at important government establishments, raised questions on the respective government institutions’ capabilities, preparedness, and integrity in safeguarding those establishments.

The TIB called upon the government to take corrective lessons from the prevailing crisis.

patients at DMCH from July 19 to July 21.

Dr Rezwan, who worked with Rhythm Blood Centre at DMCH, said, “Bullet-hit patients experience acute blood loss due to external bleeding and internal hemorrhage. Even to this date, many patients are in need of blood transfusion at DMCH.

Due to excessive need of blood from July 19 to July 21, blood transfusion of previously admitted patients could not be done on time.”

Now, blood transfusion

of regular patients, which have been rescheduled, and those with bullet-injuries, who have recently gone through surgeries, are being done, said officials.

A long queue of blood donors and relatives of patients was seen in front of DMCH’s blood bank and blood transfusion centre in the last couple of days. To tackle the crisis, the hospital authority has opened blood exchange provision for the patients in need of blood.

A notice in front of the blood transfusion centre reads, “To ensure availability of blood for all

patients, according to the directives of the director of DMCH, we would like to inform that from 16/07/24, if you do not find donors that match your patient’s blood group, you can collect blood for your patient from the blood bank by donating a bag of blood of any group.”

A duty doctor at the transfusion centre said, “Thanks to the donors and volunteers, we don’t have a blood crisis anymore. But we are going through an excessive workload. We are working day and night to serve our patients.”

Shahadat, 56, who works at a private company and the sole earning member of his four-member family, was arrested from his Pallabi residence by police early yesterday.

His daughter Fatema said, “My father did not engage in any violent activities. During the clashes across the city, he stayed home. We came to the court in the morning but failed to see him.”

Fatema’s aunt said, “The family has no money or food at home. How will they survive?”

Yesterday, like them, over a hundred relatives of those arrested in the ongoing police raids gathered before the CMM court as the curfew remained relaxed between 10:00am and 5:00pm.

## BOAT CAPSIZE

# Death toll reaches 3 with recovery of two bodies

Police recovered the bodies of two more people, who went missing after a boat sank in the Dhaleshwari river, in Kushunda under Ghior upazila of Manikganj yesterday, taking the death toll to three.

The deceased were identified as Rafiqul Islam, 35, son of Danej Ali; and Russel, 14, son of Selim of Satoria upazila.

Sukumar Biswas, officer-in-charge of Ghior Police Station, said locals spotted the bodies in Char Kushunda area of the river, one kilometre off the spot where the boat sank, around 1:00pm and informed police.

Police recovered the bodies and sent those to the local hospital morgue for autopsy.

Earlier, on Tuesday, some 50-60 people of Satoria upazila went on a boat journey in the Dhaleshwari River.

At 12:00pm, the vessel sank in the river after being hit by a bulkhead while it was returning to their home.

Five people were injured while two remained missing after the boat capsized. The others managed to swim ashore.

Among the injured, one was declared dead when taken to hospital. Police also seized the bulkhead.

## Vehicles stranded as ferry terminal in Bhola inundated

The ferry services at Bhola’s Ilisha Ghat, a ferry terminal, have been hampered for the last three days as both of its pontoons and a gangway were submerged by tidal surge caused by a prevailing depression in the Bay of Bengal, affecting transport workers, truckers, and passengers.

Hundreds of vehicles cross the river on five ferries on the Bhola-Laxmipur river route every day.

There are two separate platforms at Ilisha Ghat on the Bhola-Laxmipur route. One is a low-water ghat and the other is a high-water ghat.

Transport workers said the ghat area got submerged due to tidal surge triggered by the low over the Bay of Bengal. As a result, they have to suffer a lot to cross the river, and sometimes it can take three to four hours to board the ferry.

A number of vehicles remained stranded on both sides of the river in Bhola and Laxmipur, waiting to cross the river for the past three days.


