No decision on reopening edu institutes

Says minister; teachers to continue movement over pension scheme

Education Minister Mohibul Hassan Chowdhoury yesterday said the current situation conducive to reopening educational institutions. He said this during a meeting with university teachers at the education ministry regarding pension issues, reports UNB.

When asked if there had been any discussion in the cabinet vesterday about reopening primary schools, he said, "I will not comment on this now. Discussions that take place in the cabinet are not meant to be discussed outside.'

Meanwhile, Nizamul Hoque Bhuiyan, secretary general of Federation of Bangladesh University Teachers Association correspondent, "In the meeting, the participants came to an in-principle decision that teachers would be excluded from the Prottoy scheme.'

The summary of the discussion would be sent to the higher authorities, to make further decisions, he added.

"Until we see a final notification, our movement will continue."

Prof Abdur Rahim, joint secretary general of the FBUTA, said, "We had a positive discussion with almost all stakeholders concerning our demands. The respective authorities did not deny the rationality of our demands.'

Chief of the standing committee of education ministry, Nurul Islam Nahid, along with the finance ministry secretary pension scheme authorities, also attended the meeting.

Over 126 students arrested in a week

On Sunday, Rezaul Karim Kusum Chowdhury was waiting at Chattogram's 6th Metropolitan Magistrate Court for a bail petition hearing for his nephew Talha Mahmood Chowdhury, who was arrested in a violence case over the quota reform protests.

Talha, a final-year student at East Delta University, was arrested from the Agrabad area in the port city on July 17 and was handed over to Khulshi Police Station on July 18, where he was shown arrested.

However, the court rejected his bail petition.

On the court premises, Rezaul, a freedom fighter, told The Daily Star, "Police picked Talha up without verifying his identity and sent him to court. We told them that he is not involved with any political parties or violence but they did not pay heed."

"We filed two petitions for his bail but the court rejected them. Talha has already been taken for remand," he said.

Many other students and their guardians were also seen on the court premises.

126 students from Over different educational institutions, including Chittagong University, were arrested in the past week till GRO sections and prison sources.

Police officials said they are arresting the anarchists who were directly involved with the subversive activities.

Chattogram Metropolitan Police has arrested 532 people, including leaders and activists of BNP and Jamaat, in connection with 20 cases filed over violence and subversive activities.

Ramjan Sheikh, a first-year CU student, was arrested on July 18 in a murder case filed by police with Panchlaish Police Station.

At the court premises, his father Mostafa Sheikh, a mason by profession, said his son is innocent and not involved with any kind of politics.

"We could not trace him until police sent him to the court on July 20," he added.

In front of the court's lockup, Ramjan said, "I took part in the protests in Muradpur on July 16. On July 18, a group of BCL men came to my house in Forest Research Institute area and took me to Parkview Hospital, where injured BCL men are undergoing treatment. Later, I was handed over to police.'

"A local BCL man named Arif took me from my house," he added. However, The Daily Star could

Sunday, according to the court's not verify Ramjan's information independently.

Meanwhile, Lutfur Rahman, a student of Finance and Banking at CU, was arrested from his residence on July 17, said Prof Hasmat Ali of the department.

"On information, six teachers, including me, went to Panchlaish Police Station. Police showed him arrested in a violence case. The duty officer told us they found some photos and videos related to the protests on his cell phone," said Prof Hasmat.

Contacted, Rahman, deputy commissioner of CMP's North Zone, said, After looking at videos and CCTV footage, we are arresting those involved in clashes on July 16 and

Meanwhile, a BCL man filed another case accusing 50 persons and 30 to 35 unnamed persons with Panchlaish Police Station.

With this, a total of 20 cases have been filed in the port city, accusing over 200 named and 30,000 unnamed people.

Arif Hossen, AC of Panchlaish Zone, said, "Seven cases were lodged with Panchlaish Police Station, five of which were lodged by BCL men and their family members, while two were lodged

'My conscience brought me here today'

Says Sohel Taj after failing to meet six quota leaders

Former state minister home Tanjim Ahmad Sohel not was



allowed to meet the six coordinators of the quota reform protests when he went to visit them in the DB custody yesterday.

He visited the DB office in the capital's Minto Road around 5:00pm and stayed there for around one and a half hours.

Talking to the media afterwards, he said he asked DB chief Harun Or Rashid why these coordinators were brought here, whether they were arrested, and when they would be released.

However, Harun did not give a satisfactory answer, he said.

Sohel Taj said he had three questions for the DB

chief.
"My first question was: are they arrested or taken into safe custody? The second question was: if they have been arrested, I have nothing to say. But if they have been taken into safe custody, I want to meet them," he said.

And his third question was: when will they be released from safe custody?

The DB chief replied that they will be released once he gets order from the high-ups.

Explaining his reason for coming to the DB office, Sohel Taj said there was unrest in the country centring the quota protests. Over a hundred people, including children, students and general people, have been killed, he said.

"My conscience brought me here.'

Tying Faiyaz with ropes was a mistake

Govt tells HC

The government yesterday told the High Court that taking Dhaka College student Hasnatul Islam Faiyaz on remand and tying him with ropes was a mistake and that it will take steps so that such mistakes are not repeated.

His (Faiyaz) remand has already been cancelled and he was sent to the Child Development Centre, Additional Attorney General SM Munir told the HC bench of Justice Muhammad Khurshid Alam Sarkar and Justice SM Maniruzzaman during the hearing of a writ petition.

Supreme Court lawyer Shahdeen Malik filed the petition with the HC on Sunday, challenging the legality of taking a 17-year-old boy on a sevenday remand in a case lodged with Jatrabari Police Station on charges of "clashes and vandalism".

Faiyaz was picked up from his Jatrabari home on Wednesday night in connection with a case filed over recent violence.

Yesterday, the HC bench rejected the petition, considering that it was not presented before it as the matter has become infructuous (ineffective) after Faiyaz's remand has been cancelled.

Shahdeen Malik and Md Monjur Alam moved the petition while Additional Attorney General and Acting Attorney General SM Munir and Additional Attorney General Sk Md Morshed, who represented the state, opposed it.

On July 27, Faiyaz was produced before the Chief Metropolitan Magistrate Court of Dhaka, and the court placed him on a seven-day remand as the investigating officer of the case had sought. Though the accused claimed that he is a child,

the court granted the remand prayer as he failed to produce proof of his age.

On Sunday, accused Faiyaz submitted the relevant documents (SSC and birth certificates) in support of his age before the CMM court.

The court suspended his remand and sent Faiyaz to the Children's Court for hearing and passing order determining his age.

540 dorm rooms, 25 offices of 9 univs damaged: UGC

At least 540 rooms and 25 offices of the dormitories of nine public universities were either vandalised or damaged during the recent spell of unrest that ensued during the quota reform protests.

University Grants Commission's statistics show that universities will need at least Tk 28.80 crore to repair the

UGC officials compiled the data until Sunday, collecting information from the public universities which also shows that the vice chancellor's office and residence at Rangpur's Begum Rokeya University and VC's residence at Jahangirnagar University were vanadalised.

Dhaka University VC Prof ASM Maksud Kamal said around 300 rooms of different halls were vandalised. The university authorities will repair the halls after

getting financial allocation from UGC, he added. "We complied the data as these damaged rooms and

offices will need to be repaired. We will send a proposal to the government so that universities get funds for repair work," said UGC Secretary Ferdous Zaman. According to UGC, 300 rooms from 13 halls in DU were

vandalised, some were even set on fire. The university faced damages amounting to Tk 4.93 crore. Similarly, offices in 10 halls of Rajshahi University were vandalised, with the university suffering damages

totalling Tk 4.04 crore. A total of 226 rooms across 10 halls of Jahangirnagar University were vandalised. The university has suffered

damages amounting to Tk 1.5 crore. Meanwhile, Rangpur University suffered damages worth Tk 3.19 crore.

Bagerhat grapples with dilapidated roads

A significant portion of the Bagerhat municipality's 78.30-kilometre road network is in a dilapidated state and making transportation an ordeal for its 1.5 lakh residents.

Lack of repairs and maintenance for over a decade led to the present situation, affecting peoples' daily business commute and activities, said locals.

Visiting different areas across Bagerhat town, this correspondent found that most of the major thoroughfares, including the ones connecting between Noor Mosque and LGED Intersection, Rahat Intersection and Chanmari Bridge, as well as the road leading to Government Women's College, are in a

deplorable condition. Even the road along the central bus terminal, and those in residential areas has begun, while plans are on to initiate like Kharadwar, Basabat, and Sahapara, are barely passable.

"We have to ply the roads through numerous potholes daily, amid

discomfort to both passengers and ourselves, while bearing risk of frequent accidents," said Ajit Das, an easy-bike driver. Zakir Sheikh, a local businessman,

said, "Commuting daily through these dilapidated roads to workplace is a challenging task, even for pedestrians." Badol Das, a bus driver, said their

vehicles often sustain damages due to the poor condition of the roads, especially the one connecting the central

bus terminal. Residents, commuters, and transport workers urged the authorities concerned to repair and renovate roads urgently to mitigate their

sufferings. Contacted, Mohammad Khaled Hossain, deputy Bagerhat, commissioner of acknowledged the issue.

"Work to repair 11 roads in the town work on 11 more roads. Hopefully the situation will improve once the renovation works are completed," he
