Buddhadeb Bhattacharjee no more AGENCIES

Buddhadeb Bhattacharjee, veteran Left leader and former West Bengal chief minister, died at his south Kolkata residence this

morning. He was 80. He had been unwell for a while and had been suffering from respiratory problems that led to his frequent hospitalisation in recent years.

Last year, he had to be put on life support after he contracted pneumonia. But the veteran CPM leader made a comeback.

He is survived by his wife Meera and son Suchetan.

Bhattacharjee, also a former member of the CPM's top decisionmaking body, Politburo, served as Bengal chief minister from 2000 to succeeding Jyoti 2011. Basu in the top post. Bhattacharjee led the CPM into the 2011 state polls when the Mamata Banerjee-led Trinamool Congress posted a historic win, ending the 34-year Communist rule in the eastern state.

For years, the winner of the 2006 Nobel Peace Prize was subject to bitter criticism from Hasina and the Awami League. Hasina said Prof Yunus was behind the cancellation of World Bank funding for the Padma Bridge.

He was stalked by lawsuits that many said were aimed at harassing him. A labour court sentenced him and three other top officials of Grameen Telecom to six months in prison in a case filed over labour law violations. On Wednesday, a Dhaka

advisers. This is the first time in Bangladesh that university students are in the advisory council. At just 26, Nahid and Asif are the youngest people ever to have the status of a minister.

In 1996, another interim

government was formed under Justice Muhammad Habibur Rahman. The government interim system was included in the constitution in the face of a movement led by the Awami League.

Justice Latifur Rahman was the head of the 2001 caretaker government.

The then president, Iajuddin Ahmed, also chief served as the adviser to the caretaker government from October 2006 to January 2007.

Former central bank governor Fakhruddin took charge as the head of the caretaker government on January 12, 2007.

In 2011, the Hasina-led government abolished the caretaker government system.

Prof Asif Nazrul on August 6 said, "We are going to form the government in an extraordinary situation. There are different constitutional means and customs to legalise certain actions. We will do that."

Supreme Court lawyer Shahdeen Malik said it might not be possible to fully abide by the constitution in the context of such an extraordinary political upheaval.

The general elections held under Shahabuddin, Habibur, Lutfor and Fakhruddin were comparatively acceptable to the people.

Just after being sworn in, Prof Yunus visited the Medical College Dhaka Hospital to visit those injured in the anti government clashes.

'Interim govt will play vital role in establishing peace, stability' **Hopes US State Dept**

Washington thinks the interim government headed by Nobel Laureate Muhammad Yunus will play a vital role in establishing long-term peace and political stability in Bangladesh, said Matthew Miller, the US State Department spokesman.

"And as you heard the secretary say yesterday, any decision that the interim government makes should respect democratic principles, rule of law and the will of the Bangladeshi people," he said at a press briefing yesterday.

The US will continue to monitor developments in Bangladesh, he said.

"I have already spoken to the interim government in Bangladesh and what steps we want to see it carry out as it moves forward."

The interim government took oath last evening, three days after the fall of the Sheikh Hasina government following a mass movement calling for her resignation. Meanwhile, some media reported that

Hasina's US visa has been revoked. Asked about this, Miller said visa records are confidential under US law, so

he cannot comment on that in any way. When informed that Hasina's son Sajeeb Wazed Joy, a US resident, was instrumental in the shut down of internet in Bangladesh during the recent students' protest, Miller said he does not have any comment on statements made by a private citizen.

Speaking to The Daily Star last night, Barrister Sara Hossain said, "My main expectation from this government is that it will enable substantial reforms to institutions in Bangladesh and clear the path for truth-telling about what has happened not only in the immediate past or the past few weeks but even over the last 14 years and before that. The students' anti-discrimination movement was for reforms and against repression and these should be the interim government's main themes.

"What I perhaps am a bit troubled by is that, unlike previous years, there is no balance of political background and police. We obviously have no representation from Awami League. This absence of balance could cause a problem."

Bangladesh has a secular constitution, history and tradition, which has not denied any faith but encouraged pluralism, "But the swearing-in today did not reflect that and I hope that is not a sign of things to come."

The inclusion of students is of course unprecedented, she said, adding, "But I think it can only add energy to the whole process ... I believe they can be a part of keeping the interim government in the right direction and keep it within the demands of the students and general people. We need to remember that even post-Liberation in 1971, we had many young leaders."

Sara Hossain observed, "We are a secular country of diverse religions, beliefs, ethnicities, genders and sexualities but we have seen some parties such as Hefazat-e-Islam who

whether they have the skills for that remains a question. I think including the students [leaders of the anti-discrimination student movement] in the government brings hope."

Asked whether minority and women representation were enough, she said, "I believe those could be higher. Many other women and actors from religious minority backgrounds are skilled and have been supporting the movement, they too could have been included. More people from these segments of society could have ensured a higher possibility of a 'discrimination-free' country."

She added that since the Jamaat-e-Islami was banned, the Hefazat Nayeb-e-Ameer may have been included to balance out participation from all religious backgrounds. "We are in an

extraordinary situation and of course, we cannot expect everything to be perfect already, it will all take time.

"However, at this moment, the first thing the interim government must look after is the safety of all citizens, justice, the economy, and restoring law and order."

Samina Luthfa added, "Institutions that valued justice, law, and culture all destroyed were and politicised in the previous [Hasina] regime. Meanwhile, university administrations, which are of utmost importance for the growth of the newer generations, were also negatively influenced. All of these need rational and

logical reforms." On the other hand, she believes social inequality, and lack of justice must be addressed, regardless of

race, religion or merit.
