## JCD men attack principal

attempted to leave the college for lunch, JCD members allegedly assaulted them.  
Later, at 1:00pm, Rajshahi city BNP senior joint convener Nazmul Huda, along with Limon and other party leaders, entered the principal's office and pressured her to resign.  
This correspondent was present in the principal's

room from 12:45pm to 1:45pm.  
Despite initially resisting, Prof Amina ultimately signed the resignation paper at 1:30pm after JCD men allegedly ousted her husband from the office and attempted to pick up her son.  
Prof Amina said she became the principal based on her own merit and felt she had no choice but to resign to protect her family.

"I did not have any other way but to resign as the BNP and Chhatra Dal men attempted to beat my husband and son," she said.  
When contacted, BNP leader Nazmul Huda claimed he went to the campus as a "non-political person" to resolve the issue and ensure Prof Amina's safety.  
JCD leader Emdadul Haque did not respond to repeated phone calls from this correspondent.

"Some were forced to sign blank papers claiming that no one was missing, only that they had gone on a trip."  
The families also shared their stories of uncertainty and despair, how children born after their fathers were taken have never known if their fathers are alive.  
"Many women don't know whether they are widows or if their husbands are still alive," Tuli said.  
Another woman spoke of the fleeting hope they felt when reports emerged about the return of some missing persons after the government's fall on August 5.  
She said, "Relatives were anxiously calling for information. I can't even describe what we're going through."  
The family members demanded interrogation of the recently dismissed Lt Gen Ziaul Ahsan.  
The families demanded a probe into the recently dismissed Ziaul Ahsan, who was arrested on August 7. Ziaul, who has been linked to many controversies, was director general of National Telecommunication Monitoring Center since 2022 and held significant positions in Rab starting in 2009.  
Prof Yunus asked the families if they felt safer under the new government. One family member responded that they remain

in mental trauma.  
The meeting, which lasted about 25 minutes, was attended by seven to eight family members.  
Adilur Rahman Khan, adviser to the Ministry of Industry; IGRD Adviser Hasan Arif; and Fisheries and Livestock Adviser Farida Akhtar, among others, were present.  
In the afternoon, around 25 family members of victims of enforced disappearances, along with others, demonstrated in front of the Jamuna, to demand the return of their loved ones. They alleged that their family members were being held at "Aynaghar" (House of Mirrors), a detention facility where victims of enforced disappearances were kept during Hasina's regime.  
On August 6, a day after Hasina's fall, members of Mayer Daak gathered in front of the DGI office to know whereabouts of their missing relatives. At least three victims were released.  
The next day, DGI said there were no detainees in their Dhaka facility.

also instructed the unit officials to remain on alert so that no unwanted incidents can take place.  
Rezaul Karim, deputy inspector general (operations) of the PHQ, said, "There is no specific threat or risk centring August 15, but police will remain on high alert to avert any kind of unwanted incidents."  
On August 10, three officers, a junior commissioned officer, and five other army personnel were injured when protesters attacked army patrol teams with sharp weapons at Gopinathpur of Gopalganj Sadar.  
According to a press release sent by the Inter-

Services Public Relations Directorate (ISPR), two patrol teams of the army went to the spot after protesters blocked the Gopalganj-Dhaka highway.  
The teams were attacked with locally made weapons, it said. The protesters also hurled brick chunks at the teams. An army vehicle was set alight and another two were vandalised.  
According to the ISPR, the army patrol team fired four shots to disperse the protesters and bring the situation under control.  
Additional troops have been deployed in the area, it said, adding that the injured army personnel were out of danger and undergoing treatment.

Mayor Khaleque's six-storey residence in ward 22 was seen completely destroyed.  
Shaukat Ali, a KCC employee, said, "The mayor has not returned yet. All the belongings have been looted. Only debris remains."  
Lashkar Tajul Islam, chief executive officer of KCC, acknowledged that city dwellers have been facing significant challenges due to the suspension of KCC services in the absence of the mayor and councillors.  
"We are exploring different ways to keep the councillors' offices operational," he added.
