

KCC services in a shambles

Mayor, councillors on the run

Most of the councillors' offices in the 31 wards of Khulna City Corporation have remained locked following a spree of vandalism and looting after Sheikh Hasina's resignation on August 5.

KCC Mayor Talukdar Abdul Khaleque, along with most ward councillors, have gone into hiding.

The absence of the mayor and councillors has led to a near-complete standstill of city services. Residents are struggling to obtain necessary certificates and documents.

On Monday morning, the office of the ward 9 councillor in Mujgunni was found padlocked. Councillor Md Mahfuzur Rahman Liton has been unavailable since August 5.

Inside the office, a few individuals were seen cleaning up dirt and broken glass, with the office secretary supervising the efforts.

This scene is echoed across the city, with almost all councillors unavailable and most staffers not reporting to work.

"I came to correct my son's birth certificate but couldn't get it done because Councillor Sheikh Shamsuddin Ahmed Prince did not come to the office," said

Abdur Rob, a resident of ward 6.

Imamul Haque Masuk, another resident, shared a similar plight.

He visited both the ward 9 councillor's office and the mayor's office to obtain an inheritance certificate but failed to do so.

"I need to settle this urgently before I leave for Italy next week," he said.

Meanwhile, a few councillors and KCC officials were seen doing their best to restore some sort of normalcy.

They said waste management operations, which have been halted for several days, will resume soon.

At the ward 27 councillor's office, Jamal Hossain, a staffer, was seen overseeing the immunisation programme for newborns, which was being conducted on the ground floor.

"The ward councillor, secretary, and other officials are not coming to the office. It needs to be open for the immunisation programme, so I am here," he said.

A similar situation was observed at the ward 23 councillor's office on Sir Iqbal Road.

An employee said Councillor Imam Hasan Chowdhury is still in the area and is patrolling nightly to ensure residents' safety.

JCD men attack principal, force her to resign

Activists of Jatiyatabadi Chhatra Dal (JCD), a pro-BNP student organisation, allegedly assaulted and forced Rajshahi Government City College Principal Prof Amina Abedin to resign from her post yesterday.

According to witnesses, a group of students met Prof Amina in the morning, requesting her to ban political activities on the college campus.

After she assured them of implementing such a ban, a group of activists, led by the college unit of JCD joint convener Emdadul Haque Limon, entered the campus and began demonstrating, demanding her immediate resignation.

When the principal refused, the group issued a one-hour ultimatum for her to step down.

At 12:30pm, as Prof Amina, accompanied by her husband and son,

Passenger trains resume operations

Local, commuter, and mail trains across the country resumed operations yesterday after suspension of 25 days, said Bangladesh Railway.

Inter-city trains will resume from Thursday. The resumption comes after a turbulent period of agitation and violence across the country in the last few weeks. Freight trains started running from Monday.

Officials at Kamalapur Railway Station said the

Balaka, Dewanganj Commuter, Narayanganj Commuter, Mahua Express, Turag, Karnaphuli, and Titas Commuter trains left from Dhaka in the morning. Similarly, scheduled trains are coming towards Dhaka from different parts of the country.

The decision was taken at a meeting at Rail Bhaban on Sunday, the first working day of the interim government.

On July 16, railway tracks were blocked during protests over quota reformation in government jobs.

Law enforcers on alert for Aug 15

Law enforcers have increased countrywide surveillance ahead of August 15, as no anarchy or subversive activities will be tolerated in the name of holding programmes on that day, according to sources in the police.

Along with the police, members of the armed forces divisions will also remain on the field to ensure security.

"There will be a heavy presence of police so that no one can cause any violence," Home Affairs Adviser Brig Gen (ret'd) M Sakhawat Hussain said yesterday in reply to a query regarding a tense situation prevailing centring the observance of August 15.

Addressing reporters at the Border Guard Bangladesh (BGB)

headquarters, he said, "We will ensure all protection. We have already spoken with the DG [director general] of BGB... There will also be Rapid Action Battalion, alongside the police."

According to sources, grassroots activists and supporters of Awami League plan to pay tribute to Bangabandhu Sheikh Mujibur Rahman on National Mourning Day this Thursday across the country.

Some of the former Chhatra League leaders and a section of the party grassroots have already taken the initiative to pay tribute to Sheikh Mujibur Rahman at the Bangabandhu Memorial Museum on Dhanmondi 32, which was attacked

and set on fire after the fall of the AL government on August 5, sources added.

But no one has sought any permission from Dhaka Metropolitan Police (DMP) yet to hold any programme or rally on August 15, DMP Commissioner Mainul Hasan told The Daily Star yesterday.

Asked about surveillance, he said the police in the capital had started working but were not able to start operations in full fledge yet.

"For this reason, we will be on duty along with the officials of the armed forces to ensure security," added the DMP chief.
