Primary schools reopen after 28 days

Classes at all primary schools across the country resumed vesterday after a 28-day closure due to the quota reform movement, which was followed by widespread violence.

All government primary schools under eight city corporation areas of the country were declared closed for an indefinite period on July 17 amid tension over students' quota reform movement.

After nearly a month of closure, the Ministry of Primary and Mass Education issued an order on Tuesday academic resume activities. The directive instructed all government primary schools under the ministry, primary schools operated by the Children's Welfare Trust, and learning centres run by the Bureau of Non-Formal Education, to take necessary measures to fully resume classroom activities.

CEOs now in charge of cities LGD empowers them with full admin, financial power

The interim government vesterday decided to give chief executive officers full administrative and financial power to run the city corporations where mayors and panel mayors are absent.

In an office order, the Local Government Division said many mayors and panel mayors have been absent due to the existing circumstances. The LGD has tried to communicate with them but to no avail.

The order came into effect yesterday. Due to their absence, works and services at the city corporations remain halted.

The decision was taken for the sake of people's interest and to continue all kinds of services as well as administrative works, said the order, signed by Abu Hena Morshed Zaman, secretary to the LGD.

There are 12 city corporations - Dhaka south, Dhaka north, Khulna, Chattogram, Rajshahi, Rangpur, Barishal, Cumilla, Sylhet, Narayanganj, Gazipur and Mymensingh.

According to the sources, several mayors including Dhaka north and south, Chattogram, Khulna, Barishal, Mymensingh and Cumilla were absent from their offices since the ouster of Awami League government on August 5.

All the absentee mayors were elected with AL support. This is the first time such a decision was taken in the country.
