S Alam, Nassa got Tk 2,544cr waiver in breach of rules

Chattogram-based conglomerate S Alam Group and garment manufacturer Nassa Group were given interest waivers amounting to Tk 2,544 crore bypassing banking rules, in a testament to the outsize influence oligarchs had on the banking sector during the Awami League-led government of the past 15 years.

Founded in 1985 by Saiful Alam, a relative of former AL politician Akhtaruzzaman Chowdhury Babu and former Land Minister Saifuzzaman Chowdhury, S Alam Group has grown into one of the largest conglomerates in Bangladesh. The business giant owns controlling stakes in eight banks.

Nassa Group is led by Nazrul Islam Mazumder, who is the chairman of Exim Bank and the private bank owners' forum Bangladesh Association of Banks since 2008.

As per the central bank rules, banks can waive the partial or whole interest in the case of the death of the borrower or the closure of the project due to natural calamity, pandemic, flood or any other act of

Besides, a Bangladesh Bank notice on April 21, 2022 barred the waiver of interest that had already been transferred to their income segment. But the companies of S Alam Group and Nassa Group that were given the interest waiver facilities were operational; no natural disaster took

And the lenders -- National Bank in the case of S Alam Group and Janata in the case of Nassa Group -- waived the interest by halting the income segment, which was a violation of the banking rules.

On December 22, 2021, the central bank provided NOC through seven letters to National Bank for allowing the interest waiver facility to the loans, taken from the bank's Khatunganj branch in Chattogram SEE PAGE 2 COL 2

Provide info on bank accounts of S Alam, family **NBR** directs banks

The National Board of Revenue (NBR) has asked for bank account details Chattogram-based businessman Mohammed Saiful Alam and his family members to check if they have been paying their taxes properly.

The NBR wrote to 91 banks and financial institutions to this effect on Wednesday, said Ahsan Habib, commissioner of taxes, Tax Zone-15, an NBR field office in Dhaka, yesterday, adding that the move was part of their "routine job".

In the letters, information on the bank accounts and credit cards of S Alam, his brother Mohammed Abdullah Hasan, mother Chemon Ara Begum, and wife Farzana Parveen have been requested.

Additionally, details about any personal or business accounts jointly held in the names of S Alam's sister. daughter, or son have been sought.

STUDENT PROTEST UN team to fly in next week to probe atrocities

The United Nations will send a factfinding team to Bangladesh next week to probe atrocities committed during the student-led protests in July and earlier this month.

UN human rights chief Volker Turk announced the move when he called Chief Adviser (CA) Professor Muhammad Yunus on Wednesday, the press wing of the CA's office said yesterday.

This will be the first UN factfinding mission to Bangladesh since its independence in 1971 to investigate widespread human rights abuses in the country, according to a UN official.

During the phone conversation, Volker Türk said a UN-led investigation would be launched very soon to probe the killing of the protesters during the "Student Revolution" and that a team of UN experts would soon visit the country to set up the investigation.

Yunus thanked him for supporting the students' revolution and championing their rights during the "unprecedented and devastating killing of student protesters".

The 2006 Nobel Peace Prize winner said human rights would be the cornerstone of his administration, and the protection of every citizen is the utmost priority of the interim government.
