AL leader hacked to death in Sylhet

An Awami League leader was hacked to death while he was returning home afte praying at a local mosque in Sylhet's Bishwanath upazila on Wednesday night.

Md Maniruzzaman Lilu, 50, was the vice president of Awami League's Rampasha union unit in the upazila.

He was also a businessman and a resident of Nawdhar village.

Around 8:30pm, Maniruzzaman was returning home alone after offering Esha prayers in the village mosque when a group of assailants swopped on him with sharp weapons, police and locals said.

Hearing his screams, locals rushed to the spot and took him to Sylhet MAG Osmani Medical College Hospital, where the duty doctor declared him dead.

His nephew, Abu Foyez, said, "We do not know whether he had previous enmities, so anyone could have killed

Rama Prasad, officer-in-charge of Bishwanath Police Station, said, "The body was handed over to family after an autopsy. We will take the necessary action after a case is filed."

As a result, S Alam Group ended up repaying the principal amount of Tk 4,928 crore and no interest, according to central bank documents.

Thanks to the huge interest waiver August 31, 2021, as per the meeting to S Alam Group, National Bank, one of the earliest private sector banks in Bangladesh, logged a loss of Tk 3,260 crore for 2022. The lender is yet to recover from this hit, according to National Bank officials informed with the proceedings.

"Às far as I know, S Alam Group do not have any loan in our bank," said Touhidul Alam Khan, managing director of National Bank.

The companies have repaid all their loans and closed the accounts with the bank, said Khan, who joined the lender on January 25 this year from Premier Bank.

Similarly, at the 654th board meeting of Janata Bank in 2021, a Tk 261 crore interest waiver facility was approved for two companies of Nassa Group: Nassa Taipei Spinners and Nassa Spinners.

Janata had acquired the Tk 120 crore loans of the two Nassa companies in 2008 from Southeast Bank and Islami Bank.

The state-owned bank gave Nassa Taipei the facility subject to the collection of Tk 156.12 crore by comment.
