White paper on state of economy in the offing

Debapriya to lead panel

The government will prepare a white paper on the state of the economy so that strategic steps can be taken to stabilise the economy, reach the SDGs, and mitigate the challenges after Bangladesh graduates from the LDC grouping.

Economist Debapriya Bhattacharya will be the chief of a panel of economists and eminent citizens, who will come up with the white paper.

Debapriva, convener of the Citizen's Platform for SDGs and a distinguished fellow of the Centre for Policy Dialogue, will choose the members of the committee after talking to the chief adviser.

He said, "It [the white paper] will be a very pertinent transparency exercise to establish the benchmark of the economy. It will inform the future reform measures. I am grateful to the chief adviser that he has recognised its necessity and has taken immediate action."

The panel was given 90 days, starting yesterday, to submit the paper to Chief Adviser Prof Muhammad Yunus, said a statement from his office.

Bangladesh's economy has been suffering for a decade and a half due to mismanagement, corruption, capital flight, and unnecessary projects, said the statement.

"In this situation, the interim government should have a clear picture of the economy and [an outline of] the way out of the challenging situation. So, it decided to form a committee to prepare the white paper," it read.

The focus of the white paper will be on public finance management, inflation, food management, external balance, energy and power, private sector assessment, and employment.

The interim government is planning to formulate an ordinance to establish a commission to ensure justice for the victims of enforced disappearances and their families.

Bangladesh may sign the International Convention for the Protection of All Persons from Enforced Disappearance by August 30, chief adviser's Press Secretary Shafiqul Alam said yesterday evening.

The matter was discussed at a meeting of the advisers to the interim government.

BB to confiscate S Alam's shares; reconstitute board

After seven years, S Alam Group's control over Islami Bank ended yesterday after the Bangladesh Bank decided to dissolve the board of the country's largest private sector bank that was heavily dominated by individuals linked to the conglomerate.

"They have looted whatever is there to loot -- we now have to rescue the bank from this shattered state," said BB Governor Ahsan H Mansur yesterday in a press briefing.

The existing board, whose chairman since June last year is S Alam group chairman Mohammed Saiful Alam's eldest son Ahsanul Alam, will be dissolved in a day or two and a new

Muhammad Badiuzzaman Dider, who served as director of BB's Chattogram office, has been appointed as the administrator for a year, as per an internal order of the central bank. To support the overall operations of the administrator, six officers have been appointed.

Tanvir A Mishuk, the founder and managing director of Nagad. welcomed the move, saying it will put an end to the recent misinformation surrounding Nagad.

3m stranded as flood hits 8 dists

Feni, Noakhali worst hit; vast areas inundated due to incessant rains, rise in water levels of rivers

The overall flood situation in Feni, Noakhali, Cumilla and Noakhali worsened yesterday due to downpours and swelling of many rivers.

A pregnant woman in Brahmanbaria's Akhaura upazila died after being swept away as floodwater rushed into her home.

Vast tracts of land in Habiganj and Moulvibazar and parts of Brahmanbaria and Chattogram have gone under water.

The flooding in the eight districts has left over three million people stranded. Feni and Noakhali are the worst-affected districts.

In Feni, Parshuram, Fulgazi, and Chhagalnaiya upazilas have been badly affected. Besides, large areas under four unions of Feni Sadar and Daganbhuiyan upazilas have been inundated due to rise in the water level of the Chhota Feni river.

Shafiqul said as the interim government is committed to investigate each and every case of enforced disappearances, a National Security Adviser will be appointed soon.

The international convention is the first universally legally binding human rights instrument of the UN intended to prevent forced disappearances.

The Ministry of Home Affairs has started preparing a draft of the "Enforced Disappearance Commission Ordinance". The government is considering whether the commission should be able to exercise its power retrospectively, said an official.

A person with the rank of a High Court judge will be head of the commission. Those with experience in working on prevention of enforced disappearance will be members of the commission.

82 percent stakes in Islami Bank, documents show, but the conglomerate maintains it has 32 percent stakes.

The move to dissolve the board comes after a group of Islami Bank officials, former chairman of the board

of directors and clients requested the BB governor to do so.

Once a well-run, profitable bank, its financial health took a turn for the worse after S Alam started exerting its influence following ownership change.

Between 2017 and June this year, the Chattogram-based conglomerate and its associates' companies took Tk 74,900 crore, which is 47 percent of Islami's total outstanding loans as of March.

The loans were taken in the name of Mohammad Saiful Alam, and his wife, daughter, relatives and other officials, SEE PAGE 2 COL 5 billion empire in Singapore.

Papon's exit a signal of new era?

Nazmul Hassan Papon's long reign at Bangladesh Cricket Board (BCB) came to an end yesterday when he resigned as president of the country's most coveted sports body, paving the way for former captain Faruque Ahmed to assume the lead role.

For the past 12 years, Papon -- a lawmaker from the Bangladesh Awami League and former Managing Director of BEXIMCO Pharmaceuticals was in the spotlight as BCB president but, unfortunately, mostly for the wrong reasons.

Papon had earned the tag of 'Mr. Interferer' during his tenure as he involved himself in all cricketing matters, undermining the independent functioning of the board's departments and committees.

resignation predictably His saw Faruque -- nominated by the National Sports Council (NSC) as one of its two new directors on the board alongside veteran coach Nazmul Abedeen Fahim -- elected as the new BCB president during an emergency meeting of the board of directors at the Ministry of Youth and Sports vesterday

"He [Nazmul Hassan Papon] has

resigned as president but he still remains as a director and councillor," a board director told The Daily Star on condition of anonymity.

There had been uncertainty surrounding BCB's activities following the ouster of the Sheikh Hasina-led Awami League government on August 5, as Nazmul and many other board directors went into hiding since then.

With the election of the new president, BCB is set to start a new chapter under ex-chief selector Faruque, who is the first to take on the role of board president as a former captain.

Help us get back laundered money

CA asks UK envoy; meets Japanese ambassador

Chief Adviser Prof Muhammad Yunus yesterday sought UK support as Bangladesh wants to bring back the money laundered abroad over the years.

He sought the cooperation when British High Commissioner to Bangladesh Sarah Cooke called on him at his office in State Guesthouse Jamuna, said Chief Adviser's Press Secretary Shafiqul Alam at a briefing at the Foreign Service Academy.

"The high commissioner assured him [Prof Yunus] of looking into it.

In a statement, the UK high commission said Prof Yunus and Sarah Cooke discussed how the UK government can support the interim government, as it charts a new inclusive and democratic future for Bangladesh.

"Discussions also covered the importance of youth engagement to navigate the challenges that lie ahead," said the statement.

It said the UK is a longstanding partner and friend of Bangladesh and the two countries share a strong and enduring relationship, solidified by their deep people-topeople links and shared Commonwealth values.

Earlier in the day, during a call on by Japanese Ambassador Iwama Kiminori, Prof Yunus sought Japan's financial assistance to reconstruct and rebuild the country. The chief adviser mentioned that huge funding will be

required for this, said Shafiqul, reports UNB.

Documents pieced together by The Daily Star show that most of the loans were taken by bypassing banking rules and regulations, in a testament to how the Chattogram-based conglomerate exerted its influence on the country's banking sector.

The amount given to S Alam and its associate companies has left the bank with a deficit in its current account balance with the central bank for more than a year.

To plug the deficit, the central bank provided special liquidity support to the lender without any collateral on the orders of former BB governor Abdur Rouf Talukder.

He said floodwater entered almost every house in Parshuram, Fulgazi, and Chhagalnaiya upazilas. In Noakhali, the flood situation

deteriorated yesterday due to incessant rains and tidal surges.

Flooding has left over 1.9 million people stranded in eight upazilas, including Kabirhat, Senbagh, Begumganj, Companiganj and municipalities, said and several Dewan Mahbubur Rahman, deputy commissioner of Noakhali.

Among them are over one lakh people in the municipalities.

In Cumilla, the Gumti and the Muhuri swelled yesterday, thanks to incessant rain and the opening of a sluice gate at the Dumber Lake in Tripura, India. The flooding has affected over 50,000 people.

Floods have hit Adarsha Sadar, Burichang, Brahmanpara, Debidwar, and Muradnagar upazilas, according to the Water Development Board.

The death toll from floods caused by incessant rains and landslides has risen to eight in Tripura, according to Indian media reports

In Brahmanbaria, the Akhaura land port went under water due to onrush of water from upstream in Indian's Tripura. At least 15 villages near the port have been affected by floods, leaving around 3,000 people stranded.

decision like appointing an administrator. We believe this will be a significant step forward in the country's cashless journey."

Earlier, the government had also appointed administrators to several major institutions of the country's financial sector, including some banks and top mobile operators, Mishuk said.

"We think that the decision of Bangladesh Bank will stop the conspiracy of a circle of people against Nagad. Nagad believes it will remain on top in providing service to customers as it was in the past five years," he added.

Nagad, which entered the market back in March 2019 as the digital financial services arm of the Bangladesh Post Office (BPO), is still running on a temporary licence from the BB.

In June, the central bank extended the tenure of its temporary licence for the seventh time. The licence will expire in June next year.

The post office, however, does not have any ownership of Nagad and only gets a share of Nagad's revenue, documents show.

"We used to know that Nagad is a digital financial service provider of the Bangladesh Post Office and the central bank issued an interim licence to the Directorate of Posts to run the MFS," said BB spokesman Md Mezbaul

Haque. The central bank extended the

percent of revenue. Nagad has provided Tk 14.60 crore as revenue share to BPO. "This partnership has been instrumental in extending our services to a wider population across Bangladesh, particularly in remote and underserved areas," he added.

BB appoints administrator at Nagad

The central bank though has been accommodating to Nagad all along. For instance, in February 2022,

the central bank issued a new MFS 'Bangladesh Mobile regulation Financial Services Regulations, 2022' replacing the Bangladesh MFS Regulations, 2018 issued in July 2018.

The new regulation allowed nonbank financial institutions (NBFIs) and government entities, alongside banks, to run MFS. Previously, only banks could run MFS services, which made Nagad ineligible for a full-fledged cence.

A month later, Nagad Ltd applied to the BB for an NBFI licence. A year later, the BB issued an NBFI licence for Nagad Finance, removing any licensing ambiguities for Nagad's MFS operations.

However, Nagad surrendered the NBFI licence less than three months later as its backers manoeuvred to gain regulatory legitimacy by way of a digital bank licence. In June last year, the central bank

invited applications for digital bank licences The BB got 52 applications and but

only two got the licence: Nagad and Kori.

Ministry issued a directive granting Nagad exclusive rights to disburse the stipends. At that time, 5.4 million beneficiaries

were receiving stipends through their preferred channels, with Nagad serving only 20 lakhs. However, the division stated that the remaining 34 lakh beneficiaries would have to convert their MFS accounts to Nagad.

In the directive's headline, the division mentioned that it has approved the disbursal of stipends through Nagad, which had 'signed a deal' with BPO.

Despite this, Nagad failed to disburse the stipends properly and was given multiple time extensions until the end of June.

Eventually, the government directed that the stipends for 19 lakh beneficiaries be disbursed through other MFS providers out of the current 65 lakh beneficiaries.

Meanwhile, the Bangladesh Securities and Exchange Commission (BSEC) in 2021 found some anomalies when Nagad applied to raise capital through zero-coupon bonds.

The company's liability for digital money increased unexpectedly from Tk 447.1 crore in June 2020 to Tk 858 crore in April 2021. At that time, Nagad's losses stood at Tk 147.6 crore while its paid-up capital was Tk 3.5 crore, as per its audited financial statements as of April 30 that year.

The overall flood situation in Habiganj and Moulvibazar worsened vesterday as the Khowai. the Kushiyara. the Manu, the Dhalai, and the Juri were overflowing at many points.

More than 80,000 people were stranded as 208 villages in Moulvibazar went under water.

The flood situation in Chattogram's Fatikchhari upazila and its nearby areas deteriorated vesterday due to incessant rain. The Halda was flowing above the danger level.

A part of a dyke at the mouth of Shikder canal in Sitakunda upazila's Banshbaria area was damaged vesterday.

"A portion of the dyke was damaged due to onrush of water from upstream," said SM Tarek, sub-divisional engineer of the Water Development Board.

The interim government has taken adequate preparation to tackle the floods in the country.

"We have adequate preparation," Chief Adviser's Press Secretary Shafiqul Alam told reporters vesterday.

Briefing reporters at the Secretariat yesterday afternoon, KM Ali Reza, additional secretary of the disaster management and relief ministry, expressed concern that more areas may be flooded in the next few days.

He said they have already sent relief materials and dry food to the affected districts.

"The local administration is working in coordination with the deputy commissioners of the flood-affected districts, the coordinators of the Anti-Discrimination Student Movement, the army and volunteers," he added.

Faruque began his tenure yesterday with a huge task ahead, as the country's premier sport has struggled to progress in the right direction during Papon's tenure.

Bangladesh saw some sporadic success since he took charge in 2012, and he was credited with uncovering the darkest chapters of the country's sporting history, such as the franchisebased Bangladesh Premier League (BPL) match-fixing scandal in 2013.

However, under his leadership, domestic cricket lost its charm and credibility, and alleged corruption further hindered the game's progress.

Papon was elected board president three times, but these elections were marred by fraud and manipulation, with no competition due to the interference of his supporters who manipulated the process to ensure their own councillorship. As a result, the board was filled with 'yes-men' who came through the influence of Papon's allies.

Over time, competitiveness in domestic leagues evaporated due to manipulation by the core group in the board. On the other hand, the first-class tournaments were far from competitive, resembling 'picnic cricket'.

Also, the cash-rich BPL, the lone domestic T20 competition, gradually lost its credibility, which adversely affected the national team's development. Moreover, BCB had never been transparent about the BPL's financial issues.

While Papon had repeatedly

promised after every election to implement the long-desired regional cricket associations to decentralise the game, he failed to execute these plans. He apparently focused all his efforts

on interfering with national team issues, where the new president was also a victim, while his selected group allegedly dealt with all corruption matters.

There was no accountability or transparency in the functioning of the board, which was essentially a oneman show. Under these circumstances, everyone will be watching to see whether Faruque can reform the board's activities.

There have been widespread allegations of corruption within the board, and Faruque's first duty will be to take proper measures to uncover the truth.

The new BCB boss will need to focus on domestic cricket if he wants to set things on the right track. He must create an environment where genuine organisers feel comfortable.

Faruque was most successful as a chief selector, but he is now embarking on a much bigger role. He must ensure that the right people are in the right positions and that every committee an perform its duties with freedom.

It's worth remembering that despite the presence of a number of former cricketers at BCB, their presence made hardly any difference to the progress of the game in the country.

Can Faruque make a difference now, with reform being the buzzword in the country following a historic studentled mass protest?

The BSEC report said that the company's main function is providing mobile financial services but as per the submitted memorandum of articles and the articles of association, it is not clear whether the company can provide MFS or can act as a payment services provider.

"There were few clarifications requested by the BSEC and we have provided those clarifications and it was fully convinced with those clarifications," Mishuk said, adding that Nagad adheres strictly to all regulatory guidelines and maintains robust financial controls to ensure accuracy and compliance in all our operations.

could have investigated the money laundering allegations against S Alam before. Given the current

circumstances, starting the investigation now is a positive step." On August 13 last year, the ACC

began investigating the money laundering allegations against S Alam after The Daily Star on August 4 last year published a report titled "S Alam's Aladdin's Lamp"

The report said S Alam built a business empire in Singapore worth at least \$1 billion, although there was no record of him taking any permission from Bangladesh Bank to invest or transfer any funds abroad. It said S Alam bought at least two hotels, two homes, one retail space, and other properties over the last one decade, all the while seeking to remove his name from the paper trails.

On August 6 last year, the High Court directed the authorities to investigate the allegations of him owning businesses abroad without Bangladesh Bank's permission.

On February 5 this year, the Appellate Division of the Supreme Court scrapped the HC suo moto rule that had ordered an investigation.

However, the apex court said the ACC, the CID, and Bangladesh Financial Intelligence Unity (BFIU) can take legal steps on the matter on their own.

On August 18 this year, the ACC received a copy of the Appellate Division's order. Following the order, the ACC reopened the case on Tuesday.

Asked about cancelling those passports, the senior secretary said, "As we are cancelling the diplomatic passports of the primary passportholders, automatically their family members' passports will also be scrapped.

"If anyone [holding a diplomatic bassport] wants to take a new passport, the person has to surrender the diplomatic passport first and then an ordinary passport will be issued as per law," he added.

Home ministry sources said once the red passports are cancelled, former ministers, and MPs who have been accused in criminal cases or have been arrested may have to go through a legal process to get ordinary passports.

In that case, they can apply for a general passport only after getting a court order.

Along with the MPs, the officials of Bangladeshi missions abroad also get red passports. Those with red passports do not need a visa to travel abroad. They get a visa on arrival after landing in a particular country. Red passports or diplomatic passports are red in all countries.

Once the cancellation order is

"Intelligence agencies are above accountability and they get indemnity. This must stop. There should be independent authorities to monitor them," he said.

Ratification of the international convention is also a major step because it will make "Bangladesh answerable to the international forum."

Constitution expert and Supreme Court lawyer Arif Khan said the cases of enforced disappearances could be dealt with the existing laws.

"Courts can take assistance from international laws if they feel it is necessary. We need a localised law in line with international conventions."

According to rights organisation Odhikar, at least 708 people were victims of enforced disappearances between 2009 and June 2024.

The US in December, 2021, imposed sanctions on Rab and seven of its top officers, over serious rights abuses.

It said Rab and other Bangladeshi law enforcement forces are responsible for more than 600 enforced disappearances since 2009 and nearly 600 extrajudicial killings since 2018.

issued, former MPs or ministers who are currently abroad have to surrender their red passports to the DIP office in the respective countries or after coming back to Bangladesh.

According to ministry sources, former prime minister Sheikh Hasina was a red passport holder. In the face of a mass uprising against her government, Hasina took refuge in Indiaon August 5 after the fall of her government.

Several former ministers and MPs of the AL government have already been arrested. Some fled abroad before the fall of Hasina's government to avoid arrest.

However, there were no reports of anyone fleeing abroad after the fall.

Many former ministers and MPs are still hiding in the country, and law enforcement agencies are conducting drives to arrest them as over two dozen cases have already been filed against them.

According to the passport department, the ministers and MPs get diplomatic passports for five years of the tenure of parliament after the formation of a new government.

When the term of parliament ends, the validity of the passport also expires.

BANNED FOR FORGERY Contractors pressurise RHD to withdraw ban TUHIN SHUBHRA ADHIKARY

A group of contractors who were banned by Roads and Highways Department (RHD) over the last year for indulging in forgeries to secure contracts are now putting pressure on the authority to withdraw their ban.

They have even threatened to besiege the RHD headquarters unless the authority withdraws the ban, which has debarred 47 contractors in the past year and demanded that RHD halt all ongoing work until their demands are met. These contractors were among the highest beneficiaries

under the Sheikh Hasina-led government. On Sunday, under the banner of RHD's Affected Contractors' Coordination Committee, the group submitted a memorandum to the RHD chief engineer, incorporating 10 demands.

In this situation, the chief engineer yesterday held a meeting with the contractors to discuss their demands.

According to RHD sources, 44 contractors were banned between February and July this year for different periods for indulging in different kinds of forgeries to secure contracts. They will not be allowed to participate in any RHD bidding processes during the ban period.

Thirteen contractors, upon filing a writ with the High Court, got a stay against the debarred order, meaning the debarred order is still valid for 31 contractors, they said.

According to sources, the banned contractors had allegedly engaged in malpractice in collusion with a section of unscrupulous officials of the RHD.

Ahmad and Sohail were arrested from Rampura and Banani respectively on Tuesday night in a case filed over the murder of a shop owner, Nabin Talukder, who died after getting injured in Dhaka's Paltan on July 19 during protests.

Nabin's wife, Ruma Akhter, filed the case against unnamed persons on July 20.

Captain (retd) AB Tajul Islam, former state minister for Liberation War affairs, on nine-day remand in a case filed over attacking police and snatching firearms from law enforcers.

Tajul was arrested from Dhaka's Gulshan on Tuesday night.



KILLINGS DURING UPRISING UN reiterates call for accountability US stresses human rights, ties with Bangladesh

UNB, Dhaka

The United Nations has reiterated its call for accountability for the recent violence, loss of life, and human rights violations in Bangladesh.

'We've been speaking about accountability since the beginning of this particular crisis," said Spokesperson for the UN Secretary-General Stéphane Dujarric at a regular briefing in New York on August 20.

"There will need to be accountability for the violence, for the loss of life, and for all violations of human and political rights," he said.

Meanwhile, the United States has stated that they look forward to working together to support their shared values and interests, such as a free and open Indo-Pacific.

"We do have a defense relationship with Bangladesh," Pentagon Press Secretary Maj Gen Pat Ryder said while responding to a question during a press briefing recently. "As it relates to the Bangladesh government, of course, you know, we would expect human rights to be observed and there to be an avoidance of any type of violence," Ryder said.

Somoy TV broadcast to remain suspended SC chamber judge passes order STAFF CORRESPONDENT

Broadcasting of Somoy TV, a private channel, will remain suspended till further notice, according to an order passed by the Supreme Court's chamber judge yesterday.

The order came in response to a petition seeking a stay on a High Court order on August 19 that asked the authorities concerned to stop the channel's transmission for seven days following a writ petition filed by Shampa Rahman, managing director of Somoy Media Ltd.

The broadcasting of the channel remained suspended since that night.

Justice Md Ashfaqul Islam, chamber judge of the SC's Appellate Division, passed the order after hearing arguments from the counsels for both the parties of the case, and sent the petition to the full bench for hearing on August 25. SEE PAGE 4 COL 4

AB Party gets **EC** registration

Amar Bangladesh Party (AB Party), founded by some former leaders of Jamaat-e-Islami, yesterday got its registration with the Election Commission. with "eagle" as its electoral symbol.

The EC issued a gazette notification in this regard as per the Representation of the People Order, 1972, following a High Court order.

AB Party was among a total of 80 political parties that had applied for registration with the EC since October 2022.

Earlier on August 19, the HC bench of Justice Naima Hayder and Justice Kazi Zinat Haque ordered the commission to register it as a political party as per the Representation of People's Order, 1972 and Rules of Registration of Political Parties, 2008.

After the EC earlier rejected the party's application for registration on July 24, 2023, the party submitted the writ petition on August 23 of the same year upon instruction of its convener AFM Sulaiman Chowdhury.

Later, on August 2023, a divisional bench of HC consisting of Justice KM Qamrul Qader and Justice Md Shaukat Ali Chowdhury issued an interim rule, which was made absolute by the HC bench on August 19 this year.

1 dies, several hurt in **BNP** factional clash

A man was killed and several others were injured in a clash between two factions of BNP in Nagarkanda upazila of Faridpur yesterday.



I HAD TO GO INTO HIDING IN 2018: **MOUSUMI HAMID**

Renowned actress Mousumi Hamid recently returned to Dhaka after completing the shoot of a new film in Bandarban and Cox's Bazar. Directed by Tasnova Tabassum Atoshi, the film's title is yet to be finalised. This marks her return to work after a tumultuous month, which saw the rise of the antidiscrimination student movement and the collapse of the previous government.

However, the actress' activities haven't been confined to the entertainment industry. Mousumi was a prominent voice in the recently concluded movement. She took to the streets and voiced her support for the students on social media. "I joined the protests for four to five days. I stood with the students because I believe in their cause," she said.

Recalling a specific incident, Mousumi described how, like many others, she changed her social media profile picture to red in solidarity with the movement. Not long after, she received a phone call during the then ongoing curfew, with someone repeatedly inquiring about her whereabouts. Fearful for her safety, she and her husband fled their home. "We returned 12 hours later, only to receive another call the next day, warning me not to post anything else. But I didn't stop. I spoke and it felt great to work amid the serenity out against injustice, and I wasn't afraid."

When asked about the state of our freedom of speech before August 5, Mousumi candidly stated, "There wasn't much freedom of speech, and I am living proof of that. Everyone was afraid to speak up. But after the downfall of the former government, that fear is gone. Now, we can speak freely.

Mousumi also revisited her experience during the 2018 protests when actress Quazi Nawshaba Ahmed was arrested, "Back then, I posted several things on Facebook in support of Nawshaba, which led to me receiving threatening phone calls. I couldn't speak out then, but now, with the new sense of freedom, I feel like I can finally share my experiences."

Taking the advice of friends, Mousumi deleted some of her posts and turned off her phone out of fear after the arrest of Nawshaba. "I went underground for 13 days, being completely out of contact with everyone. I remember the fear I felt as I travelled from Cox's Bazar to Sreemangal, not knowing what would happen next.'

At that time, actor Sazu Khadem *bhai* was of great help. He called many people and told them, "Mousumi never gets involved with politics, so make sure she isn't harmed." After that, I continued shooting, but I kept thinking that I could be arrested at any moment.'

The actress also disclosed that during this period, a director warned her that a case had been filed against her and advised her to stay hidden. "That was the life I led back then," she recounted.

Reflecting on the current situation, expressed relief. "Now, I feel free. We can all express our opinions openly. Life is much better for everyone now." Mousumi shared the shooting experience of her upcoming musical,

Protests grow in India over abuse of two minors Schools, internet shut in a town near Mumbai

Internet services were cut off and schools were closed for a second straight day in a town near India's financial capital Mumbai yesterday, as protests over the alleged sexual abuse of two, four-year old girls intensified, media said.

The protests in Badlapur, about 50 km from Mumbai, come amid nationwide demonstrations over the rape and murder of 31-yearold doctor in Kolkata.

A janitor was arrested for allegedly sexually abusing the students in a school in Badlapur on the weekend. Angry protesters railway tracks blocked for hours on Tuesday, demanding justice for the children, echoing similar protests across the country by doctors and women's groups.

Tanker adrift after multiple attacks in Red Sea: agency

A Greek-flagged oil tanker was adrift in the Red Sea yesterday after repeated attacks that started a fire on the vessel and caused the ship to lose power, the UK maritime agency said.

Sounion The was first attacked by two small boats and hit by multiple projectiles about 77 nautical miles west of Yemen's port city of Hodeidah on Wednesday the morning, Greek shipping ministry and the UK Maritime Trade Operations (UKMTO) said.

There was a brief exchange of small arms fire during the incident, the UKMTO said, adding in a later update that the ship had reported a renewed attack. That caused the fire and led the vessel to lose

Death 'only certainty' for people in Gaza

Says UN official as Israeli strikes continue in enclave

AFP, Jerusalem

In Gaza, death appears to be the "only certainty" for 2.4 million Palestinians with no way to escape Israel's relentless bombardment, a UN official said Tuesday, recounting the growing desperation across the territory.

"It does feel like people are waiting for death. Death seems to be the only certainty in this situation," Louise Wateridge, a spokeswoman for the UN agency for Palestinian refugees, also known as UNRWA, told AFP from Gaza. For the past two weeks, Wateridge has been in the Gaza Strip, witnessing the humanitarian crisis, fear of death and spread of disease as the offensive rages on. "Nowhere in the Gaza Strip is

safe, absolutely nowhere is safe. It's absolutely devastating," Wateridge said from the Nuseirat area of central Gaza -- a regular target of Israel's aerial assaults.

Now in its eleventh month, the offensive has created an acute humanitarian crisis, with hundreds of thousands of people, most of whom have been displaced several times, running out of basic food and clean drinking water.

"We are facing unprecedented challenges when it comes to the spread of disease, when it comes to hygiene. Part of this is because of the Israeli imposed siege on the Gaza Strip," Wateridge said.

Israel's military campaign has killed at least 40,223 people, according to the health ministry in the Hamas-run territory. Most of the dead in Gaza are women and children, according to the UN human rights office.

Tens of thousands of people have taken refuge in schools across the Gaza Strip, an increasingly regular target of Israeli missiles. Israel's military Since fighting broke out in October, says these schools have been used as command and control centres by territory from the air, land and sea, Hamas, a charge the group denies.

We can't have same old politics on campus

Reforming the culture of student politics is crucial

ArecentProthomAlosurvey-where 93 percent of respondents, or over 326,000 people, supported banning student politicsreflects widespread frustration and disillusionment with the current culture of student politics in Bangladesh. This overwhelming sentiment cannot be dismissed lightly. For far too long, student wings of political parties have exercised unchecked control over university campuses, often resorting to violence, intimidation, and coercion to maintain their dominance. In particular, the crimes and abuses committed by Chhatra League over the last 15 years have understandably led many to conclude that banning student politics altogether is the only solution.

However, the manner in which such surveys are framed misses the critical point that it's not student politics per sebut rather party-based student politics-that is problematic. Unfortunately, much of the discussion and reaction revolving around this issue seems to stem from this faulty premise. The decision of the 19 public educational institutions including 11 universities and six medical colleges that have recently prohibited student politics, with 13 of them simultaneously banning politics for teachers and staff, is also based on this premise. "Ban student politics" has become a rallying cry since the fall of the Awami regime on August 5.

However, we must also recognise the vital role that student politics, when properly structured and purpose-driven, can play in representing student interests and addressing legitimate grievances within our educational institutions. The very uprising that ousted the Awami League government owes to the leadership of largely nonpartisan but politically conscious students. Among them were also students tied to rival political parties, many of whom sacrificed their lives. But they left behind their political identity when they joined hands with other students for a cause that unified the whole nation.

The history of student politics in Bangladesh is replete with such glorious moments transcending party lines. Students being exploited by political parties to do their bidding form the other stream of this history, and it is this stream that needs to be rectified. Interestingly, we don't even need a new law or ordinance for that. The Representation of the People Order (RPO) already prohibits political parties from having any affiliated student or teacher organisations. However, we have seen how political parties bypassed this law on technicalities, with Awami League calling Chhatra League a "brotherly organisation", and BNP calling Chhatra Dal an "associate organisation" with its own constitution. Preventing such manipulations can put an end to the culture of party-based politics on campuses, and this is where we should focus.

The rights of students or teachers to engage in political activities are inalienable, but they can do so on their own time and outside the campus. But pursuing their political rights or agenda at the expense of general students and teachers is unacceptable. Clearly, there is a fine line to balance here. So instead of banning student politics altogether, university administrations should ban party-based politics, activate and empower student unions to better protect their interests, and ensure academic and intellectual freedoms so that our students can grow to be the leaders we need. Political influences in teacher recruitment, dormitory seat distribution, and other relevant areas also must stop. No party should be given the chance to exploit our universities again.

Health sector needs



After 15 years of autocratic rule and authoritarian economic policymaking, the time has come for significant societal reform through conscious youth leadership and public participation. Such a possibility was created once in 1972 and again in 1990. We could not realise either of those two opportunities because of the betraval and hypocrisy of the big political parties. Instead, we saw them consolidate their wealth and create a new political class.

It is important that we remember the failings of the past, so that we do not replicate them moving forward. Now, there is an interim governmentwe know its limitations but we must also keep in mind its primary responsibilities. This government came to power through a mass uprising, so it has public support and responsibility to initiate some major reforms that other governments did not. Let's consider some of the things this government can do in the next one or two months.

First and foremost, inquiry committees should be formed to investigate the unprecedented number of killings and acts of repression that we have witnessed. The responsible persons, organisations, and policies that enabled these actions should be brought to justice and amended through a special tribunal. An example must be set so that this sort of mass killing can never happen again in Bangladesh.

Massive corruption, bad deals, bank robberies, loan defaults, and over-expenditures in megaprojects have been commonplace in the last 15 years. The government should publish a white paper and make public all the deals, contracts and excesses of the previous regime. The next duty would be to analyse the large amount of loans incurred-Bangladesh has never had such high levels of foreign loans. The people of Bangladesh are yet to fully realise the steep amount they will need to repay as a result of these incredibly expensive contracts, since the deals were never made public. Moving forward, we must demand full disclosure of each loan or contract signed by our

Govt must focus on purging partisan influences

A Prothom Alo report on the politicisation of the public health sector portrays a grim picture of how far the rot has spread. The report details how partisanship has pervaded the sector-from medical academia to healthcare services to projects under the health ministry-ensuring absolute dominance of the erstwhile ruling party. But Awami League was not the only one to have spread its tentacles; BNP also did the same while in power, and it seems the party is trying to do it again after the fall of the former.

Reportedly, after forming government in 2009, Awami League and its affiliates placed loyal officials in various healthrelated institutions. One example is the Bangabandhu Sheikh Mujib Medical University (BSMMU), where five consecutive vice-chancellors appointed since 2009 have either been a member of pro-AL Swadhinata Chikitsak Parishad (Swachip) or directly involved with AL politics. The same goes for pro-VCs, proctors and others in top positions. Political recruitments were also seen at 37 other public medical colleges. Elsewhere, at the 495 upazila health complexes, only officials loyal to AL were appointed as upazila health officers. Thus, lovalists were favoured in leadership positions at every level of the public healthcare sector-from the grassroots to the top-whether they were qualified or not. In the process, AL deprived anyone with suspected links to BNP and even deserving nonpartisan candidates.

During BNP's rule in 2001-2006, it was the pro-BNP Doctors Association of Bangladesh (DAB) that dominated public-sector recruitments, choosing party loyalists in important positions, and thus depriving those even remotely affiliated with AL and its politics. During the times of both regimes, those who were not affiliated with either party or their politics have suffered, and the lack of competent leadership eventually plunged the sector into an unprecedented crisis.

In the aftermath of Sheikh Hasina's fall, it seems BNP is focused on repeating the same cycle. As many as 173 doctors who were recruited in BNP's time, and deprived of promotions throughout the AL rule, were all promoted in one day-on August 8. The Prothom Alo report suggests that the spate of promotions is still going on. Frustrated DAB members are cornering relevant authorities, staging protests in various medical institutions, and in some cases even vandalising public hospitals.

We understand the frustration of pro-BNP doctors and medical professionals, but their attempt to forcefully claim what they think they deserve cannot be acceptable. Political partisanship is one of the root causes behind the ailing public health sector, and it's time to do away with it. Otherwise, much-needed reforms in the sector will continue to elude us. To restore discipline in this vital sector, we urge the interim government to be strict and judicious about all appointments and promotions. Only those who are qualified and deserving should get preference.

for resolution of differences between the president, prime minister and parliament etc. Besides, the 2014 constitution did not give due importance to ensuring various social and economic rights of the people, which acted as a catalyst behind the erosion of the constitution's popularity.

the recent mass uprising has given rise to new optimism in Bangladesh's long struggle for democratic transition. Learning from the failure of democratic transition after the 90's mass uprising, public opinion has been formed in favour of various institutional reforms including the country's constitution. In this context, lessons need to be learned from the failure and success of institutional reforms in other countries of the world.

The pragmatic and consensus-based politics exhibited by Tunisian political leaders and civil society groups in their struggle for democratic transition can be a good case study, as mentioned in The Tunisian Revolution and Democratic Transition (2022) by Mohammad Dawood Sofi. From Tunisia's experiences of success and failure, we can understand what to do and what not to do in the path of democratic transition.

Tunisian dictator Ben Ali was ousted from power in a mass uprising in January 2011. After that, to break free from the old authoritarian rule and initiate a democratic transition, a decision was made to elect a National Constituent Assembly (NCA) to draft a new constitution. A commission named High Authority for the Achievement of the Revolution Objectives (HAARO), simply known as the Ben Achour Commission, was formed to frame new electoral laws and procedures for the smooth conduct of elections for NCA. The commission with 155 members had a broad representation of legal experts, scholars, civil society organisations, and political parties. Following a free and fair election, a 217-member NCA was elected in October 2011 with representatives of various political parties.

Under the leadership of this elected constituent assembly, several specialised committees were formed to draft the various parts of the constitution, including the preamble, general principles, fundamental rights, government structure, judiciary etc. The committees prepared the drafts by taking advice from many local and foreign legal and constitutional experts. Different social groups including labour unions,

Myanmar and St Martin's Island

Let's chat about St Martin's Island, a tiny, three square-kilometre coral outpost, as referred to in Chinese media. I visited the island–also known as Narikel Jinjira-in 2001, staying there for a night—a time when it was still not on the tourist trail. It took mere minutes to walk from one end to the other. Could this fragile place really be the location for a US base, to add to their 800-plus others around the globe? Eight kilometres off the coast of Arakan, some suggest it could be a listening post and a forward deployment point. In the age of drones, could one intervene in Arakan and the rest of Myanmar? It reminds us how Bangladesh and Myanmar security forces



faced off each other in 2018.

Whether it is St Martin's or Teknaf is not the issue. Beijing is naturally alarmed by the civil war in Myanmar, with which it shares a long porous border. Instability in this resourcerich place directly affects Yunnan. Given that the US is confronting China in the Taiwan Straits, it is plausible that a "second front" might appear on the Irrawaddy (Ayeyarwady). If Dhaka shifts from Delhi to Washington's orbit with this new administration (or possibly a BNP one), Beijing will naturally look at the security implications across the Naf River and beyond.

how often have our political elites ever evinced an interest in Myanmar-and thus China?

There was one time. In 2012, there were talks of Chinese willingness to build a direct road from Kunming via Mandalay to Teknaf, which was shelved. India leaned on Yangon to block that lifeline. Later, Delhi also put an end to the longer route from Kunming to Kolkata, via Dhaka, which had been rebranded as BCIM (Bangladesh-China-India-Myanmar Economic Corridor).

Treating China like a cash cow?

This is where we come to the nub of the problem. We see China as just a giant foreign aid ATM. They are ready to lend and build as part of the Belt and Road Initiative (BRI), but they also seek a deeper partnership.

Even though I had my fears, I wrote a piece in this daily in July, titled "Mission to China." I was shocked how disastrous the trip to Beijing turned out to be. Last year, in discussions in Dhaka. I was led to believe that the Awami League government would shift dramatically to Beijing after securing its victory in the January 7 (s)election. But would Delhi allow such a thing? This year, Sheikh Hasina made not one, but two, visits to Delhi. The second one looked like a dressing down by the South Block. Chinese offers to invest over a billion dollars in saving the little water that came from the Teesta River were to be rejected. So were any major breakthroughs. So, the former foreign minister, Hasan Mahmud, and associates bandied about the sum of money they would ask out of China. \$5 billion worth of yuan, which became \$2 billion. More infrastructure-easy to syphon commissions from, perhaps.

This was capped off by a severe breach of diplomatic protocol. Hasina and her courtiers tore up the schedule and returned one night earlier. Mahmud claimed it was because she was terribly ill. Even if it was because they got wind of the seriousness of the student revolt, the then foreign minister and colleagues could have remained. But no, they returnedall smiles. Criticisms were batted away with a prime ministerial diagnosis that our heads had to be examined.

Over the last decade, we have been unable to work with China to build a new industrial export sector to wean us away from our dangerous dependency on the RMG sector. Jagaran Chakma's report in this daily last month detailed the painful odyssey of the Chinese Economic and Industrial Zone. The 784-acre site in Chattogram was allocated for Chinese industry. Intended to create as many as 200,000 jobs, it is still inoperative for eight long years.

To solve that, one needs a policy, a strategy and shedloads of capital. Right now, only China offers that quantity of capital and expertise to invest in new industries. Supply chains, componentproducing factories, industrial clusters are all exporting to earn dollars and yuan. This should form the basis of the developmental discourse, and it should be steered towards modern industry and associated technology.

In 2024, the unipolar world of yesteryear has disappeared. China is the manufacturing core of the world. It is the largest consumer market, too. It is just that we have little to sell to them, hence the urgent necessity to set up newer production lines to create higher skilled jobs.

Can Md Touhid Hossain convince us that Bangladesh has not moved merely from the Indian leg of the tripod directly to a distant Western power? I would like to hear more about how Bangladesh will work with China, to genuinely further mutual interests. This is still a least developed country. Tens of millions of young Bangladeshis are rightly impatient. Time is short.

Manufacturing praise

How honest are book reviews in Bangladesh?



The harsh truth is that without solicitation, verv few books will be written about. Sometime ago, a writer reached out to me with a request. His debut novel was being published later in the year and he was wondering if I would be open to reviewing it. I was aware of the book, having read it when it was still only a draft. The author was not someone I only knew, either, but a mentor who had supported my writing in many ways, even through monetary means. Refusing him, then, felt tantamount to betraval. But I had to in the end, and though he understood, I still came out of the exchange feeling guilty of being unhelpful or, worse, ungrateful.

Much has been written about the machinations that go behind the scenes of book criticism. The Economist, of all places, last year mourned the death of the "hatchet-job" in a piece called "Critics are getting less cruel. Alas", saying that the book review reads often like "a smug inside job". Indeed, a cursory review of book criticism in newspapers in Bangladesh lays bare the fact that it is very much the case here as well. Book reviews written by a student or well-wisher of the author is unsurprisingly common. When an unfortunate staff-writer is assigned

writing a glowing review or, if that is not possible, a tempered, "balanced" review. The latter is a phenomenon I had to personally deal with during my time working as a staff writer for literary supplements. Far from being "balanced", the term is used to refer to reviews where the meagre amount of positives of the book is amplified throughout the piece, after which the writer is free to add in a token few lines on what held the book back. I am of course to be blamed for this as well, as I too had "adjusted" a few times, caving into the pressures of producing a "balanced" review.

Mir Arif, a Bangladeshi writer based in the US, with whom I had the pleasure of working alongside as a staff-writer, says of his experience reviewing books in Bangladesh: "A major challenge was learning about the writers' backgrounds and their literary associations, which was somehow important in the existing review culture...In editorial meetings, the editors often discussed their views on the writer even before I read the book. As bad as it sounds, editors' views often influenced my reviews, sometimes even after I had submitted my drafts. On top of it, there was a general tendency a book, they are often nudged into to overpraise Bangladeshi literature..."

Bangladeshi writing in English is consistently assessed in this way. Their purported excellence is taken for granted. In an interesting piece Usraat Fahmidah, "Why don't bv Bangladeshi books reach international award shelves?" (The Daily Star, 2022), the blame on why our writers never seem to win Bookers or the DSC prize is put on literary racism, uneven output, or even a lack of interest in pursuing literature in the language, but curiously there is not one mention on the literary qualities of the books in question by any of the luminaries who had been interviewed. I do not intend to downplay the obviously real factors that the essay talks about, nor am I of the opinion that all of Bangladeshiliterature in English is second-rate, but to completely omit any discussion on whether these books deserved to win on literary grounds comes from an understanding that any such critique would disservice a fellow countryman and a burgeoning literary scene.

must explain how supporting "our" writers only ends up meaning that one has to unconditionally stump for these books and put them up on a pedestal they may not deserve. Does it not, then, achieve the exact opposite of what they want? Do we not end up looking shallow and tribal? And do we ever wonder where this talk of protecting "our" writers seems to come from? Perhaps from the very class of writers who would want that adulation? Perhaps, one must begin to think that it is contention and not celebration that really strengthens literature.

Ikhtisad Ahmed, author of Yours, Etcetera (Bengal Lights Books, 2015), concurs that "Our reviewing culture... is rife with sycophancy, intellectual dishonesty, and protection of class interests.

Ahmed, who had been no stranger to the backlash of critical reviews here, adds that, "We have eschewed intellectual debates and discussions for a celebration of works that fail to even be mediocre...This not only prevents us from taking the writing of Bangladeshis seriously enough to read and engage with our own widely, but holds us back on the world stage too."

I asked Sarah Anjum Bari, former literary editor at The Daily Star, how she dealt with conflicts of interest. She wrote back: "I don't believe in publishing a review just to bash on a book or author, so when we did run a negative review it would be one that still engaged critically with the text and had something valuable to say about it. I sometimes got in touch with the author in advance and gave them a heads up if a negative review of their work were about to come out. I also tried to push back on reviews that simply described and summarised the text-which is usually a sign of the reviewer not wanting to share their honest opinions on the text-so we would always send the draft back asking for more analysis. Ideally, we tried not to have a text reviewed by an author's friend (though this is honestly difficult to maintain in a place like Bangladesh where the community is so close knit)..."

It is not shocking to learn that there is an unhealthy overlap of friend and critic in book reviews here and an evangelical need to promote one's own for the collective cause is present among us. I am always distrustful of the praise I see, for instances of a friend of the author masquerading as a generous, conscious critic are literature in English would not get numerous. How successful this solicitation is also depends on factors such as class. Welloff and well-connected authors tend to do better. How likely is it then to envision a critical appraisal of these well-connected authors in newspaper pages with personal connections, if one can be frank? Even when their works deserve praise, it is praise that comes out as suspect. Is this the environment through which we are to make literary waves?

Reviewers, in turn, have increasingly become grifters. Far from suffering through the nauseating experience of writing something they may not mean, they enthusiastically heap praise in a bid to be agreeable, or perhaps in hopes of similar treatment when their time arrives, or even for a recommendation letter for an MFA. If nothing, a friendship can be on the table. In a piece in Esquire by Isle McElroy, "The Rise of Literary Friendships", the writer asks, "Are writers clinging to each other for support because, as publishing houses consolidate and advances decline, other writers are all we really have for support? Have the crabs in the barrel begun to hold claws?"

From the perspective of South Asia, this has been the case for a lot longer with the absence of needed institutions and opportunities. I believe this very sensibility has significantly contributed to writers receiving undeserving praise in the name of support.

Support is necessary in any case, but book critics must understand they should be servants to the text. When the Master is kind and original, they must capitulate to the magic, and when it is derivative and cruel, one must start planning a beheading. In the course of reviewing books in so many years (the first review I had written for this paper had been over a decade ago as a teenager), there were times I had gone on to worship a writer's books and times when I wished for their early demise. Never did I have the urge to be their friend.





BCB'S LEADERSHIP **CHANGE**

On Tuesday morning, it was reported that a meeting of the Bangladesh Cricket Board's (BCB) directors would occur the next day at the Ministry of Youth and Sports. Directors Iftekhar Ahmed Mithu and Khaled Mahmud Sujon confirmed this to The Daily Star, but CEO Nizamuddin Chowdhury remained unreachable.

Veteran organiser Ahmed Sajjadul Alam Bobby, meanwhile, claimed he had not received any notice, despite still being a board director. He had been asked to resign by the National Sports Council, but unlike Jalal Yunus, another NSCnominated director who stepped down, he refused.

Around midnight, BCB confirmed the emergency board meeting's location (Ministry of Youth and Sports' conference room) and time (Wednesday 11:00 am) -- and that it had requested a secure venue due to the country's current situation -further informing that there would be no media access, only recorded clips, images, and a media release afterward.

Eight board directors and former skipper Faruque Ahmed, who replaced Yunus as an NSCnominated director, alongside CEO Nizamuddin attended the meeting, where a minute's silence was observed for the lives lost in the historic student-led antidiscrimination movement.

The meeting began by approving the previous board discussions. Farugue officially joined as a director, and Nazmul Abedeen Fahim was approved as a councillor, later joining the meeting as a new NSC-nominated director.

Faruque sheds light on his way of operation

Former national team captain and selector Faruque Ahmed became the first-ever cricketer to become the Bangladesh Cricket Board (BCB) president on Wednesday. 'Awesome' fielding highlight of Day 1

Bangladesh pacer Hasan Mahmud praised his side's fielding, particularly behind the wicket, which remained as the key highlight of day one of the Rawalpindi Test against Pakistan yesterday.

After putting the hosts into bat, Bangladesh bowlers made early inroads and caused jitters, reducing Shan Masood's side to three down for 16 in a rain-delayed first session before Saim Ayub (56) and Saud Shakeel (57 not out) hit fifties to propel Pakistan to 158 for four at stumps.

Bangladesh's first session sizzle could be largely credited to the fielders as Zakir Hasan and wicketkeeper Liton Das took excellent catches.

Zakir, who was stationed at gully, dove acrobatically to the right to take hold of a sharp chance to remove Pakistan opener Abdullah Shafique while Liton lunged down the leg side to take a one-handed screamer to dismiss premier batter Babar Azam.

"It's very important to get help from the fielders. I think the boys were really good in the field. Some of the catches were wonderful today. It really feels great. They were awesome," Hasan



told reporters after the day's play.

On a rare day where Tigers practically grabbed everything that came their way, Liton took a regulation catch to send back Pakistan skipper Shan Masood, while Mehedi Hasan Miraz remained alert late in the day, taking another catch to get rid of Saim Ayub.

As expected by the green tinge on the surface, pacers were able to get purchase off the wicket. Hasan and his pace partner Shoriful Islam scalped two wickets each, three with the new ball, and looked far more threatening than the six overs of spin bowled by Miraz and Shakib Al Hasan. Hasan, however, said that the wicket did not entirely behave as expected.

"We've been practising here. The wicket was very green and I thought there was going to be pace and bounce but after the rain came it got a bit tacky and slow," Hasan said.

All sports associations dissolved

The discussion then turned to the ICC Women's T20 World Cup, which had been relocated to the UAE. Lastly, the board addressed Nazmul Hassan Papon, who had notified them via email the previous night of his resignation as board president.

Students force DU dean to quit

DUTA writes to law adviser describing 'scary situation'

One more dean of Dhaka University was forced to resign yesterday in the wake of a student protest.

Different groups of students have been pressing for removal of several other teachers from their administrative and academic roles alleging that they sided with the ousted Awami League government, and failed to provide security to the students during the recent quota reform protest.

Prof AKM Mahbub Hasan, dean of the Faculty of Biological Sciences, resigned yesterday.

Zeenat Huda, general secretary of Dhaka University Teachers' Association (DUTA), yesterday wrote to the Law Affairs Adviser Asif Nazrul expressing concern over such incidents.

According to witnesses, around 60 students of the Faculty of Biological Sciences gathered in front of the faculty building around 11:00am demanding Mahbub's resignation.

Around 12:30pm, they moved to the Teacher's Quarter building in Fuller Road area where Mahbub resides.

The protesters went inside the apartment complex. A few of them went to Mahbub's apartment and pushed and banged the door. The teacher was not in his apartment at that time.

PHOTO: AFP Blinken leaves ME without Gaza truce Warns Israel, Hamas 'time is of essence'; 50 Palestinians killed in Israeli strikes

Top US diplomat Antony Blinken headed home yesterday after failing to secure a Gaza ceasefire, warning both Israel and Hamas his plan may be the last chance to avert a broader war.

The US secretary of state appealed to Hamas to urgently accept a US-backed truce proposal, while also entering into a public spat with Israel over its future presence in the Gaza Strip.

'Time is of the essence," Blinken said after stops in key Arab mediators Qatar and Egypt as well as Israel on his ninth tour of the region aiming to halt the more than 10-month offensive.

"With every passing day, more bad things can happen to more good people who don't deserve it," he said before flying out of Doha.

'This needs to get done, and it needs to get done in the days ahead, and we will do everything possible to get it across the finish line," he said of the truce proposal.

The United States has presented ideas to bridge gaps and, through Qatar and Egypt, pressed Hamas to return to talks this week in Cairo.

But a day after Blinken said US ally Israel was on board, Prime Minister Benjamin Netanyahu was quoted by Israeli media as disagreeing on a key sticking point.

Netanyahu insisted Israel maintain control of the Philadelphi Corridor, the border between Gaza and Egypt that Israeli forces seized from Hamas, whom Israel says relies on secret tunnels to bring in weapons.
