FROM PAGE 3 Meanwhile, in Narayanganj, a murder case was filed on Tuesday night against AL leader Shamim Osman and 122 others on charge of killing Manir Hossain, 56, during the recent protests.

Mostak Ahmed. Mostak's brother filed the case with Habiganj Model Police Station. Of the accused, 111 were named.

Manir's younger brother filed the case with Siddhirganj Police Station. Manir had suffered bullet injuries during a clash in the Mizimizi area of Narayanganj on July 20 and died two days later.

In Lalmonirhat, at least 200 AL men, including the district unit AL general secretary Matiar Rahman, were sued over vandalising and torching BNP office on July 5. A local BNP leader filed the case with court yesterday.

Moreover, in Habiganj, a murder case was filed on Tuesday night against 261 AL men, including former Habiganj-3 lawmaker Md Abu Zahir, on charge of killing a youth named
