Floods in **Tripura** displace tens of thousands

Death toll rises to 23; Gomti river still above danger mark

Soldiers in lifeboats ferried people to safety in India's northeastern state of Tripura yesterday after heavy rain triggered floods and landslides, forcing more than 65,000 people from their homes and killing 23, authorities said.

Television images showed army personnel manning the rescue craft, while cars and buses were marooned in streets of knee-deep water, and disaster management officials said



four days of incessant rain had

"As of this morning, most rivers are flowing below the critical mark," said one of them, Suman Deb, although the intensity of the rain had reduced since Thursday night.

"However, the river Gomti still continues to flow above the danger mark," Deb said, referring to the state's main river, which flows through the district of Comilla in neighbouring Bangladesh to empty into the Bay of Bengal.

The displaced have gathered in 450 camps, the officials said, with a total of about 1.7 million affected, along with extensive damage to

infrastructure, crops and livestock. Most deaths were caused by landslides, though some followed the collapse of mud walls and drowning, another official said on condition of anonymity as he was not authorised to speak to the media.

Sit down for talks with Russia

Modi urges Zelensky in wartime Kyiv, offers to act as a friend to help bring peace; Russian strikes kill eight civilians across Ukraine

India's Narendra Modi vesterday urged President Volodymyr Zelensky to sit down for talks with Russia to end the war in Ukraine and offered to act as a friend to help bring peace as the two leaders met in wartime Kyiv.

The first visit by an Indian prime minister in modern Ukrainian history comes at a volatile juncture in the war launched by Russia in February 2022, with Moscow making slow gains in eastern Ukraine as Kyiv presses a cross-border incursion.

Modi, whose visit to Moscow last month was criticised by Kyiv, said he had come to Ukraine with a message of peace and called for dialogue between Russia and Ukraine at the earliest opportunity.

"The road to resolution can only be found The remarks were made during joint through dialogue and diplomacy. And we



should move in that direction without wasting any time. Both sides should sit together to find a way out of this crisis," Modi said.

"I want to assure you that India is ready to play an active role in any efforts towards peace. If I can play any role in this personally, I will do that I want to assure you as a friend," he said.

the visit as "historic". Modi spoke second and Zelensky did not have an opportunity to respond to the call for dialogue.

But the Ukrainian leader said in his remarks that "the matter of ending the war and a just peace are the priority for Ukraine".

Ukraine has repeatedly said it wants the war to end but on Kyiv's terms, not Russia's. Ukraine has been pushing to hold a second international summit later this year to advance its vision of peace and involve representatives from Russia.

Meanwhile, Russian strikes killed eight civilians across Ukraine, regional authorities announced yesterday. Attacks killed two in northeastern Sumy

region, the national police said. Further to the east, in the Kharkiv region bordering Russia, two civilians died in an attack, regional governor Oleg Synegubov said.

Lanka flags civil service pay hike ahead of vote

Bankrupt Sri Lanka will offer hefty salary increases and higher pensions to civil servants, President Ranil Wickremesinghe's office said yesterday just weeks before September 21 polls in which he is seeking re-election.

Wickremesinghe is seeking a mandate in September's presidential polls for his efforts to repair the island nation's ruined finances after an unprecedented 2022 economic crisis and \$46 billion foreign debt default.

Despite hiking taxes and reining in public spending, in line with an International Monetary Fund (IMF) rescue plan, his administration has backed a government committee's recommendation to boost public sector pay from next January.

"Regardless of which government is in power, there is a pressing need to increase the salaries of public servants," his office said in a statement.

The committee recommended increasing salaries by 25 to 50 percent, boosting pensions and expanding healthcare benefits for government

Israeli strikes on Lebanon's south kill seven people

Lebanon's health ministry said yesterday Israeli strikes killed seven people including a child in different parts of the south, with Hezbollah saying three of its fighters were among the dead.

Hezbollah, which is backed by Iran, has exchanged regular fire with Israel in support of its ally Hamas since the Israeli offensive in Gaza began on October. The health ministry said an "Israeli enemy drone strike" killed two people including a "seven-year-old" in Aita al-Shaab, and two other "Israeli" strikes killed five people in three other locations in the south.

Lebanon's state-run National News Agency said a "hostile drone" targeted a house in Aita al-Shaab with "two guided missiles". The health ministry said Israeli strikes included a raid "on the village of Tayr Harfa that killed three people", with Hezbollah later mourning three fighters killed by Israeli fire, including a man from that same village

Bangladesh saw a stable opening pair in Joy and Zakir Hasan in their last five Tests in between June 2023 and March 2024 and the injury of the former surely brought some anxiety in the camp before the opening Test as Shadman, who was a reserve opener in the current 16-member squad, hadn't played a Test since April 2022.

The southpaw was dropped following his poor show against South Africa in Durban where he could make only nine and zero in both innings and was unpicked in Bangladesh's next 13 Tests.

The 29-year-old reached his third Test fifty in 123 balls with another boundary -- a pull at deep backward square leg off Naseem Shah.

Shadman's fifty was also a big relief for Bangladesh as ever since the historic 312-run opening stand between Tamim Iqbal and Imrul Kayes in Khulna in 2015 -- a game in which both openers struck tons -no Bangladeshi openers were able to score a fifty against Pakistan in the following four Tests.

The only instance when Shadman looked to be troubled by Pakistani bowlers was when he was given LBW off an Agha Salman delivery just after the lunch break, but that decision had to be reversed following a review.

However, he failed to finish on a high as he was bowled by pacer Mohammad Ali in the last ball before

the time Shadman got dismissed, he already laid a solid platform for his side and also for himself as he had all but regained his

lost spot in the Test eleven. Bangladesh now trail by 132 runs and would hope at least one of the unbeaten set batters -- Liton Das, who scored 52 off 58 deliveries, and Mushfiqur Rahim, who is on 55 off 122 deliveries -- get to the three-figure mark that Shadman had missed out on.

Kaiser yesterday said students have put forward some demands, including removal of the VC. "We are vet to take any decision on terminating him.
