# 70 indigenous families attacked in the north

At least 70 families from the indigenous communities across five districts in the northern region have come under attack since the fall of the Hasina-led Awami League government on August 5.

The violence, which continued for three days, left 25 people injured and resulted in significant property

The Adivasi Chhatra Janata, a student body representing the communities in Dinajpur, revealed the details during a press conference at the Dinajpur Press Club yesterday.

Ishwar Tudu, a leader of the organisation, presented the keynote address, detailing the extent of the attacks. The violence occurred between August 5 and August 7,

affecting the districts of Dinajpur, Thakurgaon, Rajshahi, Chapainawabganj, and Naogaon.

The attacks involved looting, vandalism, and arson. In addition to the destruction of homes, the attackers also

looted fish from ponds and damaged or stole crops, with total financial losses estimated at approximately Tk 2.5 crore. Despite the severity of the attacks, no official cases have

been filed yet. The violence also included the defacement of the

Shidhu-Kanu sculpture, a monument commemorating the historic Tevaga movement, located on the way to the Kantajew temple in Kaharol upazila, Dinajpur.

## ACC forms panel to assist anti-graft operations

The panel was formed with the commission's approval, the ACC said.

The body will assist in searches with the ACC secretary's approval, the anti-graft watchdog added.

After the fall of the Awami League-government August 5 following a mass Khulna uprising. Corporation's mayor, most of the ward councillors, and pro-AL contractors fled.

As such, most of the ongoing projects of KCC have been halted since then.

KCC has been working on a Tk 823 crore project to develop the city's drainage system, and a Tk 607 crore project for renovation of the city's roads.

According to sources, most of the works of these projects were being implemented by

pro-AL contractors. Also, it has been alleged that some of the works were being done by the mayor himself and some councillors anonymously using the licence and work orders to other contractors. With them now on the run, these projects have been lying

City residents expressed concerns that solution to Khulna's existing problems, including waterlogging and dilapidated roads, will now either take much longer to be solved, or will be left incomplete midway.

At least 23 of the KCC's 31 ward councillors were directly involved in some of these project works

Abdur Razzak from ward-25 said the renovation work of at least four major drains have been suspended for two weeks, exacerbating waterlogging.

AKM Kibria Hossain, a resident of ward 28, said local residents are now being compelled to cross the 2km concrete road from Jorakal Bazar to Rupsha on foot as it has been left half done.

According around 50-70 percent works of the drainage and road development projects have so far been completed. However, unless the works resume soon, the projects may get delayed. Other halted projects include renovation of the

road in front of Kuet, and construction of a waste treatment plant in Shalua and Chitrali Market. The remaining works for all these projects are

worth around Tk 468 crore. A ward councillor, who is also contactor of at least

Enayetpur Police Station Sub-Inspector Assistant Abdul Malek filed the case.

# Ensure safe env in edn institutions **Ministry directs DCs**

The Education Ministry has instructed district commissioners (DCs) to oversee the overall maintenance of a conducive environment in educational institutions under the current

The ministry's Secondary and Higher Education Division issued an order in this regard yesterday.

The order stated that demands for the resignation or removal of heads and officials at some universities, colleges, and schools have led to unpleasant situations in various parts of the country. "In some cases, teachers have been personally

harassed, which caused a deterioration in law and order. Such a situation is unacceptable," the order At the university level, vice-chancellors, pro

vice-chancellors, or other officials may resign on their own. If necessary, the chancellor can remove them according to the law. The order also stated that the SHED or the Directorate of Secondary and Higher Education

can investigate and take necessary actions, including transfers, for heads or officials in government schools and colleges.

"Similarly, governing bodies or the DSHE can take action in the case of private educational institutions. In such cases, the relevant department or office complaint against a teacher or official," it also said.

# **MURDER CASES** Menon, Inu placed on remand

Workers Party President Rashed Khan Menon was remanded for six days and Jatiya Samajtantrik Dal President Hasanul Haq Inu for seven days yesterday in separate murder cases filed in Dhaka.

Menon, a key leader of the Awami League-led 14-Party Alliance, was remanded in the case over the death of garment worker Rubel during the mass uprising on August 5.

Dhaka Metropolitan Magistrate Md Saifur Rahman passed the order after investigation officer Mintu Chandra Banik, an inspector of Adabor Police Station, produced him before the court with a 10-day remand prayer, a sub-inspector working in the court told The Daily Star.

On August 22, Rafiqul Islam, father of the victim, filed a murder case with Adabor Police Station against former prime minister Sheikh Hasina and 147 others.

# Release detained **UPDF** supporters **Demands Mikel Changma**

United People's Democratic Front's organiser Mikel Changma yesterday urged the interim government to release 29 supporters of the organisation and its affiliated bodies from jail.

Speaking at a press conference at the Jatiya Press Club, Mikel Changma highlighted that while political prisoners in other regions are being released, UPDF leaders and activists in the Chittagong Hill Tracts remain incarcerated, with some detained for over five years.

Mikel presented an eight-point demand, including the formation of a special tribunal to investigate all murders and human rights violations in the CHT during what he described as "the fascist regime of Hasina".
