Bangladesh seeks to shore up reserves, repay liabilities

The government is seeking as much as \$8 billion in budget support by December from the development partners, including the International Monetary Fund (IMF), to pay back foreign liabilities and boost foreign

It is also working to get immediate funds from the Asian Development Bank (ADB) and the World Bank for rehabilitation programmes in areas

# Govt lifts ban on Jamaat, Shibir

The Jamaat-e-Islami yesterday regained its right to do politics as the interim government revoked the executive order issued by the ousted Awami League government banning the Islamist party and its student wing Islami Chhatra Shibir. The home ministry issued a gazette in this regard.

Jamaat, Shibir and all of Jamaat's front organisations were banned on August 1 as political parties and entities under the Anti-Terrorism Act-2009.

The official said an IMF staff mission is likely to visit Bangladesh to discuss the loan towards the end of next month. After the visit, Bangladesh will formally send a letter to the IMF, seeking the additional loan.

IMF officials informed the finance ministry and the central bank that it was assessing how much it could lend Bangladesh, going beyond the existing quota for the country.

The officials said a meeting on the loan arrangement could be held on the sidelines of the World Bank-IMF Annual Meetings in Washington in October. Finance Adviser Salehuddin Ahmed and the central bank governor are likely to take part in the meeting.

The IMF has so far released \$2.3 billion under the \$4.7 billion loan programme since its approval in January last year.

After the interim government took charge, the World Bank and the ADB held separate meetings with the finance adviser, the energy adviser and the central bank governor. Bangladesh sought more budget support from them during the meetings but did not specify any amount.

The energy adviser during meetings with the World Bank and the ADB sought \$1 billion as immediate budget support, according to officials familiar with the development.

Officials at the Economic Relations Division said they could get funds from the World Bank under three arrangements -- a policy-based loan, diverted regional funds or from slow-moving projects.

Besides, Bangladesh could quickly get \$1 billion to \$1.5 billion from the ADB under two arrangements -- a policy-based loan or countercyclical support. Both JICA and AIIB could join the ADB arrangement, according to officials.

The interim government took charge amid pressure of high inflation and bleeding of foreign currency reserves which have been prevalent for almost two years.

The home ministry on that day issued a gazette banning those outfits following the law ministry's approval. The AL government had taken the decision as per Section 18 (1) of the Anti-Terrorism Act-2009.

"The government has enough evidence that Bangladesh Jamaat-e-Islami and Islami Chhatra Shibir were involved in recent killings and destructive and terrorist activities directly and through incitement," read the gazette.

Following a writ petition, the High Court in August 2013 declared Jamaat's registration with the Election Commission illegal. The Supreme Court later upheld the HC verdict, it added.

### SAFF U-20 C'SHIP Next gen seal elusive silverware

Forward Mirajul Islam starred with a brilliant brace and an assist to power Bangladesh to a 4-1 victory over hosts Nepal in the title-decider of the SAFF U-20 Championship at the ANFA Complex in Lalitpur yesterday.

Rabby Hossain Rahul and Piash Ahmed Nova also netted home in an enthralling final where the two-time champions Nepal dominated much of the play. However, it was Bangladesh who rose to the challenge, lifting a trophy that had eluded them since the competition's inception in 2015.

## 'Hold talks with political parties on your tenure' Fakhrul urges interim govt, says BNP hasn't forgotten 1/11
