# My conscience drove me:

JEETU AHSAN

Actor Jeetu Ahsan, renowned for his powerful performances in film and television, found himself in the midst of protests during the recent anti-discrimination student movement. On August 4, Jeetu joined the student protesters at Shaheed Minar, standing in solidarity with those fighting against the violence and injustice gripping the country.

In an exclusive interview with The Daily Star, Jeetu shared the profound impact recent events had on him, compelling him to take a

place meant for healing. How could that be acceptable? My conscience wouldn't let me stay silent."

Despite his family's advice to remain cautious, Jeetu felt a moral obligation to act. "There was a clash at Dhanmondi 27, where a student from Residential Model College lost his life. His birthday was the same as mine, September 12. I couldn't help but

think about how many dreams he and his parents must have had, now all shattered," he reflected.

Driven conscience, Jeetu visited the scene at Dhanmondi 27 and later shared his thoughts on Facebook. "Everything I've done has been guided by my conscience. No one pressured me, and I wasn't afraid. Some friends warned me that speaking out could cause problems, but I did it anyway," he said.

Jeetu also spoke about the tragic incident involving Mugdho, a young student whose video distributing water during the protests went viral. "That video haunted me. couldn't sleep that night. I just couldn't shake the scenes from my mind. After that, we faced an internet shutdown, and social media became inaccessible," he recalled.

Jeetu was one of the artistes who gathered in

front of the Abahani Field on Sat Masjid Road, defying the downpour on August 2 to protest under the banner Artistes Against Genocide and Oppression. He voiced his concerns to the media, condemning the oppression carried out by the former AL-led government. The following day, he participated in protests at Shaheed Minar, driven not by a desire for heroism but by a deep sense of responsibility. "Thousands of students and citizens were out there, and I stood with them," he shared.

It's been a few weeks since the interim government assumed leadership of the country's administration. Regarding this, Jeetu shared, "I want to see a beautiful Bangladesh, one that is free from discrimination. I understand that change won't happen overnight. It will take time, but the effort must begin now."

He further emphasised, "The country, our motherland, must always come first. If we prioritise patriotism, our nation will progress and become more beautiful."

He also expressed concern for those affected by the severe floods in several districts, where millions are stranded. "It's heartbreaking to witness the suffering of the flood victims. These people are enduring immense pain, and

while this is a natural disaster, it doesn't lessen their hardship. I sincerely hope the water recedes quickly."

> Jeetu noted that he has been acting for over two decades, having significant contributions dramas television during his career. His work has been widely praised, following in the footsteps of his father, the esteemed actor Syed Ahsan Ali Sydney.

Reflecting on his career,

Jeetu remains active in the industry, performing in dramas, on OTT platforms, and in films. His

portrayal of Hanif Sikdar in the film Gohin Baluchor, directed by Badrul Anam Saud, received widespread acclaim and left a lasting impression on audiences.

When asked about his natural acting style, Jeetu replied, "I have a deep love for acting. This love is intertwined with my craft. I simply put in the effort; the rest is the audience's love. It's the quality work that stays in their hearts.

Jeetu's frustration grew when he heard about students being attacked while receiving treatment at hospitals, including Dhaka Medical College Hospital (DMCH). "It was sheer madness," he remarked. "Students, already critically injured, were being assaulted in a
